Delimitation Commission empowered to redraw constituencies in J&K: Centre to SC

New Delhi, Dec 01

The Centre on Thursday told the Supreme Court that a delimitation commission formed to redraw the Legislative Assembly and Lok Sabha constituencies in Jammu and Kashmir was empowered to do so.

Seeking dismissal of plea challenging challenging the government's decision to constitute a delimitation commission, Solicitor General Tushar Mehta, appearing for the Centre, told the top court that the Jammu and Kashmir Reorganisation Act, 2019 does not preclude the establishment of Delimitation Commission by the Central government.

"It is submitted that Sections 61 and 62 of the 2019 Act do not preclude the

establishment of Delimitation Commission by the Central Government under section 62 of the 2019 Act... It is submitted that the 2019 Act provides for two alternative mechanisms to carry out delimitation for the Union Territory of Jammu and Kashmir. "By virtue of Sections 60-61, while the

power to determine delimitation is conferred on Election Commission, Section 62(2) and 62(3) confers powers to carry out delimitation on the Delimitation Commission constituted under Section 3 of the Delimitation Act," Mehta told a bench of Justices S K Kaul and Abhay S Oka which reserved its



verdict on Thursday.

On March 6, 2020, Union Ministry of Law and Justice (Legislative Department) had issued a notification in exercise of power under Section 3 of the Delimitation Act, 2002, constituting a Delimitation Commission, with former Supreme Court judge (Retd) Ranjana Prakash Desai as the chairperson.

The Solicitor General also opposed the submission of the petitioners that Article 170 of the Constitution barred delimitation exercise on the basis of the 2011 census.

He said petitioners are wrong in their submission that delimitation exercise had to either happen on the basis of 2001 census or

GST Revenues Rise 11% To Rs 1.46 Lakh Crore In November

Rs 1.4 lakh crore mark. However, the collection in November was the lowest since August.

In October, GST collections had touched the secondhighest level of Rs 1.52 lakh crore on festive spending.

The gross GST revenue collected in the month of November 2022 is Rs 1,45,867 crore of which Central GST is Rs 25,681 crore, State GST is Rs 32,651 crore, Integrated GST is Rs 77,103 crore (including Rs 38,635 crore collected on import of goods) and cess is Rs 10,433 crore (including Rs 817 crore collected on import of goods).

'The revenues for the month of November 2022 are 11 per cent higher than the GST revenues in the same month last year, which itself was Rs 1,31,526 crore," the Finance Ministry said in a statement.

KPMG Partner Indirect Tax Abhishek Jain said continuing festive procurements, year-end reconciliations of input tax credits, credit notes, etc. would have played a significant role in the GST revenue uptick.

N.A. Shah Associates, Partner, Indirect Tax, Parag Mehta said the major factors for the increase in collections are the festive and wedding seasons.

'There has also been a major increase in sales for real estate and vehicle markets. Overall, there is substantial spending by consumers. Further, the authorities have been cracking down on tax evaders, defaulters, fake invoice instances etc," Mehta said.

AMRG & Associates Senior Partner Rajat Mohan said GST collections for the month of October 2022 are encouraging and now it seems to be stabilizing around 1.5 lakh crores.

'October and November are festival months, which drove up purchases of goods and services, fueling GST numbers once again. In October, individuals splurged on real estate, automobiles, vacations, and other essential items," Mohan said During November, revenues from the import of goods were 20 per cent higher and the revenues from the domestic transactions (including import of services) are 8 per cent higher than the revenues from these sources during the same month last

TIOL Knowledge Foundation, Chairman Shailendra Kumar said a very good sign is the sustained growth in IGST collections from imports, including services. This will cushion future growth in the economy.

Revenues from GST touched a record of about Rs 1.68 lakh crore in April. In May, the collection was about Rs 1.41 lakh crore, June (Rs 1.45 lakh crore), July (Rs 1.49 lakh crore), August (Rs 1.44 lakh crore), September (Rs 1.48 lakh crore), October (Rs 1.52 lakh crore) and November (Rs 1.46 lakh crore).

Tax Connect Advisory Partner Vivek Jalan said the Budgeted GST Revenue for the Government of India for 2022-23 was Rs 7.8 lakh crores out of which Central GST was Rs 6.6 lakh crore and compensation cess was Rs 1.2 lakh crore. It means that the budgeted GST collection is Rs 14.4 lakh crore approx. Till the month of November, Rs 11.91 lakh crore has already

"Hence even if one takes a conservative estimate of Rs 5 lakh crore in the next 4 months, then the fiscal year would end with an uptick of Rs 2.5 lakh crore approx which is a 17 per cent growth over budget," Jalan added. (Agencies)

J-K holds special value to embrace spiritual tourism in the country as Jammu is the city of temples while Kashmir is locally known as Rish-ver, the abode of

India made world's first COVID nasal vaccine

gets approval: Dr Jitendra

development and Clinical trials were funded by the Department of biotechnology, Government of India and BIRAC under the Mission COVID Suraksha Program. This vaccine received approval under restricted Use in emergency situations for ages 18 and above for primary 2 dose schedule, homologous booster doses.

Dr Jitendra Singh said, India's efforts through Mission COVID Suraksha under the dynamic leadership of Prime Minister Narendra Modi has not only strengthened AtmaNirbhar Bharat but also bolstered India's status as a worldwide vaccine development and manufacturing center showcasing the strength of Science and Technology. It is a matter of great pride for the country, the Minister added.

Phase-III trials were conducted for safety, and immunogenicity in ~3100 subjects, in 14 trial sites across India (supported by BIRAC). Heterologous booster dose studies were conducted for safety and immunogenicity in ~875 subjects, where a booster dose (3rd dose) of BBV154 intranasal vaccine was administered to study participants who were previously vaccinated with licensed COVID vaccines. The clinical trials were conducted in 9 trial sites across India. National Institute of Immunology (NII), an autonomous institute of DBT in New Delhi utilized their "Human Immune Monitoring and T-cell Immunoassay Platform" to examine the vaccine-induced SARS-CoV-2-specific systemic and mucosal cellular immune responses the trial participants. Interactive Research School for Health Affairs (IRSHA), Pune (supported by BIRAC) completed the "Plaque Reduction Neutralization Assay" (PRNT) to quantify the titer of neutralizing antibody for the virus from three trial sites.

This vaccine has the double benefit of enabling faster development of variant-specific vaccines and easy nasal delivery that enables mass immunization to protect from emerging variants of concern. It promises to become an important tool in mass vaccinations during pandemics and endemics.

Vaccine is a recombinant replication deficient adenovirus vectored vaccine with a pre-fusion stabilized spike protein. This vaccine candidate was evaluated in Phases I, II and III clinical trials with successful results. It has been specifically formulated to allow intranasal delivery through nasal drops. The nasal delivery system has been designed and developed to be cost-effective in low- and middle-income countries. This vaccine is stable at 2-8°C for easy storage and distribution. Large manufacturing capabilities have been established by Bharat Biotech at multiple sites across India, including Gujarat, Karnataka, Maharashtra, and Telangana, with operations pan India.

In another historic and path-breaking decision, Dr Jitendra Singh today approved subsuming of 14 Autonomous Institutions of DBT to create one Apex Autonomous Body – Biotechnology Research and Innovation Council (BRIC) for achieving centralized and unified governance to maximize impact of biotech research.

Dr Jitendra Singh the move is a tribute to Prime Minister Modi's vision of "Minimum Government, Maximum Governance" as well as his call for Greater Integration of Ideas and Institutions for cost-cutting and effective output.

Dr Jitendra Singh explained that the restructuring of DBT institutes is being carried out with a larger goal to enhance the scientific character and science outcomes at the institutes by building research synergies, new education programs in line with National Education Policy, improving human resource structures across cadres and effective management and monetization of assets emanating from the research being carried out.

The Minister hoped that BRIC will build on the foundations developed at the DBT institutions to foster synergies while maintaining their distinct research mandates. With an emphasis on interdisciplinary interactions that cut across institutional boundaries, BRIC institutes will undertake cutting edge research addressing national priorities, the Minister added.

Secretary, DBT, Rajesh Gokhale earlier welcomed the Minister and oversaw the presentation of Science activities in 2021-2022 by 9 Institutes today, while remaining 5 will give their presentations tomorrow.

"The idea was that last delimitation under the old regime took place in 1995. It was also the government's idea was to immediately give democracy to the newly-formed Union Territory... For that to wait till 2026 or to do it as per 2002 was found to be legislatively unwise. The reorganisation provided for Section 59 recognising that commission would be more apt," Mehta told the top court.

The counsel appearing for the two petitioners, Haji Abdul Gani Khan and Mohammad Ayub Mattoo, had argued that the delimitation exercise was carried out in contravention of the scheme of the Constitution and alteration of boundaries and inclusion of extended areas should not have been done

The plea had sought declaration that the increase in the number of seats from 107 to 114 (including 24 seats in Pakistan Occupied Kashmir) in Jammu and Kashmir is ultra vires constitutional provisions and statutory provisions, particularly under section 63 of the Jammu and Kashmir Reorganisation Act, 2019. It had said the last delimitation commission was set up on July

12, 2002 in exercise of powers conferred by section 3 of the Delimitation Act, 2002 after the 2001 census to carry out the exercise throughout the country. The plea had said the commission had issued guidelines and

methodology for the delimitation of assembly and parliamentary constituencies vide letter dated July 5, 2004 along with the constitutional and legal provisions. "It clearly stated that the total number of existing seats in the

Legislative Assemblies of all states, including UTs of the National Capital Region and Pondicherry, as fixed based on the 1971 census shall remain unaltered till the first census to be taken after the year 2026," the plea had said. It had sought to declare as unconstitutional the notification

dated March 6, 2020 constituting the delimitation commission to take up delimitation in the UT of J&K and states of Assam, Arunachal Pradesh, Manipur, and Nagaland by the Centre.

The plea had also challenged the consequential omission of Assam, Arunachal Pradesh, Manipur and Nagaland from the process of delimitation vide notification dated March 3, 2021, claiming that it amounts to classification and violates Article 14 (equality before law) of the Constitution. Today, the world has the means to produce enough to meet the basic needs of all people. "Today, we do not need to fight for our survival — our era need not be one of war. Indeed, it must not be one," he said.

Fortunately, today's technology also gives us the means to address problems on a humanity-wide scale, he said, adding that India with one-sixth of humanity and with its immense diversity of languages, religions, customs and beliefs is a microcosm of the world, he added

For imbuing hope in our future generations, India will encourage an honest conversation among the most powerful countries on mitigating risks posed by weapons of mass destruction and enhancing global security, he said.

As the "mother of democracy," India's national consensus is forged not by diktat but by blending millions of free voices into one harmonious melody, he said.

India is now the fastest growing large economy and its "citizen-centric governance model" takes care of even its most marginalised citizens, while nurturing the creative genius of its talented youth, he said.



Why hasn't EC acted against Amit Shah for violating MCC in Gujarat?

he BJP campaign for the Gujarat assembly election gives an insight as to how Gujarat became a 'laboratory' for the Hindutva forces and how the corporate-communal axis was forged that became known later as the 'Gujarat model'.

Some of Amit Shah's assertions in his election speeches have been startling for many outside Gujarat, but they reflect how the RSS-BJP have succeeded in inverting the reality and building a false narrative.

According to Shah, the communal pogrom against Muslims in 2002 was actually an instance of "rioters" being "taught a lesson". They were put down firmly by Narendra Modi who was the chief minister then. Since then, 'permanent peace' has been established in Gujarat. Peace of the graveyard as far as the Muslims are concerned.

Shah also accused the previous Congress governments (before 1995) of being soft on communal rioters. Thus, the biggest pogrom against minorities after independence is now being depicted as a firm suppression of 'rioters' who are all presumably Muslims.

It is this sort of warped thinking which has led to the rapists and murderers of Bilkis Bano and her family members to be released from prison by granting remission of their life sentences. According to the Gujarat government, it was Amit Shah-led Union Home Ministry that approved the remission.

The other refrain in the BJP campaign, which was voiced by Modi himself, is that the Opposition parties support anti-national or anti-Gujarat forces. Modi has attacked Congress and other smaller parties for viewing terrorism through the prism of vote banks and appeasement. So the defence of secularism and the rights of minorities translates into being soft on terrorism and therefore, anti-national.

It is such a bigoted outlook that led to the arrest and jailing of Teesta Setalvad and former DGP, R B Sreekumar, for taking the judicial route to seek justice for the victims of the pogroms.

The current campaign echoes what has been the approach during the entire tenure of Modi as Gujarat chief minister – a continuous effort to conflate Pakistan and terrorism with the minorities and accusing the secular parties of mi-

nority appeasement and hence complicity with terror. All those who question this narrative are branded anti-national and anti-Guiarat

The growth story in Gujarat has been distinctive for the emergence of the corporate-communal regime. The entire corporate sector and capitalist class rallied firmly behind Modi and the BJP. The advancement of the industry has been marked by the huge concentration of assets and wealth in the hands of big business and mercantile houses, while the urban and rural workers are paid some of the lowest wages in the country.

The contrast between the high levels of growth of the state's gross domestic product and the low level of social indicators is stark.

The discontent among the poorer sections and socially oppressed groups due to price rise, unemployment, and lack of educational and health facilities has surfaced during the election campaign. But as before, the deep-rooted communal polarisation which exists, is sought to be utilised to blunt such anger.

The target of the communal campaign – the Muslims – are themselves living in ghettoised and wretched conditions. In the

cities, there is a visible divide wherein the Muslim localities are in deplorable conditions deprived of basic civic facilities.

The BJP is confident that its mix of toxic Hindutva propaganda and promises of more benefits to labharthis (beneficiaries) should be enough to get its way with the elec-

There is nothing to check the poisonous communal propaganda. It has become normalised because of the failure of the Election Commission to intervene and act against repeated violations of the model code of conduct in previous assembly elections and the Lok Sabha elections of 2019 when Narendra Modi and Amit Shah were the culprits.

Regarding this election campaign in Gujarat, a retired senior civil servant, EAS Sarma, had written to the Election Commission to take action against Amit Shah for his speeches violating the model code of conduct and invoking the provisions of the Indian Penal Code. There was no response from the EC.

Is it because in the current dispensation, it is the Union Home Minister who sets down the law in such matters?

Twitter censoring Left tweets exposes Musk's claim of being 'free speech absolutist'

HONESTLY BELIEVED ELON Musk would use his ownership of Twitter to champion free speech. Besides the fact that the man is a professional bullshitter, it was always dubious that a guy who slaps employees with gag orders and bars them from wearing pro-union messages had a genuine commitment to the proverbial marketplace of ideas.

No one is more eager to hawk the idea of Musk as a free-speech warrior, of course, than Musk himself, who framed his growing entanglement in the social media platform around defending the principle, and recently retweeted a satirical headline charging that he'd "threaten free speech on Twitter by literally allowing people to speak freely."

Reportedly telling staff he wanted the platform to be "the digital town square" by "represent[ing] people with a wide array of views even if we disagree with those views," Musk has reinstated a spate of reactionary Twitter accounts that had been suspended, including those of Jordan Peterson, Project Veritas, and former president Donald Trump.

But it's looking more and more like the Tesla CEO's supposed commitment to free expression only goes as far as his own political biases.

At the same time that Musk has been playing footsy with noxious right-wing figures and giving a voice back to their faves, he's also banned a string of left-wing accounts - seemingly at the prodding of those same noxious voices.

Left-wing accounts being suddenly and inexplicably banned is sadly nothing new on Twitter. But what makes this instance more disturbing is that it immediately followed an exchange Musk had with far-right influencer Paul Ray Ramsey - seen here posing with neo-Nazi Richard Spencer at a conference they both spoke at whose post about Twitter "nuking pedo accounts" led Musk to personally urge the video blogger to report "anything that Twitter needs to address."



He also had an exchange with right-wing troll Andy Ngo, known for his lie-filled vendetta against Antifa. Told by Ngo that "a large number of Antifa accounts operate on Twitter" to incite various acts of violence, Ngo and the Twitter CEO then had a back-and-forth about the importance of reporting and suspending such accounts.

It ended with Ngo singling out CrimethInc for trying to "radicalise people into criminal militancy," pointing to a number of anodyne social media posts by the group, the most edgy of which was a zine about breaking windows and "the effectiveness of political vandalism." Within a few hours, the account was suspended.

This wasn't an isolated event. Journalist Steven Monacelli documented the suspensions of several more leftist accounts in recent days, including the Elm Fork John Brown Gun Club (EFJBGC), an armed left-wing group that goes to LGBTQ events that far-right militants, including some armed groups, plan to attend; Vishal Singh, a leftwing journalist and documentarian based in California who reports on the far right and law enforcement; and Chad Loder, a Los Angeles-based cybersecurity expert who used his Twitter

It's unclear how much of this is a reflection of Musk's true longstanding political leanings, or if he's taken a similar journey of Twitter-fuelled political derangement to other high-profile figures, ensconcing himself in a right-wing intellectual bubble that now drives his thinking.

In any case, after once making the questionable claim that Twitter "has a strong left wing bias," Musk now seems to have decided the solution is giving it a strong far-right bias instead.

It's also not clear how much of this anti-left censorship is due to Musk personally. But besides his personal interaction with reactionaries who have pushed to suppress groups they politically disagree with, we know Twitter's content moderation team was explicitly ordered to reinstate the conservative satirical outlet Babylon Bee - whose ban had first prompted Musk to muse about buying the platform - hours after he took ownership.

We also know that Musk told employees last week that his planned content moderation council would be purely advisory, and that he would "either agree with it or I won't," suggesting a more hands-on approach from the CEO on the subject of censorship

The real problem is that, in the

society and economic system we've created, a moron can take over a critical public resource like Twitter on a whim, as long as he or she has an enormous hoard of wealth that this system has allowed them to accrue, at which point they'll promptly inject their own blinkered biases into the way the platform operates.

This is why voices on the Left have not just warned about the dangers of resorting to excessive, heavy-handed censorship on such platforms, since changes in ownership, individual biases, and human error all mean speech one personally doesn't object to can have a target for suppression.

become a target for suppression.

They've also called for public ownership, or at the very least greater state regulation, of platforms like Twitter that have clearly become integral to life today, to provide some modicum of democratic control over them and save us from the whims of erratic billionaires.

Other possible solutions don't seem so promising. Some have fled Twitter in protest and joined "decentralized" alternatives like Mastodon, where groups and individuals can make their own servers with their own particular rules.

Yet among other things, this potentially just repeats the situation with Musk on a smaller scale, as antiwar group Code Pink recently found when it was banned from a Mastodon server by a moderator who had "re-

ceived reports the organisation was affiliated with some less than savoury groups" and was deemed "potentially controversial."

Musk is now facing an advertiser revolt, and one advertiser, the tech behemoth Apple, has, according to the billionaire, "threatened to withhold" the platform from its App Store, a potentially powerful blow to Twitter's market share if true.

This could in theory force a change to Musk's policies by essentially strong-arming him into backing down.

But do we really want the rules that govern social media platforms dictated instead by similarly unaccountable corporations using their economic heft or, in Apple's case, their monopoly power to force a change to policies they don't like?

Remarkably, in spite of all this, the liberal discourse around Musk's helming of Twitter continues to be framed in exactly the (untrue) way that he prefers it: of Musk as an overzealous free-speech champion, endangering the world through his commitment to a principle that he's shown he doesn't actually give a damn about.

This hail of misguided and reality-divorced liberal criticism ironically gives Musk the exact cover he needs, convincing the uninformed he really does walk the walk on free speech, and allowing him to keep tweeting self-aggrandizing nonsense like, "This is a battle for the future of civilization. If free speech is lost even in America, tyranny is all that lies ahead."

Yet that tyranny is already here, largely thanks to the figure of Musk himself, and to the kind of society that lets those with wealth treat vital public goods as their own personal playpens.

There's a real conversation to be had about how exactly to strike the tricky balance between protecting free expression on social media platforms and providing a safe and enjoyable user experience.

But to have that conversation, we have to wrench control of this digital public square from censorious billionaire frauds like Musk first

England sets record on first day of Test against Pakistan

NEW DELHI, DEC 01

Virus-hit England stamped its aggressive brand of cricket on its first Test in Pakistan in 17 years by amassing a world record 506-4 with four batters smashing hundreds on Thursday.

Zak Crawley hit 122 and Ben Duckett made 107 in a blistering opening stand of 233. Ollie Pope and Harry Brook blazed hundreds in the last session in an astonishing display of power-hitting against an inexperienced Pakistan bowling attack.

And the Test almost didn't start.

England confirmed it had a fit 11 and the match could go ahead only two hours before the toss. Then it destroyed a host of records in only 75 overs before play ended prematurely because of bad light.

The 506-4 total was the highest on the first day of any Test, surpassing Australia's 494-6 in 1910 against South Africa in Sydney. England also became the fastest team to score 500 runs.

Pope, who will keep wickets after Ben Foakes couldn't recover from a viral infection that hit the England camp, cemented coach Brendon McCullum's aggressive approach by making 108.

Brook struck six fours in one over by debutant Saud Shakeel in the final session to reach 101 not out. Captain Ben Stokes, who won the toss and elected to bat after recovering in time from the virus, was not out on 34 off 15 balls.

England batters smashed 73 boundaries and three sixes in a white-ball fireworks display with the red ball.

In the absence of injured spearhead Shaheen Afridi, Pakistan opted to hand debuts to three bowlers; fast bowlers Haris Rauf and Mohammad Ali, and legspinner Mohammad Zahid.

But none of the bowlers could extract any help from a slow, grassless pitch at Pindi Cricket Stadium.

Surprisingly, Joe Root was the only batter to miss out when he fell to Mah-



Rauf (1-78) and Ali (1-96) shared the other wickets.

Crawley and Duckett combined in a better-than-run-a-ball 233 stand before Pakistan picked up three wickets in the middle session when Mahmood and Rauf struck in successive overs with the

Mahmood broke the stand when Duckett went for a reverse sweep against the leg-spinner and Pakistan successfully went for a TV referral against on-field umpire Joe Wilson's not-out decision.

Rauf then swung in late and clattered Crawley's stumps in the next over. But England's intent to score at pace didn't subside after the dismissal of the two century-makers.

Joe Root was out lbw for 23 when he was struck on the back leg while attempting a sweep.

Crawley was on 99 when Naseem Shah trapped him on the backfoot, but Crawley successfully overturned the decision as the video suggested the ball would have missed the leg stump.

Two balls later, Crawley achieved the fastest test century by an England opener off 86 balls with a cover-driven boundary, and Duckett reached his maiden hundred by pulling Rauf to the

Crawley and Duckett stormed England to 174-0 in the first session.

Crawley missed an oppourtunity to become the first Englishman to smash a century before lunch in a test match when he reached 91, while Duckett dominated Mahmood's spin to make 77.

Crawley was ruthless against Rauf's short-pitched deliveries and the gentle medium pace of Ali, too, to raise his half-century off only 38 balls with 11 fours. He hit another six boundaries in Duckett dominated the leg-spin of

Mahmood with his trademark sweep shots and didn't hesitate to attack the spinner early with a reverse-swept boundary. He completed his maiden Test half-century off 50 balls.

The start of the Test was confirmed at only 7.30am local time after the Pakistan Cricket Board said England "informed (them) they are in a position to field an XI, and, as such, the first test will commence as per schedule today."

England had to make a change in its playing XI at the last minute. Foakes was replaced by Will Jacks, who will make his test debut, and Pope will keep. Liam Livingstone will also debut.

French federation files complaint over disallowed goal

The French football federation (FFF) is filing a complaint with FIFA over Antoine Griezmann's disallowed crucial equalizer goal at the end of a 1-0 loss to Tunisia at the World Cup on Wednes-

Following a VAR review, Referee Matthew Conger ruled out the equaliser goal by disallowing it. The goal was scored towards the end of the final minute of the

The FFF released a statement overnight raising their complaint. "We are writing a complaint after Antonine Griezmann's goal was, in our opinion, wrongly disallowed. This complaint has to be filed within 24 hours after the final whistle," the FFF said in a statement.

According to reports, Conger restarted the match after



the goal and then blew the final whistle after which he consulted VAR and ruled out Griezmann's goal.

It was reported that Griezmann was in an offside position when a cross came over but then retreated and appeared to be played back into an onside position following a Tunisia defender's deflection when he shot into the bottom left corner.

The FFF said that it had 24 hours from the end of the match to file an official complaint with governing body FIFA.It was France's first World Cup defeat since 2014 when it lost 1-0 to Germany in the quarterfinals.

Defending champion France finished atop Group D on goal difference from Australia and will face Poland in the last 16 on Sunday.

FIFA WC: Mexico beat Saudi, but both teams ousted

New Delhi, Dec 01

Mexico scored twice in five second-half minutes in a thrilling last-ditch effort to stay in the World Cup on Wednesday, beating Saudi Arabia 2-1 but agonisingly missing out on the last 16 on goal difference.

Goals from Henry Martin and Luis Chavez soon after the interval catapulted Mexico back into contention, but a string of superb saves by Saudi keeper Mohamed Al-Owais and two disallowed efforts denied the South Americans the elusive goal they needed to ad-

The match went right down to the wire and at one point looked like Mexico would miss out to Group Crivals Poland by virtue of having accrued more vellow cards, but Saudi striker Salem Al-Dawsari netted in stoppage time to make goal dif-

ference the decider. Mexico's exit ended a run of



pearances at the World Cup and the defeat for Saudi Arabia killed off what had looked to be a realistic chance of advancing from the group stages for the first time in 28 years.

Having failed to score in their opening two Group C matches, Mexico's chances of progressing had looked slim going into the match, hinging on the outcome of the game between Argentina and Poland which Argentina won 2-0 to top the Urgently needing to beef up

their goal difference, Mexico took the game to Saudi Arabia from the start and never stopped running, peppering the goal with long-range efforts in a desperate bid to wrest control of their own fate.

Orbelin Pineda and Chavez were the engines in a high-octane match that the Saudis struggled to get into, defending with desperation.

Mexico broke the deadlock two minutes after halftime when Cesar Montes's deft back-heel from a corner found Martin who bundled the ball over the line in a crowded goal-

They doubled their lead five minutes later when Chavez's powerful free kick 20 metres out sailed into the corner of the goal beyond the reach of Al-Owais, sparking who Mexicar celebrations on the field.

Lozano found the net but his goal was disallowed and Mexico battled hard to get the decisive third but were denied constantly by the reflexes of Al-Owais in the Saudi goal.

Substitute Uriel Antuna had a stunning late effort disallowed for offside four minutes from time before Al-Dawsari shattered Mexican hopes when he grabbed a Saudi consolation goal deep into stoppage time.

Leader Messi key to Argentina's WC title hopes

Lionel Messi may be making his last World Cup appearance in Qatar but the talismanic forward is still capable of spurring Argentina to a third World Cup title, his compatriot and former Paris St Germain head coach Mauricio Pochettino said.

Pochettino, who is well aware of Messi's game-changing abilities having worked with the 35-year-old last season, said he was still the best player in the world.

"Messi will always be decisive. He's the best player in the world," Pochettino, 50, told Argentine newspaper Ole.

"Messi has the role today that can give Argentina the World Cup. He's the clear leader of this team and everyone understands that he's the leader, all the energy is focused on that."

The Parisian club parted ways with Pochettino in July after an 18-month stint where he won the 2020-21 French Cup and 2021-22 Ligue 1 title but failed to deliver in the Champions League.

Pochettino also managed Brazilian striker Neymar and France's Kylian Mbappe at PSG,



"They're players who will always surprise you... You can understand the dimension of each one," Pochettino said.

"In football terms, I highlight Messi's simplicity. The ability to make everything simple. "It's very difficult to remember a training

The Australian prime

minister offered congratulations but left the public holiday question unaddressed.

Gen Bajwa, 61, retired on November 29 after getting a threeyear extension in 2019 by the then Prime Minister Imran Khan, who turned out to be the biggest critic of the Pakistan

It saw East Pakistan secede to form a new country called Bangladesh.

UK royals arrive in Boston to showcase youthful monarchy

New Delhi, Dec 01

The Prince and Princess of Wales embarked on their first overseas trip since the death of Queen Elizabeth II, aiming to showcase the younger face of a monarchy that is tackling important issues like climate change as it attempts to remain relevant in a modern, multicultural Britain.

The three-day trip to Boston is focused on Prince William's splashy initiative to award millions of dollars to a new generation of environmental entrepreneurs who are developing everything from cleaner burning stoves to alternatives to leather. It will include visits to a program for at-risk youth, a sustainability lab and a tour of Boston's shoreline to see the city's effort to combat climate change.

The event that started on Wednesday will culminate on Friday in the awarding of the Prince's signature Earthshot Prize, a global competition aimed at finding new ways to protect the planet and tackle climate change.

After their arrival, the beaming royal couple strolled onto a stage at City Hall Plaza William wearing a single-vent navy suit and Kate radiant in a Burberry dress and Alexander McQueen coat, and earrings by designer Shyla London amid tight security and a cheering crowd, many snapping photos and video.

Prince William told the crowd that one of President John F. Kennedy's speeches was the inspiration to hold the second Earthshot Prize in Boston.

It was that moonshot speech that inspired me to launch the Earthshot Prize with the aim of doing the same for climate change as President Kennedy did for the space race. And where better to hold this year's awards ceremony than in President

Kennedy's hometown," William said. Later, the couple sat courtside for a

Boston Celtics-Miami Heat game, joined by team managing partner Wyc Grousbeck, co-owner and president Steve Pagliuca and his wife, Judy, along with Boston Mayor Michelle Wu and Massachusetts Gov.-elect Maura Healey.

The royal couple was announced to a cheering Garden crowd during a timeout in the second quarter and briefly shown on the video screen. But a security official stepped in front of the camera, eliciting a chorus of

The visit comes less than three months after the death of Queen Elizabeth, whose personal popularity dampened criticism of the crown during her 70-year reign. King Charles III, William's father, has made clear that his will be a slimmed-down monarchy, with less pomp and cere mony than its predecessors.

I think this is less about saving the Earth and more about saving the royal family," said Boston University professor Arianne Chernock, an expert in modern British history. To be honest, we've seen Charles as king and his first months in that position trying to feel his way, find his way towards being a more relevant, more modern monarch. And I think we see something similar happening with William and Kate."

Part of that reset involves reclaiming the hearts and minds of people in America, where William's younger brother, Prince Harry, and sister-inlaw, Meghan, have dominated the media since moving to California in 2020. Harry and Meghan have criticized the royal family for alleged racism and insensitive treatment and built their own media profile by making films and podcasts for Netflix and Spotify.

Emboldened House Democrats ushered in a new generation of leaders on Wednesday with Rep. Hakeem Jeffries elected to be the first Black American to head a major political party in Congress as long-serving Speaker Nancy Pelosi and her team step aside next year.

Showing rare party unity after their midterm election losses, the House Democrats moved seamlessly from one history-making leader to another, choosing the 52-year-old New Yorker, who has vowed to get things done, even after Republicans won control of the chamber. The closed-door vote was unanimous, by acclamation.

It's a solemn responsibility that we are all inheriting, Jeffries told reporters on the eve of the party meeting. And the best thing that we can do as a result of the seriousness and solemnity of the moment is lean in hard and do the best damn job that we can for the people.

It's rare that a party that lost the midterm elections would so easily regroup and stands in stark contrast with the upheaval among Republicans, who are struggling to unite around GOP leader Kevin McCarthy as the new House speaker as they prepare to take control when the new Congress convenes in Janu-

Wednesday's internal Democratic caucus votes of Jeffries and the other top leaders came without challengers.

The trio led by Jeffries, who will become the Democratic minority leader in the new Congress, includes 59-year-old Rep. Katherine Clark of Massachusetts as the Democratic whip and 43-year-old Rep. Pete Aguilar of California as caucus chair-

The new team of Democratic leaders is expected to slide into the slots held by Pelosi and her top lieutenants Majority Leader Steny Hoyer of Maryland and Democratic Whip James Clyburn of South Carolina as the 80-something leaders make way for the next generation.

But in many ways, the trio has been

transitioning in plain sight, as one aide put it Jeffries, Clark and Aguilar working with Pelosi's nod these past several years in lower-rung leadership roles as the first woman to have the speaker's gavel prepared to step down. Pelosi, of California, has led the House Democrats for the past 20 years, and colleagues late on Tuesday granted her the honorific title of speaker

It an important moment for the caucus that there's a new generation of leadership, said Rep. Chris Pappas, D-N.H., ahead of voting.

While Democrats will be relegated to the House minority in the new year, they will have a certain amount of leverage because the Republican majority is expected to be so slim and McCarthy's hold on his party

The House's two new potential leaders, Jeffries and McCarthy, are of the same generation but have almost no real relationship to speak of in fact the Democrat is known for leveling political barbs at the Republican from afar, particularly over the GOP's embrace of former President Donald Trump. Jeffries served as a House manager during Trump's first impeach-

We're still working through the implications of Trumpism, Jeffries said, and what it has meant, as a very destabilising force for American democracy.

Jeffries said he hopes to find common ground when possible with Republicans but will oppose their extremism when we must. On the other side of the Capitol, Jeffries will have a partner in Senate Majority Leader Chuck Schumer as two New Yorkers are poised to helm the Democratic leadership in Congress. They live about a mile (1.6 kilometres) apart in Brooklyn.

There are going to be a group, in my judgment, of mainstream Republicans who are not going to want to go in the MAGA direction, and Hakeem's the ideal type guy to work with them, Schumer said in an interview, referencing Trump's

Make America Great Again slogan. Jeffries has sometimes been met with scepticism from party progressives viewed as a more centrist figure among House Democrats.

But Rep. Rashida Tlaib, D-Mich., a progressive and part of the squad of liberal lawmakers, said she has been heartened by the way Jeffries and his team are reaching out, even though they face no challengers.

There's a genuine sense that he wants to develop relationships and working partnerships with many of us, she said.

Clark, in the No. 2 spot, is seen as a coalition builder on the leadership team, while Aguilar, as the third-ranking leader, is known as a behind-the-scenes conduit to centrists and even Republicans.

WhatsApp bans 23.24 lakh accounts in India in October

NEW DELHI

Instant messaging platform WhatsApp, on Wednesday, said it banned 23.24 lakh accounts in India in October, including 8.11 lakh accounts which were barred proactively before being flagged

The number of accounts blocked in October was about 13 per cent less than the 26.85 lakh accounts the messaging platform banned in September.

"Between 1 Oct, 2022 and 31 Oct, 2022, 2,324,000 WhatsApp accounts were banned. 811,000 of these accounts were proactively banned, before any reports from users. An Indian account is identified via a +91 phone number," WhatsApp said in the India Monthly Report under the Information Technology Rules 2021 for the month of October.

The tougher IT rules, which came into effect last year, mandate large digital platforms (with over 50 lakh users) to publish compliance reports every month, mentioning the details of complaints received and action taken.

Big social media firms have drawn flak in the past over hate speech, misinformation and fake news circulating on their platforms. Concerns have been flagged by some quarters time and again over digital platforms acting arbitrarily in

RBI may go for another 35 bps rate hike before pause

NEW DELHI, DEC 01: Exactly a fortnight ahead of the Reserve Bank of India's (RBI's) next monetary policy review, a key market indicator of interest rates the overnight indexed swap (OIS) — suggests that the central bank may tighten policy by 35 basis points and then refrain from further rate hikes.

RBI Deputy Governor Michael Patra recently described the OIS as the primary instrument for hedging interest rate risk in India.The six-member Monetary Policy Committee (MPC) of the RBI will meet on December 5-7.

Overnight indexed swaps, which are derivative products, were initially developed as a tool for investors to hedge their interest rate exposure to sovereign bonds. Over time, the market evolved into one that, to a great extent, involves taking a bet on the future direction of interest

When OIS rates fall, market participants express expectations of easier finan-

A rise in swap rates typically points towards tighter financial conditions and

From October 14 to November 21, two of the most active OIS contracts – the one-year swap rate and the five-year swap rate have declined by 40 basis points and 50 basis points, respec-

brought about by softer inflation prints in India and the US.

"At present, the OIS pricing is showing a 35-basis point rate hike by the RBI in December. "The current pricing is

because of the latest inflation data, both in the US and India."Traders now feel that on the domestic front, we are somewhere close to the peak on the repo rate," said Naveen Singh, head of trading at ICICI Securities Primary Dealership.

While this recent plunge does not mean that the market expects the RBI to immediately start cutting interest rates, it shows expectations of the central bank calling an end to its current tightening cycle, traders said.

So far in 2022, the RBI has hiked the repo rate by a cumulative 190 basis points to 5.90 per cent, in order to

tackle elevated inflation.

"If you see the one-crossone forward rate (the relevant one-year forward rate), it is at 6.40 per cent, which tells us that the RBI won't hike rates beyond 6.25 per cent."The 15 bps above that is the funding cost pre-

"So, the curve is telling us that after a 35-basis point hike, the RBI will take a long pause," Singh said.

The expectation of the RBI's rate hike cycle ending after December is further elucidated by a rare occurrence -- an inversion in the swap curve.

This implies that the market expects concerns of slowing economic growth to play out over a morethan-one-year time frame, which would make a case for the RBI to opt for a looser monetary policy.

At present, two-year swap rates and five-year swap rates are sharply lower than the one-year

On Tuesday the one-year swap rate closed at 6.70 per cent, while the two-year and five-year swaps closed at 6.45 and 6.43 per cent, respectively, Clearing Corporation data showed.

Under usual circumstances, rates on longerterm debt instruments are higher than those on shortterm instruments in order to compensate for uncertainty regarding inflation and growth dynamics over a larger time frame.

This also generally holds true for yields on government bonds."Now, I think there is a consensus of a 35basis point rate hike in December with a lot of people talking about a change in stance to neutral," said Vikas Goel, PNB Gilts MD & CEO."The inversion is our way of pointing to growth slowing down a lot. If you look at the one-year swap over the two-year swap, the inversion is quite sharp.

"That is what the OIS market is telling me right now," he said.

Bickram Ghosh, co-curator at Serendipity Arts Festival, reflects on how Covid-19 reshaped music-making

fter a two-year hiatus due to the pandemic, the Serendipity Arts Festival (SAF) 2022 is back in Goa. Scheduled from December 15 to 23, the fifth edition promises to be a showstopper with hundreds of performances. A line-up of immersive and interdisciplinary programmes has been put together by a panel of curators across disciplines from performing, visual to culinary arts and crafts including Quasar Thakore Padamsee for theatre and Geeta Chandran and Mayuri Upadhya for dance.

Within the seven disciplines, Bickram Ghosh and Ehsaan Noorani will curate music for the festival with a wide range of live concerts spanning classical, folk, indie pop, and rock. Ghosh, noted classical tabla player, continued to be prolific through the pandemic by releasing music on audio platforms and OTT. Here he highlights key acts from Serendipity with The Week alongside pausing to reflect on the reinventions that the music industry underwent in the last two

How do you feel Covid impacted the independent music industry and how much of it has recovered?

There is no doubt that Covid impacted almost every industry, but music performance was very badly hit. Even top artists didn't have shows for two years. Obviously, that was a humongous setback, but interestingly human beings are creatures of invention and reinvention. I think the music industry reinvented itself very quickly. Even during the pandemic, I can speak for myself, and many others, who were doing online shows. I did quite a few online shows and even, in fact, we recorded the shows in auditoriums with camera shoots. Those shows were bought by the audi-

The music industry was also producing a lot of content for streaming platforms. I think now things are back to normal and in some ways after living without the wonderful pleasure of going out and listening to music, audiences are thronging themselves back



into the theatres. Interestingly, today after the whole wheel of reinvention, we are doing a large number of shows which are live. But we are still doing some online shows and online content. So, all of this together has resulted in a bigger market, one the live market and two, the digital market.

With cultural festivals like Serendipity back on the ground, how is likely to benefit the overall ecosystem of the music industry?

Serendipity is an iconic festival, which has gained fame in a very short period of time. It is a festival that encompasses many forms of art. Music is a very important part of the artistic texture of Serendipity. I think it is great news for music and art in general that Serendipity is back on the ground and it already receiving tremendous response. I think festivals like Serendipity, psychologically, give a big boost to musicians in the way they feel and are an assurance that everything is okay now, where we can all go and perform freely. It's a big festival where there are 2,000 performances. I feel very happy and honoured to be curating the music for it along with Ehsaan Noorani.

Some interesting acts you would like to highlight this year at Serendipity?I would like to go by the highlights of my own curation for Serendipity. First, Ricky Kej who has won his second Grammy this year. There is a wonderful classical fusion featuring Purbayan Chatterjee, Taufiq Qureshi, Rakesh Chaurasia on flute,

Ojas Adhiya on tabla. There's the act that I am not just curating but also participating in, which is called Kings of Percussions. I am also playing in that and it features Shivamani, myself, and Selvaganesh. It promises to be a very high-energy act. I would also like to highlight Sufi folk, which is a wonderful confluence of Sufi and folk music from across the nation featuring the wonderful Sufi kawals, Parvati Kumari, and the brilliant Kalpana Patowary on folk vocals. There is this show which is very close to my heart called 'The World of Pancham', which features the great R.D. Burman's numbers played by people who were actually his team of musicians. There's a synergy between screen and stage here in the show, which we are trying to make as seamless as possible. Besides, there is Sanjay Mandal and the thrown waste, which is a fantastic act with the scrap material and the kids from the street. There's River Raga, where there are 9 acts featuring several very good younger-generation classical artists both from north India and south India featuring vocal and instrumental music.

Going forward, how will the production and consumption of music change in India after this long spell of inactivity when so many people took to appreciating music a lot more?

I think the one big thing that people have realised is how much they missed music during these two years, which is why literally every show is getting a fantastic response from the audience. I did a festival called 'Naav' earlier this year and it was overflowing with people. Another takeaway is that music consumption digitally has increased many-fold. It is a big change because it means, we too, as artists have to cater to that segment. I am creating a lot of music in the studio now, releasing it both on YouTube and streaming platforms. Besides this, film for OTT is a big space and I do a lot of film scoring. A lot of digital platforms are going to become very big in the near future and we as artists have to be prepared for

verweight women are more likely to experience symptoms of long Covid, according to a new research.

The study from the University of East Anglia (UEA) shows that having a higher Body Mass Index (BMI) is linked with the condition, and that women are more likely to experience long Covid than men. It is one of the largest studies on long Covid in the UK, the study said.

The research, published in PLOS Global Public Health, also shows that people with long Covid were much more likely to need additional, and often lasting, care at the National Health System (NHS) than those who make a swift recovery.

"Long Covid is a complex condition that develops during or after having Covid, and it is classified as such when symptoms continue for more than 12 weeks," said Professor Vassilios Vassiliou, from UEA's Norwich Medical School.

"Just over two million people in the UK are thought to suffer with long Covid and it affects people in different ways. Breathlessness, a cough, heart palpitations, headaches, and severe fatigue are among the most prevalent symptoms," said Vassiliou.

"Other symptoms may include chest

pain or tightness, brain fog, insomnia, dizziness, joint pain, depression and anxiety, tinnitus, loss of appetite, headaches, and changes to sense of smell or taste," said Vassiliou.

"We wanted to find out what factors might make people more or less susceptible to developing long Covid," said Vassiliou.

The research team surveyed patients in Norfolk, UK, who had received a positive Covid PCR test result in 2020. A total of 1,487 people took part in an online survey which covered long-Covid symptoms such as breathlessness, chest pain, fatigue, memory problems, and anxiety.

They found that more than half of the participants (774) were experiencing at least one long Covid symptom, showing a high self-reported prevalence.

Next, they looked to see what factors might make people more or less likely to suffer the condition by looking at the participants' medical records.

Factors including BML say medical

Factors including BMI, sex, medication use, other health conditions, and whether they lived in a deprived area were taken into account.

"We show that more than a half of the survey respondents who tested positive for Covid in the East of England during the first year of the pandemic went on to report long Covid symptoms," said Vassiliou.

"All of these people were infected in the months before the Covid vaccination programme was rolled out and they suffered from numerous new symptoms that were not present before their Covid infection," said Vassiliou.

"Interestingly, we found that more women than men had long Covid symptoms. We also found that having a higher BMI was linked with long Covid."

"This is really important because information like this can be used to profile those people who are 'at risk' of developing long Covid," said Vassiliou.

"We also found that people with long Covid were over three times more likely to use healthcare services than those who didn't display long Covid symptoms,' said Vassiliou.

"We hope that our work will help poli cymakers plan local services and also in form the wider public of the scale of the long Covid pandemic," said Vassiliou.

"When COVID-19 struck it was new to everyone. All clinicians and the wider health and care system worked extremely hard together to deal with the impacts of the virus and protect our people and communities," said Dr. Mark Lim, interim service director of the Norfolk and Waveney Integrated Care Board

New single-dose drug 95 per cent effective against sleeping sickness in adults: Lancet study

A new, single-dose oral treatment for sleeping sickness is 95 per cent effective in adults and adolescents, regardless of disease stage, and could be a key factor in eliminating disease transmission by 2030, according to a study published in The Lancet Infectious Diseases.

Developed by not-for-profit Drugs for Neglected Diseases initiative (DNDi) and Sanofi, acoziborole, unlike current treatments for sleeping sickness, does not require multiple days of treatment, hospitalisation or highly skilled health personnel, the researchers said.

Transmitted by the bite of an infected tsetse fly, sleeping sickness, or human African trypanosomiasis (HAT), is a neglected tropical disease, which can be fatal if left untreated.

The Gambiense human African trypanosomiasis (g-HAT) form of the disease is found across countries in west and central Africa with most cases in Congo.

Until 2019, treatment for patients in the earlier stage of the disease was a daily injection for seven or more days and, for patients in the later disease stage, an intravenous drip for seven days, which requires hospitalisation, the researchers said. Patients were also required to undergo a spinal tap, where fluid is collected from the spine, to diagnose the stage of sleeping sickness to determine the most appropriate treatment, they said.

In 2019, fexinidazole was introduced, a 10-day oral drug developed by DNDi as a first-line treatment for both stages of the disease, but its administration still requires skilled staff and, often, hospitali-

The new prospective study looks at the efficacy of one oral dose of acoziborole in treating g-HAT.

"Sleeping sickness threatens millions of people across sub-Saharan Africa. Many of the people at risk live in remote rural areas where there is little access to adequate health services, and where acoziborole has the potential to revolutionise treatment for sleeping sickness," said Dr. Antoine Tarral, Head of Human African Trypanosomiasis Clinical Program at DNDi, and lead author of the study.

New drug slows cognitive decline in patients with Alzheimer's



drug candidate reduced cognitive decline by 27 percent in people with early-stage Alzheimer's compared with those on a placebo after a year and a half. The drug lecanemab from Eisai and Biogen slowed cognitive decline in a closely watched trial but may carry a risk of serious side effects for certain patients, according to detailed data from the study which were presented at the Clinical Trials on Alzheimer's Disease meeting in San Francisco. If the results stand up, the treatment would be the first of its kind to show a strong signal of cognitive benefit in a robust trial, according to a report

"Today's announcement gives patients and their families hope that lecanemab, if approved, can potentially slow the progression of Alzheimer's disease, and provide a clinically meaningful impact on cognition and function," said Michel Vounatsos, Chief Executive Officer at Biogen. "Importantly, the study shows that removal of aggregated amyloid beta in the brain is associated with a slowing of disease in patients at the early stage of the disease. We want to thank the many patients who participated in this groundbreaking global study and want to acknowledge the clinical investigators who worked tirelessly to increase the enrollment of traditionally underrepresented populations. As pioneers in neuroscience, we believe defeating this disease will require multiple approaches and treatment options, and we look forward to continuing the discussion about the significance of these findings with the patient, scientific, and medical communities."The Alzheimer's Association said the data confirms the drug "can meaningfully change the course of the disease," and called on US regulators to approve the company's application for accelerated approval.

In July 2022, the US Food and Drug Administration (FDA) accepted Eisai's Biologics License Application (BLA) for lecanemab under the accelerated approval pathway and granted Priority Review. The Prescription Drugs User Fee Act action date (PDUFA) is set for January 6, 2023. The FDA has agreed that the results of Clarity AD can serve as the confirmatory study to verify the clinical benefit of lecanemab. In an effort to secure traditional FDA approval for lecanemab as soon as possible. Eisai submitted the BLA through the FDA's Accelerated Approval Pathway so that the agency could complete its review of all lecanemab data with the exception of the data from the confirmatory Clarity AD study.

New potential drug target to treat heart disease found: Study

cientists have uncovered details of a phenomenon that contributes to coronary artery disease, more commonly known as heart disease, an advance that may lead to new drug treatments for fighting heart disease, according to a study.

Soon after cholesterol and fat start depositing on the lining of the blood vessels that supply your heart, the smooth muscle cells that give the blood vessels strength and flexibility start to get bigger and multiply.

While scientists studying the phenomenon suspect these vascular smooth muscle cells are trying to help, this atypical behavior for these strong cells instead contributes to coronary artery disease.

In a bit of a vicious cycle, stents as well as bypass grafts used to treat coronary artery disease can prompt the same response.

Now Medical College of Georgia (MCG) scientists report new insight into how the cells enable this unhealthy growth and a new target to intervene.

The endothelial cells that line our blood vessels are in constant communication with the layers of vascular smooth muscle cells that encase them and play a key role in regulating our blood pressure, said Yuqing Huo, director of the Vascular Inflammation Program in the Vascular Biology Center at MCG.

In states of good health, for example, the two cell types share messages about how it is time for our blood vessels to dilate a little because we are exercising. Early in vascular disease, however the conversations change, said Huo, corresponding author of the study in the journal Circulation.

"They get the message that something is wrong," said Huo, and existing cells get exponentially bigger and start proliferating, which these cells don't normally do, perhaps in an effort to make more room inside for blood to flow since cholesterol and fat are narrowing the existing



passageway.

"Normally, the smooth muscle cells provide strength. If they start to proliferate a lot, it changes their identity," Huo says.

Whatever the reason, the result is more narrowing and scarring of the vital passageway for blood and worsening disease. So, the scientists looked at the building blocks needed to enable the unhealthy response.

They knew that growing more and bigger cells required more DNA, RNA and the proteins they produce. To make that happen required more purines, one of two chemical compounds in the body used to make the building blocks of DNA, in this case adenine and guanine.

What they didn't know was precisely how these cells make more purine when faced with arterial disease, says Dr. Qian Ma, postdoctoral fellow with Huo and the study's first author.

There are two fundamental ways cells come up with purine: One is to essentially make it from scratch, called de novo purine synthesis, and the other is through recycling.

The MCG scientists are the first to find that the higher-energy consuming de novo purine synthesis is increased in this scenario, Ma said. In the scar tissue and

plaque inside blood vessels of mice and humans, Huo, Ma and their colleagues also found increased expression of ATIC, a gene essential to purine production.

When they knocked ATIC out body wide as well as specifically in the vascular smooth muscle cells, it inhibited purine production, which decreased the production of DNA and RNA, and the subsequent proliferation of the smooth muscle cells.

The net effect of less ATIC was reduced formation of scar tissue in animal models of both atherosclerosis and restenosis, or re-narrowing of blood vessels, including buildup inside the stents themselves, that can occur after procedures like angioplasty to open clogged vessels and placement of stents to help keep them

open.
"It takes away one of the building blocks of DNA," says Ma. "The blood vessels remained normal. The lumen stayed open."

The response shows that the production of purine plays a key role in the proliferation of smooth muscle cells and pegs ATIC as a logical point to intervene,

the scientists say.

Our model demonstrates that this ATIC is important and targetable, says

More boys with cancer being diagnosed than girls in India: Lancet study

ore boys than girls with cancer in India are being diagnosed with the disease and the probable cause for this is gender bias in society, according to a study published in The Lancet Oncology.

The researchers collected individual data of children aged 0-19 years with cancer extracted from the hospital-based records of three cancer centres in India between January 1, 2005, and December 31, 2019.

They also used data from two population-based cancer registries: PBCRs in Delhi between January 1, 2005, and December 31, 2014 and Madras Metropolitan Tumour Registry between January 1, 2005 and December 31, 2017.

The researchers from All India Institute of Medical Sciences, New

Delhi and Cancer Institute (WIA) Chennai calculated the male to female sex ratio from the three hospitals in the context of the ratio in the corresponding PBCRs.

This ratio allowed them to see how many boys with cancer were

seeking treatment for each girl seeking treatment.

The team separately analysed the male to female ratios of pa-

tients undergoing stem cell transplant which is a comparatively ex-

pensive procedure used in cancer care.

"We observed that among nearly 11,000 patients registered in

"We observed that among nearly 11,000 patients registered in the PBCRs, there was significant skew in favour of boys for getting diagnosed with cancer. Similarly, among the 22,000 children with cancer enrolled in the three hospitals, we saw that more boys were seeking treatment than girls," said Professor Sameer Bakhshi, from Department of Medical Oncology, ALMS New Delhi

"However, when we looked at sex ratios among patients seeking

ratios was no longer apparent. This tells us that the bias towards boys originates at the community level. Once children are brought forward and diagnosed, there is no further gender bias in seeking treatment," Bakhsh, the corresponding author of the study, told PTI.

The researchers noted that lesser girls were seeking treatment in hospitals in centres in Northern India as compared to Southern India

The disparity between the genders was more for patients coming from rural as compared to urban areas. This may have to do

variations in social fabric in different parts of the country, they said. The study also found that lesser number of girls were coming to the hospital if the distance of the centre from their home was over 100 kilometers, signifying that if costs related to treatment increase, the bias would likely increase.

The researchers observed that the male to female ratios in Delhi have been improving over the last 15 years.

"The study clearly shows that more boys with cancer are being diagnosed than girls and the probable cause for this is gender bias in society," Bakhshi said.


