J&K's integration into national railway network monumental step: PM

that the past decade has witnessed a transformational change in railway infrastructure modernization, enhanced connectivity, and improved facilities for passengers.

He stated that the government has laid more than 30,000 kilometers of new railway tracks in the last 10 years, nearing 100% electrification, compared to just 35% in 2014. Additionally, he noted that the country has eliminated all manual crossings on broad-gauge tracks.

"Today is a big day for new-age connectivity. It shows that the entire nation is moving forward together," PM Modi remarked.

The Prime Minister stressed that new railway divisions, terminals, and modernized stations are creating unprecedented opportunities for trade, business, and employment.Jammu local businesses

"The development of railways is creating lakhs of job opportunities. In the last 10 years, lakhs of youth have been employed in the railways, and initiatives like Gati Shakti University will further enhance the workforce's skillset," he said.

Referring to the strides in high-speed train services, PM Modi noted that more than 50 Vande Bharat trains are now operational, connecting long distances in shorter times and setting a benchmark for modern Indian trains.

"The time is not far when bullet trains will traverse across the country, making railway journeys memorable," he added.

The Prime Minister also lauded India's expanding metro network, which has grown from just 5 cities in 2005 to 21 cities today, with over 1,000 kilometers of operational tracks.

Stressing the importance of indigenous develop-ment, PM Modi said, "Under the 'Made in India' initiative, railway stations are being modernized, and high-speed train corridors are being developed. This will ensure India leads from the front in connectivity and infrastructure."

He reiterated the government's commitment to making Indian Railways the backbone of a developed and self-reliant India, saying, "This is not just about connectivity but also about fulfilling aspirations and creating a better future for mil-

The India-US defence cooperation also witnessed a major upswing in the last four years.

In October, India inked a mega deal with the US to procure 31 Predator long-endurance drones from American defence major General Atomics under the foreign military sales route at a cost of nearly USD 4 billion.

India is procuring the drones to boost its military's combat prowess along the contested borders with China.

While the Navy will get 15 Sea Guardian drones, the Indian Air Force and the Army will each get eight Sky Guardian drones.

The high-altitude long-endurance drones are capable of remaining airborne for over 35 hours and can carry four Hellfire missiles and around 450 kg of bombs. (Agencies)

China says its world's biggest dam over brahmaputra will not impact water flows to India

Sullivan, currently visiting Delhi, held talks with External Affairs Minister S Jaishankar on Monday broadly reviewing the trajectory of the India-US global strategic partnership in the last four years under the Biden administration.

Sullivan is on a visit to India two weeks ahead of Donald Trump's inauguration as the 47th president of the US.

Last month, China approved plans to build a dam over the Brahmaputra River called Yarlung Zangbo in Tibet close to the Indian border.

As per the plan, the massive dam will be built at a huge gorge in the Himalayan reaches where the Brahmaputra makes a huge U-turn to flow into Arunachal Pradesh and then to Bangladesh.

In its first reaction to the proposed dam on Jan J. India urged China to ensure that the interests of downstream states of the Brahmaputra are not harmed by activities in upstream areas.

"We will continue to monitor and take necessary measures to protect our interests," External Affairs Ministry spokesperson Randhir Jaiswal told media in Delhi.

"As a lower riparian state with established user rights to the waters of the river, we have consistently expressed, through expert-level as well as diplomatic channels, our views and concerns to the Chinese side over mega projects on rivers in their territory," Jaiswal said.

"These have been reiterated, along with the need for transparency and consultation with downstream countries, following the latest report," he said.

'The Chinese side has been urged to ensure that the interests of downstream states of the Brahmaputra are not harmed by activities in upstream areas," he added.

On Dec 27, another Foreign Ministry spokesperson, Mao Ning, defended China's plan to build the world's largest dam on the Brahmaputra River in Tibet, saying the project will not negatively affect lower riparian states and that safety issues have been addressed through decades of studies.

'The project will not negatively affect the lower reaches," she said, referring to the concerns in India and Bangladesh, which are the lower riparian states.

China will continue to maintain communication with countries at the lower reaches through existing channels and step up cooperation on disaster prevention and relief for the benefit of the people by the river," she said. She said China's hydropower development in the lower reaches of the Yarlung Zangbo River aims to speed up the development of clean energy and respond to climate change and extreme hydrological disasters. (Agencies)

Surveys are ongoing for the Anantnag-Bijbe-hara-Pahalgam (78km) and Awantipora-Shopian (28kms) rail lines. DPR is under examination for new line between Baramulla-Uri (46kms), Baramulla-Kupwara (39kms), Jammu-Poonch via Akhnoor, Rajouri (223kms), Manwal-Talra via Ramkote, Billawar and Dunera (117kms), Sopore-Kupwara (37kms), Pathankot-Leh (664kms), Bilaspur-Manali-Leh (489kms) and doubling of Baramulla-Banihal line, he said.

By linking key towns and regions, these projects promise to unlock the region's untapped potential and boost local economies, the Lieutenant Governor further added.

In view of the rapid industrialization taking place in J&K and emergence of Jammu, Samba and Kathua as industrial hubs, the Lieutenant Governor emphasized that Indian Railways should explore possibilities for establishment of Railways' Private Freight Terminal to facilitate the transportation of goods and products of traders and industries of these areas.

people of the region," the chief minister said. However, he said there are some concerns among the people related to the rail service, especially in Jammu.

"It is often said that when rail service reached Jammu from Pathankot (Punjab), the situation in Pathankot became a bit difficult. Here too, at some places, there is a notion that if trains reach Kashmir directly from Jammu, the latter might face the same situation as Pathankot.

"On behalf of my government, I want to assure the people of Jammu that the rail service to Kashmir will have no impact on the region. Rather, we assure that Jammu will benefit from it as it will enhance trade and tourism, besides increasing travel between the two regions," Abdullah said.

Praising the prime minister for his efforts to improve connectivity and road network in Jammu and Kashmir, Abdullah said the expansion of railway line to Poonch-Rajouri in Jammu and beyond Baramulla in Kashmir will be the responsibility of the Jammu railway division.

"In my previous tenure as chief minister, the last function I attended was the inauguration of the Katra railway station. After assuming charge again, this is my first major function. And both are linked to railways and held under the leadership of Modi," he said.

The inauguration of the Jammu division is the biggest proof of the efforts of the prime minister to improve connectivity and road network in the region, he said.

The ongoing work on the Delhi-Amritsar-Katra expressway project, four-laning of the Jammu-Srinagar national highway, Z-morh and Zojila tunnels to provide all-weather road connectivity to Ladakh, along with airport expansion will further enhance connectivity on their completion, he said.

Lauding the railway ministry, Abdullah said that people used to get down from the train in Pathankot before it slowly reached Jammu, but in the last four decades, the railway service kept expanding — first from Jammu to Udhampur, and then from Udhampur to Katra.

Similarly, rail service started in Kashmir from Srinagar to Baramulla, and was extended to Anantnag and Banihal and later to Sangaldan, he said.

Referring to the steep hike in air fare during the winter months when most of roads remain closed in Kashmir due to heavy snowfall, Abdullah said, "We are forced to buy air tickets worth Rs 5,000 for Rs 25,000... I hope the new rail service will not only benefit the railways, but also boost trade and industries with the in-duction of cargo trains." Congratulating the people of J-K on getting a separate railway division in Jammu, Abdullah said it was a long-pending demand which has been fulfilled now. "I am thankful to Prime Minister Modi and Railway Minister Ashwini Vaishnaw," he said. "The biggest thing is our coordination and control will not be from Firozpur (railway division), but from Jammu. And in this, we will definitely see benefits in recruitment. A small part of Punjab and a part of Himachal Pradesh have been added to this as well," Abdullah said.

The ministry said it is monitoring the situa-tion through all available surveillance chan-nels. The ICMR will continue to track trends in HMPV circulation throughout the year.

The World Health Organisation (WHO) is already providing timely updates regarding the situation in China to further inform the ongoing measures.

The recent preparedness drill conducted across the country has shown that India is well-equipped to handle any potential increase in respiratory illnesses and public health interventions can be deployed promptly if needed, the ministry stated

Vichar Kranti Manch International (VKMI) organized a symposium on "Toxin Accumulation and Its Excretion." Dr. Suresh Gupta, a retired scientist from RRL and State Senior Vice President of Bhartiya Yog Sansthan, was the Chief Guest, while Prof. Virender Gupta, a noted social activist, presided over the event.Dr. Shreyansh Kumar Jain, President of VKMI, delivered the keynote address, introducing the subject and explaining:What Are Toxins?Toxins are harmful substances that disrupt the body's normal functioning. These can come from external sources such as polluted air, water, food, and chemicals or be produced internally as metabolic by-products. Accumulation of toxins can weaken the immune system, hinder organ function, and increase the risk of chronic diseases. Therefore, regular detoxification is vital for maintaining overall health.Dr. Jain elaborated that toxins accumulate on four levels-physical, mental, emotional, and spiritual-negatively affecting well-being.1. Physical LevelExternal sources of physical toxins include processed foods, pollution, pesticides, cosmetics, and household products. Internal sources include metabolic waste and free radicals. When detoxifying organs such as the liver, kidneys, and lymphatic system are overwhelmed, toxins accumulate in tissues, leading to inflammation, fatigue, and disease.2. Sharma, retired Executive Engineer and General Secretary of VKMI, spoke on meditation and mindfulness, emphasizing their role in reducing mental toxins and enhancing spiritual clarity. MLA Arvind meets LG Sinha, highlights key issues of Jammu West Constituency

Arvind Gupta, senior BJP leader and MLA Jammu West, met with Lieutenant Governor of Jammu and Kashmir, Manoj Sinha and discussed several pressing issues concerning the welfare of the people in the Jammu West constituency.

During the meeting, Arvind Gupta raised the need for significant improvements in the medical infrastructure at the Sub-District Hospital, Sarwal. He emphasized the importance of strengthening the hospital's emergency wing to function 24×7 by equipping it with modern medical facilities, an Intensive Care Unit (ICU), and a

Blood Bank. Such upgrades, he stated, would significantly reduce the dependency on the overburdened Government Medical College (GMC) Jammu.

Furthermore, the MLA stressed the need to enhance the emergency services at GMC Jammu and its associated hospitals. He proposed the deployment of professional Medical Services Managers and the establishment of Medical Boards to oversee the treatment of critical patients, thus minimizing referrals and providing timely care to those in need.

The senior BJP leader also brought attention to the need for extending Central Government Health Scheme (CGHS) benefits

to all pensioners in Jammu and Kashmir. While acknowledging the current coverage for certain categories, he urged the administration to either expand the scheme or introduce a similar initiative for pensioners not currently covered under the scheme.

Addressing the needs of the elderly, Arvind Gupta called for the establishment of Senior Citizens Day Care Centers, similar to the one in Roop Nagar, in other parts of the city. He emphasized that these centers are essential for the welfare and social engagement of senior citizens. Additionally, he highlighted the dire condition of educational institutes in Jammu City, which suffer from inadequate infrastructure, poor manage-ment, and insufficient subjectwise staffing. Immediate intervention, he suggested, is necessary to improve the quality of education in the region.

NEW DELHI, JAN 6 President Joe Biden presented the US' highest civilian award to controversial philanthropist George Soros, along with 18 others, for their contributions to America and the world.

Reacting to the award, Tesla CEO Elon Musk criticised Biden and called it a "travesty".

"A travesty that Biden is giving Soros the Medal of Freedom," Musk wrote on X.

The Presidential Medal of Freedom is presented to individuals who have made exemplary contributions to the prosperity, values, or security of the United States, world peace, or other significant societal, public or private endeavours.

According to an official White House statement, Soros, an investor and founder of the Open Society Foundations, was recognised for his global initiatives to "strengthen democracy, human rights, education and social justice."

NEW DELHI, JAN 6 West Bengal Chief Minister Mamata Banerjee met and honoured 95 fishermen on Monday who had been detained in Bangladesh for over two months after inadvertently crossing into Bangladeshi waters. She also announced compensation of Rs 2 lakh for the family of another fisherman who died during the detainment process.

On Sunday, India and Bangladesh conducted a mutual exchange of fishermen who had crossed their international maritime borders. Bangladesh released 95 Indian fishermen, while India freed 90 Bangladeshi fishermen. The exchange was overseen by coast guard and administrative officials from both countries.

The Union Ministry of External Affairs stated that several Indian fishermen were detained by Bangladesh in recent months after unintentionally crossing the maritime border. Indian authorities had also apprehended Bangladeshi fishermen in similar circumstances.

The Indian government worked diligently to secure the release of the de-

With hardly a month left for the Delhi Assembly Elections, the Congress has already set up a war room in the state, in a bid to regain its waning foothold. Though Delhi will witness a threepronged fight between the AAP, BJP and Congress.

The Congress, which once ruled the state, failed to open its account in the last two Assembly polls and is expecting to turn the tide this time. While both BJP and the AAP have announced candidates for all 70 seats, the Congress could only so far release the first list of 48 candidates.

While the party couldn't wrest even a single seat in Delhi in the recently-concluded Lok Sabha elections even while it was in an alliance with AAP, the state election will not be a cakewalk either,



considering that it is independently contesting the elections.

War room ready

While the war room and manifesto preparation for the elections began as early as December, the party is now devising a strategy by roping in senior leaders. As per reports, chief ministers, deputy chief ministers of Congressrules states and national spokespersons have been tasked with holding press conferences and meetings to convince voters of the guarantees put forth by the party.

They include Himachal Chief Minister Sukhvinder Singh Sukhu, Karnataka Deputy Chief Minister D K Shivakumar, Telangana CM REvanth Reddy and Rajasthan former deputy chief minister and Congress leader Sachin Pilot.

The party will also organise election rallies which will see senior leaders Rahul Gandhi and Priyanka Gandhi participate in it. Party President Mallikarjun Kharge will also address voters at the mega rally.

Targeting both AAP and BJP

Despite AAP being an INDIA ally, the Congress is in no mood to go soft on AAP, as evident from its initial campaign. Congress leader Ajay Maken addressing AAP convenor Arvind Kejriwal as "anti-national" shows that Congress isn't shy of targetting Kejriwal himself. The party has also selected its sharpest weapon, Sandeep Dixit, to take on Kejriwal in his constituency. It is also fielding Mahila Congress National President Alka Lamba in Atishi's constituency Kalkaji.

Accountability and fairness in Government Quarters (Bungalows)

he recent High Court order directing BJP politicians to vacate government quarters following the end of their official tenure is a muchneeded step toward enforcing accountability. Public resources, including government-provided accommodations, are meant to serve active officials and must not become privileges that linger posttenure. While the compliance of these politicians with the court's orders is commendable, it raises critical questions about financial accountability. Rise of AI in digital learning compared to tradi-

tional learning methodologies

The conventional teaching methods towards modernisation brought about through the adoption of Artificial Intelligence (AI). IBEF has published statistics indicating that the Indian edtech market is expected to grow from a value of \$700-800 million in 2021 to \$30 billion by 2031. This growth shows the penchant for digital learning solutions that rely on AI to provide more personalised, efficient, and accessible education. Besides, a report by KPMG says that India is now the secondlargest market for e-learning, after the United States, clearly indicating the country's strong digital learning transformation.

Artificial intelligence

One of the problems which India is witnessing is the imbalance between school enrolment and higher education enrolment. Interestingly, about 25 crores students take admission in the schools every year, and just about 28% continue the higher studies, as per the TG Sitharam, chairman of the All-India Council for Technical Education (AICTE). This lag is primarily due to the economic constraints. The majority of the students find it extremely difficult to deal with the massive fee for higher studies, leaving millions of bright minds outside the opportunity spectrum. Perhaps, AI is the medium through which this problem can be addressed. It is providing affordable, accessible, and high-quality learning platforms. Tools like adaptive learning technologies can modify lessons for individual students, enhancing their educational journey. Adaptive learning, a fundamental aspect of AI in education, allows platforms to adjust the difficulty of the material based on a student's progress. Popenici and Kerr (2017) describe how the applications of AIED are rapidly evolving, reshaping how education is delivered. Generative AI technologies, which create interactive and content, engaging are attracting significant investment and are instrumental in the growing development of the AIED industry. AIED's adaptive learning techniques have proven to boost test results by 62%, with AI-driven learning improving overall student performance by 30% and reducing anxiety by 20%.

The edition of ChatGPT has been specifically designed for the higher education institutions. Its fundamental idea is to boost the privacy features along with security. This signifies that how AI is flexible and adjusting to the education scenario. These innovative offerings imply that how AI can bring a paradigm shift the future classrooms. Such innovations clearly reflect the potential of AI to shape future classrooms. It makes learning experiences efficient, tailored, and engaging at the same time.

In fact, our country, AI could be just what the education system has desperately craved for. With the high growth rate in population, facilitating quality, low-cost education becomes a hurdle. AI thus presents a promising solution. It helps to scale learning opportunities, making them more accessible and affordable. AI-based platforms create personalised learning paths tailored to each student's needs, interests, and experience, unlike traditional classrooms that use a one-size-fits-all approach.

AI is making education much more accessible. For students with disabilities, tools like text-to-speech and speech recognition give them the chance to interact with lessons in ways that suit their needs. AI also helps non-native speakers by translating educational content into different languages, removing language barriers that often hold students back. In many cases, traditional classrooms can't fully address the unique needs of all students, especially those with disabilities or language difficulties. AI fills in these gaps, making sure that education reaches more people and is more inclusive. It's not about replacing teachers or changing the core of learning but about giving more students a better chance to succeed, regardless of their abilities or language skills.

AI also augments the process of assessment. Through adaptive assessments, AI can adjust the level of difficulty of tests and quizzes based on previous submissions. In other ways, we can simply put out that AI is like an instructor in the classroom, which provides real-time recommendations/suggestions and feedback to help the students.

AI eliminates the hurdles which the traditional learning usually faces. These are restricted due to cost and location. Moreover, it encourages more inclusive and accessible educational experience. The best part is that students can have this opportunity to learn as per their wishes.

Conventional classroom education methods bank on lectures which is not always the best way to learn, but AI tools are able to meet the needs of all students. Time and the availability of the teacher also become limitations for today's traditional classrooms. On the other hand, technology allows students to access learning materials whenever they want. Traditional forms of evaluation are unable to provide detailed feedback on the student's performance, but AI enables students to get immediate feedback and understand how to improve even before the action.

As India gets ready to flag its position in the global edtech market, AI can help overcome important education challenges like teacher shortages and high costs. By making use of AI, India can offer quality education to millions of students, making learning fairer and more effective for everyone. The future of education is digital, and AI is leading the way.

Why is the depreciation of the rupee not stopping?

Sustained outflows after the September 2024 stock peak weakened the rupee as investors moved to safer assets amid speculation of a rise in US interest rates. Trade deficits, such as the high trade deficit, highlight external dependence on imports, especially for energy, widening the current account deficit during rupee weakness. India's crude oil import bill rose with the rupee depreciation, widening the 2024 trade deficit to close to \$75 billion.

Global events such as tariff threats and the BRICS currency dispute add to volatility by creating uncertainties for India's external trade and investment. The US President's 2024 tariff warning against the currency plans of the BRICS countries triggered a market sell-off, weakening India's external stability. Heavy reliance on foreign exchange reserves to stabilize the rupee restricts long-term monetary flexibility during sustained global market turmoil.

The rupee exhausted more than \$20 billion in reserves in a single quarter to pull the rupee back to 85.53 in December 2024. A weak rupee constrains domestic monetary policies, raising inflation through costlier imports while reducing fiscal space to address growth concerns. The cost of crude oil imports rose 15% in December 2024, putting pressure on policymakers to

effectively balance currency management and fiscal expansion strategies.

Protectionist trade measures, such as tariffs or sanctions, can undermine currency stability by disrupting the trade balance. Political instability or conflict between major economies creates volatility, boosting demand for the safe-haven dollar and weakening emerging market currencies. The Russia-Ukraine war led to a surge in global crude oil prices, which put pressure on India's import bill and depreciated the rupee. Tight monetary policies in advanced economies lead to capital outflows from India, putting pressure on the rupee.

flows from India, putting pressure on the rupee. The US Federal Reserve's rate hike plan in 2022-23 led to foreign portfolio outflows, which weakened the rupee. A widening trade deficit

A widening trade deficit due to a rise in imports compared to exports leads to foreign exchange outflows, weakening the rupee. India's record trade deficit in 2022 due to rising crude oil and gold imports drives rupee depreciation. High domestic inflation depreciates the currency value, making exports less competitive and imports costlier. Rising prices of inelastic imports such as crude oil push up India's import bills, weakening the rupee in 2023. A decline in domestic and foreign investment indicates weak economic growth, discouraging currency inflows. In 2024, declining corporate performance and rising stock valua-

tions led to foreign portfolio investment outflows. Central bank interventions to stabilize the currency are limited by foreign exchange reserves and can provide only temporary relief. A late RBI inter-vention in December 2024 managed to temporarily stabilize the rupee at 85.53 per dollar. A fiscally constrained government reduces its ability to manage external shocks, thereby weakening confi dence in currency stability. India's record fiscal deficit during the pandemic limited government measures to boost external resilience. The government's clear stance on currency policies boosts confidence investor and reduces speculative pressure. The RBI governor's ruling out of de-dollarization in 2024 reassured the market, temporarily easing concerns of rupee depreciation.

Measures to strengthen external resilience include boosting exports and focusing on value-added manufacturing and services to increase foreign exchange earnings and reduce trade imbalances. Strengthening sectors such as pharmaceuticals and IT can help reduce the trade deficit and stabilize the rupee. Reduce dependence on volatile crude oil and essential imports by entering into long-term agreements with diversified suppliers. Expanding crude oil imports from Russia and Middle Eastern countries reduces average oil import costs in 2023. Build strong reserves through sovereign wealth funds and gold accumulation for effective currency stabilization.

According to the Reserve record Bank, foreign exchange reserves of \$600 billion in 2021 helped manage volatility during the pandemic. Enter into agreements to settle trade in local currencies, reducing dependence on the US dollar and mitigating exchange rate risks. The India-Russia Rupee-Ruble Trading Mechanism eased pressure on foreign exchange reserves during the Russia-Ukraine crisis. Prioritize lowcost and long-term borrowings while reducing shortterm external debt to avoid currency risks.

India's increased issuance of sovereign green bonds helped attract stable foreign investment while reducing repayment volatility in 2023. A strong external sector is important for India's economic resilience amid global uncertainties. By promoting export competitiveness, ensuring prudent fiscal polidiversifying foreign cy, exchange reserves, and increasing bilateral trade in rupees, India can reduce currency volatility. A visionary strategy emphasizing structural reforms and global economic integration will ensure stability long-term and strengthen India's position in the global economy.

NEW DELHI, JAN 6 The ICC in collaboration with cricket boards of India, Australia and England is exploring the possibility of a two-tier Test system to facilitate more series between big three nations.

The Age reported that Jay Shah, the new ICC chairman, is set to meet Cricket Australia chair Mike Baird and his England counterpart Richard Thompson later this month to discuss the finer points.

"Any plan for a move to two divisions in Test cricket would kick in after the end of the current Future Tours Program in 2027," The Age reported.

The BCCI is currently gearing up for its Special General Meeting on January 12 in Mumbai where interim secretary Devajit Saikia is expected to get a fulltime role. Saikia was appointed in the interim role after Shah vacated his post last month to take over as ICC chairman

A BCCI official indicated that the discussion floated around the ICC corridors in 2016, the first-time when a two-tier Test system was seriously considered.

"We don't have any news of any such move as yet. Currently, preparations



are being made for SGM and the recent tour to Australia too needs to be discussed.

"There was such a move sometime back, but we haven't heard anything since," a BCCI source told PTI.

The BCCI and cricket bodies of Zimbabwe and Bangladesh opposed the move, citing the possibility of decreasing revenue.

They had also argued that smaller nations would miss out on the opportunity of playing against top teams if such a system comes into existence.

However, nine years down the road the modalities have changed and even some of the reputed experts such as former Indian skipper Ravi Shastri are supporting the division.

"I've been a firm believer in that if you want Test cricket to survive and be alive and thriving, I think that's the way to go.

"The top teams play against each other more often, so there is a contest; you want contests," Shastri told SEN during the recent fifth Test between India and Australia.

Even some of the top players such as England Test skipper Ben Stokes had criticised the current model of World Test Championship.

New Delhi, Jan 6 Captain Harmanpreet Kaur and pacer Renuka Singh Thakur have been rested for India women's three-match home ODI series against Ireland, Board of Control for Cricket in India announced on Monday.

A bleak Q3 awaits FMCG Economists see reforms in companies? the air ahead of Budget

NEW DELHI, JAN 6

Hit by inflation, higher input costs and pricing measures, fast-moving consumer goods companies are expected to see a contraction in their gross margin and a modest-to-flat operating profit in the October-December quarter.

Several FMCG makers are likely to log a low single-digit rise in their revenue, returning to the cycle of valuedriven growth.

One of the reasons could be that a number of companies have opted for a price hike in the December quarter due to rising costs of input items such as copra, vegetable oil, and palm oil.

The price hikes came at a time when the urban market was dragged down by lowered consumption due to high food inflation.

However, the rural market, which is slightly above one-third of the total FMCG market, stayed ahead of it.

Some of the listed FMCG companies, such as Dabur and Marico, shared their updates for the third quarter of FY25, and analysts expect either flat or low single-digit volume growth.

Home-grown firm Dabur expects a "low single-digit growth" in the December quarter along with a "flattish operating profit" as it faced inflationary headwinds in some of the segments

"In Q3, inflationary pressures were witnessed in some segments which were partially mitigated through tactical price increases and cost-efficiency initiatives.

"We anticipate flattish operating profit growth in Q3," said Dabur in an update for Q3/FY25.

Besides, in the December quarter, rural consumption for FMCG was resilient and continued to grow faster than urban, said the company which owns brands such as Dabur Chyawanprash, Dabur Honey, Dabur Pudin-Hara, Dabur Lal Tail, Dabur Amla, Dabur Red Paste, Real and Vatika.

It further said that alternative channels like modern trade, e-commerce, and quick commerce continued to post strong growth, while general trade, which mainly consists of neighbourhood kirana stores, was under pressure



Marico expressed similar views, saying, "During the quarter, the sector witnessed steady demand trends on the back of improving rural consumption and stable sentiment in urban vis-à-vis the preceding quarter."

Over domestic volume growth, Marico said it expects an 'uptick' in the December quarter but on a sequential basis and said its operating profit growth will be 'modest' due to higher input costs.

It expects a "higher-than-anticipated gross margin contraction" as key inputs faced 'higher-than-expected' inflation, said a quarterly update by Marico, which owns brands such as Saffola, Parachute, Hair & Care, Nihar and Livon, among others.

"Among key inputs, copra prices remained firm at higher-than-expected levels and vegetable oil prices moved up during the quarter, while crude oil derivatives remained range-bound.

"The rising trend in input costs is expected to result in a higher-than-anticipated gross margin contraction on a year-on-year basis, as the company continues to favour consumer franchise expansion in the current environment," said Marico.

According to Nuvama, the urban demand scenario is challenging due to in-

"Urban slow down shall continue for two-three more quarters," it said, adding, "Rural demand continues to report a gradual recovery and outpace urban demand aided by freebies and good rains."

However, he also added: "Harvest season from January to April will ease some of the pressure on margins in agricultural commodities which will help ease the pressure on commodity prices."

Following the lacklustre growth numbers in the second quarter (O2FY25), economists believe the upcoming Union Budget for 2025-26 should focus on reforms that will stimulate consumption, manufacturing and spur employment.

India's growth unexpectedly slowed to 5.4 per cent in the second quarter, due to low capital formation, weak consumption, besides adverse weather impact.

"We anticipate the government will continue to prioritise and enhance efforts towards skill development and employment generation, maintaining the positive momentum.

"This would help harness the demographic dividend, drive economic growth from both supply and demand sides and boost consumption through higher incomes," said Rumki Majumdar, economist, Deloitte India.

In the July Budget, Finance Minister (FM) Nirmala Sitharaman announced initiatives such as employment-linked incentives and internship programmes.

Economists reckon the upcoming Budget has to continue support to the MSME sector and industrial clusters with export potential and high labour intensity.

"I also feel there is a need for some consumption stimulus. FM may reinforce some of the reforms agenda announced in the last budget," said Rajani Sinha, chief economist, CareEdge.

While a comprehensive review of the Income-tax Act has been on the cards, economists believe that in order to boost consumption the FM must consider tax breaks to put more money in the pockets of people.

"We need to have income tax breaks across the board to increase consumption which has been a major challenge.

"At the same time capital expenditure has to be expedited to push investment and draw in more private interest," Madan Sabnavis, chief economist, Bank of Baroda said. In the earlier pre-Budget discus-



sions with the finance ministry, the economists were divided on whether the government should take an approach of consumer demand-led development or investment and exportled growth.

If it is any indication, Sitharaman recently spoke about the greater multiplier effects of capex in the economy compared to revenue expenditure.

She had said: "It is not going to benefit if we just spend money or put money in the hands of people to promote immediate consumption...the multiplier that it gives is far lesser than the multiplier that will gain when people are given jobs, and capital assets are built."

Sabnavis also suggested that the finance ministry should consider the production-linked incentive (PLI) scheme for small and medium enterprises to push output and also link PLI with employment as part of the reforms it plans to take in the upcoming financial year.

Among other major reforms, economists believe a revised customs duty structure to rationalise and simplify it for ease of trade, removal of duty inversion, and reduction of disputes may also be on cards.

The Budget may take into account the risk of volatility in global trade, which has increased after the US election, with potential measures such as higher import tariffs and tax cuts to promote manufacturing in the US.

plement a range of measures to enhance the competitiveness of Indian products on the global stage.

"These may include tariff rationalisation, duty exemptions and remission schemes, which would help lower the cost of Indian exports," Majumdar added.

Economists believe that controlling inflation has to be a priority for the government and the Budget may address the issue by incentivising value chain development projects, promoting digital marketplaces to provide farmers direct access to buyers.

The Confederation of Indian Industry (CII) in its Budget proposals, has called for targeted interventions such as reducing excise duty on fuel which forms a substantial portion of the overall household consumption basket and bringing down marginal tax rates for personal income up to \$20 lakh per annum.It has also suggested introducing consumption vouchers, targeted at low-income groups, to stimulate demand for specified goods and services over a designated period.

"While recent quarters have shown promising signs of recovery in rural consumption, targeted government interventions, such as increasing per unit benefit under its key schemes like MGNREGS, PM-KISAN and PMAY, and providing consumption vouchers to low-income households, can further enhance the rural recovery," said Chandrajit Banerjee, director general,

xxxxState Bank of India (SBI), in a report on Friday, claimed a significant decline in the headline poverty ratio in rural areas on account of enhanced physical infrastructure, higher consumption growth in the bottom fractile and direct benefit transfers (DBTs).

Using the latest annual Household Consumption Expenditure Survey (HCES) data for August 2023-July 2024, the report claimed that poverty ratio in rural areas declined to 4.86 per cent in FY24 from 7.2 per cent in FY23.

Similarly, the poverty ratio in urban areas fell to 4.09 per cent from 4.6 per cent during the same period.

The SBI report estimated the poverty lines in FY24 at Rs 1,632 for rural areas and Rs 1,944 for urban areas by adjusting for decadal inflation and the imputation factor in the poverty line set by the Suresh Tendulkar Committee in 2011.

R Ramakumar, professor, Tata Institute of Social Sciences, said, the SBI report uses a flawed poverty line as the Tendulkar poverty line is not a poverty line, but just a "destitutional line."

And, the previous government had to appoint the C Rangarajan committee to address criticism around it.

"It uses a method for updating the poverty line that does not account for changes in the consumption basket of households.

"Due to this, they end up using a very low poverty line.

"The poverty lines used for 2023-24 in the SBI report amount to just Rs 55 per day in rural areas and Rs 65 per day for urban areas.

"Unsurprisingly, they have underestimated the poverty line to obtain a lower estimate of poverty," he added.

Echoing similar views, Pronob Sen, former chief statistician of India, said that poverty lines are usually estimated by basing them on certain developmental norms, which keeps on



improving as time progresses.

He said to still use the norms prescribed more than a decade ago does not exude confidence in the fairness of the exercise.

"Poverty has no doubt reduced, but the question is the extent to which it has happened.

"Simply adjusting the Tendulkar line for inflation is completely wrong on account of the changes in consumption basket and the difference in the methodology of earlier consumption surveys and current HCES.

"At least use the same principles enunciated by professor Tendulkar and calculate the poverty line afresh," he added.

Methodologically, the current HCES uses a modified mixed reference period (MMRP) in which the recall period for expenditure on items like edible oil, egg, meat, milk, vegetables and fruits is 'last 7 days'.

For items like clothing, bedding, footwear, education, durable goods and medical, it is 'last 365 days'.

For all other items, the recall period is 'last 30 days'.

Earlier consumption expenditure surveys used the mixed reference period (MRP) method in which only two categories of recall periods existed.

Besides, the sampling methodol-

ogy has also undergone a significant change in the current HCES.

For example, second stage stratum classification is now made on the basis of land for rural areas and car ownership for urban areas.

This is unlike previous exercises where the divisions were made based on household status and household activity for rural areas and monthly per-capita income for urban areas.

Santosh Mehrotra, visiting professor at University of Bath, UK, said such a sampling frame gives disproportionate representation to affluent sections of the society.

This results in recording of higher consumption expenditure, which then distorts the picture.

"How can poverty have fallen when job growth and real wages came down with the inflation eating away all the resources of the poor.

190 million workers (2021-22) in India are earning just up to Rs 100 per day (in real terms at 2010 prices) which can be categorised as "absolutely poor."

This compares to just 106.1 million workers in 2011-12.

"Before jumping to a conclusion that India has been able to end poverty, we should interrogate the labour markets," he added.

Here's why he thinks the markets are falling today and what retail investors must do irrespective of market conitions

1. Disappointing Corporate Earnings and Weakening Rupee

Net-net foreigners (foreign institutional investors) still find Indian markets expensive given the fact that the (corporate earnings) growth has not resumed and the rupee continues to depreciate (against the US dollar; the rupee is trading near 86 to a US dollar in the futures market; weakening rupee is bad for an economy that is net importer of crude but benefits companies that earn dollars via their exports).

See now they (the FIIs) will continue to monitor the emerging data points (the macro economic data points like inflation, fiscal deficit, growth in manufacturing and services sector, etc) and if they see some rays of hope in the new data than they may come back to India and they will stop selling also. But we don't know when that will happen.

When will the macro and micro data start improving? We'll have to wait and watch out for these data points.

2. The Immediate Reason Could Be...

The immediate justification (for today's fall) could be the HMPV (Human Metapneumonirus; India's ICMR declared that two cases of HMPV were found in Karnataka.

The immediate reason that people (market experts) may want to attribute to today's fall would be the emergence of two cases in India.

3. GDP Concern

The main issue, however, is about earnings growth and related valuations, the rupee depreciation and the lesser possibility of concerns over GDP growth resumption in the near term.One cannot say whether they will continue to sell in this quarter (they have been net sellers to the tune of 1.9 lakh crore in the last three months of 2024 and have been net sellers to the tune of Rs 4.500 crore in the three trading days of January 2025), in the next quarter because they ultimately want to make money. They will buy India only if valuations (in relation to

earnings) become reasonable and their expectation of economic growth improves. These are some reasons why the FIIs may not be very gung ho about India at this point of time.

4. Fear Over Trump Starting A Tariff WarThat is not a concern for us at this point of time. Actually it may be better for India. At this point of time there is no need to get panicky about it.

5. Knee-jerk reaction over HMPV virus cases?I don't know whether that is the main reason for the fall but as of now we are just attributing this reason to the fall, whether this is the right reason or the only reason, I don't know.

Nobody can find any other reason at this point of time. We know only when the FII numbers are out in the evening.

Gandhi, Tejashwi Yadav to join stir

Chennai, Jan 6

The Enforcement Directorate (ED) raids at Kingston Engineering College, owned by DMK MP Kathir Anand, in Tamil Nadu's Vellore, ended on Sunday after two days.

Anand, a two-term MP from the Vellore Lok Sabha constituency, is the son of DMK General Secretary and Tamil Nadu Water Resources Minister S. Duraimurugan, the number two in the Tamil Nadu cabinet led by Chief Minister M.K.Stalin. The raids, which lasted 44 hours, involved over 15 ED officials, who arrived in eight cars. Searches were conducted at multiple locations, including the college, the resiof Anand and dences Duraimurugan, and properties associated with their associates in Katpadi and Vellore.

Sources revealed that the ED seized unaccounted cash, documents related to the college's financial transactions, and a hard disk.

College authorities, speaking

on condition of anonymity, stated that the seized money was meant for paying staff salaries and Pongal festival bonuses, and that it consisted of student

fee collections. The searches are believed to be linked to a 2019 Income Tax case against Kathir Anand involving allegations of cashfor-votes during the 2019 Lok Sabha elections.

At the time, election officials confiscated Rs 11 crore from Anand's associates, leading to the cancellation of the election in the Vellore constituency.

Then President Ram Nath Kovind, acting on a recommendation from the Election Commission, rescinded the Lok Sabha election in Vellore due to the seizure of unaccounted cash from Anand's associates.

The election, initially sched-uled for April 18, 2019, was cancelled two days earlier, on April 16.

It was then held on August 5, 2019, in which Kathir Anand, representing the DMK, narrowly defeated A.C. Shanmugham

of the AIADMK by a margin of 8,141 votes.

In the 2024 Lok Sabha elections, Anand secured a more decisive victory, defeating Shanmugham, who had since joined the BJP, by a significant margin of 2,15,702 votes.

The DMK has labelled the ED's actions as a "political vendetta".

This is not the first instance of ED raids targeting DMK lead-

In a previous case, searches were conducted at the premises of Tamil Nadu Forest Minister K. Ponmudy and his son, Gautham Sigamani, in connection with a money laundering investigation.

On Saturday, shortly after the raids began, Duraimurugan and Arakkonam MP S. Jagathrakshakan left Chennai for New Delhi by air.

Political analysts believe the ongoing ED raids are intensifying ahead of the upcoming elections, raising concerns of partisan targeting of opposition leaders.

This committee aims to amplify the voices of the students and ensure their demands are met, as they challenge systemic issues in education, employ-ment, and governance in the

state. Prashant Kishor, during his hunger strike, reaffirmed his commitment to the student-led movement in Bihar, stating that the fight would continue regardless of any government action against him.

"Even if the administration arrests me, this Satyagraha will persist. The 51-member Yuva Satyagraha Committee will now lead this movement. This committee is dedicated to reforming Bihar's broken system, and fully support their efforts," Kishor said

He emphasized that the movement has grown beyond addressing issues with the Bihar Public Service Commission (BPSC) and is now focused on overhauling the entire system in the state.

Kishor also appealed to the people of Bihar, urging them to actively support the movement. Sitting under quilts and blankets will not improve Bihar. It is your duty to stand with these young individuals," he stated. He highlighted the resolve

and determination of the youth leading the movement, describ-ing it as a powerful force for change. "Our struggle will con-tinue as a youth-led Jan Shakti. No matter how powerful the government is, there is no greater power than the power of the people," he said.



Study reveals loss of a pet can potentially trigger mental health issues in children

PET owners usually have a strong emo-tional bond with tional bond with their pets, however, according to a new study, the death of a pet can trigger a sense of grief in children that is profound and prolonged and can potentially lead to subse-cuent mental health quent mental health

issues. The new study by researchers at Massa-chusetts General researchest chusetts Generat Hospital (MGH), pub-lished in Euro-pean Child & Adolescent lished in Euro-pean Child & Adolescent Psychiatry, found that the strong emotional attachment of young-sters to pets might result in measurable psychological distress that can serve as an indicator of depression in children and adolescents for as and adolescents for as long as three years or more after the loss of a beloved pet. "One of the first major losses a child will encounter is likely to be the death of a pet, and the impact can be trau-matic especially when matic, especially when that pet feels like a mem-ber of the family. We found this experience of pet death is often associ-ated with elevated men-tal health sumptome in tal health symptoms in children, and that par-ents and physicians need to recognize and take to recognize and take those symptoms serious-ly, not simply brush them off," said Kat-her-ine Crawford, CGC, pre-viously with the Center for Genomic Medicine at MGH, and lead author of the study

the study. Roughly half of the households in developed

countries own at least one pet. And as the MGH investigators reported, the bonds that children form with pets can resemble secure human relationships in terms of providing affection, pro-tection and reassurance. What's more, previous studies have shown that children often turn to pets for comfort and to voice their fears and emo-

Improved early psychosis detection system may halve risk in young people

OCTORS have developed a new data mining method D to detect many young peo-ple with emerging psychosis. The new method, based on advanced data mining to pick up early risk signs from schools, hospitals, and general doctors, will be presented at the ECNP virtual congress and is in press with a peer-reviewed journal. Psychosis is a condition that causes you to lose touch with molity against you to touch with reality, causing you to suffer from hallucinations or delusions. There are a variety of possible causes, including migra-tion and social stress, trauma, substance abuse, etc. It represents a significant care burden, affecting about 20 million people EUR94 billion every year (2011 estimate). Clinical experience has shown that the best way to manage it is to stop it developing. manage it is to stop it developing. Over the last 25 years, doctors have developed ways of detecting young people at risk of develop-ing psychosis and predicting which young people might go on to develop the disorder, and so have been able to take steps to lower risk lower risk.

However, the way clinicians were detecting young people was not systematic and may have missed many at-risk people. Now doctors in the UK have developed new data mining methods that can potentially detect most peo-ple who are at risk of developing psychosis. This, in turn, would allow them to offer them preventive psychological interventions that can halve their risk of developing full-blown psychosis. "Prevention is the most prom-

Enhancing blood sugar control boosts brain health for people with type 2 diabetes

Construction blood sugar levels improved the ability to clearly think, learn and remember among people with type 2 diabetes who were overweight a new were overweight, a new study shows. But losing weight, especially for people who were obese, and increasing physical activity produced mixed results "It's important to properly control your blood sugar to avoid the bad brain effects of your diabetes," said Owen Carmichael, Ph.D., Professor & Director, Professor & Director, Biome-dical Imaging at Domination Biomedical Pennington E Research Center.

that people with greater improvements in blood sugar levels, physical activi-ty and weight loss would have better cognitive test scores. This hypothesis proved partially true. Reducing your blood sugar levels did improve test scores. But losing more weight and exercising more did not always raise cogni-tive test scores. "Every little improvement in blood sugar control was associat-ed with a little better cogni-tion," Dr. Carm-ichael said. "Lowering your blood sugar from the diabetes range to prediabetes helped as prediabetes helped as much as dropping from pre-diabetes levels to the healthy range." More weight loss was either better or worse depending on the mental skill involved, Dr. Carmi-cheal said People who lost

chael said. People who lost more weight improved their executive function skills: short-term memory, planimpulse control, ning, attention, and the ability to switch between tasks. But their verbal learning and overall memory declined. "The results were worse for people who had obesity at the beginning of the study. That's a 'too little, too late' type of mes-sage," he said. "People with diabetes who let their obesity go too far, for too long may be past the point of no return, cognition-wise." Increasing physical activity also generated more benefits for people who had overweight compared to those with obesiparticularly under stress, espe-cially facing the ongoing COVID-19 worry, and we need to inter-vene urgently. The future for those at risk of psychosis is to intervene before the disorders strike " Research leader strike," Research leader Professor Paolo Fusar-Poli, of the leader Institute of Psychiatry at King's

College, London, said. "We have developed a data mining method to search medical



records for those at risk of progressing to psychosis. Many med-ical records are fairly unstructured, with information of mental health being hidden in sections that do not allow systematic research. Our data-mining system does a more complete search of the records people who have been referred to hospital (secondary care), looking for keywords such as weight loss, insomnia, cocaine, guilt, etc. We can look for 14 different terms which we then evaluate for the risk of psychosis. At that point, patients might be invited for a one-to-one interview. We have found that prevention can halve the risk of psy-chosis developing," added Fusar-Poli. The systems have evaluated 92,151 patients over a long follow up period.

They were able to confirm that their method worked well to detect young people at risk, although Professor Fusar-Poli cautioned that "these results need further replication in other countries before they can enter clinical routine but they look very clinical routine but they look very promising. Replication will be facilitated by international research consortia such as the ECNP-funded Prevention of Mental Disorders and Mental Health Promotion Network" Prof. Fusar-Poli suggested that the detection of these young

that the detection of these young people is the first step towards prevention. Preventive interventions in these people can trans-late into several benefits.

This translates into real benefits. Although the initial cost for establishing specialised services detecting young people at risk of psychosis is greater, intervening before the onset of psychosis is associated with fewer treatments, fewer days in the hospi-tal, in addition to the tangible and social health benefits, meaning that the NHS saved around £1000 per patient diagnosed. Our detection systems can extend these benefits to many other young people who might be at risk of psychosis," said Fusar-Poli. ECNP Congress. "We have been working with the ECNP special group on Prevention of Mental Disorders and Mental Health Promotion, and with the EU-Funded European Brain Research Area to set up a Europe-wide system of advance warning for young people at risk of psychosis. <

Potential COVID-19 drug azithromycin may increase risk for cardiac events

ZITHROMYCIN a commonly-prescribed antibiotic is being investigated as a potential treatment for COVID-19. Azithromycin's association with cardiac events also has been debated. In 2012, the FDA issued a warning for azithromycin stating that it had been linked to cardiac events, but subsequent studies have yielded mixed results. Now, researchers from the University of Illinois Chicago have found that azithromycin by itself is not associated with an increase in cardiac events; however, if the drug is

taken with certain other drugs that affect the electrical functioning of the heart, then cardiac events increased. "Our findings should give researc-hers and clinilooking cians at azithromycin as a potenications and even muscle relaxers.

"Because QT-prolonging drugs are used so commonly, our findings suggest that doctors prescribing azithromycin should be sure that patients are not also taking a QT-prolonging drug," Patel said. In a previous study, Patel and colleagues found that one in five people prescribed azithromycin also were taking a QT-prolonging drug. Previous studies looking at azithromycin and cardiac events examined specific populations that tend to be older and have more health issues, including Medicaid patients and vet-

The researchers looked at data from more than 4 million patients enrolled in private health insurance plans who were hospitalised or visited an emergency department for a cardiac event between 2009 and 2015 who started taking either amoxicillin or azithromycin within five days of their hospital visit. There were approximately 2 million episodes in each group. Cardiac events included ventricular arrhythmias, fainting, palpitations and cardiac arrest, and death. "Drugs often prolong QT-interval but may not necessarily result in cardiac events that self-resolve over time. We looked at events that led to emergency department visits or hospitalizations in this study," Patel said.

Scientists discover bacterium linked to deadly childhood disorder

CIENTISTS at the Center for Infection and Immunity (CII) at Columbia University Mailman School of Public Health have discovered bacteria linked to post-infectious hydrocephalus (PIH), the most common cause of pediatric hydrocephalus worldwide.

Results of the study led Pennsylvania State University with CII scientists and clinical colleagues in Uganda are published in the journal Science Translational Medicine. Hydrocephalus is the most common indication for neurosurgery in children. Of the estimated 400,000 new cases each year, about half are estimated to be post-infectious, with the largest number of cases in low- and middle-income countries, especially sub-Saharan Africa.

Neonatal sepsis often precedes PIH, although the manifestations of hydrocephalus typically emerge in the months following the neonatal period as cerebrospinal fluid accumulates so that cranial expansion garners medical attention. These infants typically die in early childhood without advanced surgical management. Study co-first author Brent L. Williams, PhD, assistant professor of epidemiology at CII, examined cerebrospinal fluid (CSF) taken from 100 consecutive cases of PIH and control cases of non-postinfectious hydrocephalus (NPIH) in infants in Uganda, testing the samples for evidence of bacterial and fungal microorganisms. He found Paenibacillus species (bacteria) in CSF linked to cases of PIH, not controls.

further Williams quantitated Paenibacillus species in infant CSF samples, finding a high burden of these bacteria in infected patients. The findings were subsequently independently confirmed, and a strain of Paenibacillus was isolated and characterized through further testing by Steven Schiff, MD, the study's senior author, and colleagues at Pennsylvania State University. The researchers also found that Paenibacillus quantity was associated with clinical measures of hydrocephalus based on brain imaging scores, as well as potential signs of infection based on immune cell counts in patients.

"This discovery has the potential to reduce morbidity and mortality of this central nervous system disease in millions of children in sub-Saharan Africa by shifting treatment from surgery to antibiotics and vaccines," said Co-senior author W. Ian Lipkin, MD, John Snow Professor, and CII Director.

However, in comparison to other respiratory viruses such as the flu, COVID-19 has a higher rate of transmission (R0), at least partly due to cir-culation in a largely immunologically naive population. This means

not remains to be seen in the future. But we think it's highly likely, given what we know so far, COVID-19 will eventually become seasonal, like

other coronaviruses," adds Zaraket. "The highest global COVID-19 infection rate per capita was recorded in the Gulf states, regardless of the hot summer season. Although this is majorly attributed to the rapid virus spread in closed communities, it affirms the need for rigorous control measures to limit virus spread, until herd immunity is achieved, Dr. Yassine said.

Study connects hormones to lifetime risk for immunological diseases


IFFERENCES in biological sex can dictate lifelong disease patterns, says a new study by Michigan State University researchers that links connections between specific hormones present before & after birth with immune resp-onse & lifelong immunological disdevelopment. ease ueveropment. Published in the most recent edition of the Proceedings of the National Academy of Sciences, the study answers questions about why females are at increased risk for comdiseases that mon involve or target the immune system like asthma, allergies migraines and irritable bowel syndrome (IBS). The findings by Adam Moeser, Emily Mackey and Cynthia Jordan also open the door for new therapies and preventa-

"This research shows that it's our perinatal hormones, not our adult sex hormones, that have a greater influence on our risk of developing mast cell-associated disorders throughout the lifespan," said Moeser, Matilda R. Wilson Endowed Chair, a professor in the Department of Large Animal Clinical Sciences and the study's principle investigator.

ing of how perinatal sex hormones shape lifelong mast cell activity could lead to sex-specific preventatives and therapies for mast cell-associated dis-eases," added Moeser. dis-Mast cells are white blood cells that play beneficial roles in the body. They orchestrate the first line of defence against infections and toxin exposure and play an important role in

wound healing, according to the study, 'Perinatal Androgens Organize Sex Differences in Mast Cells and Attenuate into Adulthood.'

cells become overreactive, they can initiate chronic inflammatory diseases and in certain cases, death. Moeser's prior research linked psychological stress to a spe-cific mast cell receptor and overreactive immune responses. Moeser also previously discovered sex differences in mast cells. Female mast cells store and release more inflammatory substances like proteases, histamine and serotonin, compared with



Thus, female mast cells are more likely than male mast cells to kick-start aggressive immune responses. While this may offer females the upper hand in surviving infections, it also can put females at higher risk for inflammatory and autoimmune diseases.

"IBS is an example of this. While approximate-ly 25 per cent of the US population is affected by IBS, women are up to four times more likely to develop this disease than men," said Mackey, whose doctoral research

is part of this new publication.

Moeser, Mackey and

Jordan's latest research explains why these sexbiased disease patterns are observed in both adults and prepubertal children. They found that lower levels of serum histamine and less-severe anaphylactic responses occur in males because of their naturally higher levels of perinatal androgens, which are specific sex hormones present shortly before and after birth. "Mast cells are created from stem cells in our bone marrow. High levels of perinatal androgens program the mast cell stem cells to house and release lower levels of inflammatory substances, resulting in a significantly reduced severity of anaphylactic responses in male newborns & adults," Moeser said. "We then confirmed that the androgens played a role by studying males who lack functional androgen receptors," said Jordan, professor

& an Neuroscience expert in the biology of sex differences. While high perinatal androgen

levels are specific to males, the researchers found that while in utero, females exposed to male levels of perinatal androgens develop mast cells that behave more like those of males.

"For these females, exposure to the perinatal androgens reduced their histamine levels and they also exhibited lesssevere anaphylactic responses as adults," said Mackey, who is currently a veterinary medical student at North Carolina State University

In addition to paving the way for improved and potentially novel therapies for sex-biased immun-ological and other diseases, future research based will help resea-rchers understand how physiological and environmental factors that occur early in life can shape lifetime disease risk, particularly mast cell-mediated disease patterns.

Dulloo enjoined upon them to go through the portal developed by Jal Shakti Department to have idea about the procedure to map their assets. He encouraged them to add every new project to it besides those existing already.

The Chief Secretary maintained that there is a great scope to add hundreds of new layers for the Departments like social sector layers in addition to the infrastructural assets owned by them. He stressed on adding polygon data instead of simple points while creating geo-referenced maps of the same.

He maintained that such mapping on the PMGS portal would make our planning process quite effective and result-oriented for these maps in addition to physical infrastructure would give us clear idea about other social indicators prevalent in the specific area.

The Chief Secretary also advised the Department of Industries & Commerce, which is the nodal department for its implementation, to work out modalities for designating a threshold



limit of Rs 20 Cr for PM Gati Shakti National Master Plan Portal for planning of projects here.

The Commissioner Secretary, I&C, Vikramjit Singh gave an overall view of the performance made by the UT in the implementation of PMGS in J&K. He made out that all the 38 departments of the UT had been onboarded that in turn had added more than 600 data layers to it till date.

In a first, Kupwara was selected from J&K in a pilot phase of PMGS District Master Plan to adopt it at district level. The same model in future is going to be adopted by other districts as well.

As far as the performance of different

departments is concerned H&UDD and Jal Shakti Department were said to stand as major achievers in the UT with all of their assets mapped. It was further given out that all the departments had almost mapped their offices and other major assets over the UT Master Plan portal.

It was further revealed that 50 projects across 10 departments had been discussed in TSU/NPG meetings till date. Orientation session and portal demonstration on project planning was also held earlier in 2024 for the understanding of nodal officers.

As far as the future prospects of the PMGS is concerned it was given out that the integration for issuance of intra department NOCs and clearances would be done through the PM Gati Shakti portal.
