J&K Police Freezes Over 100 **Bank Accounts Linked To Drug** Trafficking

Those apprehended have been involved in the trafficking of narcotics and psychotropic substances, posing a signifi-cant threat to the community, particularly the youth.

"Comprehensive investigations, conducted under the relevant provisions of the NDPS Act, have led to the freezing of these bank accounts containing substantial sums, prima-facie identified as proceeds of illegal narcotic trade", they said.

"Furthermore, moveable and immovable properties valued at crores of rupees, found to be acquired through these illicit activities, have been attached under the applicable legal framework", police added.

This action has been set into motion under Section 68F(2) of the NDPS Act.

Police have urged the public to join hands in this fight by providing any information related to drug peddling or drug abuse and requested the people to contact their nearest police station or dial 112 to report drug-related suspicious activities.

PM to inaugurate 2-Morh tunnel: security forces intensify area domination exercise In Kashmir

Jammu and Kashmir Police, paramilitary forces and the Army are part of the security apparatus for Monday's inauguration. Extensive area domination exer-cises, searches and patrols are being conducted for the smooth conduct of the event, the officials said.

The sharpshooters have been deployed at vulnerable points while aerial and technical surveillance, including through drones, is also being undertaken. The area is being monitored round-the-clock, they added.

Earlier on October 20 last year, seven people, including a local doctor, were killed in a terrorist attack near the tun-nel site in the Gagangir area. The authorities have closed the Srina-gar-Leh national highway from Saturday to Monday "due to icy road conditions caused by inclement weather and to fa-cilitate maintenance work by road main-tenance agencies" tenance agencies" tenance agencies". However, it is widely perceived that the arterial road link between Jammu and Kashmir and Ladakh has been shut for the prime minister's visit. Built at a cost of Rs 2,400 crore on the Srinagar-Leh National Highway, the strategic 6.5-km Z-Morh tunnel will be a major step towards making the Ladakh region accessible by road throughout the year. The work on the project began in May 2015 and was completed last year. The soft opening of the tunnel was done in February 2024. in February 2024. The tunnel is vital in terms of the defence needs of the country in the Ladakh region and also connecting the youngest Union Territory to the rest of the country. Situated at an altitude of 8,650 feet, the Z-Morh tunnel is a two-lane road tunnel Z-Morh tunnel is a two-lane road tunnel equipped with a parallel 7.5-metre-wide escape passage for emergencies. The tunnel ensures seamless connec-tivity between Gagangir and Sonamarg, and will ease summer travel to Ladakh. Along with the under-construction Zo-jila tunnel, the Z-Morh tunnel will ensure uninterrupted connectivity to Baltal and Ladakh regions for civilian and military traffic. traffic. The National Highways and Infrastruc-ture Development Corporation Limited (NHIDCL), which oversees the project, has said the "engineering marvel" is a game changer for the region. "The Sonamarg Tunnel in Jammu and Kashmir is a game-changer for the re-

gion, offering more than just a connec-tion between Gagangir and Sonamarg. This engineering marvel is poised to unlock the full potential of the region's trade and tourism sectors," the NHIDCL said on X.

It said the tunnel is equipped with cutting-edge technologies that provide realtime updates and seamless connectivity for users. This futuristic infrastructure will not only enhance the travel experience but also set a new standard for road connectivity in the region.

Along with the Zojila Tunnel, set for completion by 2028, it will reduce the route length from 49 km to 43 km and boost vehicle speed from 30 km/hr to 70 km/hr, ensuring seamless NH-1 connectivity between Srinagar and Ladakh. This enhanced connectivity will boost defense logistics, drive economic growth and socio-cultural integration across Jammu and Kashmir and Ladakh, the officials said. (Agencies)

Satish Sharma, further added that, Jammu and Kashmir with its unique geographical and cultural diversity, has immense talent across various sports disciplines. 




Sonamarg Tunnel to Unlock New Opportunities for Connectivity, Economic Growth, and Tourism in J&K

Venkaiah Garu- life in service of Bharat

Today, India's former Vice President and respected statesman Shri M. Venkaiah Naidu Garu turns 75. I wish him a long and healthy life and also extend my greetings to all his well-wishers and supporters. This is an occasion to celebrate a leader whose life journey showcases dedication, adaptability and an unwavering commitment public service. From his early days in the political arena to his tenure as Vice President, Venkaiah Garu's career exemplifies his unique ability to navigate the complexities of Indian politics with ease and humility. His eloquence, wit and steadfast focus on developmental issues have earned him respect across party lines.

Venkaiah Garu and I have been associated with each other for decades. We have worked together and I have also learnt a lot from him. If there is one thing that has remained common in his life, it is the love for people. His brush with activism and politics began in Andhra Pradesh with student politics as a student leader. Considering his talent, oratory and organisational skills, he would have been welcomed in any political party but he preferred to work with the Sangh Parivar because he was inspired by the vision of Nation First. He was associated with the RSS, ABVP and then strengthened the Jana Sangh and the BJP.

When the Emergency was imposed almost 50 years ago, Venkaiah young Garu immersed himself in the anti-Emergency movement. He was imprisoned and that too for inviting Loknayak JP to Andhra Pradesh. This commitment to democracy would be seen time and again in his political career. In the mid-1980s, when the great NTR's Government was unceremoniously dismissed by the Congress, he was again at the forefront of the movement to protect democratic principles. Venkaiah Garu has always

been comfortable swimming

even against the most formidable tides. In 1978, Andhra Pradesh voted for the Congress but he beat the trend and was elected as a young MLA. Five years later, when the NTR Tsunami swept the state, he got elected as a BJP MLA, thus paving the way for the BJP's growth across the state.

All those who have heard Venkaiah Garu speak will vouch for his oratory skills. He is certainly a wordsmith but he is as much a worksmith. Since his days as a young MLA, he began to be respected for the rigour he put in to legislative affairs and speaking for people of his constituency. No less than a stalwart like NTR noted his talent and even wanted him to join his Party but Venkaiah Garu refused to deviate from his core ideology. He went on to play a big role in strength-ening the BJP in Andhra Pradesh, going across the villages and connecting with people from all walks of life. He led the Party on the floor of the Assembly and even became the APBJPPresident.

It was in the 1990s that the BJP central leadership took note of Venkaiah Garu's efforts and thus in 1993 began his stint in national politics when he was appointed the Party's All India General Secretary. It was truly a remarkable moment for a man, who as a teenager would go around announcing the visits of Atal Ji and Advani Ji, to be working directly with them. As the General Secretary, he was focused on how to bring our Party to power and ensure that the nation get their first ever BJP Prime Minister. After the move to Delhi, there was no looking back and he rose to become the National President of the Party.

In 2000, when Atal Ji was keen to induct Venkaiah Garu in the government as a Minister, Venkaiah Garu instantly conveyed his preference for the Rural Development Ministry. This left everyone including Atal Ji puzzled. After all, here was a leader who was being asked which portfolio he wants and his first choice was Rural Development. But, Venkaiah Garu was clear- he was a Kisan Putra, he had spent his early days in the villages and thus, if there was one area he wished to work, it was rural development. As Minister, he was closely associated with the conception and rolling out of the 'Pradhan Mantri Gramin Sadak Yojana.' Years later, when the NDA of Government 2014 assumed office, he handled the crucial portfolios of Urban Development, Housing and Urban Poverty Alleviation. It was during his tenure that we launched the important Swachh Bharat Mission and important urban development related schemes. Perhaps, he is one of the only leaders to have worked for both rural and urban development for such an extensive period.

When I came to Delhi in 2014, I was an outsider to the national capital, having worked in Gujarat for the previous decade and a half. In such times, Venkaiah Garu's insights were very handy. He was an effective Parliamentary Affairs Minister - he knew the essence of bipartisanship but at the same time he drew a when it came to line Parliamentary norms and rules.


In 2017, our Alliance nominated him as our Vice-Presidential candidate. We faced a dilemma - we thought about how the big shoes of Venkaiah Garu would be impossible to fill, but at the same time, we also knew there was no better candidate for the Vice Presidency than him. I can never forget one of the speeches he gave when he resigned as Minister and MP. He could not control his tears when he recalled his association with the Party and efforts to build it. Apart from work and politics, Venkaiah Garu is a voracious reader and writer too. For the people in Delhi, he is known as the person who brought the glorious Telugu culture to the city. His Ugadi and Sankranti programmes are clearly among the most cherished gatherings in town. have always known Venkaiah Garu as someone who loves food and also hosting people. But, off late, his self-control has also been visible to everyone. His commitment to fitness is seen in how he still plays badminton and enjoys his brisk walk.

On the issues that he is passionate about or on various developments that take place across the nation, he calls me and asks me about it. I met him most recently when our government returned to office for the third term. He was delighted and conveyed his best wishes to me and our team. I wish him once again on this milestone. I hope young Karyakartas, elected representatives and all those who have a passion to serve learn from his life and imbibe those values. It is people like him who make our nation better and more vibrant.

Sabalenka sizzles on rain-hit Meet new BCCI secretary day at Australian Open Devajit Saikia

NEW DELHI, JAN 12 Aryna Sabalenka opened her bid for a third straight Australian Open title with a 6-3, 6-2 victory over Sloane Stephens on Sunday after rain had washed away a good chunk of play on the opening day at Melbourne Park.

The top seed did not have it all her own way against the 2017 US Open champion but wrapped up the win in little more than an hour on Rod Laver Arena, one of three courts where play continued under closed roofs during the deluge.

Olympic champion Zheng Qinwen, who lost to Sabalenka in last year's final, reached the second round indoors, while men's sixth seed Christian Ruud and former world number four Kei Nishikori dodged the wet weather to secure five-set victories.

It was another matter on the outside courts where play ended after less than an hour in the morning and did not resume until more than six hours later in the early evening.

Eight of the 32 scheduled singles matches were scratched and organisers will be giving thanks for the cushion of the extra day which was first added to the tournament last year.

One of the benefits of winning three Grand Slam titles is preferential scheduling and the roof of Rod Laver Arena was open again to the evening sun as Sabalenka took to court to face American Stephens.

Five breaks of serve, 20 winners and 21 unforced errors later and the Belarusian was leading the crowd in an im-



promptu dance, having secured a second-round clash with Spain's Jessica Bouzas Maneiro.

"It's not like I played my best match, probably, but I was glad to close it out in straight sets," the 26-year-old said.

"I love playing here, it feels like home."

At the start of the day, the roofs of the showcourts were already closed before a violent thunderstorm brought the first rain and Zheng and Romanian qualifier Anca Todoni played out their baseline battle uninterrupted.

Fifth seed Zheng, who did not play a warm-up tournament, struggled against the tall Todoni in the first set, finally breaking for 4-3 only to be broken back.

The 22-year-old saved a set point before clinching the tiebreaker 7-3 and quickly raced to a 3-0 lead in the second while Todoni racked up unforced

errors as she fought to stay in the contest.

"The first match is never easy and I made some stupid mistakes," Zheng said after wrapping up her 7-6(3), 6-1 win in a shade under two hours.

Earlier, Mirra Andreeva was the first player to reach the second round when the 17-year-old Russian beat Czech Marie Bouzkova 6-3, 6-3 on John Cain Arena.

On Margaret Court Arena, Arthur Fils was the first man into second round when he came from a set down to beat unseeded Finn Otto Virtanen 3-6, 7-6(4), 6-4, 6-4,

"It's pretty nice, man. First time in my life I'm playing on a good court," the 20th seeded Frenchman said.

"To be able to play a match and to finish a match with a roof, it's much more easy than to play, to stop with the rain."

Jemimah's maiden century powers India to series win

A collective batting performance headlined by Jemimah Rodrigues' maiden hundred formed the cornerstone of India's commanding 116-run win against Ireland in the second women's ODI in Rajkot on Sunday as the hosts took an unassailable 2-0 lead in the three-match series.

India scored a massive 370/5 in their 50 overs riding on three half-centuries and a ton before restricting Ireland to 254/7 in the stipulated 50 overs.

It was the elegant skipper Smriti Mandhana, who was first off the blocks with an attacking 73 off just 54 balls, while Rodrigues' first hundred (102 off 91 balls) ensured a smooth finish for


Devajit Saikia was unanimously elected as the secretary of the Board of Control for Cricket in India during the board's Special General Meeting in Mumbai on Sunday.

The 55-year-old replaces Jay Shah, who stepped down as BCCI secretary last month after being elected as the chairman of the International Cricket Council.

A former cricketer, Saikia represented Assam in four first-class matches during the 1990s before transitioning to cricket administration. He began his career in cricket administration as the general secretary of a cricket club in Assam under the leadership of Himanta Biswa Sarma, the current chief minister of Assam.

Saikia was appointed as the advocate general (AG) of Assam in May 2021.

Last month, BCCI president Roger Binny named Saikia as the board's acting secretary, sparking a controversy. Senior Assam Congress leader Debabrata Saikia, also the leader of the

Why Bumrah may lose out on Test captaincy

NEW DELHI, JAN 12

Jasprit Bumrah is the frontrunner to replace Rohit Sharma as India's Test captain going forward. However, the pace spearhead doesn't seem to be a long-term option given his nagging fitness concerns, the latest being a back spasm that has rendered him doubtful for next month's ICC Champions Trophy.

The national selection committee remains hopeful that Bumrah still might have some role in the Champions Trophy, given it's a swelling. But looking at the bigger picture, the question arises: Can he be deemed a permanent skipper in Tests, now that Rohit's days in Tests seem to be nearing their end?

If Bumrah is fit and ready to lead the Test side in England later this year, chief selector Ajit Agarkar and his colleagues need to identify a strong vicecaptain. This is crucial to ensure the deputy can take charge in unforeseen circumstances.

Currently, in Tests, only two names are in the reckoning -- Rishabh Pant and Yashasvi Jaiswal -- with the former appearing the most suitable for the role.

It is understood that during BCCI's review meeting on Saturday with Agarkar, head coach Gautam Gambhir and Rohit, Bumrah's issues with the lower back were discussed in detail. Post the review, it appears unlikely that Rohit will travel to England for the five Tests and if all goes well, the 31vear-old Bumrah will lead India in the first Test at Headingley. The pacer, with 443 international scalps across formats in just 204 games, recently led India at Perth and Sydney in the recently concluded Border-Gavaskar Trophy series. He was the player of the series with 32 wickets -- the highest by an Indian on foreign soil. However, the back spasm in the fi-



nal Test proved to be his undoing as he said. could not bowl in the second innings of the

The injury raises concerns about Bumrah's ability to stay fit for extended periods given his workload as the pace spearhead in Tests. His presence is vital for ICC white-ball events, but managing his bowling workload is paramount.

There is no guarantee that Bumrah won't have more breakdowns during the next WTC cycle from June 2025 to June 2027, especially now that he is in his 30s. This scenario might prompt selectors to groom another strong captaincy candidate as vice-captain.

Another former India keeper Deep Dasgupta agreed that Bumrah cannot be a long-term solution as Test captain given his bowling workloads.

"It is not just the marquee series (England and Australia) that we are talking about. In between Test matches, there will be ICC events where Bumrah's presence is a must. Like this year, it is Champions Trophy and next year it will be the T20 World

Indian team for Champions Trophy to be picked on

The Indian team for the ICC Champions Trophy will be picked on January 18 or 19, said BCCI vice-president Rajeev Shukla on Sunday. The selectors had announced the squad for the five-match series against England on Saturday but did not name the squad for the following three ODIs against England as well as the Champions Trophy, starting on February 19.

India play their Champions Trophy opener against Bangladesh on February 20. Under the hybrid model, India will all play their games in Dubai while the other league games will be played in host country Pakistan.

India were dealt a major bowl as pace spearhead Jasprit Bumrah is likely to miss the group stage of the ICC Champions Trophy due to swelling in his back.

Devajit Saikia and Prabhtej Singh Bhatia were elected secretary and treasurer, respectively, unopposed at the BCCI's Special General Meeting in Mumbai on Sunday.

They both were elected unopposed after being the only ones to file nomination for the posts vacated by Jay Shah and Ashish Shelar.

Shah had to leave the secretary's post after



becoming the ICC chairman last month while Shelar resigned after taking oath as a cabinet minister in the Maharashtra government.

Saikia hails from Assam and Bhatia from Chhattisgarh. Saikia was performing the additional duties of secretary after Shah took over as ICC chairman on December 1. He was the joint secretary and now that post lies vacant.

"The Two (02) Elective Posts of the Office Bearers - Secretary and Treasurerwere Uncontested, and it was not necessary to conduct a Poll in respect of these Two (02) Posts," stated electoral officer A K Joti in his declaration of results.

Shah, who was felicitated by the BCCI on Saturday night, was also feted at the SGM.

Speaking to reporters after the SGM, Shukla said apart from the election nothing was tabled in the meeting.

"There was single point agenda (for the election of treasurer and secretary post). So nothing else was discussed at the SGM."

Following the SGM, Shukla was also part of the Women's Premier League Committee meeting.

Indian economy likely to be 'a little weaker' in **2025: IMF MD**

New Delhi, Jan 12

The Indian economy is expected to be "a little weaker" in 2025 despite steady global growth, IMF managing director Kristalina Georgieva has said. Georgieva also said she expects quite a lot of uncertainty in the world this year mainly around the trade policy of the US.

In her annual media roundtable with a group of reporters on Friday, she said global growth is expected to be steady in 2025, but with regional divergence.

Georgieva said she expects the Indian economy to be a little weaker in 2025.

The World Economy Outlook update week will have more details about it.

"The US is doing quite a bit better than we expected before, the EU is somewhat stalling, (and) India a little weaker," she said.

Brazil was facing somewhat higher inflation, she said.

In China, the world's second-largest economy, the International Monetary Fund (IMF) was seeing deflationary pressure and ongoing challenges with domestic demand, she said.

"Low-income countries, despite all the efforts they are making, are in a position when any new shock can affect them quite negatively," Georgieva said.

"What we expect in 2025 is to have quite a lot of uncertainty, especially in terms of economic policies.

"Not surprisingly, given the size and role of the US economy, there is keen



interest globally in the policy directions of the incoming administration, in particular on tariffs, taxes, deregulation and government efficiency," Georgieva said.

"This uncertainty is particularly high around the path for trade policy going forward, adding to the headwinds facing the global economy, especially for countries and regions that are more integrated in global supply chains, medium-sized economies, (and) Asia as a region," she said.

That uncertainty is actually expressed globally through higher longterm interest rates, even though shortterm interest rates have gone down, the IMF managing director said.

Donald Trump will be sworn in as

the 47th President of the United States on January 20, replacing Joe Biden at the White House.

Trump, 78, has announced plans to impose additional tariffs on countries like China, Canada and Mexico.

He has publicly announced the use of tariffs as a key policy tool.

On inflation, the IMF expects global disinflation to continue, Georgieva said."As we all recognise, the higher interest rates that were necessary to fight inflation did not push the world economy into recession.

"They have delivered the desired results. Headline inflation is converging back to target sooner in advanced economies than in emerging markets," she said.

Life insurance Dec new biz premium falls 21.7% to Rs 30,218.71 crore

NEW DELHI, JAN 12 The new business premium (NBP) of life insurance companies dropped 21.7 per cent year-on-year (Y-o-Y) to Rs 30,218.71 crore in December 2024 on the back of a steep fall in business.

According to data published by the Life Insurance Council, LIC's premium dropped 41.15 per cent Y-o-Y to Rs 13,523.87 crore while private insurers reported 7 per cent growth in NBP to Rs 16,694.85 crore as the industry absorbs the impact of the revised surrender value norms.

The fall in LIC's premium was due to a significant decline in its group single premium which halved to Rs 8,191.29 crore in December from Rs 17,601.97 crore last year.

Individual non-single premium dropped to Rs 2,628.74 crore from Rs 3,111.33 crore.

"The steep fall in LIC's group single premiums is largely due to a significant spike.

"Although it seems like a dramatic fall, compared to two years ago, this is normalization, showing slight growth over the years," said Saurabh Bhalerao, associate director, BFSI Research, CareEdge Ratings.

The largest private life insurer - SBI Life Insurance's - premium grew by 15.2 per cent to Rs 5,307.98 crore, while HDFC Life posted a 4.55 per



cent Y-o-Y drop to Rs 2,713.49 crore. ICICI Prudential Life's premium

inched up to Rs 3,221.56 crore.

Other major players like - Bajaj Allianz Life Insurance posted 9.7 per cent growth while Axis Max Life Insurance clocked 13.1 per cent drop, respectively.

Meanwhile, in the third quarter of FY25 (Q3FY25), the premium dropped by 6.55 per cent to Rs 85,872.87 crore.

LIC's premium dropped by 22.56 per cent to Rs 42,406.07 crore, while private insurers' recorded 17.05 per cent growth to Rs 43,466.81 crore.

In the April-December period, NBP of the life insurance industry improved by 9.9 per cent YoY to Rs 2.75 trillion, where LIC recorded 7.16 per cent YoY to Rs 1.58 trillion.

On the other hand, private life insurers posted 13.86 per cent Y-o-Y growth to Rs 1.17 trillion.

FPIs withdraw Rs 22,194 crore in Jan

NEW DELHI, JAN 12 Foreign investors have withdrawn Rs 22,194 crore from Indian equities this month, driven by expectations of a weak earnings season, a steady rise in the US dollar, and concerns over tariff war during Donald Trump's presidency.

This came following an investment of Rs 15,446 crore in the month of December, data with the depositories showed.

Foreign investors have scaled back their investments in Indian equities significantly amid global and domestic headwinds.

Brokerages upbeat on TCS after Q3 miss

Most global as well as domestic brokerages are upbeat on India's largest IT services provider, Tata Consultancy Services (TCS), despite its performance during the December quarter of FY25, when it missed Street estimates.

On the bourses, the TCS share price rallied as much as 6.44 per cent to hit an intraday high of Rs 4,296.80 apiece, before settling 5.67 per cent higher at Rs 4,265.55.

In comparison, the Sensex closed 0.31 per cent lower at 77,378.91 levels.

TCS reported revenue of Rs 63,973 crore for the quarter, reflecting a 5.6 per cent year-on-year (Y-o-Y) growth, or 4.5 per cent Y-o-Y growth in constant currency (CC) terms. Net profit stood at Rs 12,380 crore, reflecting a 5.5 per cent increase

However, the company missed Bloomberg estimates, which had forecast revenue at Rs 64,748 crore and net profit at Rs 12,534 crore.

Operating profit margin for the quarter was 24.5 per cent, a decline of 50 basis points (bps) Y-o-Y but an improvement of 40 bps sequentially.

Growth was primarily driven by the consumer business group (up 1.1 per cent), energy, resources, and utilities (up 3.4 per cent), and regional markets (up 40.9 per cent).

Among geographies, growth markets performed robustly, with India leading at 70.2 per cent, followed by the Middle East & Africa (up 15.0 per cent), Latin America (up 7 per cent), and Asia Pacific (up 5.8 per cent).

Total contract value (TCV) for the quarter stood strong at \$10.2 billion, against \$8.6 billion in Q2.

The last 12 months IT services attrition rate was at 13 per cent.

K Krithivasan, chief executive officer (CEO) and managing director (MD), said, "We are pleased with the excellent TCV performance in Q3. It was wellrounded across industries, geographies and service lines, lending good visibility to long-term growth."

TCS announced a dividend of Rs 76 per share, which includes a special dividend of Rs 66.

The record date for the dividend is January 17, 2025, with payment scheduled for February 3, 2025.

"In a quarter that saw significant cross-

currency volatility, TCS's strong execution, cost management and deft currency risk management helped deliver healthy margin improvement and free cash flows

"Disciplined investments in talent and infrastructure should lend good support to long-term business growth," said Samir Seksaria, chief financial officer (CFO).

Brokerages had mixed views on TCS, following its Q3FY25 performance, with several brokerages highlighting the company's growth potential despite nearterm challenges.

Hong Kong-based CLSA upgraded TCS to 'outperform,' raising its target price to Rs 4,546, citing strong growth prospects and improved demand, despite a challenging third quarter.

Jefferies reiterated a 'buy' rating with a target of Rs 4,760, highlighting management's optimistic outlook, margin improvement potential, and attractive valuation.

Similarly, Bern-stein maintained a 'outperform' rating, with a target price of Rs4,700.

In contrast, Tokyo-based Nomura maintained a 'neutral' stance, slightly lowering its target to Rs 4,020 (Rs 4,050 earlier), pointing to mixed Q3 results and uncertain growth visibility for FY26.

According to reports, London-headquartered HSBC kept a 'hold' rating with a target of Rs 4,540, acknowledging optimism for CY25 while cautioning about downside risks in FY26, especially from European market pressures and the BSNL deal.

Domestic brokerages, too, highlighted strong deal flows and valuation. Emkay sees a weaker-than-expected Q3 operating performance, with revenue declining 1.7 per cent quarter-on-quarter (O-o-O), though deal wins improved to \$10.2 billion

The firm acknowledged early signs of revival in discretionary spending and retained an 'add' rating with a target price of Rs 4,500, citing attractive valuations post recent underperformance.

from the Indian markets could be attributed to multitude of factors, such as expectation of yet another weak earning season, concerns over the tariff war under Trump's presidency, slowdown in GDP growth, still high inflation numbers and uncertainty over the commencement of the interest cut in India," Himanshu Srivastava, associate director, Manager Research, Morningstar Investment Research India, said.

Rewriting our DNA: The potential of gene editing for blood disorders and beyond


Gene editing, particularly with CRISPR-Cas9 technology, has shown potential to revolutionise medicine by offering cures for a range of genetic disorders, especially blood disorders such as sickle-cell anaemia.

Sickle-cell anaemia, a genetic blood disorder, caus-es chronic pain and lifethreatening complications for millions of people in India and worldwide. In this disease, red blood cells become crescent or sickle-shaped, which not only reduces their oxygen-carrying capacity but also makes it difficult for them to pass through blood vessels. A patient suffering from sickle cell disease may suffer from severe anaemia, sudden pain crises, organ damage and an increased risk of infection.

In most cases, these patients are offered blood transfusions, pain management, and hydroxyurea as treatments, which provides some degree of relief. But it does not relieve them of the pain and various other associated complications. Bone Marrow Transplant has so far been the only curative treatment option.

But now gene editing, an innovative treatment in which we can repair or replace the defective gene that causes the disease, is a new hope for millions suffering from the disease. Sickle-cell anaemia is caused by a mutation in the HBB gene, which encodes the beta-globin subunit of haemoglobin. Haemoglobin is the protein in red blood cells responsible for transporting oxygen throughout the body. The mutation leads to the production of abnormal haemoglobin, known as haemoglobin S (HbS). Under low oxygen conditions, HbS molecules tend to stick together, forming rigid rods that distort the shape of red blood cells into a sickle form. These deformed cells can block small blood vessels, causing painful episodes called vaso-occlusive crises and damaging organs due to restricted blood flow.

Gene editing, using the CRISPR-Cas9 technology, the new promising treatment for



genetic disorders , directly targets and corrects the underlying genetic defects. CRISPR, which stands for Clustered Regularly Short Interspaced Palindromic Repeats, is a revolutionary tool that allows scientists to make precise, targeted changes to the DNA of living organisms. The Cas9 protein acts as molecular scissors, guided by RNA sequences that match the target gene, to introduce cuts at specific locations. Once the DNA is cut, the cell's natural repair mechanisms can be harnessed to correct or

replace the faulty gene. In the case of sickle-cell anaemia, researchers have employed gene editing to either correct the mutation in the HBB gene or reactivate fetalhemoglobin (HbF) production. Fetalhemoglobin, which is naturally produced during fetal development, prevents sickling of red blood cells. Normally, HbF production ceases shortly after birth, replaced by adult haemoglobin (HbA). However, reactivating HbF can compensate for the defective HbS, mitigating the symptoms of sickle-cell anaemia. Another promising approach involves editing the BCL11A gene, which suppresses HbF production. By disrupting this gene, researchers can restore HbF production in red blood cells, bypassing the effects of sickle-cell mutation. the Early clinical trials have shown that this method can significantly increase HbF levels, reducing the frequency

and severity of pain crises and improving overall patient health.

During a clinical trial, a patient named Victoria Gray, who was then 33 years old, was treated for sickle-cell anaemia using CRISPR-Cas9 at TriStar Centennial Medical Center in Nashville in the United States. During the treatment, Gray's bone marrow cells were harvested and then edited to disrupt the BCL11A gene. Edited cells were then reinfused back into her body. The results were remarkable - her HbF levels increased significantly, and she experienced a dramatic reduction in pain episodes and hospitalisations. Gray is not the only one, many other patients have been cured of this painful disease during the clinical trials. Another approach, developed by researchers at St. Jude Children's Research Hospital, involves directly correcting the sickle-cell mutation in the HBB gene using CRISPR. This method has shown promise in preclinical studies and is currently undergoing clinical trials. Early results indicate that edited cells can be engrafted in the bone marrow and produce healthy red blood cells, offering a poten-

> ease. In the case of thalassemia, which occurs due to mutations in the genes responsible for haemoglobin production, CRISPR-Cas9 can be used to either correct the defective gene directly or induce the expression of foetal haemo-

tial one-time cure for the dis-

globin in the gene, much like in the treatment for sickle cell anaemia. Early clinical trials promising shown have results.

While the initial focus of gene editing has been on blood disorders due to the accessibility relative of hematopoietic stem cells, it is now being explored to treat various other kinds of genetic defects such as cystic fibrosis, which is caused by mutations in the CFTR gene, leading to the production of thick, sticky mucus that clogs the lungs and digestive tract, muscular dystrophy, particularly Duchenne muscular dystrophy (DMD), which is caused by mutations in the DMD gene, which encodes dystrophin, a protein essential for muscle function. While still in the early stages of research, gene editing could one day offer a cure for a neurodegenerative disorder such as Huntington's disease, which is caused by a mutation in the HTT gene, leading to the production of a toxic protein that damages brain cells.

Researchers across the world are exploring various strategies to treat or even cure many debilitating condi-

tions with gene editing. While gene editing has the potential to cure genetic blood disorders, the experience of treating sickle-cell anaemia has shown that there are several challenges that need to be addressed. One major challenged is the delivery of the gene-editing machinery to the target cells. Most current approaches involve ex vivo editing, where cells are removed from the patient, edited in the lab, and then reinfused. This process is complex, expensive, and requires specialised facilities, limiting its accessibility.

The second major chal-lenge is the cost of therapy. lower-middle-income For countries like India, developing these tools and therapies indigenously is essential. Interestingly, India is at an advanced stage of launching its own gene-editing therapies. When available, these therapies will provide its people with an affordable and

A decline in psychological wellbeing, particularly in areas like purpose in life and personal growth, in old age may precede the development of mild cognitive impairment (MCI) — a common precursor to dementia, according to new research.

The study, published in the Journal of Neurology, Neurosurgery & Psychiatry, indicates that these aspects of well-being start deteriorating two to six years before an MCI diagnosis, even when no cognitive symptoms are evident, and this decline occurs regardless of whether the individual later develops dementia.

While much research has linked psychological well-being to brain ageing and dementia, it often focuses primarily on a sense of purpose, leaving out other important components such as self-acceptance, autonomy, environmental mastery, and meaningful relationships.

The study aimed to address these gaps by analysing changes in psychological well-being in 910 cognitively intact older adults.

The long-term study, which began in 1997, includes older adults from diverse living situations in the US. Participants underwent annual check-ups, including cognitive assessments and evaluations of psychological well-being.

Over an average monitoring period of 14 years, 265 participants (29 per cent) developed MCI, with 89 of them (34 per cent) progressing to dementia.

The study found that individuals who developed MCI were more likely to experience a significant decline in psychological well-being, particularly in purpose in life and personal growth, which began to diminish three to six years before the MCI diagnosis.

The research also found that while psychological well-being declined at a similar rate before and after the MCI diagnosis, meaningful connections with others deteriorated more rapidly after the diagnosis.

These findings suggest that a reduction in psychological wellbeing, even in the absence of cognitive impairment, could be a predictor of future dementing disorders. The study emphasises the importance of psychological support for older adults to potentially mitigate these risks.

AI in Indian healthcare market to reach \$1.6 billion by 2025: Report

Artificial intelligence (AI) in the Indian healthcare market is growing at a compound annual growth rate (CAGR) of 40.6 per cent and is esti-mated to reach \$1.6 billion by 2025, a report showed on Tuesday. Expected to reach \$650 billion

by 2025, the overall healthcare sector in India has been growing at a CAGR of 22.5 per cent between 2016 to 2022 and is diversifying in terms of products, services, and markets, according to the report by Nasscom and Kantar.

AI technology promises a transformative leap for India's healthcare system by enhancing diagnostics, streamlining operations, and improving patient care nationwide, the report added.



Among healthcare providers, AI adoption is relatively high at 68 per cent but most of the de (92 per cent) are in the proof of concept (PoC) phase. According to the findings, large tech firms are adopting platformbased approaches and hybrid cloud solutions for scalable and compliant healthcare applications. While there has been a growing interest and investment in Generative AI, its adoption in the healthcare segment is in its nascent stages, with 34 per cent of healthcare organisations in the country piloted at least 1-2 GenAI use cases in 2023. Phase 3 clinical trial for dengue vaccine

The Indian Council of Medical Research (ICMR) and Panacea Biotec have initiated the phase 3 clinical trial for a vaccine to fight dengue. The trial will evaluate the efficacy of India's indigenous tetravalent dengue vaccine, DengiAll, developed by Panacea Biotec.

The first participant in this trial was vaccinated on Wednesday at Pandit Bhagwat Daval Sharma Post Graduate Institute of Medical Sciences (PGIMS), Rohtak. Based on the results of this trial, the vaccine will be rolled out for public use. The phase 3 clinical trials will take place at 19 locations spanning 18 states and Union territories and will involve more than 10,335 healthy adult participants.

Union Minister of Health and Family Welfare J.P. Nadda said the trial marks a critical advancement in the fight against dengue. "It reflects our commitment to protecting our citizens from this pervasive disease and underscores India's capabilities in vaccine research



and development," Nadda said. According to the statistics of the National Centre for Vector Borne Diseases Control (NCVB-DC), India has recorded 19,447 cases of dengue and 16 deaths

till April 30, 2024. The data shows that Kerala and Tamil Nadu registered most number of cases. While Kerala recorded 4,412 cases and 14 deaths, the latter registered 4,204 cases

and two deaths. Since April, dengue cases has been on a steady rise in Karnataka with more than 12,000 cases and eight deaths reported till July 2024. The number of dengue

cases shot up from 6,187 on July 1 to 12,000 as of July 19 in Karnataka. In Delhi also, a total of 246 cases till June this year were the highest for the time period since 2019.

According to the health ministry, dengue is a major public health concern in India, ranking among the top 30 countries with the highest incidence of the disease. The dengue virus is transmitted to humans through the bites of infected female mosquitoes, primarily the Aedes Aegypti.

"Approximately 75-80 per cent of infections are asymptomatic, yet these individuals can still transmit the infection through the bite of Aedes mosquitoes. Among the 20-25 per cent of cases where symptoms are clinically apparent, children are at a significantly higher risk of hospitalisation and mortality," according to the health ministry.

Currently, there is no antiviral treatment or licensed vaccine against dengue in India. The development of an effective

vaccine becomes all the more complex as all four serotypes of dengue virus are known to circulate or co-circulate in many regions of India.

A statement from the health ministry said the tetravalent dengue vaccine strain, originally developed by the National Institutes of Health (NIH), USA, has shown promising results in pre-clinical and clinical trials worldwide. Panacea Biotec, one of three Indian companies to receive the strain, is at the most advanced stage of developing the vaccine. "The company has worked extensively on these strains to develop a full-fledged vaccine formulation and holds a process patent for this work. Phase 1 and 2 clinical trials of the Indian vaccine formulation were completed in 2018-19, yielding promising results," the statement reads.
