Shubhanshu Shukla, Other Axiom-4 Astronauts **Board Spacecraft For Return To Earth**

NEW DELHI, JULY 14 Shubhanshu Shukla and three other astronauts of the Axiom-4 entered the Dragon Grace spacecraft on Monday and were suited up to begin their journey back to Earth after an 18-day stay at the International Space Station.

Shukla, the mission pilot, commander Peggy Whitson, and mission specialists Slawosz Uznanski-Wisniewski of



Poland and Tibor Kapu of and donned their space suits for the 22.5-hour Hungary entered the Dragon Grace spacecraft journey to Earth.

The hatch of the Dragon Grace spacecraft that connected it to the International Space Station was closed at 2:37 PM IST and the crew members were performing final checks before undocking from the orbital laboratory at 4:35 PM IST.

ACB Arrests Postal Employee In J&K's Bandipora For Accepting Bribe

accused while he was accepting the bribe amount.

The accused has been identified as Mudasir Ahmad Najar, a resident of Rohama, Baramulla, currently working as a Postal Assistant in the Post Office Bandipora.

"The complainant had approached the ACB alleging that the official had demanded Rs. 6,500 for conducting physical verification of his business unit under the PMEGP scheme for subsidy disbursement. Acting on the complaint, the ACB laid a trap and caught the accused red-handed while accepting Rs.6,000 as part of the bribe," the ACB said in a statement.

A case has been registered and further investigation is underway.

In a statement, ACB reiterated its commitment to act tough against corruption in public offices and urged people to report any such instances through the designated helpline and online complaint system.

SC To Hear On Aug 3 Pleas Seeking Transparency In NEET-PG Exam Evaluation Process

One of the pleas, filed through lawyer Tanvi Dubey, challenges the opaque nature of the evaluation system and seeks multiple directions to the National Board of Examinations (NBE), the authority responsible for conducting NEET-PG.

It also sought a direction for revaluation or rechecking in cases of score discrepancies.

widespread condemnation by ordinary Kashmiris was a "befitting reply to Pakistan and terror outfits." Asked whether the participation of local accomplices in the attack posed a fresh challenge for security forces, Sinha maintained that local recruitment of militants had fallen to record lows.

"There has been just one incident of local recruitment this year compared to 6–7 last year. There was a time when this figure used to be 150–200. But it is also a fact that Pakistan has facilitated the infiltration of a large number of terrorists in both Jammu region and Kashmir region," he noted. The Pahalgam attack dealt a temporary blow to tourism, with arrivals plunging in the immediate aftermath. "Tourist arrivals had almost stopped after the incident. We believed that the Amarnath Yatra would be the turning point," Sinha said. The LG confirmed that tourist destinations closed after the attack have gradually reopened. "Many have already opened. Others will be opened too in a phased manner, after finalising a robust security plan for each," he said.

Unsurprisingly, it provided both greater clarity and opened additional questions," Wilson said.

Over the past 30 days, he said there has been an ongoing cycle of theories, allegations, rumours and sensational headlines, many of which have later been disproven.

"Until a final report or cause is tabled, there will no doubt be new rounds of speculation and more sensational headlines... Let us not be diverted from what are our top priorities: standing by the bereaved and those injured, working together as a team, and delivering a safe and reliable air travel experience to our customers around the world," Wilson said.

The AAIB report said the fuel supply to both engines of flight AI171 was cut off within a second of each other, causing confusion in the cockpit and the airplane plummeting back to the ground almost immediately after taking off.

The 15-page report also said that in the cockpit voice recording, one unidentified pilot asked the other why he had cut off the fuel, which the other denied.

On Sunday, the Indian Commercial Pilots' Association (ICPA) said the crew of the AI171 flight that crashed last month acted in line with their training and responsibilities under challenging conditions, and the pilots should not be vilified based on conjecture. (Agencies)

The descent of the Dragon spacecraft from the ISS is designed to be completely autonomous.

After undocking, Dragon will perform a series of engine burns to safely distance itself from the ISS and begin re-entry procedures.

Final preparations include detaching the capsule's trunk and orienting the heat shield ahead of atmospheric entry, which will expose the spacecraft to temperatures nearing 1,600 degrees Celsius. Parachutes will deploy in two stages — first sta-

Parachutes will deploy in two stages — first stabilising chutes at about 5.7 km altitude, followed by the main parachutes at roughly two km.

Splashdown is expected off the coast of California approximately 22.5 hours after undocking, and the space capsule will be recovered by a specialised ship.

The splashdown is expected to take place off the coast of California at 3:01 pm IST on Tuesday.

The Axiom-4 mission began their space odyssey on June 25 when the Falcon-9 rocket carrying the Dragon space capsule blasted off from Florida towards the ISS. (Agencies)

"It is imperative that we market our trekking routes not just as a tourism product, but as part of our ecological and cultural legacy. We must not confine ourselves to markets where advisories act as obstacles. There are many countries with no such restrictions, whose tourists would be eager to explore our terrain," he said, calling for joint efforts with Ladakh to keep traditional routes alive and accessible. Referring to the current situation, Omar Abdullah said it was unfortunate that the book is being released at a time when many of the trekking routes described in it remain inaccessible due to recent developments. Reflecting on his personal regret at not having trekked these trails, Chief Minister Omar Abdullah praised the author's dedication and passion. The Chief Minister emphasized the need for digitizing the book to ensure wider accessibility. "If we want this work to benefit those who are truly interested in trekking, we must digitize it-perhaps through an app. Let the coordinates, photographs, anecdotes, and waypoints become a digital guide for adventure lovers," he suggested. He urged students to shift their mindset from being job seekers to becoming job creators, leveraging the enormous support available through various startup schemes.

Having been associated with IIM Jammu since its inception, Dr. Jitendra Singh lauded its dynamic growth and rapid strides in institutional development. "Among the IIMs established in the last 11 years, IIM Jammu has emerged as a standout performer," he remarked. He also inaugurated a newly constructed four-block hostel complex, featuring 688 single-bed rooms, and commended the institute's modern infrastructure and student-centric facilities.

He advised the institute to initiate in-house B2B startup meets, leveraging its proximity to IIT, AI-IMS, IIIM, and the Institute of Mass Communication in Jammu. He said this rare cluster of premier institutions within a few kilometers offers an exceptional ecosystem for interdisciplinary learning and early industry-academic.

Dr. Jitendra Singh emphasized the democratization of aspiration, noting that students from remote and underrepresented regions are now excelling in top national institutions and services. "By making Urdu mandatory for such important posts in the government, the NC rulers have overruled previous provisions where knowing the language Urdu was not compulsory," Sharma further said.

"We are holding protests to get it revoked. Youth are already on the streets protesting. The matter has been brought to the notice of the Lieutenant Governor as well and memorandums have been submitted through deputy commissioners, but nothing has been done so far," he said.

Sharma said that 14 BJP MLAs had even met Chief Minister Omar Abdullah over the issue. "His apparoch was positive. Still, no action has been taken, and tomorrow is the last day to apply for the posts." "They are trying to create unrest in Jammu and are forcing us to go on agitation. All 28 BJP MLAs have started it with today's two-hour-long token dharna," he added.

The former minister further said that the party will soon announce its next course of action.

"We are warning the government not to play with the sentiments of the people of Jammu, who are fed up with the discriminatory attitude of Kashmir-centric rulers," he said.

Other BJP MLAs also warned of an agitation if the Urdu language requirement is not withdrawn for the examination advertised by the government.

"Making Urdu a compulsory subject in recruitment for Naib Tehsildars is a gross injustice to the youth of the Jammu region," BJP MLA Yudhvir Sethi said, adding that such injustice will not be tolerated.

The MLAs strongly opposed the decision and said it was a "deliberate attempt" to marginalise the youth of the Jammu region.

"This is a calculated move to deprive Jammu's youth of equal opportunities," Sethi added.

The imposition of Urdu, he said, reflects the divisive and exclusionary policies once pursued by the Omar Abdullah-led government.

"We will not allow the repetition of such injustice," he said and added that the move is a clear violation of equal status accorded to multiple official languages, including Dogri, Hindi, Kashmiri, Urdu, and English.

Operation Sindoor: A Deterrent for Pakistan

Reflecting on the broader security environment during the TOI interview, Sinha said the success of Operation Sindoor had drawn clear red lines for Pakistan.

"India has made it clear that any terror attack will be considered an act of war. The manner in which our forces carried out precise hits against terror facilities in Pakistan conveyed a stern message. But a country that has made terrorism its declared state policy is not to be trusted," he cautioned during the conversation.

Despite the challenges, Sinha expressed confidence that the Union Home Ministry, Defence Ministry and intelligence agencies are fully prepared to counter any future threats.

Why war expert John **Spencer thinks Operation Sindoor**

was a signal, not a

destructive act hair of Urban Warfare Studies and ✓ US military veteran John Spencer, who was in India recently and interacted with top military leadership and defence tech entrepreneurs, claimed that Operation Sindoor was more of a signal to Islamabad than a destructive act, as India chose to use precision-guided munitions against select targets in Pakistan.

In a recent interview with the news agency ANI, Spencer observed that India was demonstrating that it has the will to do what is necessary if Pakistan wanted to continue to escalate the tensions.

The expert, who in a recent social media post pointed out that the operation demonstrated India's shift from a reactive posture to a proactive, precision-oriented doctrine, said there has been a change in India's strategic doctrine, which, according to him, will change the entire region. He claimed that India achieved its strategic goals at low cost, and in doing so, has changed the security paradigm for the region. Backing Deputy Chief of Army Staff Lt Gen. Rahul R Singh, who had said China used the India-Pakistan military conflict as a "live lab" to test its various weapon systems as Beijing is Pakistan's biggest weapons supplier, he said the conflict was indeed a testing ground for China to test its various defence equipment. When asked about the recent visit of Pakistan Army Chief Field Marshal Asim Munir to the US, he said he does not think the US is going to supply any weapon systems to Pakistan any time soon, and they will have to look somewhere else. According to him, the current US administration is not going to support those who back terrorism.

The fragmentation in the global fight against terror

The Pahalgam terror attack of April 22 has exposed, yet again, the fragmentation in the global fight against terror and Pakistan's resort to terrorism when it fears normalcy in Jammu and Kashmir. While a number of countries have condemned the Pahalgam attack, they have, at the same time, called upon India and Pakistan to exercise restraint. The United States Secretary of State, Marco Rubio, went to the extent of calling on

both parties to "work towards ... a responsible resolution that maintains long term peace and regional stability in South Asia". U.S. Vice-President J.D. Vance "hoped" that India's response would not lead to a wider regional conflict. Russian Foreign Minister Sergey Lavrov has said that "settling disagreements" between New Delhi and Islamabad on a bilateral basis should be by political and diplomatic means. The European Union's High Representative for Foreign Affairs and Security Policy Kaja Kallas could not even get around to calling it a "terror attack".

The end of a collective fight Gone are the days of "zero tolerance" to terror. Gone are the days when the perpetrators of terror were called out and accountability demanded. Some have even asked India for "proof" of Pakistan's complicity, conveniently forgetting inter alia the Pulwama (2019) and 26/11 Mumbai (2008) terror attacks. In effect, they are calling on India, the victim, to be restrained and to not go after Pakistan, the perpetrator and backer.

India should not be surprised. To begin with, the appetite for a flare-up in Asia is low after the raging wars in Ukraine, Gaza and West Asia. Moreover, successful elections in Jammu and Kashmir and tourists flocking to Kashmir are red flags for Pakistan. To top it all, the global fight against terror is no more a collective fight. It is now left for each state to fend for itself. The consensus reached after the 9/11 terror attacks in the U.S. in 2001, to fight terror comprehensively, seems to have run its course. The world has gone back to the era of "my terrorist" and "your terrorist."

Europe is focused on "its" right-wing terrorists extremism and terror. The U.S., under former President Biden, focused on Joe REMVE, or racially and ethnically motivated violent extremism. The Organisation of Islamic Cooperation (OIC) is keen only to use Islamophobia as an excuse to condone terror. Canada has told India that "your" terrorists are not "my" terrorists and that any terrorist threat against India from its soil is covered under its freedom of expression — in effect asking India to wait till a terror act is committed before approaching them. China has blocked proposals submitted by India in 2022 to "black-list", under the UN Security Council 1267 sanctions regime, terrorists operating against India from Pakistani soil. Now that Pakistan is in the UN Security Council (UNSC) for 2025-26 (as a non-permanent member), these will remain blocked for at least two more years.

The world is blindsided by the spread of terror in Asia and Africa. Terrorism in Africa has spread exponen-tially, from the Sahel to Mozambique. The Global Terrorism Index 2025 points out that the Sahel is now the epicentre of terrorism, accounting for over half of all terrorism deaths in the world. But the international community says they are "your" terrorists not "my" terrorists and is short-changing Africa.

A different yardstick for India

However, a different yardstick applies when it comes to India, which is the biggest victim of state-sponsored terror from Pakistan. First, it is about "regional stability" and not about fighting terror as Pakistan has successfully sold the "nuclear war" bogey to the world. Even as they egg Ukraine on in its war with "nuclear" Russia, the thought of two developing countries using nuclear arms scares the West enough to call on India to stop fighting crossborder terror. It is quickly forgotten that it was Prime Minister Narendra Modi who called on Russian President Vladimir Putin not to use nuclear arms in the Ukraine war for which he was thanked by the U.S. among other countries.

Further, it is now common knowledge that in Pahalgam,

the terrorists singled out the tourists based on religion and shot them. A Muslim pony ride operator was shot while trying to save the tourists. The terror attack, which The Resistance Front (a proxy of the Pakistan-based terror Lashkar-e-Taiba) group claimed that it had carried out — it retracted this statement later — was clearly done to raise tensions and create a communal divide in India.

While the whole world cries in condemning hoarse Islamophobia, anti-Semitism and Christianophobia, why does it become silent when calling out the recent attack what it is, i.e., for Hinduphobia? When even protests in American university campuses are being dubbed anti-Semitic or Islamophobic and portrayed in religious terms, rather than contextualising them in terms of the 52,000 Palestinians killed in Gaza or Israeli hostages still with Hamas, to maintain radio silence on Hinduphobic attacks is glaring, if not unexpected. Even U.S. presidencandidate tial Vivek Ramaswamy, was confronted with accusations of belonging to a "pagan, wicked" faith while on the campaign trail.

But there has been a refreshing departure - the statement by Director of the U.S. National Intelligence, Tulsi Gabbard, characterised who the Pahalgam attack in religious terms, as a "horrific Islamist terrorist attack" and recognised that the targets were Hindus. A silver lining is the extradition of Tahawwur Rana from the U.S. to India for the Mumbai attacks, even if big fish, David Headley, is still in the U.S.

predictably, Further, Pakistan used its presence in the UNSC to move for an emergency closed session on a "deteriorating regional environment and rising tension" posing "a serious risk of esca-lation". In 2019, a similar closed meeting took place, at China's behest, just after Article 370 was abrogated, but fizzled out. The meeting now was no different and no document was issued. It underlined once again that the P-5 (the five permanent UNSC member states), with the exception of China, is in mood to play no the "Kashmir" game, which it considers to be a bilateral

matter between India and Pakistan (even if parts of it have been ceded by Pakistan to China).

India's move to keep the Indus Waters Treaty in abevance has also been targeted by Pakistan at the UNSC. India will no doubt keep the pressure on the UNSC to stop any outcome document, unlike how a similar issue was dealt with in 2021 between Ethiopia and Egypt on the Grand Ethiopian Renaissance Dam. Any one country in the UNSC can stop a statement.

The path ahead

Consequently, if the world is so concerned about India not using kinetic options to fight terror from where it originates, should not India's "strategic" partners demand accountability from Pakistan rather than substituting harsh words for real action or calling on "both sides" to "defuse" tensions? To deter Pakistan, India's close Gulf partners, Saudi Arabia and the United Arab Emirates, which are themselves undertaking internal socio-religious reforms, need to step up. The international community must act to deter and sanction Pakistan, and not merely react episodically. If it refuses to act, India will act alone. Apart from the current slew of options, India will also have to think ahead

Having built a strong international framework to combat terror, including terror financing and misuse of emerging technology, the international community cannot step back on combating terror, especially state-sponsored terrorism. Three years after raising it for the first time in the UN General Assembly in 2022, India has yet another opportunity to take the lead in combating religiophobia against non-Abrahamic religions. This time its campaign should go beyond the UN, where select Indian Missions should take up the issue bilaterally with their host countries.

All this points to one thing. India should not only create geopolitical space for itself through its strategic autonomy and multi-alignment policy, but must also be prepared to use it when it matters. There is no doubt that such parleys are on.

Power and pitfalls of digital influence

As digital connectivity grows, India faces a complex battle against misinformation and de-influencing. While social media enables vital communication, it also amplifies unchecked con-tent. De-influencing — where influencers discourage purchases — can promote mindful consumption, but often relies on sensationalism and clickbait for engagement.

Despite expert advice being essential, digital platforms often become the go-to place, enabling the rapid spread of misinformation. To counter this, strict regulations are needed.

Experts consulted for the World Economic Forum's 2024 Global Risks Report identify India as one of the nations most vulnerable to misinformation and disinformation. This is largely driven by the rise of AI-generated content and the influence of social media platforms. Despite the Ministry of Consumer Affairs' "Endorsement Know-hows" and ASCI/SEBI guidelines, misleading health advice and weight loss reels blur the line between organic and paid content. Influencers often use shock tactics, clickbait, and half-truths to go viral, rapidly fuelling misinformation.

Legal landscape While Article 19(1)(a) of the Constitution guarantees freedom of speech, it is subject to reasonable restrictions under Article 19(2), including defamation, public order, and morality. The Supreme Court has upheld that free speech does not protect spreading misinfor-mation or harmful content.

The Consumer Protection Act, 2019, bans misleading advertisements, holds influencers accountable for deceptive promotions. Digital for



regulations under the IT Act (Sections 66 & 67), the Intermediary Guidelines, 2021, and defamation and e-commerce laws penalise harmful content and ensure accurate endorsements.

Though not legally binding, ASCI guidelines set ethical standards, with noncompliance leading to black-listing and public reprimands.

With stricter enforcement, influencers must prioritise transparency and credibility, making ethical content creation essential in the evolving digital landscape. An influencer's intent is

key when critiquing brands. Honest reviews aid con-sumers, but exaggerated negativity for clicks or sponsorships is a commercial tactic. Indian defamation laws protect against misleading content, highlighting the need for authenticity. While influencers operate across many fields, health-related content is held to a higher pedestal. There are norms in place, but something more critical is required in the health sector to ensure that advice is reliable and responsible

Influencer content blurs the line between fact and manipulation with selective data, ambiguous language, and cherry-picked events. Misinterpreted studies and emotional appeals create misleading narratives that prioritise engagement over

accuracy. We have all fallen for clickbait, especially when it promises to teach us "how to avoid cancer" or "how to make liver detox water." These trends highlight influencers' role in shaping nar-ratives and public discourse. Viral content often outpaces fact-checked information, making critical thinking, source verification, and expert consultation crucial.

Evolving regulation

Regulations for social media influencers are tightening, with a focus on accountability and responsi-ble content. SEBI recently imposed strict rules on "fin-fluencers," restricting realtime stock data in educational content to prevent influencers from influencing financial decisions without proper expertise or authorisation.

Legal scrutinv now extends to misleading advertisements. In Indian Medical Association vs Union of India, the Court held influencers accountable for false endorsements, and the Delhi High Court stressed claim verification, especially in health content. With nonexperts gaining visibility on unregulated platforms, health advice must come

from qualified professionals. Strong ethical norms and legal oversight are crucial to curb misinformation.

In a landmark ruling, the Delhi High Court restrained an influencer from disparaging a brand, emphasising that freedom of speech under Article 19(1)(a) is not absolute. It upheld restric-tions to prevent defamation and ruled that health content must be backed by qualified professionals with disclosed credentials.

While influencers gain trust, exploiting it for per-sonal gain damages credibility. As trust erodes, influencers and brands risk losing their authenticity.

Moreover, establishing a registration system or database for influencers disseminating public health information is essential. Such a system would function as a continuous monitoring tool, ensuring transparent accountability for the con-tent produced. This approach would help curb the unchecked spread of misinformation and empower consumers to make wellinformed, objective assessments, especially given the significant safety and per-ception challenges associat-ed with health-related content. Recognising the ethical dimensions inherent in public health communication, robust ethical practices must complement legal measures to safeguard public interests.

Brands must invest in consumer education, while regulators and platforms should enforce strict guidelines against misinformation. It is critical to enforce stringent guidelines to hold influencers accountable for their content and unchecked promotional activities, thereby safeguarding consumer interests.

Tennis authorities found the world number one bore 'no fault or negligence' for a positive test for anabolic steroid clostebol -- Sinner saying it had

inadvertently entered his system via a massage from a team member -- but he accepted a three-month ban from World Anti-Doping Agency (WADA) in February.

His title on Sunday was his first since returning in May and came five weeks after losing an epic French Open final to Alcaraz in which he squandered three match points.

KPC observes July 13 as "Batta Loot Day" with Peaceful Sit-in at Press Club Jammu



JAMMU RISING JAMMU, JULY 13

In a solemn and powerful show of remembrance and resilience, the All State Kashmiri Pandit Conference (ASKPC), under the leadership of its President Shri Moti Lal Malla, organized a peaceful sitin dharna at the Press Club Jammu today to mark July 13 as "Batta Loot Day." The event aimed to commemorate one of the darkest days in the history of the Kashmiri Pandit community, recalling the horrific communal violence unleashed on them in 1931.

Describing the day as one etched in pain and collective memory, ASKPC leaders recalled how on July 13, 1931, leaders recalled how on July 15, 1551, innocent Kashmiri Pandits were subjected to a well-organized and brutal communal attack. Homes were looted, temples desecrated, houses set ablaze, and lives lost simply because of religious identity. This incident is considered one of the earliest

and most devastating communal assaults on the Pandit community and marked the beginning of a pattern of targeted violence that would continue for decades. Speakers at the dharna drew

attention to how this cycle of violence resurfaced with the 1986 Anantnag (Danow) riots, during which scores of Pandit homes and temples were burned, and later culminated in the mass exodus of 1990. The latter forced an entire community into exile under threats, killings, and systemic persecution, making it one of the largest instances of internal displacement in post-Independence India.

A large number of displaced Kashmiri Pandits, including men, women, and children, gathered at the Press Club carrying placards and raising slogans to express their collective grief and demand long-overdue justice. The sit-in was not only a tribute to those who suffered but also a call to the govern-

ment for recognition and restitution.

Among the key demands raised by the community were official recognition of July 13 as "Batta Loot Day" at both state and national levels, acknowl-edgment of the 1931, 1986, and 1990 events as acts of commu-nal violence and ethnic cleansing, formulation of a comprehensive and dignified rehabilitation policy for the safe return of displaced Pandits to their homeland, and urgent govern-ment action to address the socio-economic challenges still faced by the community even after 35 years of exile.

A memorandum detailing these demands was submitted to the Hon'ble Lieutenant Governor of Jammu and Kashmir, urging immediate and sympathetic intervention to address the long-standing grievances of the Kashmiri long-standing Pandit community.

In his address, Shri Moti Lal Malla emphasized that the Kashmiri Pandits have always stood for peace, nationalism, and harmony. Despite their sacrifices and contributions, he said, their pain continues to be ignored. He appealed to the government and civil society to recognize the truth, deliver justice, and facilitate a respectful return of the community to their roots.

The protest concluded with a strong and unified resolve to continue the peaceful struggle for justice and dignity. As one participant aptly summarized, "We were uprooted, but not broken. We remember. We resist. And we will return.

Kavinder slams Omar for distorting history, calls Jallianwala Bagh victims true Freedom Martyrs

Says J&K paying the price for Nehru's historical blunders

JAMMU RISING JAMMU, JULY 13 Senior BJP leader and former Deputy Chief Minister, Kavinder Gupta today came down heavily on Chief Minister Omar Abdullah for his controversial remarks equating the July 13, 1931 incident in

Engines shut down due to fuel 'cutoff' within seconds leading to Jun 12 crash : Probe



NEW DELHI, JULY 14

A Preliminary report on the Air India flight AI171 crash in Ahmedabad on June 12 today revealed that fuel cutoff switches were moved from 'run' to 'cutoff' within a second of each other which led to the tragedy. The crash led to i270 people

loosing their lives.

The report reveals that within 90 seconds of take off, both engines of the aircraft shut down unexpectedly during the initial climb leading to a loss of thrust and rapid descent. After the switches of both engines flipped, the Boeing 787 Dreamliner immediately shut down mid-air seconds after take-off and began to lose thrust and sink down, the report by India's Aircraft Accident Investigation Bureau AIB) said.

"The aircraft achieved the maximum recorded airspeed of 180 Knots IAS at about 08:08:42 UTC and immediately thereafter, Engine 1 and Engine 2 fuel cutoff switches transitioned from RUN to CUT-OFF position one after another with a time gap of 01 sec. The Engine N1 and N2 began to decrease from their take-off values as the fuel supply to the engines was cut off," the 15page report said. The pilots attempted to

restart the engines by moving the fuel control switches back to the 'run' position. Engine 1 started to recover but Engine 2 was unable to arrest core speed

deceleration despite repeated attempts to reintroduce fuel and increase core speed acceleration.

The report also revealed that just seconds before the aircraft lost power and went down near Ahmedabad airport, one pilot asked the other why he had cut off fuel to the engines, the sec-ond pilot reportedly denied, saying, "did not do so.

"In the cockpit voice recording, one of the pilots is heard asking the other why he cut off. The other pilot responded that he did not do so," the report said. "The EAFR recording stopped at 08:09:11 UTC At about 08:09:05 UTC, one of the "Mayday The Air pilots transmitted Mayday Mayday ". Traffic Controller Traffic Controller (ATC) enquired about the call sign but did not get any response and saw the aircraft crashing outside the airport boundary. Significantly the report rules out any doubt about the fitness of the pilots to operate the illfated flight. "The crew of flight AI171 arrived at the airport and underwent preflight Breath Analyzer test at 06:25 UTC and were found fit to operate the flight. The crew is seen arriving at the boarding gate in the CCTV recording at about 07:05 UTC (12:35 IST)."

It also rules out any shortage of fuel or bird activity in the adjoining areas.

"Fuel on board was 54,200 Kgs and as per the load and trim sheet of the flight, the Take-off Weight was 2,13,401 Kgs (Max. allowed - 2,18,183

Kgs). The take-off weight was within allowable limits for the given conditions. "There was no 'Dangerous

Goods' on the aircraft. The report also ruled out any

bird activity saying "No signifi-cant bird activity is observed in the vicinity of the flight path.' Boeing in its initial rection to

the catastrophe said they would "continue to support" the investigation and the customers. The aviation company said it would defer to the AIIB probe to provide information about AI 171, id adherence with the United Nations International Civil Organization Protocol.

'Our thoughts remain with the loved ones of the passengers Nd crew on board Air India Flight 171 as well as everyone affected on the ground in Ahmedabad. We continue to support the investigation and our customer. We will defer to the AAIB to provide information about AI 171 in adherence with the United Nations International Protocol known as Annex 13,' it said in a state-

Air India in a statement acknowledged that it had received the preliminary report by AAIB and is working closely with stakeholders and would continue to fully cooperate with AAIB and other authorities as their investigation progresses. "We stand in solidarity with

the families and those affected by the AI171 accident. We continue to mourn the loss and are fully committed to providing support during this difficult time. We acknowledge receipt of the preliminary report released by the Aircraft Accident Investigation Bureau (AAIB) today, 12 July 2025. Air India is working closely with stakeholders, including regulators. We continue to fully cooperate with the AAIB and other authorities as their investiga-tion progresses."

Air India, however, did not comment on the findings of the report saying "Given the active nature of the investigation, we are unable to comment on specific details and refer all such enquiries to the AAIB.

Khyber Pakhtunkhwa Chief Minister and a prominent PTI leader Ali Amin Gandapur late on reached Lahore Saturday night along with the party leaders declaring the launch of the movement to free Khan, the patron-in-chief of the party.

The 72-year-old cricketer-turned-politician has been behind bars since August 2023 after he was booked in multiple cases

The PTI is gearing up to launch a massive drive from August 5 across the country to press the Shehbaz Sharif government and military establishment to free Khan.

Gandapur and other main leaders of the party are camping in a farmhouse in Lahore's Raiwind area, adjacent to the Sharif family residence, in the city to give a final shape to their protest campaign.

Meanwhile, police reportedly arrested at least 20 PTI workers who gathered to welcome their leaders at different points in Lahore.

A PTI spokesperson said on Sunday that the Punjab police have detained its several workers. "The police have been raiding the party leaders and workers' residences in the Punjab province, especially Lahore, for the last couple of days to stop them from taking part in the protest activities," he said.

A Punjab police spokesperson denied the arrest of any of Khan's party workers.

However, a police source told Press Trust of India that at least 20 PTI workers have been picked up in Lahore and elsewhere.

Speaking to the party leaders in Lahore, Gandapur said, "Any protest campaign launched from Lahore earns success and this too will be successful across the country.

Freight Train Ferrying Oil Catches Fire In Tamil Nadu, Train Services Hit

CHENNAI, JUL 14

A moving goods train carrying diesel caught fire on Sunday at Tiruvallur in northern Tamil Nadu affecting train services in the arterial Chennai-Arakkonam route, the Southern Railway said.

No casualties were reported. Passengers were, however, stranded and state transport corporation operated special buses to cater to the needs of

the travelling public. According to the Southern Railway's official release, few intermediate wagons of the goods train, carrying diesel caught fire while exiting caught fire while exiting Tiruvallur railway station at around 5.30 hours and many other wagons (3rd from engine onwards) also derailed and 18

wagons were gutted. The goods train was from Chennai Harbour to Walajah Road Siding (Walajabad). The fire, coupled with huge columns of thick smoke rose up the sky and fire tenders were rushed to the spot.

State Minister (Minorities and Non Resident Tamils Welfare) S M Nasar, alongwith officials, made an inspection and in view of the blaze and smoke people living close to the location of fire accident were taken to shelters. State transport corporations operated over 170 special services as train services were hit.

The Railway said: "Upon noticing the fire in 3rd wagon, applied the emergency brakes and Station Master, Tiruvallur, switched off the overhead (OHE) power supply as a precaution-ary safety measure." Further, the railway said: "However, by the time the train was brought to a halt, the fire spread upto

19th wagon. Consequently, the train operations in the impor-tant Chennai – Arrakonam section, linking Chennai with Bangalore, Kerala and Bangalore, Kerala and Renugunta/Tirupati had to be

Renugunta/ firupati had to be suspended. Twelve Mail/Express trains scheduled to commence from or terminating at Chennai Central were cancelled, and several other trains were either divert-ed or short-terminated." Top railway officials monitored the railway officials monitored the rescue and restoration operations in coordination with the district administration, NDRF and Fire and Rescue Services. "Residents in the vicinity were evacuated as precautionary measure, though there has been no injury to any person." As many as 30 unaffected wagons and the locomotive were safely detached and isolated from the accident site. Eighteen wagons were gutted and "four governors, but did not disclose their names.

Australia PM Albanese kicks off China visit focused on trade



BEIJING, JULY 14

Australian Prime Minister Anthony Albanese kicked off a visit to China this weekend meant to shore up trade rela-tions between the two countries.

Albanese met with Shanghai Party Secretary Chen Jining on Sunday, the first in a series of high-level exchanges that will include meetings with Chinese President Xi Jinping, Premier Li Qiang and Chairman Zhao Leji of the National People's Congress. Albanese is leading "a very

large business delegation" to China, which speaks to the importance of the economic relations between Australia and China, he told Chinese state

broadcaster CGTN upon his arrival in Shanghai Saturday.

During a weeklong trip, Albanese is set to meet business, tourism and sport representatives in Shanghai and Chengdu including a CEO roundtable Tuesday in Beijing, his office said.

It is Albanese's second visit to China since his center-left Labor Party government was first elected in 2022. The party was reelected in May with an increased majority. Albanese has managed to

persuade Beijing to remove a series of official and unofficial trade barriers introduced under the previous conservative government that cost Australian exporters more than 20 billion Australian dollars (\$13 billion)

a year.

Beijing severed communications with the previous administration over issues including Australia's calls for an independent inquiry into the origins of and responses to COVID-19. But Albanese wants to reduce Australia's economic dependence on China, a free trade partner.

"My government has worked very hard to diversify trade ... and to increase our relationships with other countries in the region, including India and Indonesia and the ASEAN countries," Albanese said before his visit, referring to the 10member Association Southeast Asian Nations.

"But the relationship with China is an important one, as is our relationships when it comes to exports with the north Asian economies of South Korea and Japan," he added.

Chinese state-run Xinhua News Agency, in an editorial Sunday, described China's relationship with Australia as "steadily improving" and undergoing "fresh momentum."

"There are no fundamental conflicts of interest between China and Australia," the editorial stated. "By managing differences through mutual respect and focusing on shared interests, the two sides can achieve common prosperity and benefit."(

Scarlett Johansson says Oscars snubbed 'Avengers: Endgame'

Hollywood star Scarlett Johansson believes the Academy didn't give Avengers: Endgame the recognition it deserved, noting that while the blockbuster earned a nomination for Visual Effects, it was overlooked for a Best Picture nod.

"How did this film not get nominated for an Oscar?" Johansson told Vanity Fair in a new cover story promoting her forthcoming directorial debut "Eleanor the Great", which is set to premiere at Cannes.

She continued: "It was an impossible movie that should not have worked, that really works as a film — and also, it's one of the most successful films of all time."

Explaining that commercial success should not preclude awards recognition, reports deadline.com.

The discussion surrounding Marvel's place at the prestigious awards ceremony has long simmered, with "Avengers: Endgame" co-director Joe Russo recently chiming in on the matter.

The ever-expanding MCU has seen its fair share of Academy nods, largely in the Visual Effects category, including for Black Panther, which won three Oscars.

All three Iron Man films have been nominated, as have all the Avengers installments, Doctor Strange, Shang-Chi and the Legend of the Ten Rings and Spider-Man: No Way Home.

Balanced diet boosts brain health and cognitive function What is your sleep pattern?



Researchers from the University of Warwick have unveiled a profound link between dietary choices and brain health. The study, which involved the analysis of 181,990 participants from the UK Biobank, has shed new light on the impact of food preferences on both physical and mental wellbeing. The research delved into a

range of physical evaluations, including cognitive function, blood metabolic biomarkers, brain imaging, and genetics, to gain insights into the relationship between nutrition and overall wellbeing. The participants' food preferences were collected through an online questionnaire, and with the help of machine learning, the researchers cat-egorized the data into 10 groups, such as alcohol, fruits, and meats.

fruits, and meats. The findings, published in Nature, revealed that a healthy and balanced diet is associated with superior brain health, enhanced cog-nitive function, and improved mental wellbeing. Participants who adhered to a balanced diet exhibited high-er amounts of grey matter in the brain, which is linked to intelligence, compared to

the brain, which is linked to intelligence, compared to those with a less varied diet. Moreover, the study emphasized the need for gradual dietary modifica-tions, especially for individu-als accustomed to highly palatable but nutritionally deficient foods. By gradually reducing sugar and fat intake over time, individuals may naturally gravitate towards healthier food choices. The researchers also highlighted the influence of genetic fac-tors on the association between diet and brain health, emphasizing how a combination of genetic pre-dispositions and lifestyle choices shapes overall wellbechoices shapes overall wellbe-

Lead Author Professor Jianfeng Feng University of of the Warwick stressed the importance of establishing healthy food preferences early in life, stating, "Developing a healthy balanced diet from an early age is crucial for healthy growth. Both families and schools should offer a diverse range of nutritious meals and cultivate an environment that supports physical and mental health.'

Addressing the broader

implications of the research, Professor Feng emphasized Professor Feng emphasized the role of public policy in promoting accessible and affordable healthy eating options. He stated, "Since dietary choices can be influ-enced by socioeconomic sta-tus, it's crucial to ensure that this does not hinder individu-als from adopting a healthy balanced dietary profile. Implementing affordable nutritious food policies is essential for governments to empower the general public to make informed and health-ier dietary choices, thereby promoting overall public health." health.'

health." Co-Author Wei Cheng from Fudan University under-scored the importance of pro-moting nutritional awareness and fostering healthier eating habits across diverse popula-tions, urging for concerted efforts in this direction. Dr Richard Pemberton a

Dr. Richard Pemberton, a Certified Lifestyle Physician and GP at Hexagon Health, who was not involved in the study, commented on the research, saying, "This excit-ing research further demonstrates that a poor diet detrimentally impacts not only our physical health but also our mental and brain health. This study supports the need for urgent government action to optimize health in our children, protecting future gener-ations. We also hope this provides further evidence to motivate us all to make better lifestyle choices, to improve our health and reduce the risk of developing chronic disease.

To better understand the impact of sleep habits on long-term health outcomes, US researchers identi-

fied four distinct sleep patterns by analysing the self-reported sleep habits of 3,683 middle-aged adults. Good sleepers: those who get optimal sleep on a regular basis; weekend catch-up sleepers: those who mostly sleep for short durations, but sleep longer on week-ends and holidays; insomnia sleep-ers: those who have trouble falling asleep, short sleep duration and high daytime tiredness; and nappers: those who are mostly good sleepers, but take frequent daytime

naps. More than half of the partici-pants were insomnia sleepers or nappers and most of them maintained their sleep patterns over the work performance to promoting course of the 10-year study period. long-term healthy behaviours."

The participants also reported on the number and type of chronic conditions. Insomnia sleepers had 72 per cent to 188 per cent greater risk of chronic health issues, including cardiovascular disease, diabetes, depression and frailty. Nappers had an increased risk of diabetes, cancer and frailty. However, being a weekend catchup sleeper was not associated with any chronic conditions. "There are sleep hygiene behav-iours that people could do to

improve their sleep, such as not using cell phones in bed, exercising regularly and avoiding caffeine in the late afternoon," said the study. "Better sleeping habits can make many significant differences, from improving acoust relationships and improving social relationships and

New study shows remarkable connection

Include 4 hrs of physical activity, 8 hrs sleep in routine for optimal health, suggests study

For optimal health, a person's ideal day should include more than four hours of physical activity involving exercise of light, moderate or exercise of light, moderate or vigourous intensity, and at least eight hours of sleep, new research has found. Light-intensity activity could range from doing chores to making dinner, whereas moderate and

and whereas moderate vigourous exercise involve more intentional movement such as a brisk walk or a gym workout, researchers said.

The ideal daily routine should also include six hours of sitting and five hours of standing, they said. The international team, led by Swinburne University of

by Swinburne University of Technology, Australia, analysed the behaviour of more than 2,000 people within a 24-hour day to determine the right mix of time spent sitting, sleeping, standing

However, even as exercis-ing is more beneficial, time use has to be realistic and

balanced, he said. "People may advocate for more time exercising, though it's not feasible to have 10 hours of exercise and zero hours of sedentary behaviour," the researcher said.

While the findings applied for able adults, he acknowledged that everyone has different considerations and advised that physical activity should be fun.



from 10,000 Data over Australian women has unveiled a remarkable connection between regular exercise during middle-age and long-term physical health. What's truly astonishing is that this posi-tive impact on health was observed even when the exercise routine was initiated as late as the mid-50s. The study, led by Binh Nguyen and his team from the University of Sydney, Australia, has brought to light the transformative effects of consistent adherence to physical activity guidelines throughout middle-age. Published on May 2 in the open-access journal PLOS Medicine, this research has the potential to revolutionize how women approach their health as they age. Unlike previous studies which were primarily based on cross-sectional studies and short-term randomized controlled trials, this new research stands out for its comprehensive longitudinal approach. Over a period of fifteen years, data was collected at threeyear intervals from 11,336 participants in the Australian Longitudinal Study on Women's Health. These women, born between 1946 and 1951, were between 47 to 52 years

old at the onset of the study.

The participants were categorized based on their adherence to the WHO physical activity guide-lines, which recommend 150 minutes of activity per week. The study revealed that women who consistently met these guidelines, as well as those who began to meet them at the ages of 55, 60, or 65, experienced a significant three-point increase in their physical health composite score (PCS). This boost in physical health was observed even after controlling for socioeconomic factors and pre-existing health diagnoses, emphasizing the profound impact of physical activity on longterm well-being. The study's findings highlight a crucial public health message: regardless of when women start, maintaining or adopting an active lifestyle in mid-age can have profound health benefits in terms of physical functioning. The authors stress the importance of women increasing their activity levels to meet the guidelines by the age of 55, emphasizing the immense benefits of being active throughout mid-age

The goal of treat-ment is to maximise the ben-efits of both PRP application and microneedling for skin and microneedling for skin renewal. However, it's very important to consult a qualified and experienced practitioner to ensure safety and effectiveness.

According to the US Centers for Disease Control and Prevention, this is believed to be the first documented case of people con-tracting the virus through a cosmetic procedure with neecosmetic procedure with nee-dles. In its morbidity and mortality report, released this week, the CDC said that an examination of the centre from 2018 to 2023 revealed that it appeared to have reused single-use disposable equipment

Malaria linked with genetic changes associated with ageing: Study

Malaria infection is linked with genetic changes, known to be brought about by ageing, according to a new study.

Researchers extracted genetic material from blood samples of more than 1,800 adults from the African countries of Tanzania, Botswana, Ethiopia, and Cameroon, where malaria is known to be

endemic, or constantly present. According to the 2023 World Health Organisation (WHO) Malaria report, published in 'The Lancet Microbe' journal, around 70 per cent of the global burden of the mosquito-borne disease is concen-trated in 11 countries, including India and 10 African countries. The team, including researchers

from the University of Pennsylvania, US, analysed the DNA in white blood cells - crucial to immunity and fighting infections - and measured the lengths of telomeres present at the ends of chromosomes, which carry the genes.

Telomeres protect the chromo-some ends from sticking to each other or getting frayed. They are known to shorten with age and can also help predict an individual's risk of getting affected by ageing-related diseases and death.

"We highlight the contributions of genetic and environmental factors influencing telomere length in leukocytes (white blood cells), and we have uncovered a potential role of malaria in shortening of telomere length across sub-Saharan Africa," said Sarah Tishkoff of the University of Pennsylvania, a co-senior author on the study published in The American Journal of Human Genetics.

The researchers found shorter telomere lengths in the white blood cells of adults indigenous to regions where malaria is highly endemic, compared to those in adults indigenous to regions with low malaria endemicity.

Malarial infection is known to cause massive destruction of white blood cells. The authors said that this process, coupled with that making new cells to restore this loss, could be a possible mechanism through which the disease shortens the length of telomeres.

They also found that the extent to which malaria was endemic to a region had a greater impact on telomere lengths, compared to environmental factors previously identified and known to impact telomere lengths.

JAMMU, JULY 14 Chief Secretary, Atal Dulloo, today chaired a meeting to review implementation of the Ayushman Bharat Digital Mission (ABDM) in Jammu and Kashmir with a focus on ensuring seamless integration of healthcare data and digital services across the UT.

The meeting was attended by Secretary, Health & Medical Education; Managing Director, ABDM; Principals of Government Medical Colleges; Director Coordination (Medical Colleges) and other senior officers of the Department.

Taking stock of the ongoing initiatives under ABDM, the Chief Secretary underscored the urgency of linking patient health records with ABHA (Ayushman Bharat Health Account) IDs, emphasizing that no stone should be left unturned to complete this vital digital transition without any further delay. He called for interlinking of Sehat, ABDM and HMIS portals, to create a unified digital ecosystem that empowers the patients, healthcare professionals and institutions to access and share data effortlessly through a single platform.

Dulloo stressed that continuous updating of patient health records must be ensured so that individuals need not carry paper records when visiting any hospital or doctor. He called for universal implementation of the Scan and Share facility across all health institutions. He directed the department to rationalize manpower, especially for data entry tasks critical to success of the HMIS module.

In a significant push towards improving accountability and data in-



tegrity, the Chief Secretary instructed the department to expedite the Health Professional Registry (HPR) and take strict measures against professionals delaying compliance. He also advised for seeking technical support from BISAG-N to professionally and swiftly conclude digitization targets under the ABDM framework.

During the meeting, Secretary H&ME, Dr. Shah, briefed about the steps already taken to accelerate digital transformation. He highlighted the Department's success in initiating the HPR, digitizing patient health records, integrating radio diagnostic reports with ABHA IDs and rolling out the Scan and Share facility in numerous health institutions.

He reaffirmed the Department's commitment towards ensuring full saturation of these initiatives within a defined timeline. He delineated the strategies that are going to accomplish the mission satisfactorily across all the healthcare facilities in J&K.

Adding to the deliberations, MD ABDM, Anant Dwivedi, outlined the mission's three core pillars including ABHA ID, Health Professional Registry (HPR) and the Health Facility Registry (HFR). He informed that J&K

has made notable strides in all these domains

As per the latest figures, it was informed that 94.49 lakh ABHA IDs have been created, covering 69.7% of the target population. It was further revealed that 100% registration of all 3,607 public health facilities (HFR) has been completed besides 87% registration of public doctors (6,713 out of 7,730) and 100% registration of public nurses (5,149) has been achieved.

Moreover, 20.58 lakh digital health records have been linked with ABHA IDs, with 1.44 lakh new records added since May. Additionally, 104 out of 105 health facilities are now actively using the HMIS (JK-e Sahaj) portal. Notably, 71.16 lakh Scan and Share tokens have been generated so far, as was informed in this meeting.

He highlighted flagship initiatives such as the Holistic Agriculture Development Programme (HADP) and the Mission for Inte-



grated Development of Horticulture (MIDH). These schemes, he explained, are specifically designed to provide financial assistance, technical know-how and market linkage support to orchardists and aspiring horticulturists.

Emphasizing the importance of adopting scientific and modern horticultural practices, Kotwal encouraged farmers in the rainfed and sub-tropical belts of Akhnoor to switch to improved cultivation techniques for fruit crops like guava, mango, citrus, and aonla-crops well-suited to local agro-climatic conditions. He called upon the farming community to actively participate in these developmental schemes to enhance productivity and profitability.

DLSMS Jammu, HDO Akhnoor and HDO Khour, also engaged with the farmers during the event, addressing their queries and providing guidance on best practices in orchard management, pest control strategies and soil health improvement measures.

The event concluded with a shared commitment from both the department and the local farming community to work collaboratively toward promoting horticulture as a sustainable and economically viable means of livelihood in the region.

effective implementation of NTCP

Deputy Commissioner (DC) Pankaj Kumar Sharma today presided over a Workshop cum District Level Coordination Committee (DLCC) Review Meeting to assess the implementation of National Tobacco Control Program (NTCP) in the district.

At the outset, Chief Medical Officer Dr. Rajinder Kumar highlighted the anti-tobacco measures launched in the district. He also discussed key components of the NTCP, including the prohibition of smoking in public places, the ban on the sale of tobacco products within a 100-yard radius of educational institutions and the restriction on both direct and indirect advertising of tobacco products.

The meeting deliberated on the need for concerted efforts, incorporating a comprehensive set of activities such as conducting Information, Education, and Communication (IEC) campaigns

in schools and communities, declaring educational institutions as Tobacco-Free Educational Institutions (ToFEI), designating at least 40 villages as Tobacco-Free Villages by the next quarterly review and conducting aggressive enforcement drives to ensure compliance with tobacco control regulations.

The DC called for adopting all laid down procedures and guidelines in implementing the NTCP in the district. He directed the Chief Education Officer to ensure that all educational institutions register on the ToFEI application and update the required 10-point Tobacco-Free attributes.

He also called for random inspection by the police, civil administration, and officers designated under the Cigarettes and Other Tobacco Products Act (COTPA), 2003.

The Block Development Officers were asked to educate all stakeholders and strengthen community-based efforts in combating tobacco use. It was also decided to designate a Nodal Officer in all offices and institutions to ensure the smooth implementation of anti-tobacco measures.

A power presentation was given by Divisional Coordinator NTCP Shiveta Raina, underling the enforcement benchmarks of the COTPA 2003, including 85% above score in declaration of Tobacco free Educational Institutions via ToFEI application.

The session also included detailed discussions on the provisions of the Cigarettes and Other Tobacco Products Act (COTPA), 2023, particularly sections 4, 5, 6 and 7, which focus on restrictions on smoking in public places, the sale and advertisement of tobacco products, and enforcement measures. The police and other designated authorities were directed to conduct enforcement drives at regular intervals to strengthen anti-tobacco measures across the district.
