LG Manoj Sinha chairs high level meeting to review Sports activities in J&K

Jammu, Aug 17

Lieutenant Governor Manoj Sinha today chaired a high level meeting at Civil Secretariat, to review the sports activities across Jammu & Kashmir.

The Lt Governor took a detailed assessment of the efforts for engagement of 35 lakh youth in sports activities targeted for this year.

J&K Sports Council and Department of Youth Services & Sports were directed to use the power of sports to prevent crime and drug use among youth.

The Lt Governor further called for ensuring maximum participation of girls. Make sporting activities more inclusive; accelerate efforts to promote women athletes. We must promote equal participation of girls and it should be ensured they have ample opportunities to develop teamwork, self-reliance, resilience and confidence. Sport has the power to change the society and we must use its unmatched potential, the Lt Governor said.



The Lt Governor also directed the officials to develop facilities for yoga centers and explore the modalities to organize rallies in the districts to promote sports culture among the younger generation at grassroot level.

Kashmiri Pandit murder: J&K administration moves to attach house of terrorist; protest held in Jammu

JAMMU, AUG 17

The Jammu and Kashmir administration on Wednesday initiated the process of attaching the house of a terrorist who killed a Kashmiri Pandit in Shopian, even as the minority community held a massive protest in Jammu against the latest killing. Police have also arrested father and three brothers of Adil Wani, a categorised terrorist of Al-Badr outfit, for sheltering him after he killed the Kashmiri Pandit and injured his brother on Tuesday. Police said Wani killed Sunil Kumar Bhat in an orchard in a Shopian village on Tuesday and later took shelter at his home in Kutpora. The security forces launched a cordon and search operation but Wani fled in the cover of darkness after hurling



grenades at the approaching police party, they said. During the search operation, police also recovered arms and ammunition from Wani's house, prompting the authorities to place his father and three brothers under arrest, besides initiating the process of attaching their house. Wani was identified by eyewitnesses and Sunil Kumar's cousin as the person who fired indiscrimi-

Jammu and Kashmir Police had announced that it would start the process of "attachment of some immovable properties which have been used for purpose of terrorism as per section 2(g) and 25 of the Unlawful Activities (Prevention) Act" and asked people not to shelter or harbour terrorists/terror associates. Meanwhile. Kashmiri Pandits serving in the Valley held a massive protest against the killing of their community member in Shopian and demanded that the employees in Kashmir under the prime minister's package be relocated to Jammu in view of selective and targeted killings. Hundreds of Kashmir-posted KP

'Congress leaders in revamped J&K unit finalised after consultations with Azad': Sources

JAMMU RISING

JAMMU, AUG 17 The Congress on Wednesday said senior party leader Ghulam Nabi Azad was consulted several times before finalising the names in the revamped Jammu and Kashmir unit of the party, rejecting reports that the former union minister was not on board.

The assertion came a day after Azad declined to head the Campaign Committee for Jammu and Kashmir after he was appointed to the post by party chief Sonia

Azad is a prominent member of the so-called 'G23'

group within the Congress which has been critical of the leadership and has been seeking an organisational overhaul.

He retired from the Rajya Sabha last year and was not renominated to the upper house by Congress. Sources in the party said

there were four rounds of consultations held with Azad before finalising the revamped panels of the Jammu and Kashmir unit of the party and the last such consultation with party leaders was held on July 14.

They said that the names of party leaders in the revamped unit were decided from the list provided by Azad himself. The sources also said that

Azad was the chairman of the campaign committee when Saifuddin Soz was the president of the party's J&K

Azad, the former chief minister of Jammu and Kashmir who was also the leader of opposition in Rajya the upper house, has declined to head the state campaign panel on grounds that he is a member of the party's all-powerful working committee and thus cannot a post

3 CISF commandos dismissed from service over security breach at NSA Doval's residence

Three CISF commandos have been dismissed from service and two senior officers of its VIP security unit transferred over a security breach at the residence of National Security Advisor (NSA) Ajit Doval earlier this year, officials Wednesday.

Mr. Doval is a 'Z plus' category protectee under the central VIP security list and the security cover is provided by the SSG unit of the

The punitive actions have been taken after a court of inquiry established by the Central Industrial Security Force (CISF) into the February 16 incident held the five officers guilty on various counts and recommended actions against them.

The officials said while three commandos of the Special Security Group (SSG) have been dismissed from service, the Deputy Inspector General (DIG) heading this VVIP security unit and his second-in-command,

Election Commission of India notifies schedule of Special Summary Revision for J&K

JAMMU, AUG 17 Chief Electoral Officer, Hirdesh Kumar addressed a press conference at Nirvachan Bhawan here today and announced the launch and schedule of Special Summary Revision in Jammu & Kashmir. It was told that in continuation to its earlier notification dated June 29, 2022, the Election Commission of India has further notified the schedule of Special Summary Revision with reference to October 1, 2022 as the qualifying date in the Union Territory of Jammu & Kashmir. According the schedule, Integrated Draft Electoral Roll would be published by all Electoral Registration Officers on September 15, 2022. Period between September 15 and October 25 has been earmarked for filing claims and objections and all disposals in this regard would be completed by November 10. Checking of health parameters and ob-



mission for final publication, updating database and printing of supplements is to be done by November 19, 2022. The Final Electoral Roll would be published on November 25. Those present during the press conference also included Additional Secretary, Sandish Kumar Gupta; State Nodal Officer, SVEEP, Akhtar Hussain Qazi and Joint Director Information Jammu, Sapna Kotwal. The Chief Electoral Officer reiterated that any person attaining the age of 18 years on or before October 1, 2022 and is otherwise qualified to be enrolled as an elector in the Electoral Roll, can apply for his registration during this special summary revision. Hirdesh Kumar said, 'Pre-revision activities as well as post delimitation follow up work is going on in the UT, wherein the existing electoral roll is being mapped into the newly delimited Assembly Constituencies as per the Delimi-

tation Commission's final order made applicable by the Union Law Ministry with effect from May 20, 2022. As part of the pre-revision activities, the process of rationalisation/ re-arrangement of polling stations, removal of discrepancies of demographically similar entries/ similar photo entries, duplicate EPICS, preparation of supplements and integrated draft roll is also going on at present'. Election Commission of India notifies schedule of Special Summary Revision for J&K

October 1, 2022 as the qualifying date, would be published by all EROs of the UT on September 15, 2022, marking the formal beginning of the revision activities. The Commission has extended the period for filing of claims and objections from 30 days to 40 days: from September 15, 2022 to October 25, 2022. During this period Special camps would also be organised by CEO Jammu and Kashmir on weekends for which the date will be publicised separately. Objections could be filled through multiple platforms- offline by submitting a hard copy in prescribed format before ERO/ AERO or concerned BLO and online objections and claims could be filled by logging into https://www.nvsp.in portal or by downloading Voter Helpline App (VHA). The final electoral roll after due disposal of all claims and objections filed within the stipulated time period would be published on November 25, 2022. FORMS The Commission has made the registration forms more user friendly and simpler. The forms have come into force since August 1, 2022. Form 6 which was earlier being used for registration of new electors and for shifting from one constituency to another constituency, shall be exclusively used for registration of new electors only. There is no change in Form 6A. Form 7 which is used for objection to proposed inclusion/ deletion of a name in existing electoral roll shall remain to be for the same purpose with a slight modification that a provision for attaching a death certificate has also been incorporated. Form 8 has under gone a major change and can be now used for multiple purposes like, correction of any particulars, shifting of residence (within or outside constituency), replacement of EPIC and marking of persons with disability. Form 8A, which was earlier used for shifting within constituency has been abolished now, as the same provision is made in the new Form 8. In addition to these a new Form 6B has been introduced for capturing Aadhaar number of the existing electors. All Forms (wherever required) have been suitably modified to capture Aadhaar number from the new electors. EPIC-AADHAAR LINKING Besides provisions of Aadhar linking, no application for inclusion of name in electoral roll shall be denied and no entries in electoral roll shall be deleted for inability of an individual to furnish or intimate Aadhaar Number. It has been emphasised that while handling Aadhaar number of the applicants, the provision under Section 37 of the Aadhaar (Targeted Delivery of Financial and other Subsidies, Benefits and Services) Act, 2016 must be adhered to. Under no circumstances should it go public. If the electors' information is required to be put for public display, the Aadhaar details must be removed or masked. A Time bound drive is being started for collection of Aadhaar number of the existing electors by or before April 1, 2023. Furnishing of Aadhaar number is purely voluntary. Objective of the programme is to establish the identity of electors and authentication of entries in Electoral Roll, the CEO maintained. FIELD VERIFICATIONS AND SUPER CHECKING FOR HEALTHY ELECTORAL ROLL For the purpose of improving the health of the electoral roll, the Election Commission has emphasised the need for field verification by the Booth Level Officers. There is a mechanism for supervision and checking for enforcing strict accountability of the work performed by different levels of electoral machinery, such as Supervisors, EROs and AEROs by field verification. Similarly, DEOs, Roll Observers and CEOs also check the work done by EROS before the final decision on claims and objections is taken. Besides, Officers from ECI and offices of CEOs are also deployed to further random checks and to supervise. Respective Divisional Commissioner have been designated Roll Observers in their respective divisions for the purpose of supervision the Electoral Roll work. PARTICIPATIVE PROCESS-INVOLVING BLAs 'With a view to ensure more involvement of political parties, the Commission has allowed Booth Level Agents (BLAs) of recognised political parties to file applications in bulk, subject to the condition that a BLA shall not submit more than 10 Forms to BLO at one time/in one day. If a BLA files more than 30 Applications/Forms during the entire period of filing claims and objections, then cross verification must be done by ERO/AERO themselves. Further, the BLA will also submit a list of application forms with the declaration that he has personally verified the particulars of the application forms and is satisfied that they are correct.'

On the accident, Lieutenant Governor of Jammu and Kashmir Manoj Sinha expressed condolences to the bereaved families of the deceased ITBP personnel.

"Deeply anguished by the bus accident near Chandanwari in which we have lost our brave ITBP personnel. My condolences to the bereaved families and prayers for the speedy recovery of the injured. All possible assistance is being provided to the injured personnel," Lt Governor Sinha said.

Union Home Minister Amit Shah also expressed his grief on the tragic incident and took to Twitter to wish for the early recovery of those injured.

"Anguished to learn about the accident of a bus carrying ITBP and police personnel in Pahalgam, J&K. My prayers and thoughts are with the bereaved families. The injured were rushed to the hospital. May they recover at the earliest," he

A doctor at the Government Medical College of Anantnag, Dr Syed Tariq said that 30 people were injured in the acci-

The mishap took place at Frislan in the Pahalgam area. The jawans were deputed in the area for the Amarnath Yatra.

"We are in touch with local administration and teams of disaster management have been rushed to the site for a rescue operation," an ITBP official said.

The Amarnath Yatra began on June 29, from Jammu amid tight security arrangements made by the Central Reserve Police Force (CRPF) along with the army and the local police.

The Amarnath shrine pilgrimage to the 3,880-metre-high cave shrine of Lord Shiva, located in the upper reaches of the Himalayas, is held from the twin routes of Pahalgam and Baltal. (AGENCIES)

Superintendent of Police (Rural) Sanjay Sharma has been formed to investigate the incident, Senior Superintendent of Police (Jammu) Chandan Kohli said.

A police spokesperson said a call was received from Habib's sister Shahzada, a resident of Srinagar's Barzulla locality, wherein she expressed apprehension that her brother might have committed suicide as he was not answering her

After reaching Habib's house, police found it bolted from inside and noticed a foul smell emanating from it, he said.

The doors of the house were broken down and four semi-decomposed bodies were found inside, he said. The locals informed police that a house nearby belongs to a

relative of the family, Gulam Husain. When the police reached the other house, they found two more bodies there, the spokesperson said. Prima facie, it appears to be a case of poisoning. It is being

ascertained whether it is a case of forced poisoning, he said. SSP Kohli also rushed to the spot and ordered a thorough

The bodies have been shifted to Government Medical College and Hospital here for a post-mortem examination, Kohl said. (Agencies)

Apni Party holds public rally at border district Kupwara

JAMMU, AUG 17

Apni Party President Syed Mohammad Altaf Bukhari on Wednesday said that the enduring violence, over the past more than thirty years, has damaged the interests of J&K to its core. He said the gun culture has not only stopped the growth of J&K in terms of its development but has also been hindering the prospect of the Union Territory (UT).

Syed Mohammad Altaf Bukhari was addressing a grand public rally at north Kashmir's Kupwara, wherein people and party workers gave him a rousing reception on his arrival at the venue. The workers, wearing similar outfits, were raising slogans hailing their leader at the rally.

According to a press release issued here, Apni Party President said that only a peaceful environment can bring J&K out of the prevailing uncertainty and chaos.

He said, "For a better future for our youth, we need sustained peace and tranquillity in J&K. We cannot expect a better future unless we get rid of the violence and evil politics. If we have peace here, we can have prosperity and development which will eventually make the future of our youth prosperous and protected.'

He said that gun has ruined J&K in terms of loss of lives and the well-being of the people. He said, "We have lost around 1.5 lakh people, mostly youngsters to the violence here during the past thirty years. Also, J&K



has got its growth in terms of development and prosperity blocked due to the violence.

"Almighty has bestowed

Kupwara with huge potential and natural resources, had these resources been harnessed over the years and decades this would have been the most developed place in J&K," He said and added, "We have huge deposits of marble, but the marble manufacturing units are halted here since the phase of violence started in J&K. This is how violence hinders the economic growth of the people and closes the employment opportunities.'

He further said that Kupwara has its significance because of its important geographical location. This district should not have been in this pathetic condition. The leaders who have claimed to be the representative of the Kupwara people have even failed to develop

the infrastructure for the dis trict hospital here. We have several places in Kupwara that can be developed as tourist places. One of such places is Bungus Valley, but we have not developed road connectivity to this beautiful place over the past 75 years. We do not have a reliable road to Sadhna Pass here."

Syed Mohammad Altaf Bukhari strongly condemned the recent attack on two Kashmiri Pandit brothers in south Kashmir's Shopian. He said, "The victims along with their families had chosen not to migrate from their motherland. They lived side by side with their Muslim brethren in their village, yet some beasts in human garb fired on two brothers killing one Sunil Kumar and injuring another Pitambar while they were working in their orchard.

This brutal act of violence

is shameful and inhuman." In his speech, Syed Mo-

hammad Altaf Bukhari demanded the restoration of statehood to Jammu and Kashmir. He said, "Stripping of J&K's autonomy and statehood was an unfortunate occurrence. But we believe that the Prime Minister and Home Minister of the country will fulfill their commitment to the restoration of statehood to Jammu and Kashmir, and Apni Party will keep striving for getting this status back to J&K.' On this occasion, people in the rally raised slogans reiterating the demand for statehood for J&K.

Two new airports to be established in Jammu, Kashmir

nion Minister for Civil Aviation Sh Jyotiraditya M. Scindia today said that new two airports shall be established in Jammu and Kashmir soon.

He said this during an interaction programme with DDC, BDC members, PRIs and locals at Harwan block of Srinagar district.

As a major development, the Minister said that an airport worth Rs. 1500 crore shall be established on 25 thousand square kilometres in Kashmir, while as another airport worth Rs. 650 crore shall be established in Jammu on 22 thousand square kilometres land size.

said that since a special focus is being given on development of both air and road connectivity in Jammu and Kashmir, a major road network including highways, ring road, tunnels and other projects are being constructed across Jammu, Kashmir and Ladakh.

The Minister said that the development of connectivity shall bring more tourists to J&K and promote local craft. He said that the promotion of tourism and crafts shall boost economic activity and prosperity of people of J&K.

Sh Scindia said that under the leadership of PM Narendra Modi, an era of peace, progress and development has already started in Jammu and Kashmir and all the three regions including Ladakh have come on track to become number one in construction and development in the country.

He said that among other major projects, work was going on in full swing on ring road worth Rs 3000 crore, while as 100 percent households are being supplied electricity now, made possible by current dispensation.

The Minister said currently 82 percent population is connected and being supplied tap water, however, the government is committed to cover all households in near future.

He said that the Modi led government was not only successful in curbing corruption in J&K but sectors including health, education and others have also flourished in the UT during these years.

Present on the occasion, various DDC and BDC members, sarpanchs and other PRIs spoke on the occasion and raised their demands.

The demands raised by the members included bridging developmental gap between urban and rural areas, construction of degree college and AYUSH Hospital in Harwan, development of area for rural tourism, better health and education facilities, deduction in power and water tariffs, loan waivers for drivers among others.

DC Srinagar, Mohammad Aijaz Assad, SSP Srinagar, ADC Srinagar, officers from RDD among others were also present on the occasion.

SC's verdict in 'freebies' case may significantly influence course of electoral politics in India

he ongoing 'freebies' case in the Supreme Court of India has reached an interesting stage, with the DMK seeking to be made a party into it. It clearly indicated that the presumption on which 'freebies' are understood would decide its fate in favour of the Centre or states, the rich or the poor, and the real objectives expressed in the Preamble of the Constitution and its several provisions.

DMK has challenged the very presumption of 'freebies' under which the Centre led by Modi government has labelled the welfare schemes introduced by the state governments alone.

Even as PM Narendra Modi has criticized other political parties in oppositionruled states for their 'welfare schemes' as 'freebies' for a long time, the opposition has questioned him why his 'welfare and other promotion schemes' should not fall in this category.

DMK has pointed out that the Centre's 'tax holidays' to foreign companies, waiver of bad loans of influential industrialists and granting of crucial contracts to favoured conglomerates should be put in the same bracket as 'freebies'.

DMK has put the matter on record in the Supreme Court and said that there was no "straight-jacket formula" to decipher which scheme deserves to be termed as 'freebies'. The Constitution of India empowers not only the Centre but also the States to promulgate welfare schemes, and the term 'freebies' cannot be interpreted to restrict States, the DMK has said

"Such schemes have been introduced in order to provide basic necessities which poor households cannot afford. They cannot be imputed to be luxuries. Schemes such as free electricity can have a multidimensional effect on a poor household," it added

The party have even mentioned that it had introduced various welfare schemes such as rice at Rs 1 per kg, free distribution of colour television sets to poor households, free bus passes to women among others for uplifting the poor households.

"A welfare scheme providing a free service is introduced with the intent to secure a social order and economic justice. In no imaginable reality could it be construed as a freebie," the party has argued.

Before going into details, one must know what is a 'freebie'. The world originated sometime during 1925-30, perhaps from a noun phrase 'free bee'. It was used in a sentence as, "Put the bee on to borrow money with not intentions or repaying it." And the money that was not intended to be repaid was referred to as 'freebie'

Going by this, all the loans given to the rich, which are not intended to be repaid,

oo count as 'freebies'.

In contemporary language, 'freebies' are defined as something given without charge or cost. No doubt, political parties and leaders have been resorting to 'freebies', including PM Modi himself, though it did not prevent him from denouncing about the "Revadi culture" on July 16, 2022 while inaugurating Bundelkhand Expressways in Jalaun. He said this 'politics of freebies' is allegedly practiced by certain political parties to garner votes. He called upon the people to be cautious of them and also rid the country's political arena of the proponents of 'Revadi (freebie) culture" as it was a dangerous trend which retarded the growth of the country. This came as a surprise, considering that BJP and its allies too are following

Other political parties, such as DMK in Tamil Nadu, Trianamool Congress leader Mamata Banerjee in West Bengal, Nitish Kumar and Tejashwi Yadav duo in Bihar, BJD in Odisha, etc have all been emerging as challengers for Modi's dream of winning 2024 Lok Sabha election. If they serve the people better, it would dampen BJP's prospects.

Political analysts say that Modi has no option but to try and curtail the effectiveness of the opposition-ruled states by constricting their financial lifeline in the name of containing the dangers of 'freebies'. It is clearly a political issue and must be fought politically, and let the

people vote for those who serve them most.

But some of those enthused by PM Modi's opinion have brought the case to the Supreme Court of India, where it is now being fought legally. So be it. But presumption should be equitable, in which neither rich nor poor be given undue advantage over the other.

Social and economic justice must be secured first; dignity of individuals must be protected along with their lives and livelihoods; equal opportunity to all must be delinked with paying capacity; equality of access must be secured for all in all educational, health, and other institutions and must not be linked with money; and finally the rules must not be made or policies adopted for the benefit of the few only in name of development.

Development of a nation must not be presumed only as the creation and accumulation of wealth in few hands by supporting them with all legal and illegal means, but it should also include the welfare of the entire humanity — the poor children, the women, and those who have been suffering from social, economic, and several other injustices.

The Supreme Court has a great issue at hand, the decision on which may impact the future of the country. The taxpayer's money should not be wasted in 'freebies', but what constitute 'freebies' and what do not is a question that clearly needs to be spelt out.

RSS-BJP rattled by Opposition consolidation, sense 2024 poll isn't a done deal

The change of regime in Bihar following Nitish Kumar's decision to snap ties with the BJP and join the Mahagathbandhan seems to have rattled the ruling party at the Centre.

This is evident from reports that even as Prime Minister Narendra Modi was addressing the Independence Day rally at the Red Fort on Monday, Home Minister Amit Shah was closeted with senior BJP leaders discussing plans to try overthrow the newly-formed Mahagathbandhan government in Bihar as soon as possible.

Earlier, the BJP's leadership had launched an allround attack on Nitish Kumar. A campaign was also unleashed to try and depict him in poor light, by labelling him as an opportunist, for instance. However, this was more of a façade, since the Modi-Shah duo realise that Nitish's action was simply a manifestation of a changing political landscape which spells trouble for them.

Sensing a looming threat to its hegemony and political supremacy, an alarmed RSS-BJP leadership scrambled to make organisational changes with an eye on the Lok Sabha polls due in 2024.

Just a day after the regime change in Bihar, old war horse Sunil Bansal, a prominent RSS face, was wheeled out as BJP's national general secretary in charge of three opposition-ruled states — West Bengal, Odisha and Telangana.

Bansal, who earlier assisted Amit Shah in the 2014 general elections and served as the party's general secretary (organisation) in Uttar Pradesh, is credited with overcoming the Samajwadi

Party challenge to ensure its victory in UP earlier this year. He has handled three elections in the key state: 2017 and 2022 assembly polls and 2019 general elections, with the party emerging victorious on each occasion.

His clout can be judged from the fact that he has replaced three important leaders serving as general secretaries: Kailash Vijayvargiya in West Bengal, Tarun Chugh in Telangana and D Purandareswari in Odisha.

One of the key tasks that Bansal is reportedly entrusted with is to prepare a blueprint for a bid to force out the Mahagathbandhan govt in Bihar besides, of course, strengthening the saffron party's position and prospects in the three states, where it made substantial gains in the last general elections. All the three states are of vital impor-

and more than them, for the RSS.

If sources are to be believed, the BJP will try to engineer a major split in the JD(U) as well as the RJD. Conversant with Amit Shah's propensity to deploy so-called Operation Lotus in opposition-ruled states, Nitish and Tejashwi are, of course, already keeping a vigil on their MLAs.

At the same time, the BJP is also said to be evolving a strategy to make up for possible electoral losses in Bihar and West Bengal, which together account for 82 Lok Sabha seats. In 2019, the BJP had won 39 seats in Bihar in alliance with JD(U) and LJP, and 18 in West Bengal.

The other reason for Modi and Shah to have attacked Nitish Kumar aggressively is a growing sense of scepticism among some BJP leaders across the country about the party's prospects under their leadership. In some states, the fall of the NDA government in Bihar has propelled factionalism and demoralised the rank and file. A shaken BJP is now trying its utmost to keep Nitish Kumar confined to Bihar and not allow him space to manoeuvre at the national level.

Meanwhile, in the bell-wether state of Bihar, the BJP faces a tough challenge with almost the entire range of political forces — backwards, extremely backwards and Dalits — joining hands with Nitish. Senior BJP leaders confess that they haven't been able to make credible inroads among these politically powerful segments of society and frantically need a powerful leader with mass appeal to remain in the reckoning.

PM Modi's Red Fort speech reinforces impression he's entirely out of touch with reality

Prime Minister Narendra Modi must have burned the midnight oil to think up his 'five pledges' to turn India into a country of his dreams by 2047, independent India's centenary year. And these 'pledges' appear to have limped away from the basic goals of education, health, jobs and shelter.

The word that comes to mind is 'esoteric'. Modi confirmed that he is distant from the lives of ordinary people, abstruse and mystic. An alternative would be the phrase 'dream on'.

Modi dropped his 'five pledges' one by one on the heads of the invitees to the ID-extravaganza fit for a developing country of India's standing — emerging economic superpower, except for the rupee which can't stop itself from plumbing the depths in its showdown with the dollar.

Of course, in Modi's lingo, the five pledges are 'paanch praan', five keys to unlock the life-saving potential of India's demographic dividend in the next 25 years when the majority of the demographic would be in their 50s, and Modi himself in the 100+. In Modi's turn of phrase, the 'paanch

praan' is crucial for India's development; indeed, to India's future.

And, effortlessly, Prime Minister Narendra Modi slipped in the cliché "130 crore Indians" to emphasize the intent forcefully. The right words fell from the Prime Minister's golden tongue: 'unite', 'love for the country', 'fight against discrimination', slavery', and 'fellow citizens'.

The iconic Red Fort, now witness to more empty words than there are loaded ones in the dictionary, would testify that Prime Minister Narendra Modi's ninth I-Day address was not much different from the eight that preceded it.

Except that the dreams have become loftier. Such that one could be excused for being Kafkaesque! Franz Kafka left a body of work that spelled 'failure' in its essence. The greatest Kafkaesque was that the human being was bound to leave things incomplete; it came naturally to man.

The irony is that the incomplete phrase applied to Franz Kafka as much as it applies to Prime Minister Narendra Modi. And to round it all, Modi bound them with "we have to keep India first...paving the way for the nation to be forever united".

The Red Fort had two mechanical elephants at one of its gates—one better than the nuts-and-bolts lion that symbolized Modi's 'Make in India' campaign. That Gir lion is not to be seen these days! Is it a sign of change in the offing? Indeed, Prime Minister Modi's 'paanch praan' leaves everything to the imagination.

Which is another way of saying that it will remain one of the many mysteries of Modi-rule that even after eight years, Prime Minister Narendra Modi still succeeds in giving the impression that he is unaware of the bread and butter wants of the teeming millions. Does the Prime Minister know, has he been told, that India has the most number of "extremely poor" in the world?

Modi's Pledge No.1 is "work for In-

dia's development". The thing to note, however, is that Modi as usual was talking in election stump generalities. Nothing in India's development of the past eight years was worth spelling out. Talk of 'Har Ghar Tiranga' and the world's most number of extremely poor wouldn't have a roof over their heads to fly the triceloup was a given!

Shelter like jobs is a mirage too far for crores of Indians. And jobs, like shelter, are sold by the crores to desperately aspirational Indians, like 'ache din' was, from the election pulpit. The number of jobs Narendra Modi promised while selling "abki baar..." could make a couple of Sri Lankas, but the 'Mood of the Nation' surveys, somehow, never gets the number of jobs created by Modi right!

Ask Franz Kafka and he would say how 'metamorphosis' is more than 'paanch praan' said in a vacuum. In the story, the protagonist is deserted by everyone because in 'his' insect state, he could no longer be the provider to the family—his presence was no longer required. The moral of the story is: a country of extremely poor, living in stark sight of a miniscule number of powerfully rich, are likely to soon get tired of a deficient provider's empty promises.

Japan makes arrests on bribery suspicions in Tokyo Olympics

New Delhi, Aug 17

A former Tokyo Olympic organising committee board member and three people from a clothing company that was a surprise sponsor of the 2020 Games were arrested on bribery suspicions Wednesday.

Haruyuki Takahashi, a former executive at advertising company Dentsu, is suspected of receiving bribes from the former head of Aoki Holdings Inc and two company employees, the prosecutors' office said.

The company that makes affordable business suits was a surprise pick to dress the Japanese Olympic team, when other nations had top fashion brands designing athletes' outfits. Aoki is linked with Japan's so-called recruit suits that youngsters fresh out of school wear for job interviews and their first jobs.

The bribery is believed to be linked to sponsorship of the Games and products related to the Olympics. Although corruption at top places among Olympic officials had long been rumoured, the arrest comes as a blow to Japan's Olympic ambitions.

Takahashi is credited with landing \$3 billion in local sponsorships for the



Tokyo Games. Japan also is pursuing the 2030 Winter Olympics for Sapporo.

Aoki said it was still looking into the matter and did not have immediate comment. The Japanese Olympic Committee was not immediately available for comment.

Japanese media reports said Takahashi denied wrongdoing, stressing he was paid for consulting services.

Tokyo played host to the Tokyo Games with much fanfare, as well as criticism, in summer 2021. The event was postponed for a year and held with

no public ticket sales because of the coronavirus pandemic.

That came as a disappointment, as the Games were supposed to have drummed up tourism revenue, and put the spotlight on Japan's prowess in a similar way as did the 1964 Tokyo Olympics. The official price tag for the latest Tokyo Games was \$13 billion, mostly public money. That was double the initial estimate when the International Olympic Committee awarded Tokyo the Games, but less than the \$25 billion some had predicted.

New Delhi, Aug 17

Manchester United forward Cristiano Ronaldo says he will reveal the truth in a couple of weeks after constant speculation about his future at the club.

The Portuguese is reported to want to leave Old Trafford despite new manager Erik ten Hag insisting he is "not for sale".

"They (will) know the truth when they interview in a couple weeks," the 37-year-old said on Instagram.

Ronaldo also liked a post from a fan saying that Atletico Madrid coach Diego Simeone wanted to sign him

Replying to the post, Ronaldo said: "The media is telling lies. I have a notebook and in the last few months of the 100 news (stories) I made, only five were right.

"Imagine how it is. Stick with that tip."

Ronaldo, who rejoined United a year ago from Juventus, has a year left on his contract.

He was their top scorer last season with 24 goals in all competitions but was criticised by Ten Hag



after leaving a pre-season match against Rayo Vallecano early after being substituted at halftime.

United missed out on the Champions League last season, finishing sixth in the Premier League, and have suffered a dreadful start to the new campaign, losing both their opening games and sitting bottom of the table.

They host Liverpool on Monday.

Former United player Gary Neville was fiercely critical of the club after Saturday's 4-0 defeat by Brentford and called on Ronaldo to be clear about his situation.

In all, 31 family members had arrived in Australia - the first in early June and the most recent last week.

Taiwan is staging military exercises to show its ability to resist Chinese pressure to accept Beijing's political control over the self-governing island, following new rounds of threatening drills from China.

The exercises Wednesday off the southeastern county of Hualien follow days of Chinese missile firings and incursions into Taiwan's sea and airspace by ships and planes from the People's Liberation Army, the military wing of China's ruling Communist Party.

"We strongly condemn Communist China's continuous military provocations around Taiwan's sea and air that undermine regional peace," Taiwan Defence Ministry spokesperson Sun Li-fang told reporters at Hualien Air Force Base.

Communist China's military operations just provide us with the opportunity for combat-readiness training," Sun

Taiwan's Foreign Ministry spokesperson Joanne Ou said China was using recent visits by US Congress members including House Speaker Nancy Pelosi as a pretext for escalating its attempts to intimidate Taiwan into accepting what it calls its terms for peaceful reunifica-

China launched military provocations on these grounds. This is absurd and a barbaric act, which also undermines regional stability and interferes with shipping and commercial activities in the Indo-Pacific region," Ou said.

China sees the island as a breakaway



province to be annexed by force if necessary, and considers visits to Taiwan by foreign officials as recognising its sover-

Alongside its military threats, China imposed visa bans and other sanctions Tuesday on Taiwanese political figures. China exercises no effective legal authority over Taiwan and it's unclear what effect the sanctions would have.

China has refused all contact with Taiwan's government since shortly after the 2016 election of President Tsai Ing-wen of the pro-independence Democratic Progressive Party. Tsai was overwhelmingly reelected in 2020.

The DPP also controls the legislature, while the vast majority of Taiwanese favor maintaining the status quo of de facto independence along with strong economic and social connections between the sides.

China accuses Washington of encouraging the island's independence through the sale of weapons and engagement between US politicians and the island's government. The US says it does not support independence and has no formal diplomatic ties with the island, but it is legally bound to ensure Taiwan can defend itself against threats from China, including a blockade.

Aside from putting its military on alert, Taiwan has largely played down the threat from the Chinese exercises and life has continued as normal among a population of 23 million that has lived under the shadow of bellicose rhetoric and saber rattling from China for more than seven decades.

MHA says it has not given any directions to provide flats to Rohingya migrants

NEW DELHI, AUG 17: The Ministry of Home Affairs (MHA) on Wednesday made it clear that it had not given any directions to provide flats to Rohingya Muslims in Delhi and asked the Arvind Kejriwal government to ensure the illegal foreigners remained at their present location.

The MHA also said the Rohingya illegal foreigners are to be kept in detention centres until their deportation as per the law and the Delhi government has been directed to declare the current site of their stay as detention centre. "With respect to news reports in certain sections of media regarding Rohingya illegal foreigners, it is clarified that the MHA has not given any directions to provide EWS flats to Rohingya illegal migrants at Bakkarwala in New Delhi," a ministry spokesperson said.

According to an estimate of the Home Ministry, around 40,000 Rohingya migrants live in different parts of the country, including Delhi.

Noting that the Delhi government proposed to shift the Rohingya Muslims to a new location, the Home Ministry said it has directed the Delhi government to ensure that the Rohingya illegal foreigners remain at their present location as it has already taken up the matter of their deportation with the country concerned through the Ministry of External Affairs. "The illegal foreigners are to be kept in the detention centre till their deportation as per law. The government of Delhi has not declared the present location as a detention centre. They have been directed to do the same immediately," the spokesperson said.

Earlier in the day, Union Minister for Housing and Urban Affairs Hardeep Singh Puri said Rohingya refugees will be shifted to apartments in Bakkarwala in outer Delhi and will also be provided basic amenities and police protection.

The EWS (economically weaker section) flats have been constructed by the New Delhi Municipal Council (NDMC) and are located in the Bakkarwala area near Tikri border. The NDMC functions under the Home Ministry."India has always welcomed those who have sought refuge in the country. In a landmark decision all Rohingya Refugees will be shifted to EWS flats in Bakkarwala area of Delhi. They will be provided basic amenities, UNHCR IDs & round-the-clock Delhi Police protection," Puri tweeted.

Last year, the government had informed Rajya Sabha that illegal Rohingya immigrants are staying in 12 States and Union Territories --Jammu and Kashmir, Telangana, Punjab, Haryana, Uttar Pradesh, Delhi, Rajasthan, Tamil Nadu, West Bengal, Assam, Karnataka and Kerala.

Union Minister of State for Home Nityanand Rai had said the government got reports that Rohingya Musilms have indulged in illegal activities in the country.

He said all foreign nationals who enter into the country without valid travel documents are treated as illegal migrants.

AIADMK leadership issue: HC orders status-quo over Jul 11 GC meet

Later, the counsel appearing for Panneerselvam said the court has said the Coordinator and Joint Coordinator posts, held by OPS and Palaniswami, respectively earlier, "had not lapsed".

The June 23 GC meet, convened jointly by the two leaders earlier, had announced that the one and only demand of the GC members is to bring in a system of a single leadership for the party, favouring Palaniswami, also known as EPS.

Crimea 'sabotage' highlights Russia's woes in Ukraine war

A spate of fires and explosions has turned Russian-annexed Crimea from a secure base for the further invasion of Ukraine into the latest flashpoint highlighting Moscow's challenges ahead in a war that is nearing the half-year mark.

A statement from British defense intelligence Wednesday that Russian commanders will highly likely be increasingly concerned with the apparent deterioration in security across Crimea, which functions as rear base area for the occupa-

Even Russia itself acknowledged it was an act of sabotage that caused Tuesday's explosions and fires that ripped through an ammunition depot near Dzhankoi in once-secure Crimea, leading to chaotic scenes when around 3,000 people had to be evacuated.

As a vivid reminder of Russia's vulnerability in Crimea, detonations at the depot near Dzhankoi were still continuing Wednesday.

A week earlier, Russia's military in Crimea already came under pressure when Ukraine said nine Russian warplanes were destroyed following explosions. At the time, Moscow still offered the possibility of a wayward cigarette butt as the cause.

No such explanations would suffice anymore as the war, which had long centered on brutal fighting in Ukraine's eastern Donbas region, has now given southern Crimea increasing importance.

Worsening the outlook in Crimea was a report by the Kommersant business paper, that explosions had also taken place near Gvardeyskoye in the centre of the peninsula. By Wednesday, there still was no comment from the Russian authori-



The British intelligence report said Gvardevskove and Dzhankoi are home to two of the most important Russian military airfields in Crimea.

Ukraine has stopped short of claiming responsibility for any of the blasts, including those at another Crimean air base last week. Russia seized the Crimean Peninsula in 2014 and has used it to launch attacks against Ukraine in the war that began on Feb 24.

If Ukrainian forces were behind the explosions, that would represent a significant escalation in the war. Such attacks could also indicate that Ukrainian operatives are able to penetrate deeply into Russian-occupied territory.

On the eastern front, the stalemate between both sides continued, with the brutality of the shelling causing ever more death and destruction.

In the Donetsk region at the forefront of the Russian offensive, two civilians were killed and seven others were wounded by recent Russian shelling of several towns

Russian Tu-22M3 long-range bombers fired cruise missiles at the Odesa region overnight, leaving four people injured, according to Odesa regional administration spokesman Oleh Bratchuk.

In the southern city of Mykolaiv, two Russian missiles damaged a university building early Wednesday but injured no one.

The Russian forces also shelled Kharkiv and various parts of the Kharkiv region overnight, damaging residential buildings and civilian infrastructure but inflicting no casualties.

On Thursday, UN Secretary-General Antonio Guterres plans to travel to Ukraine for a meeting in the western city of Lviv with Zelenskyy and Turkish President Recep Tayyip Erdogan. They are expected to discuss the grain shipments and a possible fact-finding mission to the Russian-controlled Zaporizhzhia nuclear power plant, which Russia and Ukraine have accused each other of shelling.

SC defers hearing of AIFF case after Centre says discussion with FIFA on to break some ice

NEW DELHI, AUG 17: The Supreme Court on Wednesday deferred till August 22 hearing on the All India Football Federation (AIFF) matter after the Centre said it is in discussion with FIFA over holding of the U-17 Women's world cup in India.

The court also asked the Centre to take proactive steps to hold the world cup in India and lift the suspension of AIFF.

Abench of Justices DY Chandrachud, AS Bopanna and JB Paridwala was told by Solicitor General Tushar Mehta that two meetings have been held by the government and committee of administrators with FIFA and efforts are being made to "break some ice" on the holding of the U-17 Women's World Cup in India.

He requested that the matter be deferred till August 22 so that a consensus could be arrived at between the active stakeholders of the

Mehta said that a few words from the court that the stakeholders are trying to sort this up will help them in their endeavour.

The bench said it is a great international event for the under 17 children and it is only concerned with the fact that the tournament is held in the country.



If somebody from outside is trying to interfere with it, it would not be tolerated, it said.

The bench asked the Centre to play a proactive role in the matter and facilitate the lifting the suspension of AIFF.

On Tuesday, the FIFA had suspended India for "undue influence from third parties" and stripped the country of the right to host the Under-17 Women's World Cup.

The country was scheduled to host the FIFA tournament from October 11-30.

This is the first time that the AIFF has been banned by FIFA in its 85year-old history.

A ban on India was on the cards after the Supreme Court removed Praful Patel as AIFF president on May 18 for not holding elections due in December 2020.

The court had appointed a threemember Committee of Administrators (CoA), headed by former apex court judge AR Dave, to manage the affairs of the national federation.

The CoA, which has former Chief Commissioner of India SY Quraishi and ex India captain Bhaskar Ganguly as other members, also had to frame its constitution in line with the National Sports Code and model guidelines.

However, senior advocate Vikas Singh, representing Maran and his Kal Airways, suggested mediation between the parties at the Hyderabad mediation centre which was also supported by SpiceJet through Ro-

will see," the bench said.

At the outset, Rohatgi said, "there were three issues between us.

"One is the issue arising in this matter and there are other two issues which are not part of the present mat-

"The other side is keen to settle all the three in one go.

"Two issues are foreign to this matter and out of those, one has been settled on July

"One issue was that the airline had taken a loan from a lender which was backed by the security given by the respondents (Maran and others) and the respondents wanted that we should clear the loan and the security may be released.

"We have reached a settlement with the lender and the security will be released and so that part is over," he



Another outstanding issue between the parties is the prosecution of the respondents (Maran and others) for the TDS being delayed, he said.

"We are engaging with the respondents jointly to file so that the quashing can be done and the matter is finished...," Rohatgi said, adding the matter be kept after four to six weeks to ensure that settlement on all issues is reached before the apex court itself.

SpiceJet and its promoter Ajay Singh were asked to deposit around Rs 243 crore as interest payable on Rs 579 crore, which the high court had, in 2017, asked the airline to deposit under the 2018 arbitration award in the share-transfer dis-

The high court had granted six weeks to Spice-Jet to make the payment and the deadline for the same, according to a September 2 order, expired on October 14, 2020.

After this, Maran and his firm had moved the high court for attachment of the entire shareholding of Singh in Spicejet and taking over the management for the non-payment of Rs 243

The top court had taken note of Spicejet's appeal and passed the interim order, staying the high court order.Maran and Kal Airways had moved the high court over the share-transfer dispute with SpiceJet, demanding that 18 crore warrants redeemable as equity shares be transferred to

On July 29, 2016, the high court asked both parties to settle the dispute under arbitration.

It had directed SpiceJet and Singh to deposit Rs 579 crore in the high court's reg-

SpiceJet was permitted to furnish a bank guarantee for Rs 329 crore and make a cash deposit of the remaining sum of Rs 250 crore by the high court.

The apex court, in July 2017, dismissed SpiceJet's appeal against the high court order.

On July 20, 2018, the arbitral tribunal rejected Maran's claim of damages of Rs 1,323 crore for not issuing the warrants to him and Kal Airways but had awarded him a refund of Rs 579 crore plus interest.

Maran, the owner of Sun TV Network, then moved to the high court against the arbitration award.

The matter pertained to a dispute arising out of the non-issuance of warrants in favour of Maran after the transfer of ownership to Singh, the controlling shareholder of SpiceJet.

The dispute started after Singh took back control of SpiceJet in February 2015 amid the airline facing a financial crisis.

Maran and Kal Airways had transferred their entire 35.04 crore equity shares in SpiceJet, amounting to a 58.46 per cent stake in the airline, to its co-founder Singh in February 2015 for

India supplies nearly 60 pc of vaccines used worldwide: FM Nirmala Sitharaman

Sitharaman on Wednesday said nearly 60 per cent of all the vaccines used in the world are produced in India and over the decades, the country has made remarkable contribution to vaccinating the world.

India today is double dosing every citizen and produced Covid-19 vaccines even during the lockdown period, she

Launching the book 'India's Vaccine Growth Story' by Sajjan Singh Yadav, Additional Secretary, Expenditure Department, Sitharaman said it is in the country's DNA to be able to contribute to world vaccination.

"Over the decades India has made remarkable contribution. Nearly 60 per cent of all the vaccines which are used in the world are produced in India. India has singular contribution to make to the world in terms of vaccination and that which is being produced and sup-



plied to the entire world," Sitharaman

Today, the country is double dosing every citizen, she said, adding it is not easy to produce and execute Covid vaccination at that scale.

India crossed the target of 200 crore COVID vaccinations in a time-bound manner. So far, 208.57 crore doses of COVID-19 vaccines have been administered under the nationwide inoculation

This smart contact lenses can diagnose cancer from tears

S scientists have developed a contact lens that can help in the early detection of cancer using tears and help in the

The novel lens, developed by the team at the Terasaki Institute for Biomedical Innovation (TIBI) in California, is able to capture and detect exosomes, the nanometer-sized vesicles found in bodily secretions that have the potential for being diagnostic cancer biomarkers.

The lens was designed with microchambers bound to antibodies that can capture exosomes found in tears. This antibody-conjugated signalling microchamber contact lens (ACSM-CL) can be stained for detection with nanoparticle-tagged specific antibodies for selective visuali-

This offers a potential platform for cancer pre-screening and a supportive diagnostic tool that is easy, rapid, sensitive, cost-effective, and non-in-



Exosomes are formed within most cells and secreted into many bodily fluids, such as plasma, saliva, urine and tears. Once thought to be the dumping grounds for unwanted materials from their cells of origin, it is now known that exosomes can transport different biomolecules between cells.But, the TIBI team devised their ACSM-CL for capturing exosomes from tears, an optimum and cleaner source of exosomes than blood urine, and saliva.

"Exosomes are a rich source of markers and biomolecules which can be targeted for several biomedical applications," said Ali Khademhosseini, TIBI's Director and CEO.

This drug can fight more than 300 drug-resistant bacteria


have developed a novel drug molecule that can help ward off more than 300 drugresistant bacteria.

Reported in ACS Central Science journal, the drug compound called fabimycin, inhibited drug-resistant gram-negative bacteria in lab experiments, as well as in mice with pneumonia and urinary tract

Gram-negative bacteria are a class of microbes that infect miltive bacteria and treat infections, while leaving other helpful microbes intact.

The team led by Paul Hergenrother, from the varsity's Department of Chemistry, started with an antibiotic that was active against gram-positive bacteria and made a series of structural modifications that they believed would allow it to act against gram-negative strains.

Fabimycin proved potent against more than 300 drug-resistant clinical isolates, while remaining rel-



especially difficult to treat because they have strong defense systems -- tough cell walls that keep most antibiotics out and pumps that efficiently remove those antibiotics that get inside.

The microbes can also mutate to evade multiple drugs. Furthermore, treatments that do work aren't very specific, eradicating many kinds of bacteria, including those that are beneficial.

Fabimycin, developed by a team from the University of Illinois in the US, showed potential to infiltrate the defences of gram-negagram-positive pathogens and some typically harmless bacteria that live in or on the human body.

In addition, the new molecule reduced the amount of drug-resistant bacteria in mice with pneumonia or urinary tract infections to pre-infection levels or below, performing as well as or better than existing antibiotics at similar doses.

The researchers said the results show that fabimycin could one day be an effective treatment for stubborn infections.

Lack of treatment guidelines hampering monkeypox care globally, say researchers

dearth of high quality, up to date clinical guidance on monkeypox may be hampering effective and safe treatment of the infection around the world, according to a review led by an international team of re-

Existing guidance, such as it is, too often lacks sufficient detail, fails to include different groups, and is contradictory, said the researchers from universities of Oxford in the UK, Bristol in Australia, and Liverpool School of Tropical Medicine, among others.

They said that "the lack of clarity between guidelines creates uncertainty for clinicians treating patients with [monkeypox] which may impact patient care." The "study highlights a need for a rigorous framework for producing guidelines ahead of epidemics and a recognised platform for rapidly reviewing and updating guidance during outbreaks, as new evidence emerges.'

"Human [moneypox] is providing a challenge even in high-resource settings with well-resourced healthcare systems. The lack of guidelines may especially impact clinics with limited previous experience in managing patients with [monkeypox]," the researchers wrote in the paper published in the open access journal BMJ Global Health.

The team searched six major research databases for relevant content published up to mid October 2021, plus the "gray literature" -- policy documents, newsletters, reports, for example, published up to May 2022 -- in several languages.

They found 14 relevant guidelines. Most were of low quality according to the Appraisal of Guidelines for Research and Evaluation II (AGREE) system, scoring an average of two out of a possible seven.



And most lacked detail and covered only a narrow range of topics.

There was little provision for different risk groups: only five (36 per cent) provided any advice for children; and only 3 (21 per cent) provided advice for pregnant women or for people living with

Treatment guidance was mostly limited to advice on antivirals and wasn't consistent: seven guidelines advised cidofovir, four of which specified this only for severe infection; just four (29 per cent) advised tecovirimat, and one (seven per cent) brincidofovir.

More recent guidance, including from the World Health Organization, recommends the use of tecovirimat rather than cidofovir.

While cidofovir and brincidofovir are active against pox viruses in laboratory studies, there is little data on how well they treat pox viruses in people, added to which they are only authorised for use in certain countries, note the re-

None of the guidelines detailed optimal dose, timing or length of treatment. And only one guideline provided recommendations on supportive care and the treatment of complications. All 14 guidelines recommended vacci-

nation as post-exposure prophylaxis (PEP), but not all of them were up to date on the newer generation vaccines. And PEP guidance for different risk groups was limited and at times contradictory. The researchers acknowledged that

understanding of the monkeypox virus is still evolving, which may account for some of the variability in recommendations they found.

But "even with a limited evidence base, clinical management guidelines are important tools for guiding decision-making and to reduce risk of inappropriate treatments." Given the recent global publicity surrounding monkeypox, this is an opportune moment to harness interest and investment in further research to make sure that everyone is given the best treatment, they said.

The article triggered torrid criticism on social media. Twitter users blasted it as misogy-

were appalled by what they described as demeaning stereotypes about Arab women.

Taleb, 42, said she's suing the London-based magazine for defamation. While analysts acknowledge an epidemic of obesity in the Arab world and its

connection to poverty and gender discrimination, Taleb's case and the ensuing uproar have thrown a light on the issue of body-shaming that is deeply rooted yet rarely discussed in the region.

This article is an insult not only to me but a violation of the rights of all Iraqi and Arab

women. The Economist did not respond to multiple requests for comment.

Fat-shaming is offensive enough in the US that when two sports commentators called some female athletes overweight on air earlier this year, they were swiftly fired.

In the Middle East, the report argued, the desirability of fleshy women may help explain why the region has experienced an explosion of obesity.

But the angry backlash over the article and Taleb's horror that her photo was used to illustrate growing waistlines of Arab women contradicts the oft-repeated belief that being heavy is widely seen as sign of affluence and fertility in the re-

The globalisation of Western beauty ideals through branding, TV and social media has long given rise to unrealistic body standards that skew women's expectations of themselves and others in the Arab world, research shows.

In a forthcoming study on Egypt, Joan Costa-Font at the **London School of Economics** said he found that although some older women in rural areas still view rounder women as affluent, it's not true in Egypt that being overweight is a sign of beauty, Western standards are more relevant.

Demand for cosmetic surgery has boomed in Lebanon. Some 75 per cent of female Emirati students reported dissatisfaction with their bodies, and 25 per cent are prone to eating disorders, according to a 2010 study at Dubai's Zayed University.



Earlier, Joint Director Agriculture (Extension), Subash Chander Sharma, in his welcome address interacted with Plant Doctors about various aspects of the Plant pest/disease management and discussed different bottlenecks in smooth running of E-Plant
