

Five people were trapped in flash floods in River Ans in Jammu and Kashmir's Reasi district on Wednesday and rescued by SDRF personnel, officials said.


On receiving information that some people were trapped, a team of State Disaster Response Force (SDRF) personnel rushed to the spot and carried out the rescue operation.

Section of Jammu-Srinagar NH washed away after heavy rains trigger flash floods JAMMU RISING

JAMMU, JUNE 22

Flash floods triggered by heavy rains washed away the shuttering of an under-construction bridge and a 150foot section of the Jammu-Srinagar national highway even as landslides in Ramban and Udhampur districts forced closure of the strategic road for the second consecutive day on Wednesday, leaving hundreds of vehicles stranded, officials said.

The traffic on the Mughal Road, which connects the twin districts of Poonch and Rajouri in the Jammu region with south Kashmir's Shopian district, was also suspended due to landslides, they said.

"The shuttering of underconstruction Peerah bridge was washed away due to heavy rains (on highway)", police official said, adding that the one which is nor-

mally used for traffic is safe. In Udhampur district, a 150-foot stretch of the Jammu-Srinagar highway was washed away on Wednesday near Toldi Nallah, 16 kilometers away from Udhampur town, they said. Many machines were involved in the work to restore the road patch swept away in the flash floods in the Tawi river.

"Chances of road opening

today are minimum. There are no report of any loss of life", they said."The Jammu-Srinagar highway is blocked due to fresh shooting stones and landslides at several places in Ramban district," a traffic official said.





40 Fresh Covid-19 Cases, 1 Death **Reported In J&K**

Jammu and Kashmir's Covid-19 tally went up to 454585 after 40 more people tested positive for the virus, while the death toll rose to 4755, officials said on Wednesday.

They said that 16 cases were reported from Jammu, eleven frim Srinagar, four from Kulgam, three each from Samba and Budgam, two from Udhampur and one from Kathua districts respectively. Among the total cases, 166695 are from Jammu division and 287890 in Kashmir.

There was also one death, from Jammu, due to the pathogen reported in the last 24 hours, they said. So far 4755 persons have succumbed to the virus—2330 in Jammu and 2425 in Kashmir.

Besides, they said, 15 Covid-19 patients recovered during the last 24 hours—12 from Jammu di

Afghanistan earthquake kills at least 1,000 people: official

KABUL, JUNE 22

A powerful earthquake struck a rural, mountainous region of eastern Afghanistan near the Pakistani border early June 22, killing at least 1,000 people and injuring 1500 others, authorities said. Officials warned the death toll would likely rise.

Information remained scarce on the magnitude 6.1 temblor that damaged buildings in Khost and Paktika Provinces. Rescue efforts are likely to be complicated since many international aid

agencies left Afghanistan after the Taliban takeover of

the country last year and the chaotic withdrawal of the

U.S. military from the longest war in its history.

Neighbouring Pakistan's Meteorological Department said the quake's epicentre was in Afghanistan's Paktika Province, just near the border and some 50 kilometres (31 miles) southwest of the city of Khost. Such temblors can cause severe damage, particularly in an area like this one where homes and other buildings are poorly constructed and landslides are common.

Meanwhile, due to heavy rains in the region, the Salal power station opened dam gates to release the water. The Jammu-Srinagar national highway was blocked for traffic movement on Wednesday due to landslides from hilltops at several places. The Jammu and Kashmir traffic police tweeted, "Jammu-Srinagar NHW blocked due to shooting stones/ landslides at several places, also Mughal road blocked lue to landslide at Poshana and SSG road blocked at Chini nalla due to landslide." Following heavy rainfall on Tuesday, the Jammu-Srinagar highway was blocked due to the continuous shooting of stones at Panthyal. In an advisory, the traffic police said, "Due to heavy rainfall on the whole NH-44 and shooting stones at Panthyal and other locations approx. 3000 vehicles both HMVs and LMVs are stranded on the NHW. Tomorrow on 22-06-2022, no fresh vehicle shall be allowed from either side i.e from Jammu towards Srinagar and vice-versa. If weather permitted only stranded vehicles will be allowed to move to their destinations subject to traffic-worthy road conditions. "For vehicular movement on SSG Road, the traffic police said, "Subject to fair weather and good road condition, vehicular movement on Srinagar-Sonamarg-Gimari road shall be allowed from both side--Srinagar towards Kargil and vice-versa. LMVs will be released from Minamarg and Sonamarg from 5 a.m. up to 5 p.m. and HMVs will be released from Minamarg towards Srinagar at 7 a.m. up to 11.30 a.m. and from Sonamarg towards Kargil at 1 p.m. up to 6 p.m. No vehicle shall be allowed between 6 p.m. and 5 a.m." "The Jammu and Kashmir traffic police advised people not to travel on the highway without confirming the status of the road from traffic checking units. Mughal road was closed due to a landslide at Poshana. "Commuters are advised not to travel on Mughal road without confirming the status of road from TCU Jammu/Srinagar," the advisory added.

It was also found that the said accused Executive Engineer by abusing his official position under a well knit conspiracy with other officials & the accused supplier Latief Ahmad Ganie arbitrarily fixed the rate of Furnishing / furniture items without conducting any market survey and fixed the contract for supply of said item in favour of the accused blue eyed supplier. Vide supply order No. 80/AG of 09/2009 on highly exorbitant rates without obtaining Administrative Approval and also affected purchases in favour of the supplier at exorbitant rates", it reads.

"The investigation conducted by ACB has proved that the accused officials in their capacity as public servants have abused their official positions by entering into conspiracy with the supplier and under a well knit conspiracy have resorted to manipulation/forgery of tendering records and purchased the furniture items on huge exorbitant rates thereby illegally /fraudulently giving undue pecuniary benefits to accused supplier and causing loss to state exchequer."

Bureaucratic rule no substitute to popularly elected govt: NC

The Former Minister questioned the rational behind the scheme, envisaging recruitment for four years on contractual basis with compulsory retirement for three fourths of the recruits without gratuity or pension benefits. He said the youth have genuine apprehensions about their careers being jeopardized by such measures which raise questions and doubts in their minds.

He described such moves as desperate acts of diverting attention as the BJP government has failed in generating employment and providing 'two crores' of jobs every year promised in successive elections since 2014. He said that the best recourse available to the government is to rollback the Agnipath Scheme in the larger interest of the nation and the youth.

He said that the condition of hospitals is deplorably unhygienic, replete with filth and dirt. Unfortunately the hospitals generally lack adequate facilities for the patients, who even do not get free medicines.

He added that there is acute paucity of infrastructure and shortage of teaching faculty in Govt Colleges and Schools. In this behalf no one cares even when the study of students has already hit hard due to Covid 19 pandemic in last two years. He urged the LG Administration to pay close attention in the Health and Education sector to improve infrastructure, health care as well as academic growth of students. Addressing gathering here today, Chander Mohan Sharma reiterated the party's demand for restoration of full statehood to Jammu & Kashmir before the announcement of assembly elections. "J&K has suffered a lot since the abrogation of state status as in the absence of popular govt people are feeling suffocated due to their continuous neglect on all fronts," he added. Now, they want to get rid of bureaucratic rule and waiting for the popularly elected government," he further said. He maintained that bureaucratic rule is no substitute for the popularly elected government. Snow, rains cause flash floods in J&K

have lashed Jammu and Kashmir over the past 24 hours causing flash floods that have washed away culverts and roads across the union territory.

Parts of the Valley also received snowfall including at the Baltal Base Camp near Amarnath cave, Kausarnag in Kulgam, Gurez in Bandipora district causing hardship to people living in these regions.

In view of the inclement weather and continuous rains that may cause floods, the district administrations in have established helplines for any kind of emergency arising. Schools in various Kashmir districts have been shut

from primary to higher classes for the day. Srinagar and its adjoining areas received heavy rain in the

past 24 hours since Tuesday inundating many low lying areas and roads causing trouble to commuters.

It was also the coldest day on Tuesday here in the month of June in the past 48-years, an independent Kashmir weather observatory said.

Meteorological department has forecast light to moderate rain to continue till Wednesday forenoon. From Thursday onward there is no major rainfall forecast for the next one week.Srinagar received 57.8mm of rainfall in 24 hours till 8.30 am Wednesday, Qazigund (75.2), Pahlgam (46), Kukernag (45.2), Kupwara (34.8) and Gulmarg (69.6).

There was snowfall at the Baltal base camp for Amarnath, besides Kausarnag, Gurez Valley and Pir Panjal range on Wednesday causing steep dip in mercury.

Continuous moderate to heavy rains since past few days caused landslide, flash floods at many places in the hills. A road stretch at Heff bride in Achan Pulwama washed away in flash flood. A foot bridge connecting Alyalpora to Nagbal in Shopian district of south Kashmir was also washed away.

In Kashmir, district authorities advised people not to venture close to water bodies. They have also been advised against going for any kind of work near 'nallas' or drains along the slopes.

highway in Ramban and Udhampur districts, they said. The highway was closed for traffic due to shooting stones at Panthiyal on Tuesday. Work is on to clear the highway, the officials said.

The situation at Battery Cheshma on the highway is bad as a lot of mud is to be cleared to ensure that heavy vehicles trapped in it are cleared, they said.

The road connecting Khari to Mahoo and Khari to Nachlana blocked due to mudslide and shooting stones and part of the road sank at Hirnihaal, they said, adding the people are again advised not to venture out. According to some reports, over 1,000 vehicles are stranded at various places along the highway.

As highway continues to be closed for traffic, stranded passengers were provided with food and medical facilities, they said. It is still raining in Ramsoo-Ramban sector as of now, the officials said.

The Mughal Road is blocked due to landslides at Poshana while the SSG road is blocked at Chini nallah and efforts are on to clear them, they said.

However, heavy rains are hindering the cleaning operation, the officials said. (Agencies)

Afghanistan earthquake kills at least 1,000 people: official

Footage from Paktika Province showed people being carried into helicopters to be airlifted from the area. Others were treated on the ground. One resident could be seen receiving IV fluids while sitting in a plastic chair outside the rubble of his home and still more were sprawled on gurneys. Other images showed residents picking through clay bricks and other rubble from destroyed stone houses. Afghan emergency official Sharafuddin Muslim gave the death toll in a news conference on June 22. Earlier, the director-general of state-run Bakhtar news agency, Abdul Wahid Rayan, wrote on Twitter that 90 houses have been destroyed in Paktika and dozens of people are believed trapped under the rubble. Bilal Karimi, a deputy spokesman for the Taliban Government, gave no specific death toll but wrote on Twitter that hundreds of people were killed and injured in the earthquake, which shook four districts in Paktika. "We urge all aid agencies to send teams to the area immediately to prevent further catastrophe," he wrote. In just one district of the neighbouring Khost Province. the earthquake killed at least 25 people and injured over 95 others, local officials said. In Kabul, Prime Minister Mohammad Hassan Akhund convened an emergency meeting at the presidential palace to coordinate the relief effort for victims in Paktika and Khost.

It will make job of aspiring entrepreneurs to avail the facilities that much easier and rejections on flimsy grounds will come down."

He urged for increasing the credit off take under Mission Youth and said, "I am of the belief that Mission Youth Schemes are the most attractive schemes in the entire country and large number of youth need to be covered under the scheme."

He also directed Banks to leverage the big potential in High Density Apple and other fruit plantation by devising the tailor made scheme which should be enterprise driven rather than government driven. While expressing dismay over low CD ratio of Jammu district, he urged upon the lending institutions to increase their credit dispensation so as to achieve CD ratio of at least 60 % across all the districts in the UT.

A 6.1-magnitude earthquake in 2002 killed about 1,000 people in northern Afghanistan. And in 1998, another earthquake of the same strength and subsequent tremors in Afghanistan's remote northeast killed at least 4,500 people.

Block Diwas: Public Outreach Programme held at Mahanpur

The Block Diwas proceedings were held today at PWD Guest House, Mahanpur, where District Development Council Kathua Chairperson, Mahan Singh and Deputy Commissioner Rahul Pandey listened to the grievances of the people.

Shiv Sena seeks improvement in Amarnath, Machail Yatra routes

Chandi Mata Yatra, which is located in Kishtwar district of Jammu region, in the village Machail of sub-division Paddar, is about 32 km road from Gulabgarh to Machail, is the biggest example of administrative apathy. He said that every year lakhs of pilgrims perform Machail Mata Yatra but the road contraction work which was started under PMGSY about a decade back has not been completed till date.

The Shiv Sena demanded that the Machail Yatra route, including the Jammu and Kashmir National High-

Skin Problems that Arise During Monsoons

The pleasant days of magical. monsoon are here again to provide respite from the brunt of the hot and sweaty summer. The buzz of monsoon has grown louder with barren land springs to life with lush green fields and rolling green hills across the country

Who doesn't like the rains? Lush green landscapes, romantic drives, and cosy evenings with loved ones. Can't get better than this, right? Monsoon showers have arrived to give us respite from the sweltering summer heat and hope the rain Gods bless us with a good rainy season this year.

The onset of the monsoon drizzles provides refuge from the scorching summer heat .The cool raindrops make your skin dull and cause Skin Allergies, Hyper pigmentation, Facial Folliculitis, Dull, frizzy hair due to dirt, pollution, wetness and excessive humidity. The sudden downpour take a toll on skin and hair due to bacterial and fungal infection . Your skin needs extra care in rainy season as humidity level escalates triggering excessive oil secretion in the body leading to itching which may further facilitate skin and hair related issues .

Your skin is more susceptible to infections during monsoon due to excessive sweating, dehydration, photo-toxic effects of the sun and, of course, seasonal humidity. Prickly heat is one of the most common skin issues during this season.

. If you suddenly notice skin allergies and skin infections on your face due to heat, humidity and rain then don't worry. Well, a few simple tricks to keep your skin glowing and your hair managed this monsoon.

In case of a skin infection, use an anti-fungal powder to avoid any further infection. Always keep your skin dry. Don't wear wet clothes. Also, wet shoes should be changed instantly. These small precautions go a long way in having a healthy and infection-free skin.

Beauty is not just a question of how you look, but how you feel, and at no time is this more relevant than during the monsoons. The rainy season isn't such a great time for looking or feeling good. Both the skin and hair suffer due to high humidity. Sweat and oil deposits make the skin and hair really dull. So, I always adjust my skin and hair care routine according to the season.

A flower based skin tonic is ideal. I just can't do without a rose-based skin tonic during hot and humid weather. I keep a small bowl of rose skin tonic in the fridge,

with cotton wool pads soaking in it. This way it is chilled and ready for use. One can do this with rose water too, a powerful natural skin toner. I wipe the skin with it several times a day. Rose is a natural coolant and most refreshing. The chilled toner also closes and refines the pores.

I also use cotton wool pads soaked in the skin tonic as eye pads. It is most relaxing and removes fatigue. Splashing the eyes with cold water also provides great relief. Sometimes, eye fatigue leads to puffiness. For this, I first wash the eyes with cold water and then with lukewarm water and repeat this alternate cold and warm water washing a few times. Sometimes, I soak tea bags in water and then apply them over the eyelids as eye pads. Tea helps to relieve puffiness.

For a monsoon face mask, mix 3 teaspoons oats with egg white and one teaspoon each of honey and curd. If you don't want to use egg white, add rose water or orange juice. Apply it on the face and wash it off after half an hour. Use it twice a week. Almond meal, or dry and powdered lemon and orange peels can also be added to the face pack.

Or, you can go for a fruit mask. They are most refreshing during hot and humid weather. You can also add cucumber pulp to the fruit mask, as it has an astringent effect and closes the pores. Ripe papaya pulp can be mixed with grated apple, water melon, pineapple and so on. Papaya and cucumber also help to remove tan. Mango can be most nourishing for dry skin. Apply the mask on the face and wash it off with plain water after half an hour.

In case of a skin infection, use an anti-fungal powder to avoid any further infection. Always keep your skin dry. Don't wear wet clothes Wet shoes and if you are drenched in rains then wet clothes/ wet shoes should be changed instantly.

I wash my hair more often during the monsoons. Tea and lemon juice make a wonderful hair rinse, adding shine to the hair. Just boil used tea leaves again, in enough water. Cool, strain, add the juice of a lemon. Use it as a last rinse after shampoo. The juice of a lemon and half a cup of rose water can also be added to a mug of water to make a fragrant last rinse.

You can prevent your hair from becoming dull and Frizzy by applying a mixture of Apple cider vinegar and water. Mix a tablespoon of Apple cider vinegar mixed with half a cup of water, it will calm your tresses. Use a gentle shampoo to wash your hair and avoid using chemicals on the hair. We witness more hair fall during monsoons than the rest of the season mainly due to bacterial and fungal infection. The best way to avoid Facial Folliculitis is to avoid perspiration and to keep hair dry as much as possible. This can be achieved by taking regular and more freequent baths.

We should be careful while using public toilets because there remains the possibility of the presence of infectious agents. Consume at least 10-12 glass of water as you can and also apply plenty moisturizers to keep skin hydrated. A skin moisturizer is a must irrespective of your skin type.

Sometimes, I apply the white of several eggs before my shampoo, leaving it on for half an hour. This not only gives body to the hair, but is also a wonderful cleanser.

Soaking the feet in warm or cold water can be most relaxing and also reviving. I add a tablespoon of coarse salt and half a cup of lemon juice to about one-fourth bucket warm water. Sometimes, I add a few drops of tea tree oil to the water. It keeps the feet free from skin problems. I soak my feet in this for half an hour. A cooling foot bath is also a great reviver during hot and humid weather. Add rose water, lemon juice and a splash of eau de cologne in cold water and soak feet in it to Cool, clean and adds fragrance.

Maintain regular proper hygiene and keep skin fold area dry by using anti-fungal powder to absorb the sweat.

Avoid sharing of clothes or towels. Wearing tight synthetic clothes will not allow the skin to breathe or the sweat to evaporate and hence it is advised to Wear open footwear like chappals of breathable material, cotton socks and light loose cotton/khadi clothes.

Nails become discoloured, brittle and dull due fungal infections during monsoon season. Trims your nails regularly during the rainy season as long nails attract muck, thereby leading to fungal infection.

During the monsoons, the body loses fluids through sweat. I take lots of "nimbu paani" and fresh fruit juices. I also turn to home remedies for small ailments. For sore throat and cough, I find ginger tea most soothing. I add some tender tulsi leaves to it, while it is boiling. Water boiled with just tulsi leaves can also be taken as drink in case of sore throat.

EDITORIAL Progressing J&K

ith the GI tag, Kashmiri Saffron gains more prominence in domestic, export markets To give a boost to saffron production in Kashmir, J&K Government has launched new initiatives including the introduction of GI Tagging.

GI sign is used on products that have a specific geographical origin and possess qualities or a reputation that are due to that origin.

Saffron growers are hopeful that they will now get a better price for their produce after the introduction of GI tag to the saffron grown here. Kashmiri Saffron is grown at an altitude of 1,600 m to 1,800 m above mean sea level, which adds to its uniqueness and differentiates it from other saffron varieties available across the world.

Saffron is cultivated and harvested in the Karewas (highlands) of Jammu and Kashmir and has been assigned Geographical Indication (GI) tag by the Geographical Indications Registry. The spice is grown in Pulwama, Budgam, Kishtwar and Srinagar regions of Jammu & Kashmir.

Iran is the largest producer of saffron in the world and India is a close competitor. However, with the GI tag of Kashmir saffron, India becomes the only Saffron producing Country for which GI has been assigned which will result in more prominence in the export market thereby boosting exports as well as help the farmers to get best remunerative price for economic sustainability.

The GI Certification would also cease the prevalent adulteration of Saffron and will put an end to the marketing of Saffron cultivated in other countries under the garb of being produced in Kashmir which otherwise was defeating the economic interests of the farmers associated with this crop.

Highlighting the importance of preserving the unique identity of Kashmiri Saffron, an official of Agriculture Department said that Kashmir is having a distinction of producing one of the best saffron in the world, therefore it is our individual/collective and moral responsibility to preserve this golden spice not only for a large number of families directly associated with the cultivation of saffron but for our generations to come.

Saffron, despite its price, is in high demand for its antioxidant properties. It carries a hefty price tag also because the process of converting crocus flowers into the thread-like spice is painstaking and labour-intensive as it takes around 160,000 flowers to yield a kilogram of saffron. Kashmiri saffron is of superior quality because of the higher concentration of crocin, a carotenoid pigment that gives saffron its colour and medicinal value. Its crocin content is 8.72% compared to the Iranian variant's 6.82%, , giving it a darker colour and enhanced medicinal value. Kashmiri Saffron is renowned globally as a spice. It rejuvenates health and is used in cosmetics and for medicinal purposes. It has been associated with traditional Kashmiri cuisine and represents the rich cultural heritage of the region. The unique characteristics of Kashmir saffron are its longer and thicker stigmas, natural deep-red colour, high aroma, bitter flavour, chemical-free processing, and high quantity of crocin (colouring strength), safranal (flavour) and picrocrocin (bitterness). Remarkably, a new saffron park has been started just for the sole purpose of processing and promoting the sale of saffron from Kashmir Valley. The samples brought by growers are tested here. The lab is recognised across the world. There are 8 parameters that are tested, which are internationally recognized. The 8 parameters include moisture, extraneous matter and foreign matter, and total ash and three main characteristics. They are graded and then e-auctioned. The farmers get the flowers and then the stigma separation and vacuum drying is done at the Dusoo Park. Traditionally the farmers used to dry the saffron under shade at home but due to that, the saffron used to lose the main components. Now all the parameters are saved to get the best grade, an official of the Saffron Park said. With the GI tag, saffron growers and traders are getting more benefits like legal protection to the products as well as prevention of unauthorized use of GI tag products by others.

World Music Day: Can a bird sing when her garden is burning?

I started writing on music and related subjects in the early 90's while still a collegiate, and it was because of the ample exposure to music from across the world through radios, television, music cassettes and plethora of print material on the subject; even though internet and social media had not touched our lives

Very early in my journalism I had stopped covering subjects like politics and crime for the love of arts; visual and performing, literature, poetry and human interest stories in these realms, and of course music. And I had a plethora of opportunities to explore new tales to be shared with my readers.

By the time I joined a leading national daily in Delhi in the early 2000's, our team in the supplement had so much to attend to, and write on, one music concert here, one there, one theatre performance there, one dance & music festival in one auditorium and an art show now and a little later a book launch or an ad-free radio launches like Worldspace there. To add to it was cinema and its whole culture of launching its music, bringing music directors and lyricists for interactions. Our days used to be loaded with shows and performances we had to (and loved to) attend and write about. And yet not a day would we feel tired, such was the power of the soft arts. This continues till date, with one huge difference; the lack of the celebration of diversity in our country of which, I feel, music is the greatest loser.

There are two ways any two type of people or cultures react when facing

each other. One is that of collaborating, rejoicing and respecting which helps in increasing love, peace and bonhomie. The other is when you despise, disrespect and dishonour each other. This has time and again created chasm, chaos and ultimately annihilation.

My heart aches today because I am not seeing an urge by the ruling dispensation to initiate collaborations within and from outside India, on music as well as other cultural exchanges to promote a shared co-existence, celebrating our cultural diversity, like it used to be barely half-a-dozen summers back

Bereft of celebrating a composite culture, we are left to discuss, even on World Music Day; who was lynched, how many trains were torched, whose house was bulldozed, how many remaining? Protests on the roads for employment, farm laws and citizenship, burning offices, pelting stones, Maulanas and Sants on the TV, activists in jails forced food, education, literature and culture including music out of our lives.

I believe, Indian music has all the reasons to be accepted and enjoyed by all. But it gained global recognition and acceptance thanks to Pt Ravi Shankar's fan following amongst the Beatles-the music band that had the world merry go round on its tunes. Ustad Zakir Hussain lived and stayed more than half his life in USA and made tabla a house-hold musical instrument and Pt Jasraj, Ustad Bismillah Khan and Bade Ghulam Ali gained their audience and helped popularise Indian music globally.

Apart from the maestros above, it

was Mehdi Hasan, Jagjit Singh and Nusrat Fateh Ali Khan who took the various Indian musical traditions to their zenith, and the Indian film music and its various music artists did make a mark but most went rather unsung till a genius called A R Rahman with a universal approach to his music compositions gave the world a Jai Ho (Slumdog Millionaire) and Vande Matram to chant along with him.

Collaborations in form of Rajasthani Kawas, Teejan Bais, Jahane-Khusrau were deeply rooted in Indian ethos and pure musical ragas but conceived with an intent to reach out to international platforms. All these either were a government initiative or private partnerships (in resonance with governmental acts) devoid of any religious, language or caste-based interests. The list of what music has done to India's global reach is exhaustive.

As I look for covering similar stories today, I find less of an inclusive affair than the soft power which had helped India become one of the favoured international tourist destinations, thus booming its cultural diplomacy and swelling its foreign currency too.

While our country is burning with an apparent desire to dig its prehistoric past to discover and understand its cultural roots, is it wilfully ignoring its current and future generations just to piece together its legacy? It is like praying for maghfirat (salvation) of your forefathers while forgetting to take care of your parents and children - your current and future generations! Here it is imperative to look at

tions. They promote their soft powerthrough their art galleries, food, theatre and music spaces. Even Italy, China and Japan are promoting their soft power through favourable cultural policies/ cultural diplomacy. My India was no far behind either. We had our ICCR (Indian Council of Cultural Relations), platforms like Routes to Roots, international mushairas like Jashn-e-Bahar and Shankar-Shaad where poets from across border were main attractions. While the current regime is still grappling with a steady and strong economic or foreign policy, it seems they have just lost their way on the cultural policy front, or

maybe have forgotten about it? We were witness to new experiments in music with the global partners, fusions of folk and international music bands, classical performances paired with international music vocalists, private and public collaborations and much more, irrespective of religion, caste, creed or colour. While today, collaborations of this nature are almost impossible. No international cultural collaboration is possible without music being an integral part ofit

My heart bleeds today because I can see, hear and feel that gaps have become wider with no healing remedies to look forward to. For instance, yesterday was also the World Yoga Day and the way it is being promoted, obviously by sidelining the importance of music, I feel, is abnormal. I received multiple messeges celebrating Word Yoga Day from people who are working for government projects directly or indirectly, forgetting mu-

sic is a way to meditation too. It is like restricting/projecting Gandhiji and his spectacles - to just a cleanness drive or swacchta - while ignoring his efforts to bring cultural, political and religious together for healing. Remember Gandhi ji's bhajan (devotional song) Vaishnav Vajan is all about "par dukhkhe upkar kare koi, mun abhimaan na jaane re" (the world as a family should heal each other without any ego). Now even Europeans are singing it and making videos, few have recently gone viral on the net. This beauty of music now has been plastered with a forceful remembrance of this day as just an International Yoga day.

True music, by the way, is nothing but meditation. If it were not so, the likes of Hazrat Ameer Khusrau. Kabeer and Rumi wouldn't have been universal icons of brotherhood through music, philosophy and magical words of God's praise and the call for humanity, spirituality and philanthropy above everything. Their sufi kalaams reign even today's world music arena not because of one thought, one religion, one colour but a call for love, peace and togetherness. If we sing paeans only to lord Rama, who will listen to lord Krishna, or lord Shiva, Meera or Kabeer or Ras Khan, a Muslim poet who wrote exotically ornamental devotional chhands for lord Krishna and Radha. The moment we stop celebrating such a diversity, it would breed hatred, jealousies, comparisons, complexes and above all violence for the sake of one-upmanship (and for some vested interests).

These include issuance of alerts, advisories, capacity building, training of law enforcement personnel, prosecutors, judicial officers, improving cyber forensic facilities etc. Besides, Government of India has

tion Centre (14C) to provide a framework and ecosystem for law enforcing agencies to deal with cyber crimes in a comprehensive and coordinated way.

Home Ministry has launched the National Cyber Crime Reporting Portal (www.cybercrime.gov.in) to enable the public to report all types of cyber crimes with special focus on cyber crimes against women and children. Cyber crimes reported on this portal are routed automatically to the respective states/UTs law enforcement agencies for further handling of the case as authorized by law. In addition, the Citizen Financial Cyber Frauds Reporting and Management System module has been launched for immediate reporting of financial frauds and to stop siphoning off fund by the fraudsters. For

this, a toll free Helpline Number '1930' has been operationalized to get assistance in lodging complaints/report about online frauds.

Despite such a wide scale infrastructure to fight cyber crimes having been built over the years in view of fast changing Internet-based Information Technology and the servers of all Internet Service Providers (ISPs) located abroad, tackling growing cyber crimes is a stupendous and challenging task posing a major hurdle in solving cyber crimes.


RSS-BJP bid to distort history inflicts immense damage on character and identity of India

Did AIFF hire astrologer for Indian football team's good luck?

NEW DELHI, JUNE 22 Did astrology play a role in national Indian football team's recent success at the AFC Asian Cup Qualifiers?

Well, it seems the All India Football Federation (AIFF) did make an effort to have the stars aligned.

It has come to light that AIFF splurged Rs 16 lakh on an astrology agency which it had hired to "motivate" the national team side, which confirmed its berth in the 24-team AFC Asian Cup Final.

The Sunil Chhetri-led side topped the group to qualify.

"A motivator was appointed for the National team ahead of the Asian Cup. Later on, it came to light that the company which was engaged, was an astrological firm," a team insider told PTI.

"Plainly-speaking, an astrologer was appointed to motivate the team. Huge payment to the tune of Rs 16 lakh was made," the source claimed.

The astrological firm apparently took three sessions with the Blue Tigers but a Kolkata-based player said: "At least I've not heard of this as I joined the team late."

Sunando Dhar, who is the acting AIFF general secretary, was not available for comments.

Former India goalkeeper Tanumoy Bose ridiculed the idea and hit out at the AIFF for becoming a laughing stock.

"At a time when the AIFF repeatedly



failed to conduct proper youth leagues, and many prestigious tournaments were forced to shut down, incidents like this will further tarnish the image of Indian football," Bose told PTI.

He further said it was just a "smoke screen" since the AIFF officials are quite capable of using the money to sponsor their upcoming foreign trips.

"The CoA (which is running the show in AIFF after the suspension of president Praful Patel) must go deep into this appalling incident and find out who all are responsible behind it. There are many scams waiting to see the light of the day," he added.

The Supreme Court had last month appointed a three-member Committee of

Administrators (CoA) to manage the affairs of AIFF, ending Praful Patel's long rein at the helm.

Black magic is not new to Indian football. One Delhi-based club once had roped in a Meerut-based 'Baba' for a key league match and after their triumph, the team credited its success to him.

The Sunil Chhetri-led side recorded its best-ever Asian Cup campaign as the talismanic forward led from the front with four goals from three matches to take the national team to the Finals.

India began their campaign with a 2-0 win over Cambodia and then they secured last-gasp 2-1 victory over Afghanistan before beating Hong Kong 4-0 to qualify as group toppers.

Zaheer Abbas admitted in London hospital ICU

New DELHI, JUNE 22 Pakistani batting great Zaheer Abpas has been admitted to the inten-

bas has been admitted to the intensive care unit (ICU) of a private hospital here.

According to Geo News, Abbas, 74, was moved to the ICU three days

after getting admitted at Saint Mary's Hospital in Paddington, where he was put on oxygen support.

One of the most elegant batters of his time, Abbas had contracted COVID-19 while travelling from Dubai to London. He had complained of pain and was diagnosed with pneumonia after arriving in the British capital.

"He is currently on dialysis and the doctors have advised him to refrain from meeting people," Geo News quoted sources as saying.

Abbas, who made his

international debut in 1969 against New Zealand, was one of the finest batters of his generation. He amassed 5062 runs in 72 Tests, and scored 2572 runs in 62 ODIs.

In first-class cricket, he accumulated 34,843 runs in 459 matches, which included 108 centuries and 158 fifties. After retirement, he also served as

an ICC match referee in one Test and three ODIs.

He was also inducted into the ICC Hall of Fame in 2020 alongside Jacques Kallis and Lisa Sthalekar.

ATP to trial off-court coaching including at US Open


New Delhi, June 22

The ATP will trial off-court coaching in the second half of the year, with players set to receive instructions in qualifying and main draw matches in tournaments including the US Open and the ATP Finals, the governing body of men's tennis said on Tuesday.

The trial will permit an individual to coach a player both verbally and non-verbally from a designated seat provided that it does not interrupt play or hinder an opponent.

It commences from the week of July 11 and run through to the season-ending ATP Finals in Turin in November, in a move that the body says will enhance fan experience at tournaments.

"Various coaching rules have been trialled across the sport in recent years, including on-court coaching and coaching via headsets," the ATP



Verbal coaching must consist of only a few words and will be allowed only when the player is at the same end of the court as his coach while non-verbal coaching -- through hand signals -- will be permitted at any time.

"Coaches may not speak to their player when the player leaves the court for any reason," the ATP added.

Bayern Munich sign Mane from Liverpool until 2025

New Delhi, June 22

Bayern Munich on Wednesday completed the much-anticipated signing of Senegal forward Sadio Mane from Liverpool on a three-year contact, the German champions said.

Bayern, who won a record-extending 10th straight league title last season, have reportedly agreed on a transfer worth about 40 million euros (\$42.10 million), including add-ons, for the 30year-old, who had a year left on his Liverpool contract.

[–] "Sadio Mane is a global star," Bayern president Herbert Hainer said.

"He underscores the attractiveness of Bayern and the entire Bundesliga."

The 30-year-old leaves Anfield after 269 appearances, having scored 120 goals in all competitions, a stellar return that helped the club to the Champions League title in 2018-19 and the Premier League crown a season later.

The forward became Bayern's third signing of the close season, following the arrivals of Ajax Amsterdam duo Ryan Gravenberch and Noussair Mazrouai.

"I am very happy to finally be at Bay-

The Bavarians still won the German league for a 10th straight time but failed to get past the quarter-final stage in the Champions League. Delhi High Court orders AFI to consider Tejaswin Shankar for CWG New Delhi, June 22

The Delhi High Court on Wednesday directed the Selection Committee to consider on merits the case of athlete Tejaswin Shankar, a high jumper who has been excluded from participating in the 2022 Birmingham Commonwealth Games.

The high court said Shankar's nonparticipation in the interstate championship shall not be the sole criteria for rejecting him and observed that he is a 'medal prospect' and there should not be an ego issue.

Justice Jasmeet Singh issued notice and sought a response of the Athletics Federation of India(AFI), Ministry of Youth Affairs and Sports, and the Selection Committee of the AFI for the senior category on the petition.

The plea sought to direct the AFI not to disqualify Shankar from participating at the CWG 2022 based on non-attendance at the Interstate Senior Athletics Championships, and be allowed to participate based on having met the qualifying standard at the National Collegiate Athletic Association (NCAA) championships.

"These are record holders and you don't let them go... He (Shankar) is a



medal prospect. Let it not be an ego problem," the court said.

The court was informed by advocate Parth Goswami, representing AFI and Selection Committee, that the final list of athletes has already been prepared and submitted to Indian Olympics Association (IOA).

He further said that the Selection Committee is scheduled to meet today.

To this, the court directed that "the Selection Committee shall consider the case of Shankar on merits of his jumps and his non-participation in the interstate championship shall not be the sole criteria for rejecting his candidature".

Senior advocate Gopal Sankaranarayanan and advocate Malak Bhatt, representing Shankar, submitted that he has been excluded despite being the national high jump record holder (2.29m) and being the only Indian to have met the AFI qualification standard of 2.27m with a jump of 2.27m as recently as June 10, 2022, while winning a gold medal at the NCAA Track and Field Outdoor Championship 2022 in Eugene, Oregon in the USA.

The plea said that Shankar is also part of the Target Olympic Podium Scheme (TOPS) for the last two years which is a flagship Olympic development scheme under the Ministry of Sports and has been receiving a scholarship for the same.

It said that the petitioner has not been considered by the AFI for failing to take permission to be exempted from attending the 2022 interstate championships which cannot be a disqualifying criterion.

The counsel said Shankar had sought exemption from interstate championships as they clashed with the NCAA championship and had informed the chief national coach through WhatsApp messages.

"The petitioner is at present, indisputably, the best Indian high jumper in the world, and on the basis of current form is undoubtedly a medal contender at the CWG 2022. In fact, only two high jumpers (both non-Indian) who will prospectively be competing at the CWG 2022 have a better jump than him this year," the counsel submitted.

The plea said it is in the interest of the nation that Shankar be allowed to participate in the CWG 2022, based on his merit, as established from his jumping record, both recent and otherwise.

Kohli infected with COVID after returning from Maldives vacay

India's preparations ahead of the one-off Test against England in Birmingham, starting July 1, have taken a massive hit as some of the players have contracted COVID-19.

Former Indian skipper Virat Kohli was rested by the BCCI for India's five-match T20I series

against South Africa, and given the break, he went on a vacation to the Maldives with hiswife Anushka Sharma and daughter Vamika.



However, as per the latest reports, Kohli had returned COVID positive after the conclusion of his vacation.

The Delhi-born batsman is said to have recovered from the infection now, as he recently jetted off to the UK for India's rescheduled fifth Test match against England.

According to a report in the Times of India, a source close to the developments confirmed that the former Indian skipper had tested positive for COVID-19, after returning from Maldives, but he's recovered from the infection.

29 Chinese military aircraft enter Taiwan's air defence identification zone

NEW DELHI, JUNE 22

Taiwan scrambled jets as 29 Chinese military aircraft flew into the southwestern part of Taiwan's air defence identification zone (ADIZ) on Tuesday. According to the Ministry of National Defence, this is the thirdhighest single-day total this year.

China has been flying warplanes into Taiwan's air defence zone in increasing numbers in recent months. And this has been a cause for an uptick in tensions between Beijing and Taipei. Tuesday's incursion mark's the largest air defence zone violation by China since May. China claims that Taiwan is its own territory.

This time, according to Taiwan's defence ministry, China sent 17 fighters and six H-6



bombers, as well as electronic warfare, early warning, antisubmarine, and an aerial refuelling aircraft, Reuters reported. The aircraft flew close to an area to the northeast of the Taiwan-controlled Pratas Islands. Taiwan says China's repeated nearby military activities are de-

signed to wear out Taiwanese forces by making them repeatedly scramble, and also to test Taiwanese responses, calling it "grey zone" warfare.

Taiwan's missile systems were deployed to monitor them. It also sent combat aircraft to warn the Chinese aircraft.

IUML leader's participation in RSS event invites ire of leadership

New Delhi, June 22

The recent participation of IUML leader and former MLA, KNA Khader in a cultural meeting organised by the RSS here has triggered a row as senior party leaders openly expressed strong displeasure over it and viewed it as an 'anti-party' act.

The Indian Union Muslim League (IUML) leadership viewed the actions of Khader, a two-time legislator, as serious despite his explanation that it was not a meeting of the RSS, but only a cultural event.

Senior League leader P K Kunhalikutty told reporters here that no League leader had ever attended a programme organised by the RSS while another IUML veteran M K Muneer said it was against the party's policies and the high command would discuss it. As soon as the issue came to the notice, an explanation was sought from Khader and it would be discussed at the party forum, Kunhalikutty, a former Union Minister, added.

A philosopher and noted orator, Khader was honoured on Tuesday at the cultural meeting, "Snehabodhi" held at the Kesari Bhavan here, in which senior RSS leaders including J Nandakumar were present. Not just participating in the RSS event, Khader, during his speech, also did not conceal his desire to enter the famed Guruvayoor Sri Krishna temple. He had said he could only offer donations from outside the temple but could never enter inside.

"I wonder when could I enter inside Guruvayoor Temple. I was lucky to visit many temples in northern parts of the country but unable to enter the Sri Krishna temple in Guruvayoor", he had said during his speech at the RSS function.

A veteran of the IUML, Khader is known for his speeches that in many times praised the Hindu values and traditions quoting anecdotes. Former MLA of Vengara, Khader, who had lost in 2021 Assembly elections from Guruvayoor, was criticised by Muslim organisations earlier also. A fond remark, made by him regarding Lord Guruvayurappa, was termed as "unislamic" by Sunni leaders.

It is a task she has done daily since she returned to her home town in August 2021 after her retirement as the governor of Jharkhand. Wednesday was no exception.

Hundreds of local residents saw the NDA presidential candidate with a broom in her hand and clad in an ivory coloured handloom saree with a red border sweeping the temple floor in the early hours between 3 and 4 am.

Saudi crown prince visits Turkey as countries normalise ties

NEW DELHI, JUNE 22

Saudi Crown Prince Mohammed bin Salman is scheduled to arrive in Ankara on Wednesday, making his first visit to Turkey as the two regional heavyweights press ahead with efforts to repair ties following the slaying of Saudi columnist Jamal Khashoggi in Istanbul.

The crown prince will meet President Recep Tayyip Erdogan on the last leg of a Middle East tour that also took him to Egypt and Jordan. His visit comes before U.S. President Joe Biden's trip to the region next month.

Erdogan said talks with the prince, who is commonly referred to by his initials MBS, would focus on advancing Turkish-Saudi relations to a much higher degree. Erdogan visited Saudi Arabia in April, paying his first visit to the kingdom since 2017, a year before the gruesome killing of Khashoggi by Saudi agents in the kingdom's consulate in Istanbul.

Turkey's efforts to improve ties with Saudi Arabia comes as Turkey faces its worst economic crisis in two decades and is trying to draw investments from wealthy Gulf Arab states. Turkey has also taken steps to improve relations with the United Arab Emirates, Egypt and Israel.



Saudi Arabia for its part, has been trying to broaden its alliances at a time when relations between Riyadh and Washington are strained. The crown prince also seeks to put an end to the scandal over Khashoggi's killing that damaged his reputation.

Turkey had opened a trial in absentia against 26 Saudis suspected in Khashoggi's killing, but the court earlier this year ruled to halt the proceedings and transfer the case to Saudi Arabia, paving the way for the countries' the operation to kill or capture Khashoggi, according to a U.S. intelligence assessment. The prince has denied any knowledge of the operation that was carried out by agents who worked directly for him.

While never naming Prince Mohammed, Erdogan said the operation that killed Khashoggi was ordered by the highest levels of the Saudi government.

Sonia Gandhi seeks more time for appearing before ED citing Covid recovery

New Delhi, June 22

Congress president Sonia Gandhi, who was hospitalised for over a week for Covid-19 complications, on Wednesday, wrote to the Enforcement Directorate seeking postponement of her appearance in the National Herald case by a few weeks till she recovers completely.

The 75-year-old Congress leader, who was discharged from hospital on June 20, had been summoned by the agency for questioning on June 23 in the money laundering case related to the newspaper.

Her son and former Congress chief Rahul Gandhi has already been quizzed by the probe agency for over five days.

Sonia Gandhi had earlier been scheduled to appear before the Enforcement Directorate (ED) on June 8 but had sought more time from the probe agency in view of her Covid-19 infection. The agency had then issued a fresh summons.

"Since she has been strictly advised rest at home following her hospitalisation on account of COVID and lung infection, Congress President Smt. Sonia Gandhi has written to ED today seeking the postponement of her appearance there by a few weeks till she has recovered completely," Congress general secretary Jairam Ramesh said on Twitter.

Rajasthan Chief Minister Ashok Gehlot



earlier said Gandhi should not appear before the ED as she has just returned after many days of hospitalisation.

"Sonia Gandhi has just come back from the hospital after many days, I don't think she should go there now," Gehlot told reporters when asked about her appearance before the ED.

He said she would cooperate with the ED but will not be able to go there.

Gehlot again asserted the case against the Gandhis has nothing in it as it has been reopened by the ED seven years after it was closed by the same agency.

He said since there is no money involved in the AJL case, the question of money laundering does not arise, an argument repeated by party leaders since the ED summoned the Gandhis.

"They have created a case of money laundering where there is no exchange of money involved," the veteran Congress leader said.

Assam CM Himanta's wife files Rs 100 crore defamation suit against Manish Sisodia

NEW DELHI, JUNE 22

Riniki Bhuyan Sarma, wife of Assam Chief Minister Himanta Biswa Sarma, filed a Rs 100 crore defamation suit against Delhi Deputy Chief Minister Manish Sisodia, who had alleged malpractice in giving contracts for PPE at above market rates.

Bhuyan Sarma filed the suit at the court of Civil Judge No 1 of Kamrup Metropolitan district on Tuesday and it is likely to come up for hearing on Wednesday, her counsel Padmadhar Nayak said.

Another advocate, Kishor Kumar Dutta, told PTI that Sisodia, while addressing a press meet on June 4 in New Delhi, had made "some allegations that damaged the reputation and position" of Riniki Bhuyan Sarma.

"Sisodia unnecessarily dragged the name of Chief Minister Himanta Biswa Sarma also into the controversy. That is why we have claimed that damage," he added.

Sisodia, referring to media reports had told newsmen that while the Assam government procured personal protective equipment kits for Rs 600 each from other companies, Sarma gave urgent supply orders to the firms of his wife and son's business partners for Rs 990 apiece.

The opposition Congress, CPI, CPI(M), CPI(ML)-Liberation, RCPI, TMC, Raijor Dal, Assam Jatiya Parishad and Anchalik Gana Morcha have demanded a CBI probe into the alleged corruption.

On June 1 digital media organisations - New Delhi-based The Wire and Guwahati-based The Crosscurrent had, in a joint investigative report, claimed that the Assam government had placed four Covid-19 related emergency medical supply orders, most likely without following proper process.

Citing a series of Right to Information replies, the medial portals claimed that all the four orders, placed between March 18 and March 23 of 2020, were bagged by three firms owned by Riniki Bhuyan Sarma and the family's business associate Ghanshyam Dhanuka.

In a tweet she had refuted any wrongdoing in the supply of PPE kits to National Health Mission and said she did not take a "single penny" for them.

RBI extends implementation of new credit card rules by three months

NEW DELHI

The Reserve Bank of India (RBI) on Tuesday extended the deadline by three months for financial institutions to implement certain elements of its master directions issued on April 21.

In a notification issued on Tuesday, RBI said that considering various representations received from the industry stakeholders, it has decided to extend the timeline for implementation of certain provisions of the Master Direction to October 01, 2022.

The RBI has extended the deadline for implementation of three directions card issuers seeking OTP-based consent from customers for activating credit card, ensuring there is no breach in credit limit without explicit consent from the cardholder and no capitalization of unpaid charges.

As per the new directions, card-issuers shall seek One Time Password (OTP) based consent from the cardholder for activating a credit card, if the same has not been activated by the customer for more than 30 days from the date of issuance. If no consent is received for activating the card, card issuers shall close the credit card account without any cost to the customer within seven working days from the date of seeking confirmation from the customer.

Card issuers shall also ensure that the



credit limit as sanctioned and advised to the cardholder is not breached at any point in time without seeking explicit consent from the cardholder. No capitalization of unpaid charges/levies/taxes for charging/ compounding of interest, the new directions said.

Considering various complaints from consumers, the RBI in April issued directions to scheduled banks and nonbanking financial companies regarding the issuance of new credit and debit cards and billing.

As per the directions, telemarketers engaged by card-issuers must contact customers only between 10 am and 7 pm. The direction said, "Card issuers shall ensure complete transparency in

the conversion of credit card transactions to Equated Monthly Instalments (EMIs) by clearly indicating the principal, interest and upfront discount provided by the merchant/card-issuer (to make it no cost), prior to the conversion. The same shall also be separately indicated in the credit card bill/statement. EMI conversion with interest component shall not be camouflaged as zero-interest/no-cost EMI."

According to the new directions, a request for closure of cards must be honoured within seven working days subject to payment of all dues. Card issuers were also advised to initiate the process of closing a card if it has not been used for a year after intimating the customer in this regard.

Luxury market seen as growing in 2022 despite inflation, war

NEW DELHI

Neither inflation nor the war in Ukraine are threatening to take a bite out of the luxury fashion market, according to a study published Tuesday.

While much of the world is fretting over higher fuel and energy prices, the study by Bain & Company consultancy indicated that the global luxury market remains set for growth, largely due to the continued resiliency of the world's wealthiest people.

The global luxury market grew by nearly one-third to 288 billion euros (\$198 billion) last year, rebounding from its worst recorded dip due to the 2020 pandemic lockdowns, according to the study commissioned by Italy's Altagamma association of high-end producers.

Sales of personal luxury goods including apparel, accessories and footwear posted high double-digit

growth in the first quarter of this year, despite the first signs of economic uncertainty tied to the Russian invasion of Ukraine, Bain said.

In its most pessimistic outlook, assuming global inflationary pressure, Bain forecasts growth in the sales of high-end personal goods this year to grow by 5% to around 305 billion euros. But the consultancy also sees a case for up to 15% growth if the current trends continue, pushing the market to 330 billion euros next year

The United States and Europe have boosted growth so far this year, while sales are expected to hit a hard stop in China due to COVID-19 restrictions in key cities.

Iconic 'Contessa' to be relaunched; SG **Corporate Mobility buys brand name**

NEW DELHI

The Contessa, one India's luxury cars of the 1980s will be relauched in India. Hindustan Motors on Tuesday said it has agreed to sell its 'Contessa' brand to SG Corporate Mobility Pvt Ltd for an undisclosed sum.

CK Birla Group owned Hindustan Motors has executed a brand transfer agreement with SG Corporate Mobility Pvt Ltd on June 16, 2022 for the transfer of the Contessa brand, including the trademarks having application number and certain related rights of the brand, Hindustan Motors said in a regulatory filing. The transfer of the brand shall be effective upon fulfilment of the terms and conditions as prescribed in the agreement, it added.

Positioned above Hindustan Motors' then popular model Ambassador, Contessa was a premium sedan sold in Indian market during the 1980s till early 2000s.

While it succeeded in creating a



mark for itself in the market, the entry of players like Maruti Suzuki, Hyundai, Ford and others in the Indian market posed a stiff challenge to the brand, which it could not withstand and led to its phasing out.

The competition from global players also hit Hindustan Motors badly, which

has shut its manufacturing unit at Uttarpara in West Bengal since 2014 and stopped production of the Ambassador car as well. The Ambassador brand was then acquired by French automaker PSA Groupe (now part of Stellantis) for Rs 80 crore in February 2017.

What makes Essar steel sector's comeback kid

NEW DELHI, JUNE 21:Apart from being the most successful cases under the IBC, Bhushan Steel and Essar Steel are among the best steel assets in the country.

They also ended up helping their lenders get back a significant chunk of the money while allowing Tata Steel to consolidate its position and giving the ArcelorMittal and Nippon Steel — a strong foothold in India.

A significant contrast was the pace at which these two cases were resolved under the bankruptcy code.

In the annals of the Insolvency and Bankruptcy Code (IBC), Essar Steel may go down in history as the most noticeable resolution with the world's largest steelmaker, ArcelorMittal, and the incumbent, Ruia family, locked in an intense battle spanning more than two years and ultimately resulting in full recovery of the principal amount

for the financial creditors.

The \$5.7-billion acquisition that closed after an 865-day-long saga was the largest private sector transaction in India in 2019 and the second-largest steel transaction globally that year.

But the real cherry on top was the entry of two of the world's leading steelmakers - ArcelorMittal and Nippon Steel - in India, setting an ambitious target of 300-million tonne (mt) steel capacity by 2030-31.

Making the acquisition happen wasn't easy though.

With crude steel capacity of 9.6 mt, Essar Steel was one of the largest steel assets on the Reserve Bank of India's first list of non-performing assets to be resolved under the nascent IBC and its resolution turned out to be a legal minefield for all stakeholders - bidders, lenders, et al.

Essar Steel was admitted for insolvency proceedings in August 2017.

Seven expressions of interest were submitted: Tata Steel, Vedanta, Steel Authority of India, Nippon Steel, Nu-Metal, and a fund.

But it ended up with two resolution plans - ArcelorMittal India and Numetal - in the first round.

The process got complicated after the government amended IBC and inserted Section 29A, preventing defaulting promoters from submitting resolution plans without paying overdues.

"Documentary compliance to 29A was a challenge. It made the administrative load much higher," recalls

nised through the resolution process on account of global operations of ArcelorMittal, Numetal - and their partners Nippon Steel, Russia's VTB Group - and Vedanta through the process.

Round One hit a roadblock when defaulting firms – Uttam Galva Steels and KSS Petron - with links to ArcelorMittal and Lakshmi Niwas Mittal popped up.

Although backed by VTB, Numetal stumbled on its links with the promoter family (25 per cent held by a trust having Ravi Ruia's son Rewant as trustee).

That prompted the committee of creditors to disqualify both Arcelor and NuMetal's bids, saying the promoters were tied to companies that were bank loan defaulters, and hence, ineligible.

A second round of bids followed, with more heavyweights tossing their hats into the ring.

JSW joined Numetal, while Vedanta entered the fray as a third bidder. Arcelor, was joined by Nippon, in its

All through, the battle for Essar kept flitting in and out of courtrooms, hairsplitting different aspects of the Code, reaching up to the Supreme Court on more than one count.

"Resolution of Essar Steel took time primarily due to litigation.

"But it was one of the best assets and in the end, lenders recovered the entire principal amount," says Pallav Mohapatra, MD and chief executive officer (CEO), Asset Reconstruction Com-

83 per cent of Rs 49,473 crore admitted claims in Essar Steel. Not just that, Arcelor had to pay dues on account of Uttam Galva and KSS Petron, amounting to Rs 7,469 crore to financial creditors of the companies to become eligible for the bidding of Essar Steel.

It's been two and a half years since Arcelor and Nippon completed the acquisition of Essar Steel.

The 60:40 joint venture (JV) - in which Arcelor holds 60 per cent posted record profits on the back of a strong steel cycle. In the January-March quarter of 2021-22, it was ArcelorMittal's most profitable JV, with earnings before interest, tax, depreciation, and amortisation of \$470 million (Rs 3,568 crore; Rs 75.91 for \$1, based on exchange rate as on March 31, 2021).

With a firm foothold in India - that has been long in the making – the global steelmakers are charting aggressive growth plans.

"Since completing the acquisition, we have activated a targeted capital expenditure plan, underpinned by ArcelorMittal and Nippon Steel's global steel industry expertise, operational strengths, commitment to safe, sustainable steelmaking, and industryleading research and development," says Dilip Oommen, CEO, AM/NS India.

In the works is the expansion of the flagship plant at Hazira, Gujarat, to 18 mt. In Odisha, a 12 mt plant at a cost of Rs 50,000 crore is also planned.

Mutual funds allowed to invest in international stocks

NEW DELHI, JUNE 21: Capital markets regulator Sebi has permitted mutual funds to again invest in foreign stocks within the aggregate mandated limit of \$7 billion for the industry.

This came in the wake of a major correction in global markets that brought down the valuation of international stocks.

In January, Sebi had asked

mutual fund houses to stop taking fresh subscriptions in schemes investing in overseas stocks.

The directive to stop subscription was mainly on account of the mutual fund industry crossing the mandated limit of \$7 billion for overseas investments.

The recent meltdown in global stocks reduced the cumulative value of invest-

ments made by all the mutual fund houses together. "Mutual fund schemes may resume subscriptions

and make investments in overseas funds/securities up to the headroom available without breaching the overseas investment limits as of end-of-day of February 1, 2022, at the mutual fund level," Sebi said in a communication sent to Amfi on Fri-

day.Also, the regulator has asked Association of Mutual Funds in India (Amfi) to ensure that the total utilisation of the overseas limit by each AMC or mutual fund remains capped at the February level.

The regulator's approval came after Amfi made a request to Sebi for reviewing investment in overseas securities by mutual funds.

NEW DELHI, JUNE 21: Visa delays have perturbed Indian visitors this summer. But a solution could be in sight soon, as embassies gear up to address the challenges caused by a spike in applications and staff shortages.

While the British High Commission has said it is working urgently to reduce the current visa processing time, the German Embassy has introduced extra shifts to process more visas.

However, appointments with the latter are fully booked till August-end due to high volumes. Processing of standard

UK visitor visas is taking an average of six weeks with increasing demand due to the end of travel restrictions. The UK is also prioritising Ukraine visa scheme appli-

cations in response to the humanitarian crisis caused by the Russian invasion.

"Indian students make up one of the UK's largest groups of international students, and Indian professionals are the top nationality

in the skilled visa category. "This is why the UK has its largest network of visa application centres globally in India and we are continuing to process priority and super-priority visit visa service here — despite it being paused elsewhere.

"We are working urgently to reduce the current processing time as quickly as possible," the British High Commission said in a statement.

"As a result, we are experiencing high volumes of visa applications coupled with limited appointment availability and stretched processing timelines.

"On an average, VFS Global is receiving approximately 20,000 applications from India in a day, which is close to the volumes recorded during the pre-pandemic peak season," he said.

On Friday, the Netherlands embassy in Delhi tweeted that due to heavy demand priority appointments can be facilitated for political, economic or humanitarian interests.

Other requests for earlier appointments will not be facilitated until further notice, it said.Last week, the Outbound Tour Operators Association of India flagged concerns faced by Indian tourists with embassies and consulates of various European countries in Delhi.

This includes a long wait for visa appointments and 4-5 weeks of further wait to get their passports back.

"The outbound agents are losing revenue and clients because of visa delays and we would humbly request the consulates to look into the problem on a priority basis and take immediate action," said association president Riaz Munshi.

Civil jury finds Bill Cosby sexually abused teenager in 1975

urors at a civil trial found Tuesday that Bill Cosby sexually abused a 16-year-old girl at the Playboy Mansion in 1975.

The Los Angeles County jury delivered the verdict in favour of Judy Huth, who is now 64, and awarded her USD 500,000. Jurors found that Cosby intentionally caused harmful sexual contact with Huth, that he reasonably believed she was under 18, and that his conduct was driven by unnatural or abnormal sexual interest in a minor.

The jurors' decision is a major legal defeat for the 84-year-old entertainer once hailed as America's dad. It comes nearly a year after his Pennsylvania criminal conviction for sexual assault was thrown out and he was freed from prison. Huth's lawsuit was one of the last remaining legal claims against him after his insurer settled many others against his will.

Cosby did not attend the trial or testify in person, but short clips from 2015 video deposition were played for jurors, in which he denied any sexual contact with Huth. He continues to deny the allegation through his attorney and publicist.

Jurors had already reached conclusions on nearly every question on their verdict form, including whether Cosby abused Huth and whether she deserved damages, after two days of deliberations on Friday. But the jury foreperson could not serve further because of a personal commitment, and the panel had to start deliberating from scratch with an alternate juror on Monday. Cosby's attorneys agreed that Cosby met Huth and her high school friend on a Southern California film set in April of 1975, then took them to the Playboy Mansion a few days later.

Huth testified that in a bedroom adjacent to a game room where the three had been hanging out, Cosby attempted to put his hand down her pants, then exposed himself and forced her to perform a sex act.

Huth filed her lawsuit in 2014, saying that her son turning 15 the age she initially remembered being when she went to the mansion and a wave of other women accusing Cosby of similar acts brought fresh trauma over what she had been through as a teenager.

Huth's attorney Nathan Goldberg told the jury of nine women and three men during closing arguments Wednesday that my client deserves to have Mr Cosby held accountable for what he did.



Grey hair causes and treatment: Expert shares insights

From race to ethnicity to oxidative stress, here are a few causes of premature greying of hair, as pointed out by the expert. Know all about it here.

Greying hair can be a serious issue. When premature greying of hair starts to happen, it can lead to stress and anxiety in people. According to experts, the human body consists of hair follicles, which line the skin cells. These follicles consist of pigment cells known as melanin. These cells give the hair its colour. But over time, these hair follicles can lose pigment, resulting in white hair. Speaking to HT Lifestyle, Dr. Anup Dhir, senior consultant, Apollo Hospital and ex-president, Indian Association of Aesthetic Plastic Surgeons, said, "Any deficiencies of vitamin B-6, B-12, biotin, vitamin D, or vitamin E can lead to premature greying. A 2016 study reported in the International Journal of Trichology looked to factors related to premature greying in young Indians Trusted Source under 25 years of age. Serum ferritin, which stores iron in the body, vitamin B-12, and the good cholesterol HDL-C were all low in those with premature hair greying.'

He further noted down the causes of greying hair and the possible treatment options available. Take a look:

Causes: Genetics: Sometimes genetics play an important role in a person's possibility



of greying hair and how it can affect age them.

Race and ethnicity: Dr Anup Dhir said, "According to the same 2013 study, premature greying in white people can begin as early as 20 years old, whereas it can begin as early as 25 years old in Asians and 30 years in African-Americans."

Oxidative stress: The doctor pointed out that beside genetics and race, oxidative stress can play a huge role in premature greying of hair.

Medical conditions: Some medical conditions like thyroid dysfunction and autoimmune diseases may increase a person's risk for greying early.

Multivitamin supplements for hair growth help arrest thinning and dam-

Treatment:Dietary changes: Premature greying can be reversed in some cases with the appropriate diagnosis and treatment. A well-balanced diet and regular hair care could also help. Antioxidant-rich foods including fresh fruits and vegetables, green tea, olive oil, fish, etc. Should be included in the diet. Curry leaves, bhringraj and amla can also help. The use of ridge gourd oil on a regular basis can help to prevent hair from going white.

Lifestyle changes: The doctor recommended that reducing or stopping smoking and consuming more anti-oxidants can help in reducing oxidative stress. This can further help in slowing or reducing greying hair.

Feeling of detachment after trauma has worse impact on mental health: Study

The study, which was conducted under the direction of McLean Hospital researchers and the findings of the research were published in the journal American Journal of Psychiatry'.

The presence of dissociation, a profound sense of detachment from one's sense of self or surroundings may indicate a high risk of developing severe post-traumatic stress disorder, anxiety, physical pain, depression, and social impairment for people who have experienced trauma, according to findings from the largest prospective study of its kind.

The study, which was conducted under the direction of McLean Hospital researchers and the findings of the research were published in the journal 'American Journal of Psychiatry'.

"Dissociation may help someone cope in the aftermath of trauma by providing some psychological distance from the experience, but at a high cost--dissociation is often linked with more severe psychiatric symptoms," said lead author Lauren A. M. Lebois, PhD, director of the Dissociative Disorders and Trauma Research Program at McLean Hospital and an assistant professor in psychiatry at Harvard Medical School.



"Despite this, dissociative symptoms remain under-studied and under-diagnosed due to a relative lack of understanding in medical and clinical practice."

To provide insights, Lebois and her colleagues examined information from the Advancing Understanding of RecOvery afteR traumA (AURORA) Study. The data pertained to 1,464 adults treated at 22 different emergency departments across the United States who reported whether they experienced a severe type of dissociation called derealization. Also,145 of the patients underwent brain imaging during an emotional task. Three months later, researchers collected follow-up reports of post-traumatic stress, depression, pain, anxiety symptoms, and functional impairment.

to develop the neurological disease known as "post-encephalic parkinsonism" after the 1918 influenza pan-

demic, they said.

The study, published in the journal Movement Disorders, found that the-SARS-CoV-2virus could raise the brain's susceptibility to a toxin that causes the death of nerve cells seen in Parkinson's disease.

"Parkinson's is a rare disease that affects 2 per cent of the population above 55 years, so the increase in risk is not necessarily a cause for panic," said study first author Richard Smeyne, from Thomas Jefferson University, US.

"But understanding how coronavirus impacts the brain can help us prepare for the long-term consequences of this pandemic," Smeyne said.

The study expands on prior findings from the Smeyne lab indicating that viruses can increase the suscepti-



ment. The latest study employed mice

employed mice that were genetically altered to express the human ACE-2 receptor, which the SARS-CoV-2 virus utilises to get ac-

cess to the cells in our airways.

These mice were infected with SARS-CoV-2 and then allowed to recover, the researchers said.

The dosage used in this research corresponds to a mild COVID-19 infection in people, with around 80 per cent of infected mice surviving, they said.

Thirty-eight days after the surviving mice had recovered, one group was given a modest dosage of MPTP that would not ordinarily trigger neuron loss.

The control group was given saline. The animals were sacrificed and their brains were examined two weeks later.

The researchers found that COVID-19 infection alone had no impact on dopaminergic neurons in the basal ganglia. health. Infertility affects about one in every 6-to 7 couples and is treatable only in a few cases but only up to a few extents.

In an interview with HT Lifestyle, Dr Sanjay Kalra, Endocrinologist and Expert panel at Kindly, shared a few tips to help men optimise their sexual and reproductive function. These include -

1. Resolve stress-related issues: Stress and anxiety contribute to sexual problems and men must address such issues to minimise the impact on their sperm quality as well as sexual desire.

2. Add antioxidants to your diet: Oxidative stress, caused due to factors like pollution, cigarette smoke, and a diet high in sugar and fat, can have a negative impact on sperm production and quality. Antioxidants can help address oxidative stress and free radicals, restoring semen health. Foods like leafy greens, berries, citrus fruits, olives, and tomatoes contain antioxidants that can help.

3. Support your diet with supplements: It is important to bridge nutritional gaps with supplements such as Coenzyme – 10 which has shown a significant increase in sperm motility, count and improvement in fertility rate. You can also add lemon to your diet, which keeps the male dysfunction and distress away,

4. Avoid smoking and excessive drink-

ing: Studies on smoking and semen quality found that smoking affects many aspects of sperm health, including decreased sperm counts, decreased sperm motility (the swimming ability of the sperm), and sperm shape. A study of people with alcohol use disorder found that only 12% of the men had completely normal sperm counts and health, compared to 37% of non-smokers and nonalcoholics.

5. An overall healthy lifestyle: A healthy diet, physical activity, stress management, and sleep pattern, help improve sexual desire and also sperm quality.

Adding to the list of tips on how men can uplift their fertility, Dr Saumya Tripathi (MD), Demat Consultant, suggested simply avoiding these 5 ordinary habits in their lifestyle:

1. Watch your weight (obesity) - Carrying some extra kilos is always a risk for infertile males. Whether you are underweight or overweight, it might affect your testosterone levels in the future and can alter the structure of germ cells.

2. Reduce alcohol consumption - Alcohol directly affects men's fertility. It reduces libido, and lower down s testosterone levels which in return affects the quality of the sperm. So don't take it beyond your capacity.

3. Smoking - To all those who smoke, go and check your sperm count. A nonsmoker will always have more sperm counts than a smoker. Smoking also causes erectile dysfunction and premature ejaculation in men.

4. Self medication/drug abuse - Using medicines without prescription or without consulting a doctor can be hazardous. There are certain drugs that have a negative impact on men or side effects like it might reduce the production of sperm.

5. Stress and lifestyle - Most men are facing issues like sedentary lifestyle, no exercise, work stress, junk food and lack of sleep when all of these unhealthy habits affect the general well-being of the patient, thereby affecting his sexual health and fertility.

Male reproductive health should not be viewed from a man-only prism. It should be viewed from a couple-centric lens, one must ensure not only male and female health but also good communication and interaction between both partners.

Do optimists really live longer? Here's what the research says

o you tend to see the glass as half full, rather than half empty? Are you always looking on the bright side of life? If so, you may be surprised to learn that this tendency could actually be good for your health.

A number of studies have shown that optimists enjoy higher levels of wellbeing, better sleep, lower stress and even better cardiovascular health and immune function. And now, a recent study has shown that being an optimist is linked to longer life.

To conduct their study, researchers tracked the lifespan of nearly

160,000 women aged between 50 to 79 for a period of 26 years. At the beginning of the study, the women completed a self-report measure of optimism. Women with the highest scores on the measure were categorised as optimists. Those with the lowest scores were considered pessimists.

Then, in 2019, the researchers followed up with the participants who were still living. They also looked at the lifespan of participants who had died. What they found was that those who had the highest levels of optimism were more likely to live longer. More importantly, the optimists were also more likely than those who were pessimists to live into their nineties.

Researchers refer to this as exceptional longevity, considering the average lifespan for women is about 83 years in developed countries.

What makes these findings especially impressive is that the results remained even after accounting for other factors known to predict a long life including education level and economic status, ethnicity, and whether a person suffered from depression or other chronic health conditions.
