which right was snached by LG.adminstration.I n recent years, the revocation of bans on employee protests and strikes has become a significant milestone for labor rights globally. The ability of workers to organize and voice their grievances is fundamental in any democracy, and restrictions on such actions have long been a point of contention between governments, businesses, and labor groups.

Historically, many countries and companies imposed bans on employee protests and strikes, citing the need for productivity, public safety, or national security. In some cases, these bans were implemented during periods of political instability or economic crisis, where governments feared that labor unrest could exacerbate national problems. However, these restrictions often resulted in greater discontent among workers, leading to underground movements and worsening working conditions.

The recent revocation of such bans in several countries has been viewed as a victory for labor rights activists. For example, countries like Tunisia, Chile, and South Korea have made strides in rolling back restrictions on worker protests in various sectors. This shift is seen as part of a broader global trend toward increasing protections for workers, driven by international labor organizations, human rights groups, and growing public support for fair labor practices.

In many of these cases, the decision to lift bans has been influenced by changing economic conditions and political will. Governments are beginning to recognize that employee protests and strikes, when conducted lawfully, can be an essential mechanism for maintaining balance in the labor market. Workers now have greater agency to demand fair wages, safe working environments, and reasonable hours, which has the potential to reduce exploitation and improve productivity in the long run.

Murmu "Groundwater is not only getting pol-luted but also depleting. This is a seri-ous concern," the president said while conferring the National Water Awards on Tuesday.

Murmu emphasised the role of the state governments in water manage-ment, praising the Ministry of Jal Shakti and minister C R Patil for their dedication to conservation.

The president lauded the winners of the National Water Awards for their ef-forts and urged that their best practices be shared widely.

The awards, organised by the Depart-ment of Water Resources under the Ministry of Jal Shakti, recognised efforts across nine categories, with Odisha securing the top spot for Best State, followed by Uttar Pradesh while Gujarat and Puducherry were joint third place.

The National Water Awards started in 2018 to promote water conservation in line with the government's vision of a 'Jal Samridh Bharat' (water-sufficient India). (PTI)

sion. LG Sinha said the panchayat elections should have been held earlier, but the administration is awaiting the report on reservations for Other Backward Classes (OBCs). "If the elections had been held with-out this (report), the court would have stopped them. Therefore, we had to go to Parliament to amend this. Preparations (for polls) are certainly com-plete," he said. Sinha said as soon as the report of the backward classes commission is received, and based on the availability of security forces and weather conditions, local bodies elections will be held. The Jammu and Kashmir government has set up a commission to recommend the number of seats reserved for Other Backward Classes (OBCs) in local bodies.

The module is in continuous touch with handlers and members of terrorist organisations across the border and is learnt to be using encrypted internet messaging platforms, besides other software applications, the officials said.

The counter-intelligence wing said the investigation is aimed at disman-tling the terror ecosystem in the Union territory by not only identifying over-ground workers supporting and abet-ting terrorism but also by ensuring legal action as envisaged by the law.

"Once a curtailment schedule is announced, we must ensure it is followed rigorously, otherwise our credibility is at stake. We need to re-examine the schedule, considering the resources currently available to us and what we anticipate in the near future," the Chief Minister stressed.

He further reiterated the importance of strict compliance with the schedule once it is finalized. "I will personally monitor the situation on a daily basis, especially as winter sets in," he said.

The Chief Minister also emphasized that the curtailment schedule must remain fair and equitable, without any influence from political or other exter-nal forces. "There must be no interfer-ence from those with political or other forms of influence. The schedule should be transparent and fair for all," he added.

In an effort to incentivize efficiency, the Chief Minister suggested that areas demonstrating better management of electricity usage should be rewarded. "Reward those areas that are more efficient in managing curtailment. The schedule should be localized and reflect performance, particularly in ar-eas where AT&C losses are lower," he advised.

Earlier, the HED Minister was given a detailed presentation wherein she was informed about the major digital interventions in

higher education, component wise Capex Budget 2024-25, National Education Policy, industry- academia collaboration, status of posts among other things. She also reviewed the hostel facility for students in colleges and said that work on all the under construction hostels should be expedited. Shankaracharya calls for declaration of 'Gau' as 'Rashtra Mata'

JAMMU RISING JAMMU, OCT 22 Jyotishpeethadhishwar

Shankaracharya Swami Avimukteshwaranand Saraswati '1008' ji, during his two day visit to Jammu district, led the installation of the Gau Dhwaj and presided over a Gau Mahasabha, as part of his ongoing 'Gau Dhwaj Sthapana Bharat Yatra'.

Upon his arrival to the winter capital of Jammu and Kashmir on Monday, a traditional 'Paduka Poojan' ceremony was held. This was followed by a visit to the Bawe Wali Mata temple, where he paid obeisance to the revered deity of Jammu.

On Tuesday, Shankaracharya Ji inaugurated Ranbir Library at ancient Raghunath Temple, and performed the installation of the Gau Dhwaj at a Gaushala in Lower Gadigarh, Jammu, alongside Param GauBhakt Pujya Gopal Mani Ji, who spearheads the Gau Pratishtha Andolan, Nirmal Swaroopji Brahmachari and Devendra Pandey Ji, President, Hindu Mahasabha. The event saw the participation of hundreds of devotees, members of civil society, and local residents.

In his address at the Gau Mahasabha. Shankaracharya Ji elaborated on the significance of the Gau in Sanatan Dharma. He emphasized that the First Revolt of Indian Independence in 1857 was ignited by the issue of greased cartridges made from cow fat. Expressing concern over the rising incidents of cow slaughter in India, especially in recent years, causing the drastic decline in the population of sacred cows, he called upon the nation to remove the sin and shame of cow slaughter from Indian soil and to work toward declaring the Gau as Rashtra Mata (Mother of the Nation).

He remarked, "Those who view the



cow merely as a source of milk or meat, fail to understand its divine significance. Serving cows is akin to attaining divine blessings, as the Lord Himself says, 'Gavam Madhye Vasaamyaham', meaning 'I always reside among cows.' The cow is integral to our rituals, and serving the cow is equivalent to serving our 33 crore deities. In fact, the first bread of every day is traditionally offered to the Gau, which embodies these divine entities. Without the Gau, all religious rituals and worship are incomplete and meaningless."

Shankaracharya Ji also recounted the ancient tale of King Dilip, who, heartbroken due to his lack of heirs, followed the advice of Guru Vashistha and served a Gau for 40 days. As a result, he was blessed with a son, Aja, from whose lineage Bhagwan Ram, the epitome of dharma, was born. Bhagwan Ram is worshipped particularly at the famed Raghunath temples of Jammu.

In his concluding remarks, Shankaracharya Ji praised the efforts of Gopalmani Ji for his unwavering dedication to the cause of cow protection. He

urged the gathering to extend their support to the movement and further strengthen the campaign.

The Gau Dhwaj Sthapana Bharat Yatra, which commenced on September 22, 2024, from Ayodhya Dham, aims to have the Gau officially declared as the Rashtra Mata. The journey began after a sacred circumambulation of Ramkot and has since traveled across various states and Union Territories, installing the Gau Dhwaj and raising awareness about cow protection.

A significant milestone in this movement was achieved when the Chief Minister of Maharashtra, Shri Eknath Shinde, under the guidance of Shankaracharya Ji, declared the indigenous Rama cow as the Rajya Mata (Mother of the State). The cabinet resolution formalizing this declaration was ceremonially handed over to Shankaracharya Ji Maharaj.

Following the event in Jammu, Shankaracharya Ji's Yatra will continue toward Shimla, Himachal Pradesh, as part of the next leg of this historic journey.

Jammu Kashmir Teachers Association meets **Chief Minister Omar Abdullah**

A high-level delegation from the Jammu and Kashmir Teachers Association (JKTA), led by its UT President Bhupinder Singh, met with the Hon'ble Chief Minister Omar Abdullah at the Civil Secretariat in Srinagar. The delegation extended their heartfelt congratulations to the Chief Minister on his appointment as the leader of the Union Territory of Jammu and Kashmir. During the meeting, the delegation engaged in a comprehensive discussion regarding the critical issues affecting the employees and officers of the School Education Department, emphasizing the need for immediate reforms and improvements in the education sector.

The meeting centered around several key demands, starting with the longoverdue Departmental Promotion Committee (DPC) process, which has been stalled since 2014. The delegation strongly urged the Chief Minister to expedite the DPCs, particularly for teachers awaiting promotions to master roles. Such promotions, the delegation emphasized, are crucial for the profes-

sults in an unequal distribution of teaching staff, has been a long-standing concern for the association. Rural areas, in particular, face acute shortages of teachers, while urban schools tend to be overstaffed. To remedy this imbalance, the JKTA proposed that future transfer drives take proximity to teachers' residences into account, reducing disruptions to the academic calendar and improving teacher satisfaction.

A major point of contention has been the lack of a unified attendance system for teachers. Currently, teachers are burdened with multiple systems for marking attendance, which detracts from their primary responsibility of teaching. The delegation stressed that a single, streamlined attendance system would significantly enhance efficiency and free up valuable time for classroom instruction.

The JKTA also addressed the urgent need for a fair and transparent transfer policy for Rehber-e-Taleem (RET) teachers, particularly for female teachers, allowing for intra-district transfers based on family circumstances. They also proposed a Zonal-level transfer policy for male teachers to ensure a more equitable distribution of teaching staff across different regions. One of the most pressing concerns raised by the delegation was the plight of Educational Volunteers (EVs), who have contributed significantly to the education sector but remain in precarious

employment conditions. The JKTA called for the immediate regularization of EVs, ensuring job security for these valuable contributors to the education system

In addition to these demands, the delegation highlighted the growing administrative burdens placed on teachers, which detract from their ability to focus on teaching and student development. The association recommended that ministerial staff be provided to high schools and higher secondary schools, allowing teachers to concentrate on their core responsibilities.

To ensure better accountability and transparency, the delegation proposed the establishment of a time-bound grievance redressal mechanism within the Zonal and Chief Education Offices. Such a system would ensure that teachers' concerns are addressed efficiently and promptly, without unnecessary delays.

The promotion and preservation of cultural heritage through education was also a key point of discussion. The JKTA strongly advocated for the inclusion of indigenous languages such as Bhaderwahi Bhalesi Padri Sarazi and Pogali in the school curriculum. Introducing these languages at the primary level would help preserve the linguistic heritage of the region and foster a sense of cultural identity among students.



EDITORIAL

Indian Foreign Minister S. Jaishankar's recent visit to Pakistan for the Shanghai Cooperation **Organisation (SCO) sum**mit in October 2024 marked a rare diplomatic engagement between the two countries, as tensions have remained high since the revocation of Kashmir's autonomy by India in 2019. Although no bilateral talks were held, the visit has sparked cautious optimism about potential improvements in the relationship.

Jaishankar used the SCO platform to reinforce India's stance on terrorism, extremism, and the need for cooperation based on mutual respect. His message, though not directly naming Pakistan, was clear in calling for introspection on the use of terrorism as a state policy, a longstanding Indian concern regarding Pakistan. At the same time, Jaishankar emphasized importance the of regional cooperation in areas such as trade and connectivity, which could greatly benefit South Asia if handled with mutual respect for sovereignty. Former Pakistani Prime **Minister Nawaz Sharif** expressed hope that this visit could signal a fresh start, urging both nations to focus on long-term peace and collaboration on critical issues like energy security and climate change. However, despite these hopeful gestures, deep mistrust remains, and both sides acknowledge that it will take sustained effort to bridge the gap in relations.

Protests mark a new era of awakening

At a time when the country's political landscape has left successive generations disillusioned, eroding faith in the principles of fairness and justice, the "Never-Seen-Youthquake" Before in Kolkata stands as a beacon of hope. The gruesome incident at RG Kar Medical College and Hospital served as the tipping point, unmasking the deep-rooted nexus of politicians, officials, and antisocial forces. In response, a new generation is rising, asserting its voice with unwavering resolve across Kolkata and beyond, demanding accountability and change. The unrelenting protests led by the community of junior doctors, strongly supported by various sections of society including the differentlyabled and senior citizens reflect a powerful collective desire to dismantle the entrenched political structures that uphold the unjust systems they stand to inherit. These protests signify a refusal to accept a legacy of unfairness, marking the rise of a movement determined to reshape the future with and integrity fairness. Primarily, the vouth-led protests continued for several weeks, drawing widespread attention both nationally and globally. Eloquent, principled, and resolute, the protesters actions and demands were beyond reproach. In a striking display of creativity and courage, the protesting doc-tors held aloft the symbolic emblems of their movement plastic replicas of the human spine, human brain, and brooms embodying the fearless, selfless spirit of a cause destined to be remembered as a defining chapter in the history of speaking truth to power and challenging the illusion of invulnerability maintained by those ensconced in their self-perceived ivory towers. In a rare display of collective concern and unity, Kolkata witnessed truly heartwarming scenes: poor daily wage earners and rickshaw pullers joining the protest, roadside tea vendors offering free tea, small eatery owners providing food at no charge, delivery personnel from food service apps dis-

tributing bottled water, and ordinary citizens including septuagenarians bringing provisions from distant places to support the protesting junior doctors.

Kolkata reminded the entire country, and perhaps the world, that even in an era dominated by the attention economy and transactional exchanges, there are still those who genuinely uphold the values of shared humanity and solidarity. The unique strength of the protest lies in its ability to push the political class to the periphery, rendering them almost irrelevant a remarkable achievement in a state that has long been politically charged yet largely insensitive and anesthetized. If the populace had been more aware and engaged, the Left Front would not have maintained power for 34 years, nor would the Trinamool Congress continue to hold sway.

Now, a rising consciousness across society has ignited widespread outrage against those entrusted with governance, those who have either enabled or directly participated in institutionalized corruption and misconduct, allowing it to flourish in an organized and systemic manner. This widespread frustration is not merely a reaction to the brutal rape and murder of a young doctor but an enduring and deep-seated anger that persists in defiance of the prevailing political malaise. Until just a few weeks ago, the Trinamool Congress's grip on power in

West Bengal seemed unquestionable, unshakable, and undeniable. Youth-led protests have long been a powerful catalyst for social change, and the scale of the demonstrations in Kolkata and beyond is a powerful reminder that the youth serve as the conscience of the nation.

What sets these protests apart is their apolitical stance, illustrating that regardless of how firmly a government may seem entrenched in power, move-ments grounded in just causes can reveal even the most resilient regimes as surprisingly vulnerable, as recent events have clearly shown. People everywhere are anxiously awaiting the outcome.

Given the history of questionable investigations, the entrenched methods of the system, and the clear lack of political will, it is increasingly evident that public inquiries alone are insufficient. Their outcomes frequently veer off course, resulting in endless cvcles of blameshifting that enable politicians, perpetrators, and regulators to evade accountability. The country has witnessed how these delays often serve a hidden agenda to diffuse guilt, shift blame beyond reach, and allow the responsible parties to disappear from view. Yet, as always, there remains a glimmer of hope that this time, justice will be delivered swiftly measured in days, not years.

Like any crisis, the current protests present an opportunity amidst pervasive poor governance: a chance to grasp the extent of the decay that has infiltrated every facet of society, to acknowledge and address the genuine concerns and earnestness of the people, and to recognize the urgency of embracing our collective responsibility as citizens. Looking towards the future, our social awareness must strengthen, as the weaker it is, the more fertile the ground becomes for the political class to evade accountability. We must look within, confront our own deficiencies, and hold a mirror to the areas where we fall short. The government's mandate is clear: tackle corruption headon, uphold fairness, and dismantle the pervasive nexus at every level.

However, achieving these goals will require more than mere rhetoric; it demands genuine, sustained action and accountability. Finally, to our junior doctors, we extend a salute for enduring the scorching sun and torrential rain, standing resolute in their commitment - a powerful lesson for us all, rooted in principles we seldom acknowledge or appreciate. This lesson transcends generations, cultures, and geographical sites of resistance.

Refreshed Australia eager to make KL Rahul vs Sarfaraz: India's amends against India

New Delhi

Australia captain Pat Cummins is determined to 'make amends' against India in the upcoming five-match Test series, as he aims to reclaim the Border-Gavaskar Trophy for the first time in over a decade.

The two teams will face off in a fivematch series starting November 22 in Perth. India will come into the contest with the Border-Gavaskar Trophy firmly in their grasp, having held it for nearly a decade and winning two consecutive series in Australia.

"We've had a bit of a break, so I'm excited for the five match Test series. Excited to get into it," the 31-year-old told Star Sports.

"We haven't had a lot of luck against India over the last few Test series, but we always pride ourselves on playing well here in Australia.'

India had won the last Border-Gavaskar series in Australia 2-1 in 2020-21. Rishabh Pant's second innings heroics of unbeaten 89 in the final Test saw India chase down 328 to seal a historic three-wicket win at the Gabba.

It came after enduring a humiliating collapse in the first Test in Adelaide, where they were shot out for 36 -- their lowest-ever Test score.

The last two series were a long time ago, so I think we've gotten over it. But we have really high expectations when we play Test cricket in Australia," Cummins said.

"I think that's from the fans and the media as well. So anytime we don't win down here, of course, you look at those series a bit more closely.

"The last series, in particular, was a really tough one. It went right down to that last session at the Gabba, and un-



fortunately, we couldn't pull it off. A lot of the guys in the team are the same as those who played in that series, and we're here to make amends," he added. Cummins identified Rishabh Pant as India's 'X-factor' but stressed that his team is focused on rectifying the setbacks from four consecutive series defeats to India.

"Rishabh had a great series here in Australia last time. He's always a bit of that X-factor in the middle order," he said.

"You never quite know what you're going to get, which is exciting, even as the opposition. And he's always got something to say behind the stumps -he's very funny, makes me laugh."

Asked how the Australian bowling line-up rates talented youngsters like Shubman Gill and Yashasvi Jaiswal, Cummins said: "I've played a little bit against Shubman. Haven't seen a lot of Jaiswal, just a bit in the IPL.

"But they both look like young guys who've scored a fair few runs in different formats. We'll get down here and have a good look at them. But yeah, we're still a little while away from the series, so I can't say I've been planning too closely for them yet."

Cummins also rued about missing key all-rounder Cameron Green who has been ruled out for six months after choosing to undergo surgery for a stress fracture in his lower back.

"He's a big loss for us. Not only for his batting, but he's probably the best gully fielder I've ever seen, and a great bowler we need as well, so we're really going to miss him," he said.

Australia will face Pakistan in a white-ball series before the much-anticipated Test series against India.

It will be the first Test series between India and Australia comprising five matches since 1992.

middle-order battle heats up NEW DELHI

India assistant coach Ryan ten Doeschate said on Tuesday that middle-order batters KL Rahul and Sarfaraz Khan are locked in a selection battle for the second Test against New Zealand here even though head coach Gautam Gambhir is keen to give the former, a long rope.

With India looking to bounce back from the eight-wicket thrashing at Bengaluru in the opening Test, focus will be on the team combination with Washington Sundar being added to the squad. Shubman Gill and Rishabh Pant are both aiming to shake off injury concerns for the match starting Thursday.

"Yeah, there's no point in sugarcoating it, there's a fight for a spot," ten Doeschate told the media when asked if Rahul and Sarfaraz were battling for a place in the team, here at the MCA Stadium ahead of India's training session.

"Sarfaraz was obviously brilliant in the last Test. I went to KL after the last Test (and) said how many balls do you play at (and) miss at? He didn't play at (and) miss at one ball and that's what tends to happen when you're not getting runs

"There's certainly no concerns about KL, he's batting nicely, he's in a good mental space. But we are certainly going to have to fit seven pieces into six spots for this Test and look at the pitch now and decide what's going to be best for the team," he said.

Sarfaraz scored a second-innings 150 in the Bengaluru game, while Rahul re-



mained off-colour in both essays.

While admitting that it is difficult to keep Rahul out of the equation in the Test format, ten Doeschate said head coach Gautam Gambhir is "keen to" give him a long rope.

"It's not like we're worried about his form. If you go on just the past three months since Gauti has been in here, he's keen to give him (Rahul) as much rope as we can. We have a lot of faith in him," he said.

"But at the same time, it's a very competitive environment, with Sarfaraz getting 150 plus runs (222 not out) in the Irani Trophy final. The decision will be what's best for the team, but we'll certainly back all the guys in," he added.

Pant, who did not keep wickets for a significant part of the opening Test, and Shubman Gill, who missed the match due to stiffness in his neck, are close to attaining their full fitness.

"Rishabh is pretty good. I think Rohit (Sharma) touched on it the other day. He was having a little bit of discomfort at the end range of his movement with the knee. But fingers crossed, he'll be good to keep in the Test as well," he said.

"He (Gill) looks so (available for this Test). He has batted last week in Bangalore, he had a few nets, he's got a little bit of discomfort, but I think he'll be good to go for the Test," he added.

Table tennis, squash and triathlon have also been axed in a bid to limit the cost and streamline logistics given that only four venues will host the entire showpiece. The total number of events at the Games will be nine fewer compared to the 2022 Birmingham edition. "The Games will include 10

30 flights get bomb threats on Monday night

NEW DELHI

As many as 30 domestic and international flights operated by Indian airlines received bomb threats on Monday night, according to sources.

The flights of IndiGo, Vistara and Air India were among those that received the bomb threats, the sources in the know said.

An IndiGo spokesperson on Tuesday said four of its flights on Monday received security-related alerts. They are 6E 164 (Mangaluru to Mumbai), 6E 75, (Ahmedabad to Jeddah), 6E 67 (Hyderabad to Jeddah) and 6E 118 (Lucknow to Pune).

Passengers from these flights disembarked safely, according to four separate statements from the airline.

"We worked closely with the relevant authorities, and standard operating procedures were followed," the spokesperson said about the security alerts related to the four flights.

An Air India spokesperson confirmed that some Air India flights that operated on Monday were subject to security threats received on social media.

"Following the laid down protocols, relevant authorities were immediately alerted, and all security procedures strictly adhered to, as per guidance from the regulatory authorities and security agencies," the spokesperson said in a



statement.

A Vistara spokesperson said a few of its flights that operated on Monday received security threats on social media. "We immediately alerted the relevant authorities and are following all security procedures as directed by them," the spokesperson said in a statement.

In little over a week, more than 120 flights operated by Indian carriers have received bomb threats.

Even though bomb threats are hoaxes, things cannot be taken non-seriously, Civil Aviation Minister K Rammohan Naidu had said on Monday.

Meanwhile, the government is planning legislative actions to deal with bomb threats to airlines, including placing the perpetrators in the no-fly list.

Amendments are being proposed to The Suppression of Unlawful Acts against Safety of Civil Aviation Act (SUASCA), 1982 whereby the perpetrators could be arrested and probe can be initiated without a court order for offences when an aircraft is on the ground. Also, changes are being planned to aircraft security rules to ensure stringent punishment for perpetrators of bomb threats to flights.

A thick layer of smog enveloped Delhi on Tuesday morning as the city's air quality deteriorated to the 'very poor' category with 27 monitoring stations falling in the red zone, the Central Pollution Control Board said.

What's Holding Up Candidate **Lists In Maharashtra?**

NEW DELHI

Assembly elections to the 288-member Maharashtra Vidhan Sabha are by the middle of November

Exuding confidence, Maharashtra Pradesh Congress President Nana Patole said last fortnight: 'All the problems have been solved. The Congress will contest the larger number of seats (in the alliance). We will announce our candidates on Vijayadashami (October 12).'

He was referring to a composite list of candidates of the Maha Vikas Aghadi (MVA), which has the Shiv Sena (Uddhav Balasaheb Thackeray, or UBT) and the Nationalist Congress Party (Sharad Chandra Pawar, or SCP), apart from the Congress and smaller parties as its members.

On October 9, Nationalist Congress Party (NCP) leader and Ajit Pawar associate Praful Patel said the Bharatiya Janata Party-led Mahayuti alliance (comprising the BJP, Shiv Sena, and the NCP along with some smaller parties) would 'announce its first list of 235 candidates on Saturday, October 12'.

Vijayadashami came and went and even a day after that, there is no sign that either alliance is ready with a list of candidates.

The problem can be summed up in one word: Split.

Both alliances have two divided parties

While the Election Commission of India has arbitrated and has ruled on the name and symbol of the split parties, the squabble is over the relative strength of the factions and how this should be judged: Should its pre-split status be respected? Or post-split?

Adding another dimension, Prithviraj Chavan, former Maharashtra CM

and a Congressman, said: "The Congress won the maximum seats in the Lok Sabha polls in Maharashtra, and it will repeat its performance in the assembly polls. The next chief minister of Maharashtra will be from the Congress."

But a chief minister can be elected only if the party contests and wins the largest number of seats. So how will the seats be divided?

"Winnability will be the criterion for distributing tickets," Chavan said.

Winnability is one problem. How will this be judged? On the basis of the pre-split result, or the post-split result, or the Lok Sabha poll result?

Chavan was unwilling to spell out the details.

This is not the only issue. It is also the strike rate. How many seats did parties fight and how many of those did they win?

In the Mahayuti, the nature of the discussions is no different.

Union Home Minister Amit A Shah was in Mumbai to iron out wrinkles and BJP sources say the party will contest around 150 seats, becoming the 'senior' partner in the alliance.

But the BJP would like to use the Eknath Shinde faction of the Sena strategically against its previous party colleagues.

"We want to use a thorn to take out the thorn," said a BJP member from Maharashtra.

So, in Mumbai and its suburbs -wherever the two Sena factions are strong -- the BJP would like to deploy them against each other and keep its own forces in reserve.

Obviously, this is causing resentment in some quarters in the BJP. This is just one example of the size of the problem.

BJP state President Chandrashekhar Bawankule strongly refutes this.

"Like the last elections, this time too, the BJP will contest in more seats in the Vidarbha region while in the rest of the regions there will be proper seat distribution. Hindutva is our main agenda. Ticket distribution will not happen based on caste and community, but merit and the winnability criterion only," he said.

The setback faced by the Congress in Haryana has not helped the situation.

Even before the full result was out, in Maharashtra, SS UBT Spokesperson Priyanka Chaturvedi was on camera, demanding the Congress treat it with more respect.

'The Congress needs to think about its strategy because wherever there is a direct fight with the BJP, the Congress gets weakened,' she said.

Congress spokesman Jairam Ramesh didn't bother to put a gloss on his rebuttal.

'I would like to remind (everyone) that the Congress was the number 1 party in Maharashtra during the Lok Sabha elections. There is a coalition dharma in alliance and any talks should take place between partners and not through the media,' said Ramesh, without naming anyone.

Although he holds the finance portfolio, Ajit Pawar left a cabinet meeting midway and denied he had 'walked out' because of any differences with Chief minister Eknath Shinde.

His clarification gave the game away. He said: 'The cabinet has the right to overrule the finance department.'

The strains are telling as old friends and new enemies face each other in the battlefield.

"16 children", Tamil Nadu Chief Minister M K Stalin said on Monday while referring to a Tamil adage. His comments came just two days after his Andhra Pradesh counterpart N Chandrababu Naidu asked women to have more children to stabilize the population in his state.

Stalin, who was attending a mass marriage event in Chennai, referred to a Tamil saying pathinarum petru peru vazhvu vazhga, meaning acquire 16 different kinds of wealth and lead a prosperous life while talking about the census and delimitation process which will redraw the electoral map of India.

"The Parliament delimitation process may encourage the couples to have many children and give up thoughts of a small family. But whatever be the outcome, provide Tamil names to your children," the CM said after solemnising the marriages of 31 couples at a function held under the aegis of the Hindu Religious and Charitable Endowments department.

There is a concern among southern states that the delimitation process based on population may reduce their representation in Parliament, penalising them for successfully implementing population control measures. In February this year, the Tamil Nadu Assembly also passed a resolution opposing the delimitation process.

Stalin's comments came two days after Naidu said there was a need to manage the population in Andhra Pradesh given there will be an increase in the aging population.

"Till 2047, we will have the demographic dividend, there will be more youngsters. After 2047, there will be more old people, if less than two children are given birth (per woman), then the population will reduce. If you (each woman) give birth to more than two children, then the population will increase," Naidu said on Saturday during a

public meeting in Amaravati.

Noting that the southern state's birth rate has plummeted to 1.6, he feared the continuation of the current situation could lead to a further decline of the birth rate to 1 or lower, where only "old people will be visible in the society".

Stalin said in the past, the elders used to bless newly married couples to acquire 16 kinds of wealth (pathinarum petru peru vazhvu vazhga) including fame, education, lineage, wealth, etc., and not 16 children. Gradually, people have come to believe in raising a small family for prosperity, he said.

"That blessing doesn't mean beget 16 children, now a situation has arisen where people think they should now literally raise 16 children and not a small and prosperous family," Stalin said.

Responding to Naidu's comments, senior YSRCP leader Jupudi Prabhakar Rao questioned the efficacy of the CM's 'vision' of asking people to have fewer number of children about 10 years ago and more now. "What about himself (Naidu). He has only one son and his son (Nara Lokesh) also has only one son. He is a visionary right," Rao told PTI.

Further, the opposition party leader asserted that the people of the state did not follow birth control heeding Naidu's advice, advising the CM to refrain from comparing himself to some erstwhile Chinese leader who had given such successful calls in the past.

AP Congress welcomed Naidu's call for raising the population. Andhra Pradesh Congress Committee (APCC) vice president Kolanukonda Sivaji observed the CM gave such a call keeping the best interests of South India in mind

"Because, under delimitation, Parliament seats in our region (south India) will reduce and they will get added to the northern states. That's why, to overcome this there is no time. So, when the population here increases, our seats will be with us," said Sivaji.

Saving South India's Parliament seats as the correct interpretation of Naidu's call, Sivaji noted the NDA ally did not directly drive home this message but subtly chose the plummeting birthrate ploy to avoid friction with Prime Minister Narendra Modi and the Sangh Parivar.

Private banks leading AI adoption in Brics likely to focus on closer energy banking services, says RBI study

NEW DELHI

Private sector banks in India are taking the lead in the adoption of Artificial Intelligence (AI) in areas like fraud detection, customer segmentation, and chat automation, according to a Reserve Bank of India (RBI) study.


The asset size and capital adequacy ratio are influencing the rate of adoption.

The size and financial health had a positive influence on the banks' focus on AI, reflecting the impact of economies of scale and the availability of investment on technological advancement, notes the study titled 'How Indian Banks are Adopting Artificial Intelligence?'.

Private banks often cater to more financially aware and affluent customers and therefore could see higher potential for leveraging AI-based solutions like customer segmentation, robo-advisory, and robo-wealth management tools to cross-sell or provide other financial services.

Private banks, especially those with a smaller branch network, are also much more likely to adopt AI-based solutions to gain new customers or cross-sell different products, as it represents a more cost-effective solution, it said.

On the other hand, public sector banks (PSBs) already have well-estab-



lished offline channels, especially in rural and semi-urban areas.

However, with the rapid advancements in AI, especially Generative AI and Large Language Models in the last two years, public sector banks also appear to be increasing their usage of AIbased solutions.

AI is expected to have the potential to reduce inefficiencies through automation by minimising errors in human decision-making and by providing cost-effective solutions.

AI is expected to make banking services accessible to the population at the

bottom of the pyramid, the study said. While the integration of AI into banking and finance offers immense opportunities, it also presents challenges such as the possibility of bias, lack of transparency, and issues surrounding the ethical use of data.

The ethical use of data requires an indepth evaluation in view of its implications for the financial sector and the overall economy, the study added.

The 16th Brics Summit beginning Tuesday in Kazan, Russia, is expected to see more focus on creating a sharper energy policy for Brics that ensures closer partnership among members in both energy security and energy transition, official sources said.

Subsequently, Russian President Vladimir Putin had last week emphasized the dominance of Brics countries -- Russia, India, China, and South Africa -- in essential markets such as energy, metals, and food that are critical to ensuring sustainable economic development.

On the NSE, the stock made its debut at Rs 1,934, down 1.32 per cent. Later, in the trade shares of the firm tumbled 5.88 per cent to Rs 1,844.65.

The company's market valuation stood at Rs 152,290.52 crore during the late morning trade.

In traded volume terms, 11.72 lakh shares of the firm were traded at the BSE and 177.84 lakh shares on the NSE.

On Monday, they sold another Rs 2,262 crore (\$270 million) worth of shares, the provisional data provided by the exchanges suggested, taking the selling tally this month to \$10.17 billion.

Before this, the highest FPI outflows took place during the peak of Covid-19 sell-off in March 2020, at \$7.9 billion

The sudden sell-off and the uncertainty around the economic impact of the pandemic had triggered a 23 per cent collapse in the Sensex and the Nifty 50 index back then.

This time, however, despite the record FPI selloff, the Nifty 50 index is down just 4 per cent and the Sensex 3.7 per cent.

Strong inflows from domestic institu-

tional investors (DIIs) mitigated the blow from overseas selling.

In October, DIIs have been net buyers, accumulating shares worth Rs 77.000 crore.

They have bought shares worth Rs 4.1 trillion so far this year.

"No one was expecting China to do anything positive.

"It was a massive underperformer. Foreign investors liked India but did not like its valuations.

"They had to come here because there was nowhere else to go," said Andrew Holland, CEO of Avendus Capital Alternate Strategies.

When China started the massive stimulus first, they had to cover whatever short positions they had, and then they had to get exposure as quickly as possible for fear of missing out.

"The Middle East and higher oil prices affect India.

"The economic data from the US has raised concerns about interests not falling as quickly as investors hoped. And flows are going to go to China as earnings are not great either in India," he added.

China's Hang Seng trades at 9.4 times its one-year forward earnings, while the Shanghai Composite Index trades at 12 times.

In contrast, the Nifty and the Sensex trade at 20.6 and 20.7 times, respectively.

"India's equities are facing triple

negatives: weakening GDP growth, high EPS expectations (17 per cent), and historically the highest multiples (nearly 23x)," pointed out a note by Macquarie last week.

Several large companies missing earnings estimates too has added to the gloom.

The escalating tensions between Israel and Iran have also kept investors worried and guessing about the impact of the conflict on oil prices and global trade.

The sudden sell-off and the uncertainty around the economic impact of the pandemic had triggered a 23 per cent collapse in the Sensex and the Nifty 50 index back then.

This time, however, despite the

record FPI selloff, the Nifty 50 index is down just 4 per cent and the Sensex 3.7 per cent.

Strong inflows from domestic institutional investors (DIIs) mitigated the blow from overseas selling.

In October, DIIs have been net buyers, accumulating shares worth Rs 77,000 crore.

They have bought shares worth Rs 4.1 trillion so far this year.

"No one was expecting China to do anything positive.

"It was a massive underperformer. Foreign investors liked India but did not like its valuations.

"They had to come here because there was nowhere else to go," said Andrew Holland, CEO of Avendus Capital Alternate Strategies.

"When China started the massive stimulus first, they had to cover whatever short positions they had, and then they had to get exposure as quickly as possible for fear of missing out.

"The Middle East and higher oil prices affect India.

"The economic data from the US has raised concerns about interests not falling as quickly as investors hoped And flows are going to go to China as earnings are not great either in India,' he added.

China's Hang Seng trades at 9.4 times its one-year forward earnings. while the Shanghai Composite Index trades at 12 times.

In contrast, the Nifty and the Sensex trade at 20.6 and 20.7 times, respectively.

"India's equities are facing triple negatives: weakening GDP growth, high EPS expectations (17 per cent), and historically the highest multiples (nearly 23x)," pointed out a note by Macquarie last week.

Several large companies missing earnings estimates too has added to the gloom.

The escalating tensions between Israel and Iran have also kept investors worried and guessing about the impact of the conflict on oil prices and global trade.

Raaj Kumar: Bollywood's moody master of the drawn-out, deadly dialogue



Urdu poet Jigar Moradabadi could have never conceived that the opening couplet of his ghazal placing man at the centre of the cos-mos would achieve such fame — but as an iconic Bollywood dialogue per-formed by a rather unlikely hero whose spare frame hero whose spare frame, unconventional looks, and signature diction were, however, offset by an evident aura of over-the-top superi-

ority. "Hamko mita sake ye mein dam nahi/Hamse zamana khud hai zamaane se ham nahi,' declaimed Raaj Kumar, playing an idealistic professor in the academic crime thriller Bulundi' (1981), making the sher his own. It would be added to the list of his trademark, crowd-pleasing, oneliners he regularly delivered over his nearly half-a-century film stint.

In an industry known for idiosyncracies, Raaj Kumar, born Kulbhushan Pandit to a Kashmiri Pandit family on this day (October 8) in Balochistan in 1926 and a Sub-Inspector of police in Bombay's Colaba or Mahim before joining films, was in a league of his own.

Added to his grating and drawn-out but by no means unpleasant style of speaking, prefixed with 'Jaani', was a penchant for his flamboyant outfit, especially white shoes, the way the camera intro-duced him on screen, and clear choices with whom he would work - or not. There was a story that he was offered the role Amitabh Bachchan would go on to

make famous in 'Zanjeer', but turned it down because he could not abide the smell of the oil that the director (Prakash Mehra) used in his hair, or alternatively, he did not like his face!

However, ace filmmaker B. R. Chopra, who brought Raaj Kumar to prominence with his lost-and-found epic Waqt' (1965) and 'Hamraaz' (1967), termed him an "an absolute delight to work with."

"He was totally a director's actor who put in that extra little something which only belongs to the greats. The only little difficulty that takes place is right at the begin-ning. He needed exactly 48 hours to discuss the script with the writers. If he was satisfied with the role, he would sign on immediately. He always needed to be approached properly. He always arrived well prepared always arrived well prepared and was most punctual. When I heard about his prob-lems with other directors, I used to chuckle to myself. They must have allowed themselves to be taken for granted," he wrote in a piece for a film magazine after the actor's demise in 1996. And that was horne out by

And that was borne out by his performances over the years, whether he played a hapless peasant or a debauched nawab or zamindar with skeletons in his closet, a dedicated police officer or a canny gangster, a committed doctor or a resigned patient.

During his stint as a Bombay cop in the 1940s, Raaj Kumar was reportedly urged by his friends to take the plunge into films and he finally agreed. However, sometime in the late 1940s, he is said to have point-blank refused an offer made by the legendary Sobrab Modi who legendary Sohrab Modi, who spotted him among the audispotted him among the audi-ence at a cinema, was impressed, and approached him. Raaj Kumar debuted with 'Rangeeli' (1952) but that and his next three bombed badly. He finally came to promi-nence as the hapless handi-canned husband of Nargis in

capped husband of Nargis in Mehboob Khan's 'Mother India' (1957), the rebellious elder son of the unswervingly elder son of the unswervingly righteous Sultan of Iran in Sohrab Modi's 'Naushervan-e-Adil' (1957) — which showed that the filmmaker had forgiven him his earlier refusal, and then, the elder brother of Dilip Kumar in 'Paigham' (1959). Raaj Kumar went on to solidify his prowess with tear-jerker 'Dil Apna Aur Preet Parai' (1960) — the first of a quartet of hit films with the talented Meena Kumari

the talented Meena Kumari till 'Pakeezah' (1972) where his observation on the heroine's feet became legendary too, romantic drama 'Dil Ek Mandir' (1963) — which fetched him a Filmfare Award for Best Supporting Actor, and 'Godaan' (1963), based on Munshi Premchand's story.

World Sepsis Day: Timely treatment key to ward life-threatening infection



Immediate treatment is crucial to warding off sepsis a life-threatening emergency caused by a dysregulated host immune response to an infection, said experts on World Sepsis Day on Friday.

World Sepsis Day takes place annually on September 13 and is aimed at raising awareness of the devastating condition that claims millions of lives globally each year.

In 2020 alone, there were 48.9 million sepsis cases globally, leading to 11 million deaths — representing 20 per cent of all global deaths.

The burden is particularly heavy in low- and middleincome countries, where 85 per cent of sepsis-related deaths occur.

In India, there were an alarming 11.3 million cases and 2.9 million deaths in 2020, underscoring the

urgent need for improved prevention, early diagnosis, and effective treatment strategies. Sepsis can lead to severe outcomes, including organ failure, septic shock, and mortality high rates. Survivors may face long-term effects like chronic muscle weakness, pain, fatigue, and cognitive issues.

"Sepsis is a life-threatening emergency where the body's response to an infection spirals out of control, leading to self-damage of organs and impaired function," Dr. Chinnadurai R, Lead Consultant – Critical Care, Aster RV Hospital, told IANS.

The critical condition often results from bacterial infections like pneumonia, urinary tract infections, abdominal infections, or bloodstream infections. Viruses such as influenza and Covid-19 can also trigger sepsis, while fungal and parasitic infections are less common causes.

"Immediate treatment is crucial and involves early detection, administering broad-spectrum antibiotics

within the first hour, providing supportive care (for example, intravenous fluids, oxygen), and controlling the abscesses or removing infect-ed tissue," Chinnadurai said.

Dr. Aakashneel Bhattacharya, Consultant, Infectious Diseases, Paras Health Gurugram said: "Preventing sepsis starts with taking precautions such as practicing good hygiene, keeping wounds clean and covered, staying up-to-date on vaccinations, and seeking timely medical care for infec-

tinns before they escalate". The experts also called for raising awareness about sep-sis through public education, early treatment, training healthcare professionals to manage sepsis effectively, and adhering to evidence-based guidelines are key

strategies. With timely recognition and treatment, the rates of hospitalisation and death from sepsis can be significantly reduced.

Scientists develop nasal drop that can treat common cold in kids faster

Using hypertonic saline nasal drops can reduce the duration of the common cold in children by two days, a new study led by an Indianorigin scientist has found. Every year, children may suffer

from up to 10 to 12 upper respiratory tract infections, commonly known as colds, which can significantly affect them and their families. There are medications that can alleviate symptoms, such as ibuprofen and paracetamol, but there are no cures for colds that can heal more quickly.

The study by the University of Edinburgh in the UK found that salt-water nasal drops can help reduce the duration of cold symptoms in children.

"Since salt water solutions are commonly used as a cure to nasal infections as well as for gargling, that was the inspiration for this idea, to check whether a homemade cure could be replicated in a largescale trial as well," said Dr Sandeep Ramalingam, consultant virologist, Royal Infirmary of Edinburgh and honorary clinical senior lecturer, University of Edinburgh.

For the study, the researchers recruited 407 children aged up to six years and found that those using salt-water nasal drops had cold symptoms for an average of six days, compared to eight days for usual care. The children also needed fewer medicines during their illness. The study also found that fewer households reported family members catching a cold when chil-dren received salt-water nasal drops, with 82 per cent of parents saying the drops helped the child get better quickly and 81 per cent say-ing they would use them in the future.

The research also showed that parents can safely make and administer nose drops to their children, giving them some control over the common cold affecting their children.

Offering parents a safe and prac-tical way to limit the impact of colds on their children and family would represent a significant reduction in the health and economic burden of this most common condition. This incredibly inexpensive and simple

Apple Watch Series 10 likely to feature sensor to detect sleep apnoea

soon-to-be-The launched Apple Watch Series 10 is likely to feature an upgraded ECG sensor that can help detect sleep aprioea, according to media reports.

People suffering from the condition repeatedly take pauses in breathing, as well as snort and gasp - all while in sleep. This lowers blood oxygen levels, making the condition potentially fatal. The reports noted that using the sleep tracking feature, the new Apple Watch Series 10 will be able to detect sleep apnoea in users. It can then alert the user and recommend further tests. Other key health features include a change in the processing of the health data collected by these sensors.

Overlooking invasive fungal infections could prove deadly

Invasive fungal infections (IFIs) represent a serious and often overlooked threat to human health. These systemic infections occur when fungi, typically present in the environment, establish themselves in deep tissues, leading to potentially fatal outcomes. The morbidity and mortality rates associated with IFIs are alarmingly high, especially when left undiagnosed or misdiagnosed. IFIs can be classified based on their histologic forms, including yeast, mould, or dimorphic fungi, with common examples being invasive aspergillosis (IA), invasive mucormyco-sis, invasive candidiasis (IC) and invasive cryptococcosis. One of the most insidious aspects of IFIs is their ability to masquerade as other respiratory conditions, such as asthma and chronic obstructive pulmonary disease (COPD), or to complicate pre-existing diseases like tuberculosis (TB). This overlap in clinical presentation can lead to significant diagnostic challenges, resulting in missed or delayed diagnoses and suboptimal patient outcomes. Asthma and COPD are prevalent respiratory conditions, affecting millions of individuals worldwide. Both diseases are characterised by chronic inflammation and airflow obstruction, manifesting in symptoms like wheezing, coughing, shortness of breath, and chest tightness However, these symptoms are not unique to asthma and COPD; they can also be indicative of IFIs, particularly those caused by Aspergillus species, such as invasive aspergillosis. Overlapping Symptoms: The clinical overlap between IFIs and conditions like asthma and COPD is profound. Patients with underlying lung diseases are particularly vulnerable to these fungal infections, which can exacerbate their exist ing respiratory symptoms. This overlap often leads to misdiagnosis, as the standard diagnostic tests for asthma and COPD, such as spirometry and imaging studies, are not designed to detect fungal infections. Diagnostic Challenges: The diagnostic challenges posed by IFIs in this context cannot be overstated. Patients with undiagnosed IFIs may receive inappropriate treatments, such as corticosteroids, which are commonly prescribed for asthma and COPD. While corticosteroids can alleviate inflammation, they also suppress the immune system, potentially worsening an underlying fungal infection. A pertinent example of this diagnostic dilemma is Allergic Bronchopulmonary Aspergillosis (ABPA). ABPA occurs when the immune system reacts to Aspergillus spores, leading to severe asthma-like symptoms. Without proper diagnosis and antifungal treatment, ABPA can cause irreversible lung damage, further complicating the clinical picture and leading to long-term health consequences.

Lift or stairs? Always choose stairs

According to a study presented at ESC Preventive Cardiology 2024, climbing stairs is associated with a lower risk of cardiovascular disease and death. Even though cardiovascular disease is the leading cause of death in the world, it is largely preventable through regular exercise. However, about one in four adults do not meet the recommended levels of physical activity. Climbing stairs is an easily accessible way to incorporate physical activity into your daily routine.

To find out if climbing stairs could reduce the risks of cardiovascular disease and premature death, UK researchers examined nine studies that included a total of 4,80,479 participants, aged 35 to 84 years, and 53 per cent women.

The research included participants who were healthy as well as those with a previous history of heart attack or peripheral arterial disease. Studies were included regardless of the num-

ber of stairs people climbed or the speed at which they climbed. Climbing stairs was associated with a 24 per cent reduced risk of dying from any cause and a 39 per cent lower risk of dying from cardiovascular disease, compared with not climbing stairs.

Stair climbing was also linked with a reduced risk of

cardiovascular disease including heart attack, heart failure and stroke. "Based on these results, we would encourage people to incorporate stair climbing into their day-to-day lives. Our study suggested that the more stairs climbed, the greater the benefits-but this needs to be confirmed. So, whether at work, home, or else-

Mammogram recommended from age 40

The US Preventative Services Task Force (USPSTF) has issued new recommendations for all women to start getting mammograms every other year beginning at age 40 and continuing through age 74. Previously the task force had recommended women to start screening at age 50, and women between the ages of 40 and 50 could choose to have breast cancer screening based on their risk factors and health history. "More women in their 40s have been getting breast cancer, with rates increasing about two per cent each year, so this recommendation will make a big difference for people," the Task Force chair said. "By starting to screen all women at age 40, we can save nearly 20 per cent more lives from breast cancer over-

reduce risk of postpartum depression

Esketamine injection may



A single low dose injection of esketamine given right after childbirth can reduce the risk of major postpartum depression by about three quarters, finds a US study published in The BMJ. Up to 26 per cent of women suffer from depression during the perinatal period which is a strong predictor of postpartum depression.

Esketamine is made from a drug called ketamine which is used as an anaesthetic and to treat depression. To find out if a single low dose injection of esketamine given just after childbirth might reduce postpartum depression in mothers, the researchers enrolled 361 mothers, of an average age of 32 years, across five Chinese hospitals. The women did not have a medical history of depression, but had mild prenatal depression as indicated by a depression scale.

Participants were randomly

assigned to receive either esketamine or placebo intravenously infused over 40 minutes after childbirth.

They were interviewed 18 to 30 hours after childbirth and again at seven and 42 days. None of them took antidepressants or received psychotherapy during the follow-up period. Forty-two days after giving birth, 6.7 per cent of mothers given esketamine experienced a major depressive episode compared with 25.4 per cent of those given a place-bo-a risk reduction of about 75 per cent

Mothers treated with esketamine experienced more adverse events such as dizziness and double vision, but the symptoms lasted less than a day and did not require treatment. "Low dose esketamine should be considered in mothers with symptoms of prenatal depression," the authors concluded.

These women should talk to their health care provider.

According to it one in six breast cancers are diagnosed in women in their 40s. About 75 per cent of women diagnosed with breast cancer have no family history of the disease. How anger can hurt your heart

Getting angry can constrict blood vessels and increase a person's risk of developing heart disease, according to a US study published in the Journal of the American Heart Association.

Previous observational studies have already shown that negative emotions like anger can increase the risk of heart attacks and strokes. To explore how this happens, the researchers recruited 280 healthy adults aged 18 to 73 years who were free of cardiovascular disease and other risk factors such as hypertension, diabetes, and high cholesterol. All participants were non-smokers and did not have a history of mood disorders.

The researchers measured blood flow changes in the blood vessels of each participant's dominant arm. Then, they were randomly assigned to four groups: those in the anger and anxiety groups were asked to talk for eight minutes about personal experiences that had evoked those emotions; the sadness group was asked to read aloud for eight minutes statements that elicited sadness; and the control group just counted numbers for eight minutes to induce an emotionally neutral state.

The ability of the blood vessels to dilate was reduced by more than half among those in the angry group compared with those in the control



group. And these negative effects lasted up to 40 minutes after the angry episode. However, being anxious and sad did not have any impact on blood vessels."If you are a person who gets angry all the time, you are having chronic injuries to your blood vessels," said the study leader. "It is these chronic injuries over time that may eventually cause irreversible effects on vascular health and eventually increase your heart disease risk." Studies have linked impaired

blood vessel dilation to the development of atherosclerosis, or the buildup of fatty deposits inside the vessel walls, which in turn can lead to heart attack and stroke. The study underscores the importance of anger management to reduce the risk of heart disease.
