#### JAMMU, MAR 24

Jammu and Kashmir Congress president Tariq Hameed Karra on Monday questioned the BJP's claim of normalcy after the abrogation of Article 370 and demanded an all-party meeting to discuss the "deteriorating" security situation in the union territory.

He said the frequent terror incidents, especially in the Jammu region, indicate that the militancy has shifted base from Kashmir to the otherwise peaceful region, which is negating the BJP's "false narrative" that terrorism has ended in the union territory.

Congress headquarters ahead of the start of the party's intensified campaign for the restoration of statehood to Jammu and Kashmir.

His remarks came a day after security forces on Sunday launched a massive offensive to neutralise a group of terrorists who took shelter in a dense nursery after infiltrating from across the border in Hiranagar sector of Kathua district in the Jammu region.

A key component of this initiative is the Indian Tuberculosis Genomic Surveillance Consortium, (InTGS) spearheaded by the Department of Biotechnology (DBT), the Council of Scientific and Industrial Research (CSIR), and the

of the NHAI, had allegedly sought the bribe of Rs 15 lakh for "extending undue favours in processing and passing of the bills related to the contracts/works of the NHAI", the CBI said in a statement.

"Searches conducted in this regard have led to recovery of Rs 1.18 crore cash (approx.)," it said.

The CBI had booked 12 accused, including six public servants of the rank of chief general manager and general manager (GM) and other senior ranks of the NHAI, one private company, four senior representatives of the private company, including its two GMs, besides one other private contractor and unknown other public servants and private persons in connection with the bribery case.

The CBI raided the meeting place between the accused GM and the employee of a private company where both were caught immediately after the bribe was exchanged, officials said.

"Searches were conducted by the CBI at the residential and official premises of the accused at Patna, Muzaffarpur, Samastipur, Begusarai, Purnia, Ranchi and Varanasi which led to recovery of Rs 1,18,85,000/ (approx.), several incriminating documents and digital devices," the statement said.

Jammu and Kashmir Chief Minister Omar Abdullah on Monday observed that border dwellers face numerous challenges and said his government will convene a meeting of MLAs from border areas in April to address the issues faced by them.

He also said that over Rs 144 crore have been disbursed to farmers, whose lands were affected by fencing along the International Border (IB).

Responding to supplementary questions from various MLAs representing different parties regarding concerns raised by border residents, Abdullah told the House, "This is a humanitarian issue. Border residents face numerous challenges." He added that following the conclusion of the session in April, a meeting with all border area MLAs will be held.

"I will convene a meeting with all MLAs representing border areas along with officials. The government will take whatever steps are necessary," he said.

Several BJP members, including Vijay Kumar, Surjit Singh Salathia, Devinder Kumar Manyal, and CPIM member M Y Tarigami, raised issues related to land compensation, agricultural activities by locals before fencing, and poor conditions of border hamlets.

A heated exchange of words also took place between Tarigami and BJP MLA Balwant Manokita, who alleged there is no border area in the constituency of the member, who is asking questions about a border areas of Jammu.

Tarigami countered him by saying he can raise question about any area and Jammu does not belong to him alone.

The chief minister said Rs 155.08 crore has been allocated as compensation, out of which Rs 144.12 crore has already been disbursed to landowners, with the remaining amount pending title verification.

"We are not sitting on funds. Rs 11 crore remain unspent in the disbursement process. We will instruct the department to expedite the disbursement efforts on fast track." he assured.

The Minister said that the government is also driving transformational growth in the livestock sector through targeted interventions that enhance productivity, employment and income generation for farmers. He said 3,220 dairy units were established in 2024-25 under Integrated Dairy Development Scheme, generating employment for nearly 5,000 people. Similarly, 2,170 units were set up in 2024-25 under the Integrated Sheep Development Scheme.

Jammu and Kashmir's agriculture sector is experiencing a remarkable transformation under the Holistic Agriculture Development Program (HADP), delivering tangible results, said the Minister. He extolled that agriculture in the UT is undergoing a transformative shift, from a focus solely on produce to a producercentric approach. This evolution is driving higher returns for the farmers, nurturing entrepreneurship and creating a more sustainable and commercially viable agricultural ecosystem, he added.

He said that there are 29 projects under HADP, spanning across all sectors within the Agriculture Production Department (APD), driving a fundamental transformation in Jammu & Kashmir's agri-economy.

The Minister highlighted significant strides in horticulture, particularly in the expansion of High-Density (HD) Plantations. The government is developing rootstock banks and mother orchards to support growth of HD plantations across 5,500 hectare under Project 21 of HADP. During 2024-25, the government promoted protected cultivation with 9,083 square meters already developed for rootstock production besides establishment of 45 hectares as mother orchards and cultivating 18.6 hectare for rootstock production, he maintained.

He said that assistance will now be disbursed in three phases, 50 percent after plantation, 30 percent upon sprouting and the final 20 percent after one year, if survival reaches 90 percent, to address setbacks in traditional orchards due to reduced farmer engagement post-financial support.

The Minister said that the government is also launching scientific measures to improve livestock breeding besides implementing Embryo Transfer Technology (ETT) and Artificial Insemination (AI) to enhance the genetic potential in cattle, sheep and goats. He said that 191 satellite heifer rearing units had been established in 2024-25 to reduce dependence on animal imports and improve the quality of dairy animals in J&K. Additionally, 19 milk value-addition SHGs were supported with Rs 25 lakh each, equipping 88 SHGs with automatic milk collection units linked to bulk milk coolers.

Regarding the mutton sector, he informed that four breed-based farms (each housing 500 sheep) and 673 commercial sheep farms had been established during 2024–25 said. Besides, the government is importing 900 high quality Texel and Dorper sheep from Australia to enhance the meat production.

The Minister said that introduction of the rail network in Kashmir will be a game-changer for the apple growers, significantly reducing freight costs and ensuring better profitability.

"Jammu & Kashmir Competitiveness Improvement Project (JKCIP) is a forward-looking initiative being launched with support from the International Fund for Agricultural Development (IFAD)" the Minister said.

Javid Dar said that in J&K, there are 10.82 lakh active KCC accounts, 8.49 lakh for crops and 2.33 lakh for animal husbandry. This year alone, 61,316 new KCCs were issued. The total sanctioned limit stands at ?9,726 crore with an outstanding credit of Rs 7,393 crore. The NPA ratios remain low at 4.7% for crops and 2.1% for animal husbandry, reflecting strong credit discipline. In FY 2025–26, we aim to add 1 lakh new KCCs in the crop sector and 2 lakh in Animal Husbandry, he added.

He said that the Pradhan Mantri Formalization of Micro Food Processing Enterprises (PMFME) scheme is also being implemented to promote small food processors, improve value addition and enhance market access. Based on a One District One Product (ODOP) strategy, it offers a 35% credit-linked subsidy up to ?10 lakh, and support to SHGs and FPOs. He said upto 2024-25, 1743 applications were cleared by District Committees, with 1,326 sanctioned, 927 disbursed and 1,000 new units targeted for establishment in 2025-26.

Police also urged residents to remain vigilant and report any suspicious activity to law enforcement agencies to contribute to ongoing efforts in maintaining peace and security.

can significantly improve diagnostic accuracy and enable faster resistance profiling, reducing the time needed to determine effective treatments from weeks to mere hours or days. This, he said, will help in tailoring treatment regimens to individual patient needs and reduce the risk of treatment failure or relapse.

Drawing from his own medical background, Dr. Jitendra Singh reflected on the historical challenges of TB treatment in India, from the stigma surrounding the disease to the evolution of medical advancements. He called for greater community engagement, emphasizing that TB eradication is not just a scientific or medical challenge but a societal one. "Unless we involve common people, raise their consciousness, and evoke their participation, our fight against TB will remain incomplete," he said.

Appreciating the pioneering scientific advancements and their instrumental role in fight against tuberculosis, Hon'ble Minister said that while phenotypic drugsusceptibility tests and M. tuberculosis culture are generally regarded as the gold standard for diagnosis, genome sequencing technologies are increasingly being applied for strain identification and drug resistance prediction, providing valuable insights for clinical decision-making and surveillance activities. He also added that the adoption of molecular methods for TB diagnosis and resistance testing remains uneven, significantly influenced by socioeconomic disparities across countries. To fight the incessant TB, it is important to propel these innovations to scale and embed them into real-world implementation. Dr. Rajesh Gokhale, Secretary DBT, hailed the compl

In a separate written reply to an unstarred question by National Conference legislator Khurshid Ahmad, Chief Minister Omar Abdullah said 1,288 houses were gutted in separate fire incidents across J-K over the past two years.

While 574 houses were gutted in 2023-24, the number increased to 714 in 2024-25, Abdullah, who is also minister in-charge disaster management, relief, rehabilitation and reconstruction department said.

He said the maximum 107 houses were gutted in Kishtwar district, 97 Kupwara, 64 Kulgam, 61 Anantnag, 56 Srinagar, 52 Budgam, 51 Baramulla, 47 Ramban, 36 Bandipora, 20 Doda, 21 Shopian, 17 each Pulwama and Udhampur, 16 Rajouri, 15 Reasi, 12 Poonch, 11 Ganderbal, seven Samba and six Jammu in the FY 2024-25.

Similarly in 2023-24, the maximum 91 houses were gutted in Srinagar, 76 Kupwara, 71 Anantnag, 68 Baramulla, 48 Bandipora, 30 Budgam, 27 Ramban, 25 Kulgam, 21 Kishtwar, 20 Pulwama, 18 Poonch, 14 each Udhampur and Jammu, 11 each Shopian and Rajouri, eight Ganderbal,

"If the government is claiming that everything is alright, then why has militancy intensified in the Jammu region that has been declared militancy-free by the previous popular governments," he said.

Karra accused the BJP of sacrificing the national interest over its interests by ignoring the security threat.

"We request the government to call an all-party meeting to deliberate on measures to control the growing militancy, which is the biggest concern for all of us," he said.

The Congress leader said the central government is answerable to the people over the growing terror activities as Jammu and Kashmir Police is directly under its control.

"The terrorists are striking at will ... the ongoing operation in Hiranagar in Kathua is the latest example," he said.

The central government should give up its "misadventure" as the prevailing security situation in Jammu and Kashmir is not in the national interest.

Karra further said, "The BJP should stop selling its hollow narrative and instead take effective and positive measures to deal with the situation otherwise it will continue to deteriorate further."

The Congress has flagged the issue time and again but the central government has taken no action except holding security review meetings, he said. (Agencies)

The Minister said that 210 trout units, 6 Recirculating Aquaculture System (RAS) units and 8 biofloc units had been established in 2024-25, to boost fish production, improve livelihoods and promote sustainable aquaculture in J&K. He added that the government is focusing on improving irrigation coverage, promoting climate-resilient cropping and ensuring judicious use of water resources for expanding irrigation infrastructure and enhancing water efficiency in rainfed areas.

He informed that the District Irrigation Plan aims to cover 415,000 hectare of Culturable Command Area (CCA). So far, 191,000 hectare has been covered and efforts are underway to bring an additional 33,000 hectare under irrigation. He said that, to bridge this gap, 18 projects are in progress under UT Capex and 14 new projects worth Rs 48.83 crore have been sanctioned. Also, 20,102 hectare has been brought under irrigation during 2024-25. Over the next three years, an allocation of Rs 116.86 crore will be utilized on establishment of 200 community borewells, integrated with drip and sprinkler irrigation systems to significantly enhance water use efficiency and boost agricultural productivity across 2,000 hectare.

The Minister said that, simultaneously, the Rainfed Area Development (RAD) Project 16 is focused on making rainfed farming more sustainable and climate resilient under HADP. He said that the department through its project on "Promotion of Vegetables and Exotic Vegetables under Open and Hi-Tech Protected Cultivation" is expanding both open-field vegetable cultivation and hi-tech protected farming, ensuring higher yields, better quality and greater market competitiveness.

The Minister revealed that 21 lakh soil health cards have been issued to farmers under the Soil Health Card (SHC) Scheme.

He said that currently there are 37 mandis with 24 fully operational and the remaining 13 in various stages of development. Significantly, out of the 19 wholesale mandis, 17 have already been integrated with the e-NAM platform, while the integration of the remaining two is underway. In 2024-25 alone, 54,975 stakeholders were registered on the platform, including 3,634 growers, 72 traders and 108 Farmer Producer Organizations (FPOs). In 2024-25, a total of 9.44 lakh quintal of agricultural and horticultural produce worth Rs 594 crore, was traded through e-NAM, as compared to 6.55 lakh quintal worth Rs 416 crore in 2023-24, he said.

#### Jammu Smart City Project: Over rs 800 cr spent in past six yrs

He said 400 complaints relating to installation of unique Digital Door Number (DDN) plates were received, out of which 350 have been resolved. The DDN plates are being installed as part of the government plan to geo-tag and assign the unique number to every household and commercial property.

Similarly, 300 complaints relating to e-Bues operation, ticketing, misbehavior by driver or conductor were received and in 285 cases penalties on defaulting persons or agencies were imposed, he said.

# **Commissioner Secretary HUDD** chairs meeting on Interest Subsidy **Scheme under PMAY-Urban 2.0**

JAMMU RISING JAMMU, MAR 24 Commissioner Secretary, Housing & Urban Development Department (HUDD), Mandeep Kaur, today chaired a high level meeting with sen-

ior officials from J&K Bank (Lead Bank, J&K UTLBC) and other financial institutions operating in Jammu & Kashmir.

The meeting focused on devising strategies for effective implementation of the Interest Subsidy Scheme (ISS) component under Pradhan Mantri Awas Yojana-Urban 2.0 (PMAY-U 2.0).

Pertinently, the Pradhan Mantri Awas Yojana-Urban 2.0, launched by the Prime Minister on 17th September 2024, included the Interest Subsidy Scheme (ISS) as a key initiative to enhance affordable housing accessibility. Under this Central Sector Scheme, the eligible beneficiaries from the Economically Weaker Sections (EWS), Lower Income Group

(LIG) and Middle-Income Group (MIG) categories will receive an interest subsidy on home loans sanctioned and disbursed on or after 1st September 2024. The subsidy aims to support the beneficiaries seeking to construct or purchase a house.

The Commissioner Secretary emphasized the urgent need for all banks to sign a Memorandum of Understanding (MoU) with any Central Nodal Agency (CNA) designated by the Ministry of Housing & Urban Affairs (MoHUA), Government of India. This step is crucial to facilitate the timely claim and transfer of subsidies to the eligible beneficiaries.

Under the scheme, the eligible beneficiaries with an annual family income of up to ?9 lakh can avail of an interest subsidy of ?1.80 lakh. Home loans up to ?25 lakh for properties valued at up to ?35 lakh, with a carpet area of up to 120 square meters, qualify for a 4.0% subsidy on the first ?8 lakh for a loan tenure of up to 12

During the meeting, Mandeep Kaur asked the J&K Bank, as the Convenor of J&K UTLBC, to ensure that the Interest Subsidy Scheme (ISS) is thoroughly reviewed in the upcoming J&K UTLBC meeting. She also urged all financial institutions to actively participate in the scheme's rollout and provide necessary support to beneficiaries.

Deputy Commissioner Dr. Rakesh Minhas emphasized the need for sustained efforts to ensure a TB-free Kathua and urged the community to actively participate in the mission.

Earlier, Chief Medical Officer Dr. Vijay Raina flagged off an Information, Education, and Communication (IEC) awareness van for public announcements across Kathua city.

The initiative aims to spread awareness about TB and promote health-seeking behavior among the public.

Dr. Raina was joined by District Tuberculosis Officer Dr. Radha Krishan and Block Medical Officer Parole, Dr. Vivek Mangotra. The staff of the District

Among the points Chanchad raised were the "hypocrisy" embedded in Congress's federalism stand that manifested in the party's social media warriors "openly questioning the very existence of regional parties", fixing one's own house before mocking others, and either reinventing the party or fade into oblivion.

In the euphoria over AAP's fade-out, the Congress has not cared to reflect on its own role and conduct in the Delhi polls or even attempt to nail the local leaders who reportedly counselled Gandhi to assail Kejriwal and AAP

instead of attacking the BJP.

The Congress's conflicted stand over seeking regional electoral partners has significant implications for the virtually defunct INDIA bloc that beamed a ray of hope in the opposition when it was launched in Bihar in July 2023. It was meant to be a big-tent coalition of 'progressive' federal forces to chal-lenge the BJP-led NDA.

The Congress arrogated to itself the right to head INDIA by virtue of its national presence, but none of the other parties were willing to concede leadership to the Gandhis. The bloc has since unravelled. Nitish Kumar, who cheerfully piloted the project as part of a 'secular' coalition, was the first to jump ship and embrace the BJP.

The Janata Party and Janata Dal experiments of the past-a ragtag of state parties wedded together by the anti- Congress glue—at least took off and made a go of it until the ideological contradictions between the BJP and some others became irreconcilable. For the BJP, more than the egos nursed by its leaders such as Atal Bihari Vajpayee and L K Advani, it was the RSS's pressure to work towards getting an independent majority on the Hindutva plank that scup-pered the Janata coalitions.

To be noted, however, is the BJP's exemplary pragmatism towards the so-called smaller participants when help was needed in cobbling the numbers required for a majority in the Lok Sabha and state legislatures. The Congress, on the other hand, could never shed the aura of being the 'grand old party' and a selfanointed supremo.

Today, the BJP holds power in 12 states on its own, and with an ally, the Janata Dal (United) in Bihar. It has NDA chief ministers in Andhra Pradesh, Sikkim and Meghalaya. In contrast, the Congress can call just three states as its own. It is part of the coalition governments in J&K and Jharkhand, and a constituent of the DMK-led compact in Tamil Nadu. It was part of the Maha Vikas Aghadi and Mahagathbandhan governments in Maharashtra and Bihar, which could not complete their tenures.

Regardless of the Delhi verdict, is the Congress positioned to disparage regional parties on whose backs it rides in at least five states? Any party in its place, grand or unprepossessing, would be casting round for partners to face a slew of impending elections.

In Maharashtra, the MVA, consisting of the Shiv Sena (Uddhav Thackeray), NCP (Sharad Pawar) and Congress, exists notionally. Uddhav, a former chief minister who lost most of his MLAs to a BJP-engineered coup, declared his intent to fight the prestigious local body polls in Maharashtra solo. The cash-rich Brihanmumbai Municipal Corporation is on his radar as well as the BJP's. NCP chief Sharad Pawar, wounded as much as Uddhav from the defections his party was subjected to, will need a miracle to revive the original NCP. The Congress is rudderless as its allies are looking for life away from the Gandhis.

In Tamil Nadu and Bihar, the Congress will willy-nilly

have to ride on the back of the DMK and RJD, while in J&K, after its poor showing in Jammu, it has no choice but to go by the NC's diktat. In Uttar Pradesh, where the Samajwadi Party put up an impressive performance in the Lok Sabha election, there's no way its chief Akhilesh Yadav will yield more seats to the Congress than what he deems deserv-

Rather than the federal forces, the Congress is fast losing its salience within INDIA or what remains of it. The Congress treated the AAP, notionally an INDIA constituent, as its arch-enemy in Delhi. It got a shock when Akhilesh Yadav, Mamata Banerjee, Uddhav Thackeray Sharad Pawar and announced their support for the AAP, although materially it made no difference.

The prospect of regional parties, loosely aligned with Congress, banding the together to form a separate non-Congress coalition cannot be ruled out because those like Jagan Mohan Reddy's YSR (Congress) might find such a formation more palatable than Congress's ÎNDIA.

Can ideology be a cementing element in today's circumstances? The BJP has artfully finessed the skill of blending ideology with the lure of power to add to its strength. The Congress's ideology remained fuzzy in the post Mandal-mandir era. Regional parties, including the socialist-secular adherents, couldn't care less about ideology, mouthing their anti-BJP rhetoric for the consumption of the religious minorities.

"(It is) never easy -- (the) first game against CSK -- it's a big game. But purely the way he responded, hats off to him," former India and current MI bowling coach Paras Mhambrey told the media after the match on Sunday night.

"He was able to hold his nerves and handle pressure superbly, (he) really got us in the game. Very happy about his performance," he added.

MI have unearthed talent like Jasprit Bumrah and Hardik Pandya from the far-reaches in the past and Puthur only serves a reminder of their robust scouting system.

"Amazing, MI is known for that -giving youngsters opportunities, the scouts do this for 10 months and he (Vignesh) is a product of that," said MI's stand-in skipper and India T20I captain Suryakumar Yadav after the match.



"We never expected him to play in the first match itself. We are so happy. We never even thought he will get an IPL contract. Now, a lot of people are calling us to congratulate, and hopefully he will live up to everybody's expectations," said Sunil Kumar, his father.

Puthur's mother Bindu was equally delighted.

"He had called up last evening saying there was a chance for me to play tonight. We were watching every ball last night, and this was his performance. He called us around 12.30 am last night after the match and then again he called after an hour.

"He was so happy. I have never seen him so happy. We also could not sleep because of happiness."

Vignesh Puthur celebrates Shivam Dube's wicket with Mumbai Indians brey said. "The idea at MI is always seeing the potential more than anything else, and when we saw him for one of our trials, we saw the potential in him rather than looking into how much cricket he has played in the past."

# Inside the bizarre world of anti-ageing millionaire Bryan Johnson: Hush NDAs on discussing 'sexual activities' and more

NEW DELHI, MAR 24 Tech entrepreneur and multimillionaire Bryan Johnson recently took the internet by storm on the release of the Netflix documentary, Don't Die: The Man Who Wants to Live Forever. Suddenly jettisoned to a health guru of sorts in pursuit of immortal life, no Lazarus pit could ready him for the latest damning NYT expose.

While the documentary feels like a long-drawn advertisement for his longevity startup Blueprint to sell more healthcare equipment, diet plans, and health supplements, Johnson presented it as a gift to the world, as some sort of research for humanity to reach its "lowest possible biological age."

His breakout moment came when 47-year-old Johnson shocked the world with extreme anti-ageing techniques, including receiving blood transfusions from his then-17-year-old son, and running tests on his penis to increase erections.

Yet, the most bizarre thing about Johnson was revealed in the latest report which stated that at least three of Johnson's employees, including his former fiancée, filed complaints against him. The accusations? Wild confidentiality and non-disclosure agreements (NDAs) that violate US federal labour laws.

It is alleged that Johnson used these NDAs to silence his staff. More than 20 pages long, these confidentiality agreements covered almost everything-any non-public information regarding Johnson's home, office, personal effects, spaces and vehicles rented or owned by Johnson, everything.

Johnson, on X, posted that the agreement just evolves along with improvements to Blueprint. But the icing on the



cake was an 'opt-in' agreement that the report underscores employees felt coerced to sign.

In this optional NDA, employees were to be okay with Johnson wearing "little and sometimes no clothing/no underwear" and with "discussions of sexual activities, including erections", NYT revealed.

From selling a \$49 "longevity mix" supplement pack to billing \$2,100 to participants of clinical testing, the information of the expose is damning despite the flowery Netflix documentary that came out in January.

According to the report citing internal documents, 60 per cent of the 1,700 participants of his study of supplements and meals called "The Blueprint Stack" developed at least one side effect. Some even saw their testosterone levels plummet and turn prediabetic, too, it stated.

Johnson hit back on X, posting: "The New York Times knowingly published false and misleading statements about Blueprint'

"There was no statistically significant change in testosterone and it remained normal throughout the study," he said. Calling the prediabetic claim "false", Johnson added, "The NYT made it up. There was not a statistically significant change in HbA1c, Insulin, or Glucose."

In his documentary, Johnson in 2023 announced that he reversed his biological age by more than 5 years. He revealed that he spent \$2 million each year on his bizarre routine, including popping north of 50 pills and supplements, tracking his nighttime erections, and even shock therapy.

Fast forward to 2025, and Johnson has already announced his own 'AI' religion "Don't Die"-after his slogan for longevity.

How this former Mormon missionary-turned-health guru will respond to the expose legally is yet to be seen, but this adds to a long list of things filed under "don't believe everything you see on the internet".

### **RBI** approves ATM interchange fee hike by ?2 for cash withdrawals, effective May 1 NEW DELHI, MAR 24

The Reserve Bank of India approved a hike in ATM interchange fees, according to a Financial Express report. The rise in charges, effective May 1, includes a ?2 hike for financial transactions and ?1 for non-financial ones.

Interchange fees are paid by a customer's bank (Bank A) to the bank that the ATM belongs to (Bank B), whenever the Bank A customer uses Bank B's ATM.

The move comes after various reports last month hinting that the National Payments Corporation of India (NPCI), recommended a slew of transaction fee raises to the RBI, including lifting the maximum cap for cash transaction fees and the ATM interchange fees for

New Delhi, Mar 24 In mid-August 2024, Young Liu, chairman of the world's largest electronics manufacturer Foxconn, landed

Housing sales to fall 23% in Q1 in top 9 cities

NEW DELHI, MAR 24 Housing sales are estimated to decline 23 per cent annually to nearly 1.06 lakh units during January-March across nine major cities on subdued demand due to high prices and concern over economic growth, according to PropEquity.

Real estate data analytics firm PropEquity on Sunday released its housing sales data for January-March period.



As per the data, housing sales are estimated to fall to 105,791 units in the first quarter of the 2025 calendar year from 136,702 units in the same period last year.

Only Delhi-NCR and Bengaluru are expected to witness a rise in sales this quarter among nine major cities.

Samir Jasuja, founder & CEO, PropEquity, said: "The housing market is witnessing some correction after three years of record supply because of which absorption/sales is also on a declining trend."

New supply of housing properties is estimated to decline 34 per cent to 80,774 units in the current quarter from 1,22,365 units in the year-ago period.

"Rise in home prices and caution on the part of investors due to geopolitical developments and certain weaknesses in the Indian economy have resulted in drop in sales," Jasuja added.

# GCCs reach new heights in India with neo and mid-sized banks

#### NEW DELHI, MAR 24

Neo banks, along with mid-sized banks, are establishing global capability centres (GCCs) in India, mirroring the expansion strategies of larger global counterparts.

This trend is being seen as the next major wave in the country's banking, financial services, and insurance (BFSI) sector.

Neo banks exist solely online and operate independently or in partnership with traditional banks.

Their market size is expected to grow to \$395 billion in 2026, up from about \$19 billion in 2018, according to PwC.

Such banks, spread across the United States (US), the United Kingdom (UK), Australia, and Japan, are looking to tap the huge number of engineers in the country and work in some highvalue, cutting-edge technology and finance operations with fewer people than what behemoths such as JP Morgan, HSBC, and Goldman Sachs need.

Often the number of people in these small banks is a tenth of the larger peers, or even less than that.

Some prominent names that have set up or are likely to set up GCCs include First Citizens Bank, PNC Financial, and Fifth Third Bank from the US; Nataxis, Credit Agricole, and Santander from France; UniCredit from Italy; and Revolut and Monzu from the UK, according to people familiar with knowledge of the matter.

"Not only is there a cost advantage but also the talent is there.

"The presence of large players has a ripple effect on the vendor partner ecosystem," said Nilesh Iyer, manag-

ing director and chief executive, Nataxis Services, India.

The French bank started operations in 2021 and has about 300 people in corporate investment banking, trade lifecycle, global market operations, having customers on board, credit analysis, and risk management.

"Headcount is not the predominant measure of success anymore," Iyer added when asked if the bank would ever scale up to the size of HSBC, Wells Fargo, or Deutsche Bank in India.

Simar Singh, partner and national sector leader, KPMG India, said BFSI GCCs in India started with a minimum of 10,000 people nearly two decades ago.

It previously needed a solid business case and an established presence.

"We might soon have very good news, hopefully, coming out of that drive," Rajaa said during a fireside chat.

What was the rationale behind it?

I'm not overly concerned about daily stock price fluctuations -- we are in this for the long term. Our investors have already seen strong returns.

In fact, a down market presents an even better opportunity for investors to enter.

One way to look at it is that we were the last to go public in a challenging market. The day we listed, the market wasn't at its best, but that didn't deter us.

The reality is that every company, regardless of industry, is striving to become a platform-driven business.

There is no shortage of long-term, secular demand for our services.

How do you see the impact of artificial intelligence (AI) on growth?

There is some truth to the statement that software engineering will be compressed. If I need to write a piece of code, it'll take me less time, but the volume of code that needs to be written is multiplying all the time.

The current slowdown for the sector has been the longest. How has it impacted you?

It depends on what one defines as a slowdown. We just announced our 2024 results. We consider January to December as the financial year.

Look at any of the last four quarters -- except for three companies -- most firms have reported 2-4 per cent growth.

We're not seeing a slowdown. If we grow at 20-22 per cent, we will be happy to do so, and I think there's an opportunity for us to grow faster.

What is driving Hexaware's doubledigit growth?

Our industry outperformance is not a one-year story. What is working is quality management, great teams, engineers, platforms, and highly differentiated services.

Add to this our culture and how we treat our customers. We have 170 customers in the \$1 million segment.

However, 90 per cent of our revenue comes from 40 customers, with about 50 being strategically crucial for us

But 2022-23 was single-digit growth?

That's actually the lowest in our history. But even that is higher than anyone else. The only company that has consistently done better in the long term is Persistent.

What will be your focus areas to maintain this growth?

We have identified a few strategic priorities, which are a combination of services, markets, and geographies.

The first is legacy modernisation, which ties directly into AI. I believe using AI to make someone's job 20 per cent faster or cheaper is useless.

Legacy modernisation is one area where AI can help because humans can't decipher code written 50 years

Second, we have been pivoting to sell more to product companies. Even the software we build for enterprises increasingly resembles what you would sell to product companies.

We now have a clear focus on large product companies. There's absolutely enough for us to go after in the pureplay large product company segment.

The third pivot is private equity as a channel, something Persistent does better than us.

From Rs 25 lakh to 1.2 crore: Complaint against former Union Minister Sadhvi Niranjan Jyoti for illegal property gain

NEW DELHI, MAR 24

A complaint has been sent to Lokpal demanding an investigation into allegations of gain of illegal property against former Union Minister and MP Sadhvi Niranjan Jyoti. The complainant against Jyoti, who last held the portfolio of Minister of State for Rural Development, is Amitabh Thakur, a former IAS officer-turned-politician.

This comes on the heels of an allegation by Mukhlal Pal, the Fatehpur district president of the BJP against whom his party has conducted an inquiry into the alleged taking of a Rs 50 lakh bribe. Pal has in turn accused other BJP leaders, including Jyoti of conspiring against him; and also that they too had a hand in the transaction.

Thakur has attached Jyoti's election affidavits of 2014, 2019 and 2024 to support his complaint.

According to these affidavits, in the year 2014, her total property was about 25 lakhs, which increased by Rs 45 lakhs to 70 lakhs by the year 2019. Her total income in these five years stands at Rs 24 lakhs. According to the affidavit



of the year 2024, her assets increased from Rs 1.2 crore to Rs 1.9 crore between 2019 and 2024; but her total income in these five years was only Rs 33 lakh

Thakur has termed this as 'very suspicious' and written to the Lokpal to investigate.

Samajwadi Party president, Akhilesh Yadav has also taken a jibe at Jyoti wondering how someone could have acquired 300 bighas of property and 50 dumpers in the decade that the complaint refers to. This is the figure that Pal had quoted in his defence when confronted with the bribe allegations.

Jyoti, is no stranger to controversies. In 2014 she had, in a public rally, asked that it was up to the people to decide whether they wanted to be governed by Ramzade (the sons of Ram) or 'Haramzade' (bastards). Despite a huge uproar, she was not stripped of her ministerial post just then.

# **Telangana tunnel collapse:** Trapped for 32 days, search continues to save 7 workers

NEW DELHI, MAR 24

The search operation to save seven workers trapped inside the partially collapsed Srisailam Left Bank Canal in Nagarkurnool, Telangana is progressing at a brisk pace, with authorities continuing efforts to locate workers trapped for over a month.

According to authorities, efforts are continuing to dewater and remove soil and debris from the locations identified for possible human presence. Steps are also being taken to remove the Tunnel Boring Machine (TBM) which got stuck inside the tunnel during the collapse. In a statement, District Collector B. Santhosh said the broken parts of the Tunnel Boring Machine, which were blocking excavation at the D1 and D2 spot where human presence was found, are being removed.

The muck inside the tunnel was being removed using water jet and soil was being shifted out using excavators and a conveyor belt, authorities said in a statement. Officials have also expedited search operations inside the tunnel, they added. Authorities have restored electricity and ventilation at the accident site as about 12 agencies are working to locate the trapped workers. Over 700 personnel were involved in the operation. The state government has also deployed robots to carry out rescue operations at dangerous spots within the tunnel.

Eight workers got trapped inside the under-construction tunnel in Nagarkurnool on February 22. The workers include four labourers, two engineers and two operators. Rescuers recovered the body of Gurpreet Singh, a TBM operator from Punjab, on March 9, and handed over to his family in Punjab. The Telangana government also announced a solatium of Rs 25 lakh for his family. Trapped persons have been identified as Manoj Kumar (UP), Sunny Singh (J&K), Gurpreet Singh (Punjab) and Sandeep Sahu, Jegta Xess, and Anuj Sahu, all from Jharkhand.

**RG Kar case: Calcutta HC asks CBI** to clarify whether there were signs of gang rape

#### NEW DELHI, MAR 24

Following the Supreme Court's approval, the Calcutta High Court on Monday asked the Central Bureau of Investigation (CBI) to clarify whether more people were involved in the rape and murder of the trainee doctor at RG Kar Medical College and Hospital in August last year along with Sanjay Roy, the only convict in the case so far.

During the hearing of a plea by the victim's parents requesting further investigation into the case, Justice Tirthankar Ghosh also directed the CBI to present the case diary in court and provide an update on the progress of the investigation in the next hearing on March 28.

Unhappy with the CBI investigation, the victim's parents approached the Calcutta High Court, which directed



tioned by the federal agency. During the day's hearing, Justice

Ghosh further questioned the CBI, asking whether there were indications of gang rape and who were initially on the list of suspects when the investigation began. The CBI informed the court that the investigating officer is currently out of the state. The agency requested some additional time, assuring that they would respond to all queries.

about how his government had curtailed land jihad and 'thook' (spit) jihad.

He touched on the government's priorities in the last three years: the future of the youth, women's empowerment, and the prosperity of farmers. The next two years, he said, would be devoted to creating new employment opportunities, further enhancing tourism, implementing special schemes for women and youth, and strengthening of infrastructure. The guiding lights would be self-reliance, prosperity, and sustainable development,

# Karnataka BJP to seek revocation suspension of its 18 MLAs

Law and Parliamentary Affairs Minister HK Patil passed a motion suspension against the 18 MLAs - BJP chief whip Doddanagouda Patil, former Deputy CM C N Ashwath Narayan, S R Vishwanath, B A Basavaraju, M R Patil, Channabasappa, B Suresh Gowda, Umanath Kotyan, Sharanu Salagar, Dr Shailendra Beldale, C K Ramamurthy, Yashpal Suvarna, B P Harish, Bharath Shetty, Dheeraj Muniraju, Chandru Lamani, Muniratna and Basavaraj Mattimud, which was adopted by the House. The legislators have been suspended from the House for six months and barred from attending the standing committee meetings too.



The Deputy Chief Minister said that the matter has been taken up with MoRTH for re-sanction of the Project by the NHIDCL and the bids will be invited pursuant to sanction of the project from MoRTH. He further informed that there is no proposal under consideration for Changer, Bhoonda, Choidraman, Warwan, Dardpora and Vailoo Tunnels.

#### Govt intends to eliminate bogus, ineligible ration cards

Minister for FCS&CA, Satish Sharma, today said that funds worth Rs 1833.40 lakh have been released for Gujjar and Bakarwal Hostels across Jammu and Kashmir during the current financial year under DIET head.

The Minister was replying to a question, on behalf of the Minister for Tribal Affairs, raised by Iftikhar Ahmad.

Regarding the Gujjar and Bakarwal Hostels, the Minister informed the House that, during the current financial year 2024-25, funds to the tune of Rs. 1833.40 lakh including Rs. 1801.90 lakh under Major Head and Rs. 31.50 lakh under sub-head were released in favour of the 28 G&B Hostels, having an intake capacity of 3000 students.

The Minister, while speaking about the Pahari Hostel, said that Rs. 294.00 lakh have been released under the DIET head for the financial year 2024-25 and the grant has been disbursed for intake capacity of 700 inmates in respect of 09 Boys/Girls Pahari Hostels. The Pahari Board has desired to enhance the diet/food charges due to expensive essential commodities and other daily needed items in the market, he added

He said that Rs 541.18 lakh were released under Article 275 (1) of the constitution of India for welfare of Scheduled Tribes in Rajouri Constituency during 2024-25. Out of which, Rs 328.63 have been spent, so far, on various projects including construction of Eklavya Model Residential School in Gurdhanbala, construction of roads, pathways, harvesting tank among other projects. The Minister added that there are 76 ongoing projects worth Rs 270.75 lakh under UT CAPEX in the Rajouri Constituency being executed under the Tribal Plan.

# Govt aims to boost farmer income, productivity & sustainability: Javed Dar

JAMMU, MAR 24 Minister for Agriculture, Javed Ahmad Dar, today said that the government is focused on revolutionizing agriculture in Jammu and Kashmir with emphasis on enhancing farmer's income, productivity and sustainability.

The Minister was replying to a question raised by Ranbir Singh.

He informed the House regarding key initiatives being undertaken to transform the agriculture sector in J&K. These included introduction of advanced technology, crop diversification, soil health management, Integrated Pest Management (IPM), financial support and subsidies, Research and Development, Training and Capacity Building, Infrastructure Development, Market Linkages and Promotion of Agro-based Industries.

The Minister further said that various schemes have been initiated by the government to extend financial assistance to unemployed youth in the agriculture sector under Interest Subvention and Credit Linked Schemes including KCC, AIF, AHIDF, PMFME and NLM.

He added that several initiatives have been undertaken to promote agricultural growth and sustainability in the UT, as part of Holistic Agriculture Development Programme (HADP). These included Custom Hiring Centres, Hi-Tech Polygreen Houses, Controlled Cropping Mushroom Unit, Establishment of Pasteurized Compost Unit, Apiculture, KKG, Millet Restaurants, Establishment of Millet Mills, Establishment of Mini Soil Testing Labs, Establishment of Seed Processing Units, Dairy development projects, Self Sufficiency in Mutton Production, Poultry Development Project, Fish Seed and Trout Production besides Fodder production.

The Minister said that, similarly, many other schemes have been initiated under the Agriculture Sector Centrally Sponsored Schemes. These included Rashtriya Krishi Vikas Yojana (RKVY), Soil Health Card, Sub-Mission on Agriculture Mechanization (SMAM), Per Drop More Crop scheme, Rainfed Area Development (RAD), Paramparagat Krishi Vikas Yojana (PKVY), Sub Mission on Agroforestry (SMAF), Sub-Mission on Agriculture Extension (SMAE), National Food Security Mission (NFSM), National Mission on Edible Oils (NMEO) besides Sub- Mission on Seeds and Planting Material (SMSP).

The Minister informed that 4.14 lakh hectare of total land has been brought under Culturable Command Area (CCA), of which, 1.91 lakh hectare has already been covered. Besides, 0.33 lakh hectare is being covered under new projects to facilitate the farmers to overcome irrigation challenges.

He said that 18 irrigation projects are currently being implemented with financial assistance from NABARD while 14 additional projects have been sanctioned under RIDF with an outlay of Rs 4883.54 lakh to cater 11678 Hectare of land in J&K. He added that 200 community bore wells are under construction under the Per Drop More Crop scheme.
