# SIM smuggling racket busted with 5 nabbed for aiding cross-border gaming network

NEW DELHI, MAY 25 The IGI Unit of the Delhi Police has busted a SIM smuggling racket with alleged links to an international online gaming network, officials said on Saturday.

Five people, all from Madhya Pradesh, were arrested for fraudulently procuring and sending 398 activated Indian SIM cards abroad, primarily to Dubai, police in a statement said.

The racket came to light when the CISF intercepted one Sunil Rawat at Terminal-3 of IGI Airport on February 15.

Rawat, an Indian national scheduled to board a flight to Dubai, was found in possession of 398 active SIM cards, registered un-Pradesh and sent to him der different names, read via courier," it read. the statement.

# Mohan Bhagwat calls for unity in hindu society, making bharat mighty but righteous

#### NEW DELHI, MAY 25

RSS chief Mohan Bhagwat has called for unity in the Hindu society and making Bharat so mighty in military power and economy that it cannot be "conquered" even if "multiple powers come" together.

He, however, stressed that strength should be combined with virtues and righteousness as a "mere brute power" can be directionless leading to "blatant violence".

India has no option but to be powerful as it has been "witnessing the wickedness of the evil forces" on all its borders, Bhagwat said in an interview published in the latest issue of RSS-linked weekly magazine Organiser.

The interview was conducted following the RSS' highest decision-making body Akhil Bharatiya Pratinidhi Sabha's meeting in Bengaluru about two months ago.

"We must strive for strength. As we pray through the daily (prayer): prarthana 'Ajayyam cha visvasya dehisa saktim' (Grant us such strength that globally we are invincible)," Bhagat told the magazine when asked to share the Sangh's vision on national security, military strength and economic power.

He stressed that India must not be dependent on others for national se-

curity. "True strength is internal. We should be able to defend ourselves. No one should be able to conquer us, not even if multiple powers come together." "There are evil forces in the world that are aggressive by nature,' he said, adding, "We have no option but to be powerful as we have been witnessing the wickedness of the evil forces on all our borders." community and individuals from leading media and think tanks on Saturday, Tharoor said that India's message to Pakistan has been clear: "We didn't want to start anything".

"We were just sending a message to terrorists. You started, we replied. If you stop, we stop. And they stopped. There was an 88-hour war. We look back on that with a great deal of frustration because it needn't have happened at all. Lives have been lost. But at the same time, we look back on this experience with a steely and renewed sense of determination.

"There is now got to be a new norm. No one sitting in Pakistan is going to be allowed to believe that they can just walk across the border and kill our citizens with impunity. There will be a price to pay and that price has been going up systematically," Tharoor said.

He said that India has focused on a very different narrative from some of its neighbours.

"Our focus for some years now has been on being the world's fastest growing free markets democracy, attempting to focus on the development of our economy, our high emphasis on technology and technological growth and pulling large numbers of people from below the poverty line" not just into the 21st Century, but into the world and the opportunities the 21stcentury offers.

Tharoor spoke in detail about the horrific April 22 Pahalgam attack in Jammu and Kashmir in which 26 civilians were killed, including one Nepalese citizen, for which The Resistance Front took responsibility and then retracted.Jammu dining guide

He highlighted the dastardly manner in which the tourists were singled out and targeted based on their religion, and the retaliatory measures taken by India through Operation Sindoor, which targeted terror infrastructure in Pakistan and Pakistan-occupied Kashmir through precision strikes. He also listed the various terror attacks – from the 26/11 Mumbai terror attacks to attacks in Uri and Pulwama – carried out in India by Pakistani terror outfits.

The delegation led by Tharoor includes Sarfaraz Ahmad (JMM), Ganti Harish Madhur Balayogi (TDP), Shashank Mani Tripathi (BJP), Bhubaneswar Kalita (BJP), Milind Deora (Shiv Sena), Tejasvi Surya (BJP), and India's former Ambassador to the US Taranjit Sandhu.

The delegation reached New York on Saturday and will travel to Guyana from here. It will return to the US on June 3.

Tharoor underscored that India is "not interested, and we still remain absolutely clear, we are not interested in warfare with Pakistan.

"We would much rather be left alone to grow our economy and put our people into the world" of the 21st century, he said.

"We have no desire to have anything that the Pakistanis have. Sadly, we may be a status quo power. They are not. They are a revisionist power. They covet territory that India controls, and they want to have it at any price.

"And if they can't get it through conventional means, they're willing to get it through terrorism. That is not acceptable to us, and that's really the message that we are here to give all of you in this country and elsewhere," he said. Tharoor added that India is "determined now that there's got to be a new bottom line to this." He said over the vears, India has tried everything from giving international dossiers, complaints to the sanctions committee, diplomacy. "Everything has been tried. Pakistan has remained in denial. There has been absolutely no conviction, no prosecution of terrorists, no attempt to dismantle the terror infrastructure in that country and the continued presence of safe havens. "So from our point of view, this is it. You do this, you're going to get this back. And we have demonstrated with this operation that we can do it with a degree of precision and with a degree of restraint that the world, we hope, will understand. "We have a right to self-defence. We've exercised that right. We have not done so irresponsibly ... That's really the message I wanted to give you all today." "I don't work for the government, as you know, I work for an opposition party," Tharoor said, adding that he had authored an op-ed within a couple of days of the Pahalgam attack, saying "the time had come to hit hard, hit smart". "And I'm pleased to say that's exactly what India did." He added that "India sent a clear message" that it was not going to take terror lying down and it would answer. "But equally, that by delivering very precisely calculated, calibrated strikes on very specific targets, it was also sending a message that this was not meant to be the opening salvo in a protracted war, but just an act of retribution, that we were prepared to stop with that act." The delegation also visited Bab Al Bahrain, a historic landmark in Manama, which Panda described as a "symbol of Bahrain's rich cultural heritage and enduring ties with India." The delegation reached here on Saturday for a two-day visit. During the visit, they also met prominent Indians and civil society members.

"We are here at a difficult time... The difficulty has to do with the latest terror attack in Pahalgam and the hostilities with Pakistan thereafter.

"We come here in friendship to seek support. 26 men were killed at short range in front of their wives after verifying their religion. India has faced many such terrifying terrorist attacks... Our problem is that our terror attacks are all coordinated by one of our neighbours," he said during the meeting on Saturday.

He also added, "Bahrain and India have a deep and long-standing relationship ... I would like to thank the government of Bahrain for the consistent stand that it has taken. We truly appreciate Bahrain's strong comments during recent developments." AIMIM leader Asaduddin Owaisi, also a member of the delegation, while answering a question during the meeting, said, "Our government has sent us here, and various other delegations comprising all party members across various parts of the world, so that the world knows of the threat that India has been facing." The Panda-led delegation will head to Kuwait on May 26 as part of the diplomatic outreach to apprise prominent personalities and the Indian community there about India's stance against terrorism. Besides Panda and Owaisi, former Union Minister Ghulam Nabi Azad, ex-National chairperson of the National Commission for Women and Rajya Sabha MP Rekha Sharma are also among the delegation members.

Tensions between India and Pakistan escalated after the April 22 Pahalgam attack, which claimed 26 lives. India carried out precision strikes as part of Operation Sindoor on terror infrastructure in Pakistan and Pakistan-occupied Kashmir in the early hours of May

It was followed by Pakistan's attempt to attack Indian military bases on May 8, 9, and 10. The Indian side responded strongly to the Pakistani actions.

According to IMF data, India's per capita income has doubled from USD 1,438 in 2013-14 to USD 2,880 in 2025.

The IMF in its WEO report also said the Indian economy is projected to grow at 6.2 per cent in 2025-26, slower than earlier estimated rate of 6.5 per cent, due to escalated trade tensions and global uncertainty.

"For India, the growth outlook is relatively more stable at 6.2 per cent in 2025, supported by private consumption, particularly in rural areas," the IMF had said.

According to the report, the global growth is projected at 2.8 per cent in 2025, lower by 0.5 percentage points estimated earlier. In 2026, the global economy is estimated to grow at 3 per cent.

NITI Aayog approach paper titled "Viksit Rajya For Viksit Bharat @ 2047' said from being considered a part of the 'fragile five' economies of the world, India rose to become the top five economies of the world in just a decade.

The World Bank defines high-income countries as those whose annual per capita income is more than USD 14,005 (2024- 25). India has the potential and aims to be a high-income country by 2047. The approach paper said a Viksit Bharat @ 2047 will be a USD 30 trillion economy.

"It will have all the attributes of a developed country with a per capita income that is comparable to the high-income countries of the world today,; the paper said.

According to the paper, in order to achieve the goal of a Viksit Bharat by 2047, an overall framework for strategic interventions and reforms based on six key building blocks, with a total of 26 themes covered across all the building blocks have been identified.

The six key building blocks are: Macro-Economic Goals and Strategy; Empowered Citizens; A Thriving and Sustainable Economy; Technology and Innovation Leadership; A Global Leader, Vishwa Bandhu; Enabling factors — Governance, Security and Justice delivery. (Agencies)

Continuing with his argument, the RSS chief said, "So we must worship both virtue and strength. For the protection of the good, for the destruction of the wicked — should be the nature of our power." "When no option is available, then wickedness has to be eradicated forcefully," he said. "We are not doing this to dominate world trade, but to ensure that everyone should be able to lead a peaceful, healthy and empowered life." Asked if human rights defenders at the global level care about Hindus facing "exploitation and violence in the neighbouring countries", the RSS chief said someone would worry about Hindus only when Hindus are strong enough.

"As the Hindu society and Bharat are intertwined, the glorious nature of Hindu society will bring glory to Bharat. Such a strong Hindu society can only present a model for taking along the people of Bharat who do not consider themselves Hindus, as at one point they were also Hindus.

# **Movement Kalki Expresses Strong Outrage** over Disrespect of Cow; Demands Strict **Action from Administration**

# Lalu Yadav expels elder son from party, snaps family ties

NEW DELHI, MAY 25 Rashtriya Janata Dal president Lalu Prasad Yadav on Sunday expelled his elder son Tej Pratap Yadav from the party, besides declaring that he 'shall have nothing to do with the family'.

Tej Pratap had on Saturday evening announced on social media that he was 'in a relationship for 12 years' with a woman, despite being married and his divorce petition still pending before a family court in Patna.

He, however, deleted the post a few hours later, claiming on X that his Facebook page was 'hacked'.

Lalu Yadav, who announced his drastic move on social media, made no mention of the previous day's happenings, but criticised his elder son's actions, public conduct and 'irresponsible behaviour', saying 'disregard for moral values in personal life weakens our collective struggle to achieve social justice'.

He admonished Tej Pratap for behaving in a manner 'not in consonance with the values of my family' and declared that 'he shall have no role, henceforth, in the party and the family. He is expelled from the party for six years'.



The development came with barely a few months left for the Bihar assembly polls, which the RJD will fight under the leadership of Lalu's younger son, Tejashwi Yadav.

When Tejashwi Yadav, the former deputy chief minister, was asked about what was the proverbial last straw, he gave a guarded response but minced no words in stating 'things have not been to my liking'.

"My elder brother is an adult. He is free to make any choice in his personal life. But there are certain things we cannot tolerate. And this is what our national president has asserted in his post," said Tejashwi Yadav, the leader of the opposition in the state assembly.

Tej Pratap Yadav had made his political debut in the assembly polls of 2015, and is a second-term MLA with two brief stints in the state cabinet.

But unlike his younger brother, he has been in the news for all the wrong reasons.

A few months ago, he made headlines for threatening a policeman in his security with suspension upon refusal to dance as per his command and speeding on a two-wheeler without wearing a helmet.

Earlier, he had been in the news for an ugly marital dispute, besides antics like supporting rebels in the 2019 Lok Sabha polls, floating a parallel outfit 'Lalu Rabri Morcha' and occupying the chair reserved for the national president while at the RJD office.

Reacting to the turmoil in RJD, Janata Dal-United spokesperson Neeraj Kumar said, "Lalu Prasad has used a jack to salvage his reputation after his elder son tried to cover up his misdemeanour with the claim that his Facebook page had been hacked."

"But Lalu Prasad must remember that he will still be charged with dynasty rule and keeping mum when his daughter-in-law, a grandchild of a former CM, was humiliated," he said.

The allusion was to Aishwarya, the granddaughter of Daroga Prasad Rai, who tied the knot with Tej Pratap Yadav in 2018 but left his house a few months later, alleging that she was driven out by her husband and in-laws.

# **Delhi govt to suspend officials** for Minto Bridge flooding

NEW DELHI, MAY 25 The Delhi government is likely to take disciplinary actions against erring officials responsible for waterlogging at the Minto Bridge underpass after overnight showers, sources said on Sunday.

According to government sources, a junior engineer and pump operator responsible for the underpass will be suspended and the assistant engineer will be issued a show cause notice for supervisory lapses.

# **Women-led water revolution turns** dacoits into farmers in Rajasthan

NEW DELHI, MAY 25

Until about 15 years ago, Sampatti Devi and many women like her in Rajasthan's Karauli district lived in constant fear, dreading the day their husbands might not return home.

Repeated droughts, driven in part by declining rainfall linked to climate change, had turned their land barren.

Water sources dried up, crippling agriculture and animal husbandry, the lifeblood of their livelihood.

With no other way to survive, many men were forced into dacoity, hiding in jungles and risking their lives every day to evade the police.

Karauli's average annual rainfall dropped from 722.1 mm (1951-2000) to 563.94 mm (2001-2011), according to government data.

But in the 2010s, something remarkable happened. The women, weary of fear and despair, resolved to reclaim their lives

They convinced their husbands to come out of the jungle and give up arms.

Together, they began reviving old, dried-up ponds and constructing new pokhars (water bodies) with the help of Tarun Bharat Sangh (TBS), an Alwarbased NGO dedicated to water conservation since 1975.

"I would have been dead by now. She convinced me to come back and start farming again," recalls Jagdish, Sampatti Devi's husband, now 58, who surrendered his weapons and chose peace. Pooling every penny earned over the

years by selling milk, they built a pokhar at the base of a hill near their village, Alampur, in 2015-16. Bee Keepers of India Selling Pure

When the rains came, the pokhar filled and for the first time in years, their family had water, enough to sustain them for a longer period.

"Now, we grow mustard, wheat, pearl millet and vegetables," says Sampatti Devi, sitting proudly on the pokhar's embankment. She even rents it out for water chestnut cultivation, earning about Rs 1 lakh each season.

Over the years, 16 such pokhars have been built in the surrounding forest each capturing runoff from the slopes. Diesel pumps now lift water to irrigate fields.



says Karauli Superintendent of Police Brijesh Jyoti Upadhyay.

Community-led water conservation revived groundwater sparked hope and renewed farming opportunities.

Sumit Dookia, an associate professor at Guru Gobind Singh Indraprastha University and a Rajasthan native, says the Chambal region's rocky terrain hastens rainwater runoff, limiting groundwater recharge.

He says that similar transformations have also occurred in Uttar Pradesh's Etawah, where former dacoits returned to farming.

In Karauli, this wave of conservation has transformed the Serni, once a seasonal river, into a perennial one.

Just a decade ago, the river would run dry after Diwali, leaving people desperate for water.

"Now, the river holds water even in the peak of summer. The groundwater level has risen to just five to 10 feet below the surface," says Ranveer Singh from TBS.

Forty years ago, he says, the river flowed all year round, but overuse and climate change had drained it dry. With no options left, some men migrated to cities in search of work, while others turned to mining or dacoity.

"Illegal mining exposed them to lethal silica dust, causing silicosis, a painful and incurable lung disease. Many did not live past 40," said Rajendra Singh, the Magsaysay Award and Stockholm Water Prize-winning water conservationist who leads TBS.

A 2013 study by the National Institute of Miners' Health (now part of ICMR-NIOH) found that 74 per cent of surveyed sandstone workers in Karauli suffered from silicosis.

Water scarcity even disrupted marriage decisions. Families of prospective brides avoided sending daughters to this parched land, while poverty forced many Karauli parents to marry off their daughters early.

In Bhoorkheda village, where many families were forced to marry off their daughters early under the weight of financial hardship, 55-year-old Prem, the wife of a former dacoit, gave up four bighas of her own land to build a pond has brought water to grow wheat and pearl millet and fed the families in her village

Lajja Ram, 60, also from Bhoorkheda, admits he turned to dacoity out of desperation.

"My father was a farmer. There was enough water in his time. But as I grew up, rainfall declined, wells dried up and farming became impossible. We were lucky to produce even two to four manns (80-160 kg) per bigha. Our cattle died, and we felt like we were next," says Lajja Ram, who once faced 40 criminal cases.

It was his sister who finally persuaded him to surrender and join water conservation efforts.

Now, they grow wheat, mustard, chickpea and pearl millet on their 10 bighas of land, own eight buffalos, several goats and have enough to eat. "'Ab aanad hai' (Now, there is happiness)," he says.

In Arora village, 70-year-old folk singer Siyaram remembers when rains failed, crops withered and children wept from hunger.

His 30 bighas of land lay parched and his sons migrated to cities. His wife, Prem Devi, who passed away two years ago, had inspired him to join water conservation.

Siyaram sings of that time: "Paani ki dori hath nahi, tum chaho to barsat nahi. Paani ki ajab kahani hai. Ab bhai khuwari bin paani hai'. (You cannot control rain; it won't come when you wish. Water's story is strange. Now, brother, the land is barren without water)."

Today, Siyaram sings another tune of hope.

"Paani hi jeevan ka saathi, paani bin mar jaye haathi. Sun lo dada, bhai, naati... mil jayega dhan ratan, agar hum paani rokne ka karein jatan'. (Water is life's companion. Without it, even the elephant dies. Listen, elder, brother, nephew... We will find treasure if we work to conserve water.)"

soon, strict disciplinary action, including suspension, will be taken against the responsible engineer.

The government had earlier identified the Minto Bridge underpass as one of the seven critical waterlogging hotspots, where special attention had to be given and the monitoring was done by the engineer-in-chief of the department.

"The engineer-in-chief has been directed to issue warnings to all the PWD officials to avoid such incidents in future," sources added.

The PWD received approximately 40 calls regarding waterlogging due to heavy overnight rains.

With the Central Board of Secondary Education (CBSE) directing schools to set up dedicated 'Sugar Boards' to underline the importance of limiting sugar consumption, experts feel the move will encourage both students and parents to make informed choices on sugar intake.

The initiative targets a growing public health concern: the silent but significant rise in childhood obesity, Type-2 diabetes, and metabolic disorders.

As part of the move, which has stirred up enthusiasm among health experts, educators and nutritionists, schools across India have been directed to prominently display sugar awareness boards on their campuses to encourage both students and parents to recognise the 'hidden' sugars in their daily diets.

Dr R Goswami, professor of endocrinology at AIIMS Delhi, called the move a good initiative.

"Carbohydrates, especially those with excess of free sugar such as cold drinks and maida-rich food, are relatively cheaper sources of energy and calories when compared to protein-rich

# Liberian ship with hazardous cargo sinks off Kerala coast

#### NEW DELHI, MAY 25

A Liberian cargo ship carrying 640 containers onboard, including 13 hazardous cargoes, has capsized and sunk in the sea off the coast of Kerala, officials said on Sunday, raising fears of environmental damage.

"In the early hours of 25 May, MSC ELSA 3 listed rapidly and capsized at position 09°18.76'N 076°08.12'E and sank," a Coast Guard statement said on Sunday.

It said the three remaining crew abandoned the sinking vessel and were rescued by INS Sujata, which joined operations last evening.

The ICG said the ship Saksham, equipped with pollution response equipment, has been positioned at the scene to respond to any oil spill scenario.

Of the 640 containers onboard, 13 contained hazardous cargo, while 12 containers with calcium carbide were present, it said.

"The ship had in its tanks 84.44 MT of diesel and 367.1 MT of furnace oil," the ICG said

Noting that the sensitive coast of Kerala is home to both vivid biodiversity and is a major tourist attraction, it further said the ICG has geared up pollution response preparedness and coordination with the state administration for all possible scenarios.

"ICG aircraft with advanced oil spill mapping technology are undertaking an assessment of the situation. Presently, no oil spill has been reported," it added.

The Indian Coast Guard also said it is fully geared to respond to the emerging scenario and is closely monitoring the environmental impact in the aftermath of the sinking of MSC ELSA 3.

The development comes amid intense efforts by the Indian Navy and the Coast Guard, which were exploring methods to assist in towing the vessel.

The Liberian container ship, carrying marine fuel, listed several degrees about 38 nautical miles off the Kerala coast on Saturday, causing its cargo to spill into the sea.

A Defence PRO said another vessel from the parent company had reached the area as part of the assistance efforts. Earlier, authorities had stated that out of the 24 crew members on board, 21 were rescued, while three remained onboard as per instructions from the company.

He added that the Coast Guard, which spearheaded the rescue operation, and Indian Navy ships are maintaining their positions in the area and monitoring the situation.

The Kerala State Disaster Management Authority (KSDMA) has cautioned the general public against touching any cargo containers or oil spills that may wash ashore.

They have also urged people to immediately inform the police if they spot any containers or oil on the shore. The 184-metre-long vessel, MSC ELSA 3, departed for Kochi from Vizhinjam port on Friday.

At around 1.25 p.m. on May 24, the company owning the ship informed Indian authorities that it was listing by 26 degrees and sought urgent assistance.

The Coast Guard was coordinating rescue operations by maintaining ships and aircraft near the distressed vessel.

The vessel's 24-member crew comprises one Russian (the Master), 20 Filipinos, two Ukrainians, and one Georgian national.

According to the Kerala State Disaster Management Authority, there is a possibility that cargo --including containers and oil-- may wash ashore. KS-DMA also warned that oil films could appear along parts of the coast.

The Coast Guard has confirmed that the vessel was carrying Marine Gas Oil (MGO) and Very Low Sulphur Fuel Oil (VLSFO).

# Factors that will drive the markets this week

NEW DELHI, MAY 25 Movement in the equity market this week will be guided by a host of macroeconomic data announcements, global trends and trading activity of foreign investors, analysts said.

Stocks markets concluded the last week on a subdued note, as investors grappled with global uncertainties.

"The market's muted performance was driven by a combination of global and domestic factors.

"On the global front, rising US bond yields and concerns over the United States' mounting debt burden triggered foreign portfolio outflows, putting pressure on emerging markets, including India," Ajit Mishra, SVP, Research, Religare Broking Ltd, said. In the week ahead, the release of India's industrial and manufacturing

for May 28, along with the Q1 GDP growth figures, will offer insights into the economic recovery trajectory.

Updates on the progress of monsoon will also be closely monitored, he said.

On the global front, developments in the US bond market, the release of FOMC (Federal Open Market Committee) minutes, and progress in the India-US trade negotiations will continue to influence market sentiment, Mishra said.

"Moreover, the scheduled monthly expiry of May derivatives contracts and the final leg of the Q4 earnings season with results from key companies like Bajaj Auto, Aurobindo Pharma and IRCTC will remain in focus," Mishra added.

Last week, the BSE benchmark dropped 609.51 points or 0.74 per



cent and the NSE Nifty declined 166.65 points or 0.66 per cent.

"Looking ahead, markets are expected to remain firm, with participation likely from the broader market segments as macro and earnings tailwinds continue to provide support.

"Investors will also be closely watching key data releases this week, including quarterly GDP figures for both India and the US," Siddhartha Khemka, Head - Research, Wealth Management, Motilal Oswal Financial Services Ltd, said.

The Reserve Bank on Friday announced a record Rs 2.69 lakh crore dividend to the government for FY25, 27.4 per cent higher than 2023-24, helping the exchequer to tide over challenges posed by US tariffs and increased spending on defence due to the conflict with Pakistan.

In the week ahead, market participants will first react to the RBI's record dividend transfer of Rs 2.7 lakh crore to the government and its impli-

ed cations for fiscal policy, Mishra said.

"Given the continued uncertainty surrounding the US economy, foreign investment flows, and trade negotiations, Indian markets may see a phase of consolidation in the near term," Gaurav Garg, Analyst, Lemonn Markets Desk, said.

The market has been volatile throughout the last week amid concerns over US fiscal health due to rising debt, an expert said.

Vinod Nair, head of research, Geojit Investments Limited, said, "Investor attention is further revolving around US-India trade talks and strong domestic macroeconomic indicators.

"However, recent FII outflows, driven by rising US bond yields amid concerns over mounting US debt, may weigh on the market sentiment."

Optimism around a potentially record-high dividend from the RBI is boosting hopes for fiscal consolidation, reflected in falling Indian bond yields, Nair added.

# Centre plans to list at least five RRBs by FY27-end

NEW DELHI, MAY 25 After the merger of regional rural banks (RRBs) under the "One State, One RRB" policy to improve their efficiency and minimise competition among public-sector banks (PSBs) that sponsor them, the government is planning to list at least five RRBs by the end of financial year 2026-27 (FY27).

After the latest amalgamation that came into effect on May 1, there are 28 RRBs in 26 states and two Union Territories (UTs), with more than 22,000 branches covering 700 districts.

"Our aim is to strengthen the reputation of RRBs as credible and valuable institutions, both for stakeholders and investors.

"If RRBs pursue public listings, it will not only boost public accountability but also help them operate more efficiently by securing additional funding," a senior government official said. Improve grammar, word choice, and

According to the finance ministry's draft guidelines of 2022, RRBs with a minimum net worth of Rs 300 crore must also have a capital adequacy ratio above the regulatory minimum level of 9 per cent in each of the preceding three years.

Additionally, these regional lenders must have reported an operating profit before tax of Rs 15 crore in three out of preceding five years.

The identified RRBs must also have a return on equity (RoE) of 10 per cent and a return on assets (RoA) of 0.5 per cent in three out of five preceding expected to reach around 5.2 per cent by FY30 from about 3.7 per cent as of FY24, according to a PwC India report.

Oriented towards rural areas, RRBs were established regionally, with capital contributed by the Government of India, state governments, and sponsor banks under the RRB Act, 1976.

RRBs predominantly operate in rural setups, with approximately 92 per cent of their branches in rural or semi-urban areas.

Prior to consolidation, the number of loss-making RRBs steadily declined from 18 in FY20 to three in FY24.

The company has a truck-management platform and a freight-forwarding business.

"These are capitalised businesses. They come with very high return on capital employed (ROCE)," said D Muthukumaran, chief financial officer (CFO) of APSEZ, adding that growth in logistics is likely to be inorganic (business growth from acquisitions).

JSW Infrastructure (JSW Infra) acquired a majority stake in Navkar Corporation, a logistics firm, for Rs 1,644 crore in FY25.

Lalit Singhvi, whole-time director and CFO of JSW Infra, told Business Standard earlier the company is looking for more inorganic opportunities in logistics and has submitted bids to the National Company Law Tribunal for acquisitions.

JSW Infra has two Gati Shakti Cargo Terminals (GCT) and plans to participate in more such opportunities to build a nationwide logistics network of 15-20 GCT centres in five years to have an "industry-leading ROCE".

The company aims to use 100 acres



of undeveloped land in Panvel, Maharashtra, and Morbi, Gujarat, for its logistics plans.

It seeks a logistics revenue of Rs 8,000 crore and a 25 per cent ebitda margin by FY30, led by adopting an asset-light model via GCTs, synergies with the JSW Group, opportunities in the logistics sector, and major cleanup in accounts, said analysts at Ellara Capital in a note. (Ebitda stand for earnings before interest, taxes, depreciation, and amortisation)

The logistics strategies of APSEZ and JSW Infra are a natural extension of their port businesses, according to experts.

The companies seek to earn more from customers by offering "end-toend solutions", improved port efficiency, and more cargo volumes.

Manish Goel, founder and managing director (MD) of Equentis Wealth Advisory Services, said, "APSEZ benefits from scale, a pan-India port presence, and early investments in multi-modal connectivity and warehousing, making it one of the few players capable of offering genuine end-to-end solutions.

"Meanwhile, JSW Infra leverages the group's industrial backbone. With steady captive cargo and access to inhouse infrastructure, it enjoys operational certainty and volume visibility—two critical ingredients in logistics."

APSEZ's FY25 logistics revenue grew 38.6 per cent to Rs 2,881 crore, while ebitda increased 18.9 per cent to Rs 642 crore.

Margins declined to 22 per cent from 26 per cent in FY24.

Expansion will reduce overall ebitda percentage but increase ROCE, the company said.

It has guided trucking revenue, which was Rs 428 crore in FY25, to grow at least three-fold in FY26.

JSW Infra reported a logistics rev-

enue of Rs 250 crore and ebitda of Rs 41 crore in FY25.

It has guided FY26 logistics revenue to grow 50 per cent, driven by rake additions, terminals, and GCT initiatives. The expansion plans of the two companies may have mixed financial implications as logistics is a low-margin business, experts said.

According to Vijay Agrawal, MD investment banking at Equirus Capital, ports give ebitda margins of 60-70 per cent and ROCE of 12-17 per cent.

Logistics generates lower ebitda (15-25 per cent) and ROCE (12-15 per cent).

"For example, APSEZ's logistics contribute 12 per cent of revenue but only 4 per cent of ebitda.

"JSW Infra is better positioned with low leverage and a 54 per cent margin at the group level, though logistics returns are yet to materialise fully."

APSEZ plans a multi-year capital expenditure of Rs 20,000 crore to Rs 20,500 crore in land, new trucks, agriculture silos, trains, MMLPs, and warehouses.

JSW Infra has earmarked Rs 9,000 crore for expanding its logistics business between FY25 and FY30.

Goel believes that such huge capital outlays by operators is a risk.

"For APSEZ, logistics yields around 18 per cent ebitda margin — lower than core port operations. As capital intensity rises, this margin pressure could dilute overall profitability.

"The company's net debt-to-Ebitda ratio is also expected to increase, adding to financial strain."

There are challenges like a volatile trade environment, potential delays in land acquisition, regulatory clearances and scarcity of skilled human capital.

However, the experts believe the two companies' logistics plans are worth it, as they are long-term investments with strategic methods of expansion. survival. "Profitability would be sustained this year as we expect improvement in net interest income," Debadatta Chand, MD and CEO, Bank of Baroda, tells Abhijit Lele and Anupreksha Jain/Business Standard.

Net profit for Q4 grew, albeit marginally, despite a fall in the net interest income, as the other income provided the support.

What is your outlook on treasury income going forward?

Despite a fall in the net interest income, profits grew because of healthy treasury income and recovery from written-off accounts.

As we are in the rate-easing cycle, income from the treasury is going to sustain, that is what our sense, as further rate cuts are expected.

The profitability would be sustained this year as we expect improvement in net interest income (NII) owing to change in liquidity and interest rate trajectory.

However, that is not going to happen in the first quarter because deposit repricing happens with a lag.

So, on a full year basis, I am hopeful that the NII growth would be higher.



In terms of profitability, we will maintain return on investments (ROI) in excess of 1 per cent.

You said the bank does not require fresh capital now as the capital adequacy ratio is healthy. How much credit growth would the current capital base support?

What is the size of the sanctioned pipeline for the bank to support guidance for 10 per cent growth in corporate credit in FY26?

We are almost at a level of 14 per cent growth in the loan book. So, with the current capital it can support 15 per cent loan growth on a consistent basis. Bank has enabling provision to raise capital up to Rs 7,500 crore over a longer period of time.

The bank is very well capitalised and can sustain growth for at least next three to five years based on the internal approval.

As of today, the pipeline is Rs

60,000 crore. The sanctions which were done till last year, many of them are term loans. They are disbursed over a period of time.

RBI has announced final guidelines for liquidity coverage ratio (LCR), how much benefit do you expect from the revision in LCR norms?

LCR depends upon many aspects such as liability profile, high quality liquid asset. As on March 31, our LCR was at 123 per cent.

The revised guidelines will release around 7-8 per cent of liquidity.

While I am not quantifying the absolute amount, I think it will allow us to lend more in order to achieve a higher profit.

It will add around 8 per cent to the current LCR.

The bank reduced home loan rates. In order to protect margins, does the bank plan to increase the spread on other loans as well?

KRCEEA Urges Immediate Restoration of Reservation in Promotion in J&K UT in Light of Supreme Court Orders, High Court Orders, CAT Jammu, CAT Kashmir Order and Constitutional Provis ions

The J&K Reserved Categories Electrical Engineers Association (JKRCEEA) strongly appeals to the administration of the Union Territory of Jammu & Kashmir to immediately restore reservation in promotion for reserved category employees, as mandated by various constitutional amendments, Supreme Court judgments, J&K High Court ,CAT Jammu as well as Srinagar bench orders and statutory laws.

While addressing media in Jammu, Legal Advisor JKRCEEA Shashi Bhushan Thappa and Advocate Anwar choudhary, advocate Parvez Ahmed Choudhary, Mohd Akram Choudhary said, In 2015, the Division Bench of the Hon'ble High Court of J&K struck down reservation in promotion under the Reservation Act 2004 and Rules 2005 in the Ashok Kumar Sharma & Others vs State of J&K case. This judgment was stayed by the Hon'ble Supreme Court in multiple tagged Special Leave Petitions (SLPs), including those filed by Mohammad Hanief Lone, Gagan Jyoti, judiciary officers, and engineers in Nasib singh vs State of J&k SLP. The Supreme Court allowed promotions for reserved category employees, subject to eligibility and availability of vacancies.

Despite clear legal backing, certain officers in the Law and General Administration Departments misled the Executive Heads, resulting in the non-restoration of promotion reservations. In 2019, the President of India extended the 77th Constitutional Amendment to J&K through a Presidential Order, rendering the High Court's 2015 judgment infructuous. Post the abrogation of Article 370 and enactment of the J&K Reorganization Act 2019, the Reservation Act 2004 remained fully applicable to the UT, yet reservation in promotion remained withheld.

Further, GAD Circular No. 10-JK(GAD) of 2021 introduced an illogical policy on reserved slots that was challenged and quashed by the Hon'ble Central Administrative Tribunal benches in Jammu and Srinagar. The Hon'ble High Court of J&K and Ladakh, in Mohammad Jamal Sheikh & King Kumar vs J&K UT (judgment dated 06-03-2025), also directed the government to promote reserved category employees on their respective slots based on quantifiable data and barred further promotions unless this is ensured.inspite of filling vacant reserved category slots, Govt. is making placement/ incharge promotions to deprive the reserved categories employees from promotions. Adding to this, the Hon'ble Supreme Court's judgment in Jarnail Singh & Others vs Lachhmi Narain Gupta & Others (28-01-2022) restored reservation in promotion nationwide, directing all governments to collect quantifiable data and implement reservation accordingly. Following this, most states and UTs complied-except J&K, which continues to deny promotions under the false pretext of pending litigation. JKRCEEA calls for accountability against those officers in GAD and Law Department responsible for misleading the administration and causing injustice to lakhs of SC/ST/OBC employees, who comprise nearly 50% of J&K's government workforce. Departments issuing "look-after" and "staff gap" promotions are in direct contempt of the High Court's rulings and must immediately cease such practices. We urge His Excellency the Lieutenant Governor, Hon'ble Chief Minister (when appointed), Hon'ble Members of Parliament, Chief Secretary, and all MLAs from reserved categories to intervene decisively. It is imperative that reservation in promotion be restored immediately in compliance with constitutional, legal, and judicial mandates to uphold the rights of marginalized communities in the Union Territory.

AMR occurs when micro-organisms such as bacteria, viruses, and parasites develop some mechanisms to resist being killed by antimicrobial. Thus infection is formed and continues to spread to others. The antibacterial component has to rapidly emerge as the world's public health crises to not understand the role of 'diagnostic stewardship' i.e. proper use of drugs in the second place after climate change. The way of suitable and better use of medicines and not knowing its properties and defects, the body becomes home to a variety of diseases, those medicines also stop working, which was so better bearing in the beginning. This problem is all over the world. According to the organisation, this global health threat is expected to grow at a wider level. All the mulls in the world should look into it as a priority. At the time of Corona, millions of people had died despite being treated on the basis of mere symptom of Covid-19. The U.S., Italy, China and India were major countries, where the impact of Corona was widespread. Since then, it had started to feel that due to new diseases in the future, it could continue to be a panic among people at all times because of nonreceipt of medicines or the impact of the medicine being minor. Forty lakh 19 thousand deaths were linked to antimicrobial resistance in 2019, according to a study published in 'Laset' magazine. The the study suggests that any person, at any stage of life, can have antibacterial properties bearing. According to medical field researchers, the 'antimicrobill stewardship' initiative aims to ensure that the right antibiotic is given to the right patient from time to time, with the right causing at least dose. harm to the sick. But the kind of disorder that is in the field of medicine, does not think that the ill gets the appropriate medicine at the right time and without any extra pressure without proper treatment. There are a variety of discrepancies and complications in the field of Indian medicine. The entire system of this area is a waste

corruption.

Significantly, drugs have a huge market in India. Here arbitrarily they decide the prices of medicines. With this, millions of people are spontaneously ill with the business of fake drugs and are getting into the mouth of death. Yet we should expect that the global panic will not arise from AMR as it happened in the Corona period.

# Mediaism: A new faith shaping views

We live in a happening world. And the world is in chaos. Look around: what we see are geopolitical instabilities due to the wars that are currently on, and equally, the wars that could erupt in the near or medium-term future. Geopolitics is suddenly the new politics. And war is the language at play again. Even as I write this, Pakistan's minister Hanif Abbasi has threatened India with a "fullscale war" if India stops water supply to Pakistan in retaliation for the recent barbaric killings in Pahalgam. Abbasi even threatened India with nuclear retaliation, saying 130 nuclear warheads in Pakistan's arsenal are kept "only for India". The language is offensive. Offence is the new defence. The chaos we live amid is further compounded by the different philosophies that dominate the world. In some parts, right-wing politics is coming to the fore with gusto. Even as this happens, there is a clarion call to get back to the basics of religion and religious belief systems that have dominated our lives for centuries. While some parts of the world are singing the death of the "inclusive" and the "all-embracing" movements, other parts are emerging as protest-centres against all that is "different" and "not meant to be". In other parts of the world, there is a clear divide between the war philosophies at play. A case in point is Israel and Palestine. The entire world is divided on the lines of two differing philosophies on them. And in another part of the world, it is Ukraine versus Russia, and the completely divergent sets of passion across these two lines of thought and action. In some parts of the world there is ethnic strife, just as there is drought, malnutrition and poverty in another. In yet another part of the world, there is a battle against obesity. There is the flood-ravaged part of the world, just as there is the drought-mangled. The world sure is a complex place. A complex place with a complex set of issues. Issues that get their share of voice on the basis of the perspective that popular media in that country and region take.



The world is a perspective.

Media has a rather important role to play in shaping perspectives. These perspectives are really not individual perspectives and views that must become the collective one. Instead, these are collective perspectives that need to become the singular view of a nation. Sadly, this is not the way it always works. More often than not, the singular view becomes one that gets embraced by a society that believes in the rule of the majority.

To an extent, the media shapes and drives everything in a society. While this may sound a bit too much, just think of it this way. If you were not to read a single newspaper, not listen to the radio or watch television at all, and if you were to disconnect yourself from everything that you do on a smartphone, and finally if you were to switch off from word-ofmouth and word-of-digital altogether, wouldn't you live in an ideal (and Utopian) world? A world where your primary concern would be you and your immediate family and the local community?

The fact remains solid. Media today does not just present the fact. It actually adds value (or depletes value, depending on which side of the fence of this argument you sit) to the fact. A television anchor reads the fact with a tone of voice that in itself conveys a lot. Anxiety is in the voice and the manner. It would be so boring otherwise, wouldn't it?

Added to it, the presenter adds perspectives. There are voices invited to contribute. Each voice and face contributes an individual perspective. Some add anger, some fear, some anxiousness and some others add bluster. The viewer then is "exposed" fully. The viewer needs to make up his mind on which argument to buy. And he does. You are indeed what you watch. The exposed individual then adds to the cascade with his own notions on his micro social media feeds that cater to yet another impressionable audience down the line across the food chain of news and views consumption.

In a simple society, it is quite likely that there are a host of people who just have no view on a subject. Media helps and aids to create and curate a view. Media helps to cobble together a perspective and a view. Media corrupts even. Aids you to hold a view that you possibly mustn't hold even in a civilised society (whatever that means).

Primary mass media vehicles such as television, print and radio, aided by secondary cascade mediums such as micro social media feeds, create the perspective that society holds. There is no perfect method to the madness of perspective building though. The perspective that you build within yourself of an issue becomes you. Shallow views and opinions become rigid as they stew in their own sauce. And rigid opinions and views have a way of becoming a way of thinking itself. And that is a religion in itself.

I do believe there is a new religion in our midst today. I will call it 'mediaism'. You and I are a function of what we read, watch and hear. Media helps (or hurts) us in all of this. Media is what the interstitium is to the human body. It binds us all internally. It helps create the you that you have become. It helps create the I that I have become.

If you do not believe in the argument I put forth, just sit back and think about your view on any issue that is confronting you, your family or for that matter the nation. How were you introduced to the issue? Who "exposed" you to the issue? What was your first opinion on it? Was that opinion (if you had one) based on the residue of what you had read or heard in passing sometime in the past? If you did not have an opinion at all, how did you form one? Who helped you form that? What mediums 'helped' in forming it. Was it just one medium? Was it one person? Was it one news-presenter? Was it one ethos? Was it one bias? Was it an experience you had while growing up?

Like it or not, all of us are zealots. The religion you and I are immersed in today is 'mediaism'. We have been a part of it for a while now. I suspect we will be for a long, long time as well.

# Real Madrid bids farewell Michael Schumacher's Ferrari sets to Ancelotti, Modric New Delhi, MAY 25

#### NEW DELHI, MAY 25

Real Madrid delivered manager Carlo Ancelotti and midfielder Luka Modric a victory in their final game at the Santiago Bernabeu on Saturday, with Kylian Mbappe scoring twice in a 2-0 win over Real Sociedad to end their LaLiga season.

Ancelotti will become Brazil coach after leaving Real, while Modric is set to leave the club after next month's Club World Cup, which will be held in the United States.

Despite Madrid having little to play for after surrendering the LaLiga title to rivals Barcelona, the atmosphere at the Bernabeu was emotionally charged as home fans focused on providing a fitting tribute to their departing icons.

Ahead of the match, giant banners were unveiled with images of Ancelotti and Modric, while the stadium announcer's confirmation of the Croatian's place in the starting line-up was met with thunderous applause.

The crowd also rose to their feet in the 10th minute to chant "Modric, Modric" and both teams came together to give the midfielder a guard of honour when he was substituted in the 87th minute.

Spaniard Lucas Vazquez, who is reportedly leaving the club at the end of the season, also received a standing ovation when he walked off the pitch in the second half.

Carlo Ancelotti is thrown in the air in celebration by his players after his last

In an action-packed opening 45 minutes, Mbappe kept Sociedad's defence busy with a number of attempts at goal, before Madrid were awarded a penalty in the 37th minute when a VAR check confirmed Pablo Marin's handball.

Mbappe's tame effort from the spot was easily saved by goalkeeper Unai Marrero, but the Frenchman was quick to rifle home the rebound for his 30th league goal.

Ancelotti brought on Vinicius Jr in the second half and the Brazilian engineered Real's second goal, playing a delicate through ball that was turned in by Mbappe from a tight angle, all but ensuring a Pichichi award as LaLiga's top scorer.

Mbappe's first goal also made him just the fourth player in LaLiga history to score 30 league goals in his debut campaign, matching the accomplishments of Pruden (1940-41), Romario (1993-94) and Ronaldo (1996-97).

Madrid finished second in the standings on 84 points, one behind champions Barcelona who have a game in hand.

Luka Modric tries to work his way past a host of Real Sociedad defenders. Japanese winger Takefusa Kubo, who

was on the books at Real for a few seasons, was Sociedad's best outfield player, but his mazy runs in the hosts' final third failed to generate any real opportunities.

There was also cause for emotion in the visitors' dugout as Sociedad bid farewell to manager Imanol Alguacil, who ended a seven-year spell in charge during which he won the Copa del Rey and led the club to European football for five successive seasons. Michael Schumacher's Ferrari Formula One car that won the 2001 Monaco and Hungarian Grand Prix races was sold for \$18.17 million, according to RM Sotheby's.

Selling ahead of qualifying in Monaco on Saturday, the F2001 car that the legendary German driver used en route to that year's world title became the most expensive F1 vehicle driven by Schumacher to be sold at auction.

The \$18.17 million price tag topped the \$13.2 million a bidder paid for Schumacher's 2003 Ferrari F2003 in 2022. It also became the fourth-most expensive F1 car ever sold. The world record sits at \$52.52 million, which occurred earlier this year for a Mer-



cedes W196 streamliner that was driven by Formula One legends Juan Manuel Fangio and Stirling Moss in the 1950s. Schumacher, now 56, drove the F2001 Ferrari in his fifth and final

Monaco Grand Prix win, which he followed up with a victory at the Hungarian Grand Prix. The latter win clinched Schumacher's fourth F1 world title.

# Real Madrid appoint Xabi Alonso as new manager

#### NEW DELHI, MAY 25

Xabi Alonso has been appointed Real Madrid manager, the LaLiga club said on Sunday as the Spaniard returns to the Santiago Bernabeu where he spent six seasons as a player and won several trophies.

Alonso has signed a three-year contract until June 2028 and the 43-yearold replaces Carlo Ancelotti, who took charge of his last game on Saturday.

With Ancelotti finishing his second stint at Real without winning a major trophy, Real moved quickly to change coaches after the veteran Italian agreed to coach Brazil.

Alonso had been in charge of Bayer Leverkusen and confirmed he would be leaving the German club this month.

The Spaniard took charge of Leverkusen in October 2022 and guided them to the double last season as they lifted their first Bundesliga title, without losing a game. They also won the German Cup and reached the Europa League final.

He had a contract at Leverkusen until 2026 but the club said

Alonso will be presented as Real coach on Monday and will take charge from June 1, ahead of the Club World Cup which starts in the United States next month.

The former Spain international joined Real in 2009 from Liverpool and made 236 appearances for them, winning a LaLiga title, two Copa del Rey trophies and the club's longawaited 10th European crown.

He began his coaching career at Real's youth academy where he managed the Under-14 team during the 2018-19 season, winning the league and the Champions tournament.

He took charge of Real Sociedad's

Mumbai Indians, Punjab Kings in

reserve team before making the big step up to take the Leverkusen job.

Alonso will hope to follow in the footsteps of another Real Madrid midfielder, Zinedine Zidane, who returned to coach the Spanish club and won three Champions League titles in a row.

Under Ancelotti, Real will finish second in LaLiga behind Barcelona, who also beat them in the Spanish Super Cup and Copa del Rey finals this season.

Real were knocked out of the Champions League as holders in the quarterfinals by Arsenal.

Alonso's first test will be the Club World Cup where they are in a group with Saudi side Al-Hilal, Mexican club Pachuca and Austria's RB Salzburg in the new 32-team tournament that kicks off on June 14.

#### **TOKYO, MAY 26**

# Congress backs EAM Jaishankar's 'India will never succumb to nuclear blackmail' remarks

#### NEW DELHI, MAY 25

Congress on Saturday fully backed the External Affairs Minister (EAM) S. Jaishankar, who delivered a strong message during his official visit to Germany, asserting that India will never yield to nuclear threats and will continue to handle issues with Pakistan on a bilateral basis.

statement Jaishankar's received rare bipartisan sup-port back home, with leaders across party lines endorsing his firm diplomatic tone.

Congress leader Sandeep Dikshit welcomed the state ment, saying: "Absolutely right. We have always had this right, and I would also expect that when we are engaging with countries like Germany, we seek their support against Pakistan as well. What Pakistan does, what its economy is like, that's their concern. We've always said that we want good

relations with all our neighbours.

He added that for the past 30-35 years, the way Pakistan has promoted terrorism, these are outright criminal acts, crimes against humanity

"These countries should also identify Pakistan as a rogue state and act accordingly," he said.

Meanwhile, echoing a similar sentiment, Shiv Sena (UBT) spokesperson Anand Dubey said that EAM Jaishankar is India's External Affairs Minister and an expert in diplomatic affairs

"If he is stating in Germany that India will not tolerate terrorism at any cost and won't succumb to Pakistan's repeated nuclear threats, then this reflects not just the stand of the opposition, but the sentiment of the entire nation and our armed forces," he said.

EAM Jaishankar's remarks came days after the deadly

Pahalgam terror attack on April 22 and India's decisive response through Operation Sindoor.

Speaking alongside German oreign Minister Johann Foreign Wadephul during a joint press conference, EAM Jaishankar said: "I come to Berlin in the immediate aftermath of India responding to the Pahalgam terror attack. India has zero tolerance for terrorism. India will never give in to nuclear blackmail, and India will deal with Pakistan purely bilaterally. There should be no confusion We also value Germany's understanding that every nation has the right to defend itself against terrorism."

Germany also expressed solidarity with India in the fight against terrorism, with Minister Wadephul affirming Berlin's support and acknowledging India's right to defend its citizens and sovereignty.

# No tariffs, no US sales: **Trump's warning to Apple** on India production

NEW DELHI, MAY 24 US President Donald Trump has said it is ok for Apple to go to India to build its plants, but then the tech company will not be able to sell its products in America without tariffs.

Trump's remarks came as he signed multiple executive orders in the Oval Office to boost US nuclear power.


"But I had an understanding with Tim (Cook) that he wouldn't be doing this. He said he's going to India to build plants. I said, 'That's okay to go to India, but you're not going to sell into here without tariffs.' And that's the way it is," Trump said on Friday.

"We're talking about the iPhone. If they're going to sell it in America, I want it to be built in the United States," he said.

Early on Friday, Trump said in a social media post that he expects Apple iPhones that will be sold in the US to be manufactured in America and not India, or anyplace else, threatening to put a 25 percent tariff on the tech company's products if it does not comply.

"I have long ago informed Tim Cook of Apple that I expect their iPhones that will be sold in the United States of America will be manufactured and built in the United States, not India, or anyplace else. If that is not the case, a Tariff of at least 25% must be paid by Apple to the US. Thank you for your attention to this matter!" Trump said.

Just last week, Trump had said in Doha during his visit to the Middle East that he had told the Apple CEO to not build in India and instead build its manu-



ment.

cturing capacity in the US

We have Apple, as you know, that's coming in, and I had a little problem with Tim Cook yesterday, Trump had said in Doha in remarks to top executives.

"I said to him, 'Tim, you're my friend. I treated you very good. You're coming here with \$500 billion but now I hear you building all over India. I don't want you building in India. You can build in India if you want to take care of India because India is the highest, one of the highest tariff nations in the world. It's very hard to sell into India. And they've (India) offered us a deal where, basically they're willing to literally charge us no tariff," he had said.

Earlier this month, Cook had said in a Q2 2025 Earnings Conference call that the existing tariffs that apply to Apple today are based on the product's country of origin.

"For the June quarter, we do expect the majority of iPhones sold in the U.S. will have India as their country of origin and

Vietnam to be the country of origin for almost all iPad, Mac, Apple Watch, and AirPods products sold in the U.S," Cook had said.

On Trump calling for Apple to shift iPhone production from India to the US, research firm Counterpoint Research Research Director Tarun Pathak had said last week that "this is a familiar Trump tactic: He wants to push Apple to localise more and build a supply chain in the US, which is not going to happen overnight. Making in the US will also be much more expensive than assembling iPhones in India.

Counterpoint Research vice president Neil Shah said that Apple has been doing a lot of groundwork in India, which has helped it successfully manage some of the US iPhone demand from its India production facilities.

In terms of capacity, India has enough to potentially meet all US iPhone demand in the future, but the ecosystem needs to be ramped up.

Anand Dubey told IANS: "Jaishankar is our Foreign Minister and an expert in diplo-matic matters. If he says in Germany that India will not tolerate terrorism under any circumstances, that is not just his personal view — it is the voice of the 140 crore people of this country. It is the shared senti-ment of the Opposition, the Indian Army, and all citizens."

Dubey added: "We will not bow down to threats from Pakistan, even if they repeatedly invoke their nuclear capability. Operation Sindoor is not over; it has merely been paused. When necessary, our armed forces will resume such operations and eliminate terrorist threats. Pakistan must change its behaviour and uphold peace. If it does not, we will alter their geography, this is the new India. This is an India that enters enemy homes to strike. If you speak to India with love, we will reciprocate. But if you send terrorists, we will respond even more forcefully."

emphasised that Jaishankar's statements repre-

sent national consensus. "Whether it is Germany or any other country, the world

stands with us. We are the land of Buddha, but when required, we are also a country of valour and war," he said.

Commenting on the NITI Aayog's 10th Governing Council meeting chaired by Prime Minister Narendra Modi, Dubey said the platform is a crucial mechanism for development and state-centred coordination.

"NITI Aayog meetings are convened periodically and chaired by the Prime Minister. The Chief Ministers of most states attend, and alternative arrangements are made if someone is unavailable. The Aayog plays a vital role in discussing key developmental issues and fostering cooperation between the Centre and the states," he said.

"If the Prime Minister is convening such a meeting, it is a positive step, and the states will benefit from the deliberations."

Reacting to Congress's nationwide initiative to hold 'Jai Hind Sabha' from May 24 to May 31 in honour of the armed forces, Dubey said patriotism should transcend party lines.

"This country belongs to everyone, not just the BJP. Every political party should engage in initiatives such as Tiranga Yatras or Jai Hind Sabhas. BJP is doing it, Congress is doing it — and we will also participate. Every citizen and party has a role to play in taking the country forward," Dubey told IANS.

He added, "Our army must be respected by all. We do not engage in symbolic politics like

#### the BJP. We serve the country with genuine dedication. Whether it's a Jai Hind Sabha or a Tiranga Yatra, we welcome participation from all corners."

Anand Dubey also voiced concern over the rising number of COVID-19 cases.

"COVID-19 cases are increasing, and this is not the time for politics. The focus must be on public health. The BMC and state government must prioritise treatment, testing, masking, and social distancing. This is not just about governance — it's about saving lives,' he said.

He praised the previous Maharashtra government led by Uddhav Thackeray.

'Under Uddhay Thackeray's leadership, the previous government handled the pandemic effectively. Their efforts were recognised not just by the people but also by institutions like the Supreme Court and NITI Aayog. The current administra-tion must issue clear guidelines, increase testing, and take immediate action to curb the spread."

Dubey further commented on the recent incident where Pakistan denied emergency landing permission to an IndiGo flight, calling it a humanitarian failure.

"Allowing emergency landings is a basic tenet of humanity, but we cannot expect such compassion from Pakistan. Hundreds of passengers were stranded onboard, and in a situation involving natural or medical emergencies, Pakistan should have allowed the flight to land safely. Fortunately, the passengers were unharmed," he said.

He added, "If the situation were reversed, India would have helped Pakistan out of humanitarian concern. This reflects the unfortunate nature of our neighbouring country - even during a crisis, they refuse to cooperate."

Dubey reiterated that national interest, public health, and humanitarian values must rise above politics.

"Whether it is the fight against terrorism, the handling of a pandemic, or a humanitarian crisis — India must respond firmly, unitedly, and morally, he concluded.

# Pakistan links of arrested JMB activist in Bengal being probed

#### KOLKATA, MAY 25

Pakistan links of one of the three Indian associates of Bangladesh-based Islamic fundamentalist group Jamaat-ul-Mujahideen Bangladesh (JMB), who were arrested by the Special Task Force (STF) of West Bengal Police earlier, are being probed.

Sources said coded encrypted messages recovered from the mobile phones of Aazmal Hossain and Saheb Ali Khan, who were arrested from Birbhum district earlier this month, show their links only with associates of Bangladeshbased fundamentalist outfits, namely JMB, Hizb-ut-Tahrir (HUT), and Ansarullah Bangla Team (ABT).

However, the sources added that similar coded and encrypted messages recovered from the mobile phones of the third arrested local associate of JMB, Abasuddin Molla, show his regular communication with some

individuals based out of Pakistan as well as with those associated with the Jammu and Kashmir-based fundamentalist group Ansar Ghazwat-ul-Hind.

Molla was arrested from Paturi village in the minoritydominated Diamond Harbour area in South 24 Parganas district of West Bengal, just a day after two others were held from Birbhum district.

The cops have also recently updated a district court in Birbhum about their initial findings against these arrested accused, both from interrogation as well as through the coded and encrypted messages recovered from their mobile phones.

The investigating officials, the sources added, are currently interrogating the trio to get details of their recruits for the sleeper cells of JMB in the state.

Recently, the Union Home Ministry received information from intelligence agencies about the alleged role of illegal Bangladeshi intruders behind the violence and vandalism at the minority-dominated Murshidabad district over violent protests against the newly promulgated (Amendment) Act.

The names of JMB, HUT and ABT surfaced in that intelligence input. However, considering the geographical locations of the pockets where the tension and violence had been maximum this time, especially Samserganj, the possibility of ABT playing some role behind the latest violence sounded more logical.

On the eastern side of the international borders Samserganj and Dhulian, is the Bangladeshi district of Chapai-Nawabganj, which is considered the stronghold of ABT.

The sources added that because of this geographical proximity, the chances of ABT's involvement in the latest developments at Murshidabad are most likely.

# **Riddhima Kapoor Sahni reveals why 'diet' is** a foreign word for the Kapoor Family





# Link between stress, cervical cancer uncovered

new study has established an association between cervical cancer and stress in patients, stating that females having cervical cancer with stress-related disorders are at a higher risk of succumbing to the disease. Findings of the study were published in researchers the journal 'Cancer Research'. "Patients receiving a cancer diagnosis are at increased risk of several stress-related psychiatric disorders, such as depression, anxiety, and stress-reaction and adjustment disorders," said Donghao Lu, the study's author.

Lu added, "Emerging evidence from both experimental and epidemiological studies indicates that psychological distress might affect the progression of many cancer types." For the following study, researchers gathered and examined records of 4,245 patients diagnosed with cervical cancer in Sweden between January 1, 2002, and December 31, 2011. At the same time, researchers also identified patients who had experienced a stressful life event, such as the death or severe illness of a family member, divorce, or being between jobs, as these events would increase emotional burden on patients.

# AGO trap: Eliminates female mosquitoes to help curb chikungunya virus

Autocidal Gravid Ovitrap (AGO trap) that attracts and captures female mosquitoes looking for a site to lay eggs. Researchers reported that AGO traps successfully protected people from virus infection and surveys recorded chikungunya virus.

The lack of effective tools to control

Aedes aegypti mosquito populations has resulted in the continued expansion of dengue virus, Zika virus and chikungunya virus. Some recent attempts at curbing mosquito populations have resulted in reductions in mosquito density but not reductions in human disease AGO traps consist of a pail with hay and water to attract eggbearing female mosquitos and a sticky lin-

ing to which the insects adhere. Previous studies have shown that placing three AGO traps outside of 85% of homes in a community resulted in an 80% reduction in adult mosquito populations but the studies did not assess rates of mosquitoborne diseases in humans, reported the

study published in the journal of PLOS Neglected Tropical Diseases. The researchers randomly selected 290 households in Puerto Rican communities that had AGO trap interventions and 349 households in communities without AGO traps. 175 household members

Blood samples were collected from each participant to detect chikungunya demographic information as well as data on mosquito repellent and

bed net use and frequency of mosquito bites. A total of 114 participants (34.9%) were seropositive for the chikungunya virus. Among people who spent most of their daytime hours inside the community they lived in, 10.3% were seropositive for chikungunya virus in communities with AGO traps whereas 48.7% were positive for chikungunva virus in communities without traps. Among all participants, including those who did not spend as much

daylight time within the community, 26.1% were seropositive for chikungunya virus in the intervention communities and 43.8% were positive in communities without traps.

"AGO traps are a novel chemical-free, effective approach to control Ae. aegypti populations and provide protection from infection with the pathogens that these mosquitoes transmit. Further evaluations should determine if AGO traps are sustainable and effective in larger-scale community trials," said one of the researchers of the study.

A study reported in the July 2000 edition of Agricultural Research Magazine found that consuming 1g of cinnamon per day can increase insulin sensitivity and help manage or reverse type 2 diabetes.

The study published in the journal of Scientific Reports proposes that focusing highenergy particle beams on a small spot deep inside the body could potentially enable clinicians to target cancerous tumour preciselv. Of these people, half will be treated using radiotherapy or a combination of radiotherapy and chemotherapy.'

While more research will be needed to further validate the findings, recent studies have suggested that malaria could be a contributor to functional and structural changes in the myocardi-

um, which is the muscle tissue of the heart. Experimental studies have also shown that malaria may affect the blood pressure regulatory system causing hypertension, which is a contributor to heart failure. Malaria can also affect vascular path-

ways that cause inflammation in the heart, which could lead to fibrosis and then heart failure. to the According European Society of Cardiology (ESČ), a combination of high blood pressure, diabetes, obesity, and coronary artery disease are among the most common risk factors for heart failure. The findings were

presented at the ESC Congress 2019 together with the World Congress of Cardiology in Paris. Among the high malaria burden countries, India has made substantial progress in disease control. The malaria burden has declined by over 80 per cent malaria cases came down to 0.39 million in 2018 from 2.03 million cases in 2000. Malaria deaths in India have declined by over 90 per cent from 932 deaths in 2000 to 85 in 2018, according to Indian Council of Medical Research.

ESEARCHERS have found single-cell RNA R sequencing to identify a type of cell that may be able to regenerate liver tissue, treating liver failure without the need for transplants. The scientists have identified a new type of cell called a Hepatobiliary Hybrid Progenitor (HHyP), that forms during our early development in the womb.

Surprisingly, HHyP also persists in small quantities in adults and these cells can grow into the two main cell types of the adult liver (Hepatocytes and Cholangiocytes) giving HHyPs stem cell-like properties. The team examined HHyPs and found that they resemble mouse stem cells which have been found to rapidly repair mice liver following major injuries, such as occurs in cirrhosis. The findings are published by The Journal Nature Communications.

Dr Tamir Rashid from the Centre for Stem Cells & Regenerative Medicine at King's College London said, "For the first time, we have found that cells with true stem cell-like properties may well exist in the human liver. This, in turn, could provide a wide range of regenerative medicine applications for treating liver disease, including the possibility of bypassing the need for liver transplants."

Symptoms of liver disease include jaundice, itching and feelings of weakness and tiredness and in more severe cases, cirrhosis. The only treatment for severe liver diseases at present is a liver transplant which can lead to a lifetime of complications and for which the need for donor organs greatly outweighs the increasing demands. Liver disease can be caused by lifestyle issues such as obesity, viruses, alcohol misuse or by non-lifestyle issues such as autoimmune and genetic mediated disease.

"We now need to work quickly to unlock the recipe for converting pluripotent stem cells into HHyPs so that we could transplant those cells into patients at will. In the longer term, we will also be working to see if we can reprogramme HHyPs within the body using traditional pharmacological drugs to repair diseased livers without either cell or organ transplantation," said Dr Rashid.
