Domestic violence act applicable to every woman irrespective of religious affiliation: SC

JAMMU RISING

JAMMU, SEPT 03 The Protection Women from Domestic Violence Act, 2005, is a civil code that is applicable to every woman in India irrespective of her religious affiliation or social background, the Supreme Court has said.

A bench of Justice B V Nagarathna and Justice N Kotiswar Singh said the 2005 legislation was applicable to all women for more effective protection

of their rights guaranteed under the Constitution.

"The Act is a piece of civil code which is applicable to every woman in India irrespective of her religious affiliation and/or social background for a more effective protection of her rights guaranteed under the Constitution and in order to protect women victims of domestic violence occurring in a domestic relationship,' the bench said.

The apex court deliv-

ered its verdict on an appeal filed by a woman challenging an order of the Karnataka High Court in a matter related to the grant of maintenance and compensation.

The woman had earlier filed a petition under section 12 of the Act which was allowed by a magistrate in February 2015 granting Rs 12,000 as monthly maintenance and Rs 1 lakh towards compensation to her.

The top court noted that

the husband had filed an appeal against the order which was dismissed by the appellate court on the ground of delay. It noted that later, he

filed another application under section 25 of the Act, which deals with duration and alteration of orders, before a magistrate but the same was dismissed.

The bench said thereafter, he filed an appeal

before the appellate court, which allowed it and remanded the matter to the magistrate with a direction to consider his application by giving an opportunity to both parties to adduce their evidence.

It noted that aggrieved by the order, the woman approached the high court which dismissed her plea in April last year and directed the magistrate to consider the application filed by the man under section 25 of the Act.

In its verdict, the apex court referred to section 25 and said it was evident that an aggrieved person or a respondent as defined under the Act can seek for alteration, modification or revocation of an order made under the provisions of the Act if there was a change in the circumstances as per sub-section (2) of section 25.

The bench said a magistrate, while exercising discretion under section 25(2) of the Act, has to be satisfied that a change in the circumstances has occurred, requiring to pass an order of alteration, modification or revocation.

It noted a change in the circumstances under the Act may be of either a pecuniary nature, such as a change in the income of the respondent or an aggrieved person, or it could be a change in other circumstances of the party paying or receiving the allowance which would justify an increase or decrease of the maintenance amount ordered by the magistrate.

"The phrasing of the provision is wide enough to cover factors like the cost of living, income of the parties, etc. Further, a change in the circumstances need not just be of the respondent but also of the aggrieved person," the top court said.

"However, for the invocation of section 25(2) of the Act, there must be a change in the circumstances after the order being passed under the Act," it said, adding, "Thus, an order for alteration, modification or revocation operates prospectively and not retrospectively".

The bench said the husband cannot seek its retrospective applicability so as to seek a refund of the amount already paid as per the original order.

The bench set aside the orders of the high court and the first appellate court and dismissed the application filed by the man.

"However, liberty is reserved to the respondent (man) herein to file a fresh application under section 25 of the Act, if so advised," it said. (AGEN-CIES

"The state of the nation today is beyond my dreams. I never imagined. I did not conceive of the Bharat that it is today," Dhankhar said, comparing the present-day situation with that of the 1990s.

The vice president said the 1990s were a period when India had to pledge its gold with Swiss banks to sustain its financial credibility as forex reserves had plunged to USD 1 billion and financial institutions, such as the World Bank and the International Monetary Fund, issued directives to India in the garb of advisories.

"Now, the IMF says India is the most-favoured global destination for investments and opportunity, and the World Bank calls India a role model on digitisation," he said.

Dhankhar said the 1990s were also an era of middlemen on the corridors of power, corruption was rampant and only a person with pedigree could get access to opportunities.

"Now, the power corridors are fully sanitised. The middleman has disappeared.... All transactions take place digitally, without a human interface. That is the change I never imagined," he said.

The Vice President expressed satisfaction that recognition for the scientific community has increased significantly.

"Soothing to note that in the last few years, recognition for the scientific community has gone up. It has gone up in several ways, including the Government being very serious about it, and the Prime Minister's heart and soul are deeply in the scientific community," he said. (Agencies)

72-Bishnah (SC) Assembly Constituency comes next with 1,19,988 registered voters; 63,385 males, 56,602 females and 1 third gender voter. To ensure smooth electoral process, 139 polling stations have been established across the constituency, of which 18 are urban and 121 are rural polling stations

Similarly, 73-Suchetgarh (SC) Assembly Constituency has 1,13,449 voters, among which 59,727 are males, 53,720 females and 2 transgender voters. A total of 128 rural polling stations have been set up in the constituency for smooth and hasslefree voting process.

Likewise, 79-Jammu North AC has 1,11,811 voters; 57,213 males, 54,595 females and three third gender voters. To facilitate the voters of this constituency, 117 polling stations have been set up, including 87 urban and 30 rural polling stations.

76-Jammu East AC has a total of 1,07,213 voters; 54,021 are males, 53,189 are females and 3 third gender voters. In order to ensure a participatory voting process, 153 polling stations have been established in the constituency, including 131 urban and 22 rural stations.

Likewise, 78-Jammu West AC has 1,06,252 voter population, of which 53,811 are males and 52,441 are females. For smooth voting process, 118 polling stations have been established, including 112 urban and 6 rural polling stations.

82-Chhamb AC has 1,06,035 voter population; 54,295 are males and 51,740 are females. 165 polling stations have been set up in the constituency, with 8 in urban areas and 157 in rural areas.

-Nagrota AC has 96,007 registered voters, with 49,735 males and 46,272 females. The ECI has set up 145 rural polling stations in this constituency.

81-Akhnoor (SC) Assembly Constituency has 95,386 voters, comprising 48,954 males, 46,430 females and 2 third gender voters. To facilitate voting, 127 polling stations have been established, with 12 in urban areas and 115 in rural areas.

80-Marh (SC) Assembly Constituency, with the lowest voter count, has 93,598 registered voters, including 48,640 males, 44,957 females and 1 third gender voter. The constituency has 114 polling stations, with 12 in urban areas and 102 in rural areas.

Interestingly, the upcoming elections are set to be a coming-of-age moment for 47,963 first-time voters. These young voices are spread across the district, with 82-Chhamb AC leading the pack with 5,647 new voters, while 78-Jammu West AC has the lowest count at 2,801.

Jammu's senior citizens, who comprise nearly 18% of the total electorate, are poised to play a pivotal role in the upcoming elections. These 2,15,338 voters, aged 60 and above, bring their wealth of experience to the polling booths. However, it is the centenarians who truly embody the spirit of enduring democracy. Jammu boasts 404 voters between 100-109 years old, 29 super-centenarians aged 110-119 and remarkably, six voters who have lived through over 120 years of India's history.

Meanwhile, all arrangements are being put in place for a smooth and peaceful polling in the district where voting is taking place on October 1. Currently, a number of voter awareness programmes are underway in various parts of the district to generate interest among the electorate regarding importance of exercising the franchise and to maximize the voter turnout.



JAMMU, SEPT 26 The latest episode of Kaun Banega Crorepati (KBC) season 16 saw a thrilling moment as 22-year-old Chander Prakash, a UPSC aspirant from Jammu & Kashmir's Akhnoor, became the first crorepati of the season.Hosted by the legendary Amitabh Bachchan, the show is a beloved quiz-based program where participants answer increasingly difficult questions to win large sums of money. The first episode of KBC 16 was aired in August year and Chander Prakash is the first contestant to bag the crorepati title.Chander Prakash's story is one of immense courage and perseverance. Since birth, he has dealt with numerous health complications, including a severe blockage in his intestine. He has undergone seven surgeries so far, with his doctors recommending an eighth. Despite this, Chander never allowed his medical issues to hinder his ambitions. He is currently preparing for the highly competitive UPSC exam, aspiring to serve the nation in the future. His participation in KBC showcased his indomitable spirit, and his appearance on the show quickly won the hearts of viewers.On Wednesday's rollover episode, the episode began with a warm welcome from Amitabh Bachchan, who praised Chander's determination and tenacity. Chander's backstory of facing health struggles was briefly revisited, setting the stage for a gripping episode as he faced his next set of questions on the road to becoming a crorepati. The first question posed by Bachchan that day was worth Rs 3,20,000: "A 'Yokozuna' is the highest rank attainable in which contact sport?" Confident in his knowledge, Chander selected Option B) Sumo Wrestling and won the amount with ease. His quick decision-making and



calm demeanor impressed both the audience and the host.Next up, Chander he successfully answered seven questions in a row in the "Super Sandook" segment. He said he would repay loans that his parents had taken for his medical treatment. Chander continued to answer questions confidently, reaching a sum of Rs 12.5 lakh. Amitabh Bachchan then presented him with the question for Rs 25,00,000: "Which of these is a 21stcentury 'superfood' rich in omega-3 fatty acids, that was cultivated by the Aztecs more than 500 years ago?" Chander selected Option D) Chia Seeds, which turned out to be the correct answer. The next question, worth Rs 50,00,000, tested Chander's knowledge of mythology: According to the Padma Purana, with whom did Lord Krishna wage a battle over the fate of Chitrasena?" Unsure of the correct answer, Chander decided to use his first lifeline. "Video Call A Friend." However, the response he received did not fully satisfy him, leading him to use another lifeline, the "Audience Poll." With the audience's help, he selected Option B) Arjuna, which was the right answer. The audience once again stood to applaud him, and Chander described the mo-

ment as a dream come true.Chander then faced the Rs 1 crore question, which was: The largest city in which country is not its capital but a port with an Arabic name that means 'abode of peace'?" After deliberating and applying logic to narrow down the possible answers, Chander used the "Double Dip" lifeline.He chose Option C) Tanzania, and to his immense relief, it was the correct answer. Chander had officially become the first crorepati of Kaun Banega Crorepati season 16. He also bagged a gift from Hyundai, Venue SUV.Facing the Rs 7 Crore Jackpot QuestionHaving reached the Rs 1 crore mark, Chander was presented with the jackpot question for Rs 7 crore: Who was the first recorded child born to English parents in North America in 1587?" This year's theme, "Pharmacy Strengthening Health Systems," underscores the essent ial funct ion that pharmacists perform in enhancing healthcare systems worldwide. Pharmacists are not only responsible for dispensing medications but also serve as accessible health advisors, providing valuable quidance on drug interactions, preventive healthcare, and chronic disease management. In many parts of the world, pharmacists are often the most readily available heal theare profession als, serving communities where doctors and hospitals may be limited.

Throughout the COVID-19 pandemic, the importance of pharmacists was underscored. As the healthcare system strained under the pressure, pharmacists were on the frontline, ensuring that critical medications were available and that patients received accurate information. They played a key role in supporting vaccine distribution and counseling patients about the pande mic'sevolving challenges.

Yet, despite their crucial contributions, pharmacists are often overlooked in discussions about healthcare reforms and policy decisions. This neglect stems partly from the misconception that their role is pure lytransact ional-limited to dispensing drugs rather than encompassing a more holistic approach to patient care.

One of the key dallenges facing the pharmacy profession is the growing burden of non-communicable diseases (NCDs) such as diabetes, hypertension, and cardiovascular illnesses. Pharmacists are uniquely positioned to combat these issues through medica-

Seven Decade journey of Education

India is another name for hopes and possibilities. India is a country which has shown the way to the world with the torch of knowledge for ages. Our Vedas and Upanishads are equally relevant even today after thousands of years, which tell us the ways to achieve fame by following the path of religion along with moral values. Even when the world was constantly fighting between justice and injustice, fame and fortune, people from far and wide used to come to world famous schools like Nalanda and Takshashila. Our ancient heritage in the field of knowledge is undoubtedly very great, and this tradition was broken and damaged when external terrorists came to India, sometimes in the form of Gauri, sometimes in the form of Babar. The British used education as a weapon for imperialism.

When India got independence, the Indian education system was very pathetic. There is no evidence as to how many schools there were. There were community systems like Gurukul or missionary schools and a few private schools. In 1951, there were about 13 thousand primary and 7,000 higher secondary schools. The literacy rate was 12 percent, which is now more than 74 percent. Talking about universities, there were 27 universities at the time of independence, which has increased to 760 today. After independence, the slogan of education for all was given and for this a separate education department was established, which was later transformed into the Ministry of Human Resources and education department was established in every state so that the basic needs of education were fulfilled. This was necessary because it is a part of the concurrent list of the Constitution.

In 1952-53, the Secondary Education Commission was formed, and NCERT was established in 1961 with the aim of focusing on the quality of education. In the initial phase, there were many challenges before the Planning Commission regarding how to take education to the masses and it was also kept in mind that primary education should be linked to the health of children, because the infant mortality rate was high during that period and schools were not functioning well. Through this, a concrete plan was implemented, and the role of Panchayats was also included in it, because Panchayats could better understand the number of schools needed and the needs of the students. In 1968, following the recommendations of the Kothari Education Commission, the

National Education first Policy was adopted and in 1975, the Integrated Child **Development Services Scheme** was started for the proper development of children up to 6 years of age. Understanding the responsibilities of both the states and education, the Constitution was amended in 1976 to change education from a 'state' subject to a 'concurrent' subject. The journey was still long and a lot of work was still to be done, and to fulfill this objective, a new National Education Policy was adopted in 1986, which was revised by Acharya in 1992. Some changes were made in the National Education Policy based on the review by the Ramamurthy Committee.

With the aim of increasing the attendance of children in schools, the Centrally Aided Midday Meal Scheme was started in primary schools. Going two steps ahead, the Constitution was amended in 2002 under the Atal government to make free and compulsory education a fundamental right. By now the computer and internet revolution gained momentum. had Keeping this need in mind, a satellite dedicated to education 'EduSat' was launched in 2004. The year 2009 brought a major achievement when the Right of Children to Free and Compulsory Education Act was passed by the Indian Parliament.

However, the social and economic background of the country was still a major obstacle with many problems like child marriage, child labor, poverty, discrimination, etc. But it is also true that the solution to these problems was also hidden in education itself. From the point of view of systematic development, campaigns and laws like Sarva Shiksha Abhiyan, Mid Day Meal and Right to Education played a big role in the field of education, due to which a large number of students joined schools. Today there is a primary school within a radius of every 1 kilometer. Work is currently underway on a new education policy to further improve school education.

Meanwhile, today the reputation of Indian schools has increased rapidly. Not only private, but government schools have also performed well. Indian school students have achieved many successes in the country and abroad. For them, education not only means earning a living, but also means service to the country and society. Dropout of children from schools is a big problem. Undoubtedly, we have been successful in bringing children up to 14 years of age to schools through the right education, but the path ahead is difficult. The previous UPA government also

brought a no-detention policy that no one would be failed till class 8, but it did not yield any significant positive results; rather, it led to a decline in the standard of education. A major reason for the decline is the absence of teachers in schools and wherever they are, their qualifications are under question.

Today lakhs of posts are lying vacant in schools. The student-teacher ratio reveals the reality that generally thousands of posts of teachers are vacant in every state. The country is currently facing a shortage of 12 to 14 lakh teachers. Apart from this, currently 5 lakh untrained people are teaching in private schools and more than 2.5 lakh untrained people are teaching in government schools, which is quite harmful. Many such challenges are still facing us today.

If we talk about higher education, today there are 30,000 colleges and more than 700 universities in the country in which more than 1.5 crore students are enrolled. If we talk about the budgetary allocation on education, then while Rs 1,144 million was spent on education in the 1951 budget, this year in the 2017 budget there is a provision of Rs 79,685.95 crore on education. With a view to bringing changes in the field of higher education, the University Grants Commission or UGC was established in 1956. According to the 2011 census, only 25.2 percent of the population is able to achieve primary education, while 15.7 percent can reach secondary, 11.1 percent can reach matriculation, and only 8.6 percent can reach intermediate (higher secondary). Only four and a half percent of people in the country are graduates or have attained higher education. The British Council has found in one of its studies that by the year 2025, the highest number of people of studying age will be in India. The Government of India has set a very ambitious target.

In a country like India, where even today many district headquarters do not have colleges or universities, the medium of distance education is very popular. It is a flexible medium, which allows students to pursue other hobbies while studying. The biggest thing is that it is also showing the path of higher education to working and employed people. Diploma, graduation, post graduation and management courses are run in these distance education centres. It is a better open university to study and make a career. IGNOU, whose method of study is different from traditional universities, has adopted a multimedia approach to

learning. Courses in science, computers, nursing, engineering and technology are also included. Enrolling in the open university is not difficult. These universities are quite flexible in their rules. The fees here are also generally less than normal institutions. Weekend classes are conducted at many places, which provides convenience to working people.

In India, distance courses are currently offered in 1 national and 13 state open universities and more than 200 centers of different institutions. About 40 lakh students study in these. About 22 percent of the students taking admission in higher education institutions choose distance courses, while distance and open education accounts for 24 percent of the enrollment each year in India's educational institutions.

Saying something about IITs and IIMs is like pointing a lamp to the sun. Engineers, managers, and professionals educated here are proving their skills in big companies all over the world. The first IIT was established in Kharagpur in 1951 and after this the second Indian Institute of Technology was established in Mumbai in 1958. After this, in 1959, IITs were established in Kanpur, Chennai, Delhi and Guwahati. Similarly, the first two Indian Institutes of Management were established in Ahmedabad and Kolkata. Today, there are many institutions on the lines of IITs and IIMs, from where thousands of students are shaping their future.

On the initiative of the Prime Minister, Skill India was started with the aim of providing skills to every hand and employment to every hand so that the problem of unemployment in the country could be eliminated. Amazing results were seen from this scheme and in a short time, lakhs of entrepreneurs were created because the need to link education with employment had been felt for a long time.

In the future, our population will be more young and technology will play a big role in the mobile revolution that has taken place today. There is still work to be done on how this technology can be better used in the field of education. However, in the 7 decades of independence, many revolutionary changes have taken place in the field of education, which are still continuing. It is expected that in the coming years, 100 percent of our population will not only be literate but will also establish us as a superpower in the world.

India-Bangladesh series: Kanpur Test to be Shakib Al Hasan's swansong unless...

New Delhi

Bangladesh all-rounder Shakib Al Hasan on Thursday announced his retirement from T20 Internationals with immediate effect and also said that the second Test against India will be his last if his country's board doesn't give him a farewell match against South Africa at home.

His final international game for Bangladesh will be in the Champions Trophy which is likely to be held in UAE and Pakistan.

The 37-year-old great, who featured in 129 T20Is for Bangladesh will, however, continue to play in franchise leagues.

"I have played my last T20 match in T20 World Cup. We have discussed this with the selectors. Looking at the 2026 World Cup, this is the right time for me to move out. Hopefully, BCB will find some great players and we will perform well," said Shakib on the eve of the second and final Test against India in Kanpur.

Shakib, who has played 70 Tests, scoring 4,600 runs and taking 242 wickets, might just play his last Test in the north Indian industrial town in case the cricket board cannot assure him of his security after being accused of murder although he was not even in the country at that time.

"I have expressed my desire to play my last Test in Mirpur to BCB. They agreed with me. They are trying to organise everything so that I can go to Bangladesh. If that won't happen, the



match against India in Kanpur would be my last in Test cricket," he added.

Shakib was named as an accused in a murder case back home during the political unrest that led to the ouster of Prime Minister Sheikh Hasina.

He was a member of parliament from her party, the Awami League.

Shakib made the announcement while interacting with Bangladeshi media but spoke in English following a request from the Indian journalists.

In an unexpected turn of events, Shakib was named in an FIR in a murder case related to the civil protests in Bangladesh last August.

The case pertains to the death of garment worker Mohammed Rubel, whose father, Rafiqul Islam, filed the complaint on August 7.

The 37-year-old Shakib indicated that

Is Kanpur's Green Park Stadium, the venue of second India-Bangladesh Test, unsafe?

NEW DELHI

With India winning the first Test against Bangladesh in Chennai by 280 runs, the Indian fans will be hoping for another clinical performance when the two sides clash in Kanpur in the second and final Test tomorrow.

The Green Park Stadium will be hosting the first international match since 2021. But, much to the spectators' dismay, the Uttar Pradesh Public Works Department (PWD) has, reportedly, declared one of the stands in the stadium as dangerous.

PWD engineers inspected the Balcony C stand and have, reportedly, asked the Uttar Pradesh Cricket Association (UPCA) to close it during match, as it was in dire need of repair and may collapse if packed to full capacity.

"The PWD has raised some issues and we have agreed that we will not sell all the tickets of Balcony C. We have been told to sell only 1,700 tickets for the stand, which has a capacity of 4,800. The repair work will continue for the next couple of days," UPCA CEO Ankit Chatterjee told The Indian Express.

The Green Park Stadium, which is owned by the state sports department and is not directly under UPCA, has



had limited international game exposure because of the presence of the relatively new and better-equipped Ekana Cricket Stadium in Lucknow.

Will Kuldeep Yadav play at home? the focus shifts from the stands to the pitch, all eyes will be on whether

local boy Kuldeep Yadav will make the playing XI. He made his Test debut more than

seven years ago, but has played only 12 Tests till date. Despite 53 wickets at an average of 21.05, Yadav has mostly been included in the squad as a backup spinner to his illustrious partners Ravichandran Ashwin and Ravindra Jadeia.

The second Test in Kanpur will be the best chance for Yadav to get a look-in. According to the Green Park Stadium curator, the pitch will help the pacers in the first two sessions and assist spinners on the last three days.

The pitch there is made from black soil, which is sourced from Kali Mitti village near Unnao. Such pitches traditionally help spinners, while red soil pitches help the pacers. The pitch is expected to play low and slow.

The catch, however, is that a turning pitch can also benefit Bangladesh, who have able spinners in their team like Mehidy Hasan Miraz and Shakib Al Hasan.

Rodri ligament injury: What we know so far about Manchester City midfielder's return date

Manchester City midfielder Rodri has ligament damage in his right knee, the club said Wednesday without giving a time frame for his potential absence.

The Spain international, who is among the favourites to win this year's Ballon d'Or award for the best player in the world, limped off after 20 minutes of the 2-2 draw against Arsenal in the Premier League on Sunday.

The 28-year-old Rodri travelled to Spain on Monday to seek specialist consultation on the problem and City has confirmed he suffered a ligament injury.

Assessment remains ongoing to ascertain the full extent of the injury and expected prognosis, the English champions said.

City manager Pep Guardiola said Tuesday he expects to be without Rodri for "a long time" but revealed there were "some opinions that it will be less than we expect.

We're waiting for the last phone calls from the doctors to know exactly what definitely he has and the type of surgery he has to get, Guardiola said after City's 2-1 win over Watford in the English League Cup.



His importance to Guardiola's team was underlined last season when City lost four of nine games without the inspirational midfielder in all competitions. By comparison, City lost just one of 50 games with him in the team.

Guardiola said Tuesday that Rodri is the best midfielder in the world and de-

ICC Test rankings: Rishabh Pant re-enters top 10; Rohit, Kohli fall

Riding on a sensational century in his Test comeback, wicketkeeper-batter Rishabh Pant on Wednesday re-entered the ICC rankings at an impressive sixth position but India skipper Rohit Sharma and Virat Kohli slipped in a major shake-up in standings.

(731), who smashed a stunning century in the opening game of the two-Test series against Bangladesh in Chennai, was placed sixth, while opener Yashasvi Jaiswal (751), moved up to fifth thanks to a half-century in the first innings of the Test match.

Former France and Real Madrid center-back Raphael Varane announced his retirement on Wednesday, ending a career that included a World Cup title and a big haul of club trophies.

The 31-year-old Varane signed with promoted Serie A club Como in July but injured his knee during his only appearance with the club an Italian Cup match against Sampdoria last month.

"In my career I have taken on many challenges, rose to occasion after occasion, almost all of it was supposed to be impossible," Varane wrote on Instagram. "Reflecting on these moments, it is with immense pride and a feeling of fulfilment that I am announcing my re-

tirement from the game that we all love.'

Varane was arguably the tournament's standout defender when France won the 2018 World Cup in Russia, where he scored the most important of his five international goals with a header against Uruguay in the quarterfinals

An elegant, ball-playing defender with excellent positional sense thanks to his quick reading of the game, Varane formed a solid center back pairing with Samuel Umtiti in that tournament.

He also helped Madrid to four Champions League titles and three Spanish league trophies

He moved to Manchester United in

2021 but was restricted to 95 appearances in his three seasons in England mainly because of injuries

Varane began his career at Lens.

From Lens to Madrid to Manchester, and playing for our national team. I have defended every badge with everything I have, and loved every minute of the journey, Varane said. I have no regrets, I wouldn't change a thing. I have won more than I could have even dreamed of."

Varane had already retired from France's national team, a few months after the World Cup final defeat to Argentina in 2022. During that match, his 93rd for Les Bleus after making his debut in 2013, he fell to the ground exhausted deep into extra time.

Those whose family made country pauper now damaging its image abroad: Thakur targets Rahul

PUNE, SEP 26

Former Union minister Anurag Thakur on Wednesday launched a veiled attack on Congress leader Rahul Gandhi, stating that those whose family and party ruled the country for long and made it pauper are

now denting its image abroad. The BJP leader also alleged that the Congress' mentality is to finish off the system of reservation in the country.

Thakur was speaking to reporters on the sidelines of 'Viksit Bharat Ambassador -Yuva Connect Program' held at Fergusson College here.

Asked about Prime Minister Narendra Modi and Rahul Gandhi's separate visits to the US in the recent past, Thakur said that after Modi became the PM, the respect of the country and its 140 crore people increased at the global level and India is now ranked in the first five economies. "But those whose family and party reigned the country for 60 years and made the country pauper, they are now damaging the image of the country abroad," he said.

Union Minister Manohar Lal Khattar has said the closure of the Shambhu border is a "big problem" for traders and locals alike as he lashed out at protestors sitting on the Punjab side of the state's border, claiming they are wearing masks of farmers who want to destabilise elected Governments. The for-mer Haryana Chief Minister was addressing a gathering in Ambala City on Tuesday in favour of BJP candidate Aseem Goel. "The big problem is the (Shambu) closure border.Common people, especially traders, are facing problems due to its closure," Khattar, who is MP from Karnal, said.

"We had plans to open the border..But those sitting across are not farmers, but wearing mask of farmers, few such people who want to damage the

system, destabilise the established governments, they are such people," he alleged.

"Don't have to go into details, you also know who they are, Khattar said.

As Ambala city is close to Shambhu border, Ambala is facing the brunt and people face difficulties, he said.

"We were moving ahead, but the matter was taken up in courts. Now, the case is before the Supreme Court, which has formed a committee. I feel a solution will be found.. But keep in mind the court will not allow (the border) to open without condition. And there is reason for this. The kind of havoc they created last time (during farmers' stir in 2021), which farmer will disrespect the nation by climbing the Red Fort," he said.

Farmers under the banner of the Samyukt Kisan Morcha (Non-Political) Kisan and

Mazdoor Morcha are spear-heading the 'Delhi Chalo' march to press the Government to accept their various demands which include that the Centre should give a legal guarantee for MSP for crops.

The protesting farmers have been staying put at the Shambhu and Khanauri border points between Punjab and Haryana since February 13 when their march was stopped by the security forces. The Supreme Court had

recently constituted a committee headed by former Punjab and Haryana High Court judge Justice Nawab Singh to amicably resolve the grievances of protesting farmers at the Shambhu border.

The court was then hearing the Haryana Government's plea challenging the High Court's order asking it to remove within a week the barricades erected at the Shambhu border.

SC asks Maharashtra govt to hold meeting with CJ on redevelopment of Bombay HC annexe building

NEW DELHI, SEP 26

The Supreme Court on Wednesday asked the Maharashtra chief secretary to hold a meeting with the chief justice of the Bombay High Court and other judges for taking a decision on re-development of a PWD and annexe buildings adjacent to the present iconic high court building in Mumbai for shifting some courtrooms and other facilities there.

Chief Justice of India D Y Chandrachud on September 23 laid the foundation stone of the Bombay High Court's new complex in Mumbai's Bandra region.

The apex court, which is hearing a suo motu case titled as 'Heritage Building of the Bombay High Court and allotment of additional lands for the High Court', was of the view that till the time, the new high court building comes up at Bandra, some of the facilities needed to be shifted to a PWD building adjacent to the present high court premises.

A special bench comprising the CJI and Justices B R Gavai and JB Pardiwala was also of the view that the annexe building of the high court, where some of the courts and other facilities are still there, needed urgent repairs as well.

'A meeting will be called by

the chief justice of the Bombay High Court (Justice D K Upadhyaya) and other judges with the chief secretary to discuss the redevelopment of a certain portion of the PWD building and the repairs of the annexe building," the bench said.

The top court also asked the state government to explore providing some space to the high court to set up its arbitration and mediation centre in the Air India building in south Mumbai and discuss this aspect as well in the meeting between the chief secretary and the HC chief justice and other judges.

The apex court's strong observations came as it closed the suo motu proceedings over Karnataka High Court judge Justice V Srishananda's alleged objectionable comments during court court proceedings. The Supreme Court also noted that he had apologised for his obser-vations during open court pro-ceedings on September 21. A five-judge bench headed by

Chief Justice D Y Chandrachud observed that since Justice Srishananda was not a party to proceedings before it, "we desist from making any further observations save and except to express our serious concern about both the reference to gender and to a segment of the

community". The top court on September 20 took suo motu cognisance of the judge's comments against a woman lawyer during court proceedings in a case and his reference to a Muslim-majority area in Bengaluru as "Pakistan" in another.

Casual observations may well reflect a certain degree of individual bias particularly when they are likely to be perceived as being directed to a particular gender or community," the bench, also comprising Justices Sanjiv Khanna, B R Gavai, Surya Kant and Hrishikesh Roy, said on

Wednesday. "Courts, therefore, have to be careful not to make comments in the course of judicial pro-ceedings which may be construed as being misogynistic or for that matter prejudicial to any segment of our society," it said.

Referring to the text of a report submitted before it by the registrar general of the Karnataka High Court, the bench said it amply indicated that observations made in the course of proceedings there were unrelated to the course of proceedings and should have best been eschewed.

"The perception of justice to every segment of society is as important as the rendition of

justice as an objective fact," it said said. "Such observations are liable

to be construed in a negative light, thereby impacting not only the court of the judge who express them but the wider judicial system," it said.

After the bench dictated the order in the court room, Attorney General R Venkataramani referred to some messages on X about the observations and termed them 'absolutely vitriolic"

"Now you have seen the nature of the observations. We can't call any part of the territo-ry of India as Pakistan. Because that fundamentally is contrary to the territorial integrity of the nation," the CJI observed.

Solicitor General Tushar Mehta said social media can't be controlled and the anonymity attached with it makes it 'very dangerous". "But should I tell you, the

answer to sunlight is more sunlight. Not to suppress what hap-pens in the courts," Justice Chandrachud observed, adding that the answer was not to close doors and shut everything down

The bench said the preva-lence and reach of social media has included wide reporting of court proceedings and most high courts in the country have now adopted rules for live streaming or for conduct of video-conferencing.

"Emerging as a necessity in the course of the COVID-19 pandemic, video-conferencing and live streaming of proceedings has emerged as an important outreach facility of courts to promote access to justice," it

The bench said all stakehold-ers in the judicial system, including the judges, lawyers and litigants particularly par-ties-in-person, have to be con-scious that the reach of pro-ceedings which takes place in ceedings which takes place in

the courts does not extend to merely those who are physically present but also to audiences. "This places an added responsibility on judges and lawyers as well as litigants who

appear in person to conduct proceedings conscious of the wider impact of casual observations on the community at large," it said. The bench said it was impor-

tant that every judge should be aware of their own predispositions.

'The heart and soul of judging is the need to be impartial and fair. Intrinsic to that process is the need for every judge to be aware of our own predispositions because it is only on the basis of such aware ness that we can truly be faithful to the fundamental obligation of the judge to deliver objective and fair justice," it said.

The bench said it was emphasising this point because it was necessary for every stakeholder to understand that the only values which must guide judicial decision making were those which were enshrined in the Constitution.

The top court noted that report of the high court's registrar general deals with two proceedings before the judge, the first which took place on June 6 and the other on August 28.

Sri Lanka's Parliamentary election to cost more than presidential poll, says official

COLOMBO, SEPT 26

Sri Lanka's parliamentary election to be held on November 14 will cost more than last week's presidential poll, the island nation's top election official said on Wednesday.

Saman Sri Ratnayake said that the parliamentary election would cost 11 billion Sri Lankan rupees (approximately INR 3 billion) up from 10 billion rupees for the presidential election.

President Anura Kumara Dissanayake, who won the presidential elections, dissolved Parliament on Tuesday to call a snap election.

The last parliament was convened in August 2020. The dissolution has come 11 months ahead of schedule.

However, the money for the parliamentary election was not allocated in the current year's budget.

"The president is legally obliged to provide monies to hold the election even without allocations", budgetary Ratnayake said.

The previous president, Ranil Wickremesinghe, planned to hold the parliamentary election next year as they were due



in August next year.

Wickremesinghe, as the minister of finance, had limited the money allocation this year only to cover the presidential election.

The highest court in early August ruled that Wickremesinghe as the finance minister had violated fundamental rights of voters by his refusal to provide monies to hold the 2023 local council elections.

Wickremesinghe, 75, who took charge in 2022 after thenpresident Gotabaya Rajapaksa resigned, held there was no

money then due to the economic crisis and the economic recovery was more important than holding the local elections.

On Tuesday, President Dissanayake appointed his cabinet of four, including himself and also Harini Amarasuriya was sworn in as the new Prime Minister of Sri Lanka, making her the 16th person to hold the position.

The Election Commission also noted that the voter registration list prepared for the presidential election will be used for the general election.

UN remains prisoner of past, Global South cannot continue to be short-changed: Jaishankar on UNSC reform

Asserting that the United Nations remains a "prisoner" of the past, External Affairs Minister S Jaishankar said countries of the Global South cannot continue to be "shortchanged" and their proper representation in the permanent category in a reformed UN Security Council is a "particular imperative".

Jaishankar made these remarks at the 2nd Foreign Ministers meeting of G20 Brasil 2024 on the theme 'Building a just world and a sustainable planet'.

"The world has evolved into a smart, interconnected and multipolar arena and its members have increased fourfold since the UN's inception. Yet the UN remains a prisoner of the past," Jaishankar said.

He said that as a result, the UN Security Council struggles to fulfil its mandate of maintaining international peace and stability, undermining its effectiveness and credibility.

Addressing the event in the UN Headquarters Wednesday, Jaishankar said that "without reforms, including expansion in both categories of UNSC membership," the lack of effective-ness of the 15-nation body will only continue.

"Expansion and proper representation in the permanent category is a particular imperative. Asia, Africa and Latin America - the Global South cannot continue to be shortchanged," he said adding that they must be given their legitimate voice.

Jaishankar emphasised that real change needs to happen and happen fast.

India has been at the forefront of years-long efforts calling for reform of the Security Council, including expansion in both its permanent and nonpermanent categories, saying the 15-nation Council, founded in 1945, is not fit for purpose in the 21st Century and does not reflect contemporary geo-political realities.

Delhi has underscored that it rightly deserves a permanent seat at the horse-shoe table.

India last sat at the UN high table as a non-permanent member in 2021-22. A polarised Security Council has also failed to deal with current peace and security challenges with Council members sharply divided on conflicts such as the Ukraine war and the Israel-Hamas conflict.

Secretary-General UN Antonio Guterres has also

had 51 Member States when it was established nearly 80 years ago, and today it is made up of 193 nations. The UN chief warned that the 15-nation United Nations Security which he has Council. described as "outdated" and whose authority is eroding, will eventually lose all credibility unless its composition and working methods are reformed. The UN chief has given a clarion call that "we can't build a future for our grandchildren with a system built for our grandparents."

On reform of the multilateral trading system, Jaishankar said India remains unwavering in its commitment to rulesbased, non-discriminatory, fair, open, inclusive, equitable and transparent multilateral trading system, with the World Trade Organisation (WTO) at its core.

Delhi strongly supports poli-cies that foster trade and investment, enabling every nation to flourish in an interconnected and dynamic world, he said.

He said that to foster a favourable trade and investment environment, "we must ensure a truly level playing field and fair competition. Market distorting practices and protectionism must be firmly discouraged," he said.

India calls for comprehensive reform of the WTO to enhance its functions through an inclusive, member-driven and transparent process.

"It remains committed to constructive discussions for realising a fully operational and effective dispute settlement system accessible by all members.

He stressed that a reformed and fair multilateral trading system is vital for "our future to be more equitable and inclu-

Jasleen Kaur's Turner Prize shortlisted exhibition goes on display at Tate Britain

Glasgow-born artist Jasleen Kaur, whose artwork inspired by her life growing up in Scotland's Sikh community was shortlisted for the prestigious Turner Prize, on Wednesday opened to the public as part of a major exhibition at Tate Britain

in London. London-based Kaur, in her 30s, has created sculptures from gathered and remade objects, each of which are ani-mated through an immersive sound and musical composition interspersed with the artist's

own renditions. Back in April, Kaur was shortlisted alongside three other fellow UK artists – Pio Abad of Filipino heritage, Black British Arts Movement founding member. Claudette, Johnson member Claudette Johnson and Delaine Le Bas of Romani heritage – for the prize which will award the winner GBP 25,000 (USD 33,420 approx), with GBP 10,000 (USD 13,370 approx) each for the nominated artists.

While the winner will be announced at an awards cere-mony at Tate Britain on December 3, the exhibition of their works will run at the museum on the banks of the River Thames until mid-

February 2025.

"Jasleen studied jewellery making and then applied art, so she's very interested in making objects in combinations around the stories that they can tell," said Linsey Young, co-curator of the exhibition at Tate Britain.

"Her room is made up of installations that are looking at anti-colonialist discussion, anti-imperialist struggles and really assessing those against her lived experience, her family and upbringing. It includes a Ford car and she talks about it as being one of her dad's ambi-tions and migrant desires; when he moved from India to Glasgow, having a car like that

was an aspiration. "It's covered in a crocheted cotton doily (ornamental mat), so a kind of domestic object made very, very large where the cotton material relates to histories of migration and labour - of Indian people coming to the north of England after the war and working in cotton mills," she said.

Other items making up Kaur's display include family photos, a harmonium, a lush carpet inviting visitors to sit and kinetic worship bells, all orchestrated to convey the artist's upbringing in Scotland. A central feature is music

entitled Yearnings 2023', an improvised vocal soundscape of the artist's voice layered over from the speakers of 'Sociomobile 2023' – the vintage Ford Escort – filling the space with Kaur's musical memory.

In an accompanying film at the exhibition, the artist reflects upon the Sikh concept of Miri Piri, which talks of finding a balance between the political and spiritual and wants to explore the different ways for humanity to live together through her art.

The Turner Prize praised her "evocative combina-tion of sound and sculpture to address specifics of family memory and community strug-

gle". "This year's artists each make vibrant and varied work that reflects not just their personal memories and familial stories, but also speaks to wider questions of identity, myth, belonging and community. Through their varied practices, they offer us a lens through which to reconsider both our tangled histories and our shared futures," said Alex Farquharson, Director of Tate Britain and chair of the Turner Prize jury Prize jury.

Individuals exposed to the radiation emanating from a CT scan are at an elevated risk of developing thyroid cancer and leukemia, a new study says. Moreover, researchers concluded that patients receiving CT scans had in general marked increases in the risk of developing thyroid cancer and leukemia, especially in female patients and patients younger than 45. "Our study found that CT scans are associated with an increased risk of thycancer roid and leukemia in adults in

tion on disease diagnoses, procedures, and drug prescriptions, and the enrollment profiles of all patients. Patients were

excluded if they were under 25 years at the time of the cancer diagnosis, had less than three years of follow-up before cancer diagnosis, or had a history of cancer before the year 2000.

Results showed that patients who developed thyroid cancer and leukemia had a significantly higher likelihood of having received CT scans.

In studies that combined patients across age groups, exposure to medical CT scans was not associated with increased risk for non-Hodgkin lymphoma.

However, in patients between 36 and 45 years of age, there was a three-fold increased risk of non-Hodgkin lymphoma associated with CT scans.

In older patients, the association between exposures to CT scans and non-Hodgkin lymphoma was not evident.

"The risk is stronger in patients who have higher cumulative doses from multiple scans. <


Amidst some existing consumer concerns that statins might pose a negative impact on an individual's cognitive health, researchers in a new study have found that it is not so.

Statins are a class of drugs that are known to cure a number of health issues including reducing illness in people who are at high risk of cardiovascular disease.

In the study conducted on over 1,000 elderly individuals and assessed over six years, researchers have revealed there is no link between statin medication and cognitive decline, such as memory loss.

The study was published in the Journal of the American College of Cardiology. "We carried out the

most comprehensive analysis of cognition in elderly statin users to date, and found no results to support that cholesterol-lowering statins cause memory impairment," said study's first Professor author Katherine Samaras, Head of the Clinical Obesity, Nutrition and Adipose Biology



lab at the Garvan Institute and endocrinologist at St Vincent's Hospital Sydney.

"Many factors can contribute to the cognitive symptoms that isolated case reports describe. What we've come away with from this study is a reassurance for consumers to feel more confident about their

statin prescription," added Samaras. Statins are among the most widely prescribed medications, safely administered since the 1990s to treat people with heart disease or high

cholesterol to reduce the risk of future heart disease events.

However, isolated case reports of cognitive decline in statin users have concerned some consumers. Up to half the individuals prescribed statin therapy do not fill their prescriptions largely due to this concern.

Researchers in the current study assessed changes to the brain in 1,037 elderly individuals, measuring five areas of cognition using 13 different tests and MRI scans of the brain, over six years.

"Controlling for important and potentially contributory factors, such as age, sex and obesity, we found no difference in the rate by which memory and other aspects of cognition changed over time, between statin users and those who had never used the medication.," explained Professor Samaras.

"Our findings demonstrate how crucial a healthy metabolism is to brain function, and how therapies can modulate this to promote healthy ageing," said Professor Samaras.

New method found to detect neural activity centre in brain

Researchers have developed a new lightbased method to capture and pinpoint the epicentre of neural activity in the brain.

The device successfully captured neural activity in specific subregions of the striatum involved in the release of dopamine during specific behaviours. The approach has effectively allowed sci-

Many parents have trouble differentiating between teen angst and depressive symptoms

Being able to differentiate between normal mood swings and something serious remains the top challenges faced by parents in identifying youth depression, suggests a recent study.

Though the majority of parents say they are confident they would recognise depression in their middle or high schoolaged child, two-thirds acknowledge barriers to spotting specific signs and symptoms, according to the C.S. Children's Mott Hospital National Poll on Children's Health at the University of Michigan.

Forty per cent of parents struggle to differentiate between normal mood swings and signs of depression, while 30% say their child is good at feelings, hiding according to a new poll.


As the researchers have discovered how the lung disease idiopathic pulmonary fibrosis (IPF) progresses, they will now be able to provide a method to discover new treatment targets for the disease.

The study, led by Naftali Kaminski, M.D., the Boehringer-Ingelheim Endowed Professor of Internal Medicine and chief of the Section of Pulmonary, Critical Care, and Sleep Medicine at Yale School of Medicine, and John E. McDonough, instructor, and researcher at the medical school appeared in -- JCI.

In the study, researchers examined differentially affected regions in the lungs obtained from individuals with IPF and found that what looks like normal lung is already undergoing changes in specific genes.

They then tracked how these genes continue to change, increasing or decreasing, as the disease progresses.

A unique feature of the paper, said Kaminski, is that it provides the first computational model of disease pro-

IPF is a chronic disease in which the lungs become increasingly scarred and unable to function; it affects some 200,000 people in the U.S., with about 30,000 new cases each year.

Animal models for IPF work to show how pulmonary fibrosis impacts the lungs, but not what regulates changes at the genetic level to drive IPF progression in humans.

The investigators used a unique system that allowed them to quantify the amount of fibrosis in differentially affected regions in the lung and then to measure the expression of all the genes in the human genome in exactly the same region by RNÅ sequencing. They also measured microRNAs, small noncoding RNAs known to regulate the expression of genes. They applied advanced systems biology methods to identify tracks of gene expression associated with the progression of IPF in the lung and the molecules that regulate them. Using this approach, they made three key findings. First, they discovered that what looked like normal tissue in the diseased lung was in fact abnormal. Second, they identified gene expression changes that were specific to tissue associated with early, progressive.

She said that Magistrates are vital to the smooth functioning of assembly elections, ensuring that the democratic process is carried out efficiently, securely, and fairly on poll day and prior to polls. She further said that their responsibilities are integral to



the electoral process especially in maintaining law and order situation and addressing any issue that may arise at the polling stations.

The DEO also called on the officers to remain vigilant and be in sync with the latest protocols and procedures mandated by the Election Commission of India (ECI). She said that in case of any significant issues, such as malfunctioning of EVMs, disruption of the voting process, or law and order disturbances, Magistrates are first emergency responders and they

have to take immediate action and report to higher election authorities.

further She said that Magistrates act as a point of contact between polling officials at polling stations and Election authorities, besides this they will have to establish contacts and have close coordination with all agencies of the concerned area.

DEO directed concerned magistrates to visit all their allotted polling stations by tomorrow and take first hand appraisal of AMFs, security concerns and other

shortcomings if any and report back. She emphasized that submission of 2hourly error free voter turnout reports are very crucial for magistrates on the day of poll.

Sameer Jan, Special Nodal officer elections provided insights to the Magistrates for a seamless voting process on the day of the election and prior to election. He stressed them to participate in the training regarding familiarization of Electronic Voting Machines (EVMs) and other processes without any fail.
